## Introduction

## How To Get The Most From This Course

UNIT 1 LINEAR ALGEBRA

### 1.0 INTRODUCTION

Linear algebra is the branch of mathematics concerning vector space and linear mappings between such spaces. It includes the study of lives, places and subspaces, but is can also be said that linear algebra is concerned with some of the properties common to all the vector spaces. Linear algebra is also central to both pure and applied mathematics. For instance, abstract algebra is when we relax the axioms of a vector space, leading to a number of generalizations. However, functional analysis studies the infinite - dimensional version of the theory of vector spaces.

### 2.0 OBJECTIVES

At the end of this unit, you should be able to:

- understand the history of linear algebra
- know how to calculate linear equation
- also know meaning and how to calculate exponential equation


### 3.0 MAIN CONTENT

### 3.1 History of Linear Algebra

The study of linear algebra first emerges from the study of determination that were used in solving different systems of linear equations. It should then be noted that Leibniz in 1963 and Gabriel Gramer derived Gramer's rule for solving the theory of linear systems by using Gaussian elimination.

Matrix algebra was also first to emerge in England in the mid-1800. The theory of extension was published by Hermann Grassmann which is now been called today as linear algebra.

### 3.2 Linear Equation

A linear equation is called an algebraic equation in which each term is either a constant or the product of a constant is a single variable. An example of a linear equation with only one variable, say $x$ can be written as $a x+b=0$, where a and b are constants and $a \neq 0$. In the equation above the constants may be numbers parameters or linear functions of parameters. However, the differences between the variables and parameters may depend on the problem.

Let us take a look at three variable linear equations $a x+b y+c z+d=$ 0 , where $\mathrm{a}, \mathrm{b}, \mathrm{c}$ and d are constants and $\mathrm{a}, \mathrm{b}$ and c are now zero. Linear equations can then occur frequently in most areas of mathematics and especially in applied mathematics.

Let also take a look at equations with exponents greater than one are non-linear and an example of such non-linear of two variables is $a x y t b=0$ where a and b are constants and $a \neq 0$. It also has two variables x and y and is non-linear because the sum of the exponents of the variables in the first term axy is two.

Let us start our calculation with one variables;

### 3.2.1 One Variable

$$
\begin{equation*}
a x=b \tag{1}
\end{equation*}
$$

If a $a=0$, then when $\mathrm{b}=0$, every number is a solution, but if $\mathrm{b} \neq 0$ there is no solution.

## Example 1

Given $2 x=8$

& x=4 .
\end{aligned}
$$

## Example 2

Given $16 x=32$

$$
\begin{aligned}
& x=\frac{32}{16} \\

m=\frac{Q}{16}
$$

### 3.2.2 Two Variable

For two variable; $y=m x+b$, where m and b are constants or parameter.

## Example 4

Given

$$
y=2 x+4 m . \text { find } m \text { in terms of } y .
$$

## Solution

$y=2 x+4 m$
$y-2 x+4 m$ (make $m$ the subject of the formular)
Divide both sides by 4

$$
\frac{y-2 x}{4}=\frac{4 m}{4} .
$$

$$
m=\frac{y-2 x}{4}
$$

## Example 5

$2 x+8=-6 x+4$

Find $x$

## Solution

Collect like terms of $x$ together and constant together
$2 x+6 x=4-8$
$8 x=-4$
$x=-\frac{4}{\not 又} 2$
$x=-1 / 2$.

### 3.3 Exponential Equation

An exponential equation is one in which a variable occurs in the exponent for example
$5^{2 x+3}=5^{3 x-1}$, when both sides of the equation have the same base, the exponents on either side are equal by the property $x^{a}=x^{b}$ then $a=b$.

However, if $x^{\circ}=1$.

## Example 6

Given $2^{4 x} \times 4^{2 x-1}=16^{x} \times 32^{x-2}$

Find $x$.
$2^{4 x} \times 4^{2 x-1}=16^{x} \times 32^{x-2}$.
$2^{4 x} \times 4^{2(2 x-1)}=2^{4(x)} \times 2^{5(x-2)}$.
*from the law of indices when $x^{a} \times x^{b}=x^{a+b}$

* applied the law of indices; we have:
$2^{4 x}+2(2 x-1)=2^{4(x)+5(x-2)}$

From the law of exponential equation, if the base are equal, then we equate the powers.
$4 x+2(2 x-1)=4(x)+5(x-2)$
$4 x+4 x-2=4 x+5 x-10$

Collect likes terms together.
$4 x+4 x-4 x-5 x=-10+2$
$8 x-9 x=-8$
$-x=-8$.
Multiply both sides by negative.
$-(-x=-8)$.

### 1.0 INTRODUCTION

Simultaneous linear equation is also known as a system of equations or an equation system is called a finite set of equations for which common solutions are bought. However, an equation system is usually classified in the same manner as single equations. There are three types of simultaneous equations namely: Elimination Method, Substitution Method and Graphical Method. However, in this unitthe scope of this course material only is the Elimination method and the Substitution method will be used.

### 2.0 OBJECTIVES

- know meaning and how to calculate Elimination and Substitution methods of simultaneous equation.


### 3.0 MAIN CONTENT

### 3.1 Elimination Method

One way of solving a linear system is to use the elimination method. In the elimination method you either add or subtract the equations to get an equation in one variable.

When the coefficients of one variable is an opposites you add the equations to eliminate available and when the coefficients of one variable are equal you subtract the equations to eliminate a variable.

## Example 1

## Given

$$
\begin{equation*}
3 x+4 x=6 \tag{1}
\end{equation*}
$$

$5 y-4 x=10$
From the equation above, we can eliminate the $x$-variable by subtracting equation two from equation one.

$$
\begin{gathered}
3 y+4 x=6 \\
5 y-4 x=10 \\
\hline 8 y=16 \\
y= \\
y= \\
y=
\end{gathered}
$$

We can then substitute the value of $y$ in any of the original equation to find the value of $x$.
$3 y+4 x=6$
$3(2)+4 x=6$
$6+4 x=6 \Rightarrow 4 x=6-6$

$$
\begin{gathered}
4 x=0 \Rightarrow x=\frac{0}{4} \\
x=0 .
\end{gathered}
$$

Therefore, the solution of the linear system is $(x, y) \Rightarrow(0,2)$

## Example 2

To eliminate x or y it depends on you. So if you want to eliminate x , you will use the coefficient of $x$ in equation one to multiply equation two (That is 6) while the coefficient of $x$ in equation two is to multiply equation one (that is 10 ).

Then subtract equation (iv) from (iii)

### 3.2 Substitution Method

Substitution method is an algebraic method used to find an exact solution of a system of equations. Suppose there are two variables in the equation $x$ and $y$. to use the substitution method, find the value of $x$ and $y$ from any of the given equations.

Then we can substitute the value we obtain of the given variable in the other equation such that a single variable equation is obtained and solved. The following steps should be followed to solve substitution method:

## Step 1

Write any of the equations to get the value of $x$ or $y$.

## Step 2

Substitute that value of x or y in the other equation.

## Step 3

Solve the obtained single variable equation.

## Example 3

Given :

$$
\begin{align*}
& x+y=2  \tag{i}\\
& 2 x+2 y=6 \tag{ii}
\end{align*}
$$

From equation $x+y=2$
Make $x$ the subject of the formula

$$
\begin{equation*}
x=2-y_{1} \tag{iii}
\end{equation*}
$$

The substitution x in equation (ii)

$$
\begin{align*}
& 2 x+3 y=6  \tag{ii}\\
& 2(2-y)+3 y=6 \\
& 4-2 y+3 y=6

If you remember in example three (3) above we make use of equation (i) by making $x$ the subject of the formula.

But, let us now make use of equation (ii) in this example 4.

$$

Recall that you are to decide whether you want to get the value of $x$ or $y$ first. The values you want to get first determine the equation you are going to have.

Let us get the value of $x$ first here, so that we can make $y$ the subject of the formula in equation (iii).

So, from equation (ii) $\quad 4 x+2 y=2$

$$
2 y=2-4 x
$$

$$
\begin{equation*}
y=\frac{2-4 x}{2} \tag{iiii}
\end{equation*}
$$

Now let us substitute for y in equation (i)

### 1.0 INTRODUCION

A sequence sometimes called a progression is an ordered list is known as 'elements' or the 'items' of the sequence. It can also be a set of numbers arranged in a definite order according to some definite rule or a function whose domain is the N of natural numbers.

However, a series is what you get when you add up all the terms of a sequences, where the addition and the resulting value are called the sum or the summation. For example 1, 2, 3, 4 is a sequence, with terms 1,2 , 3 , and 4 , the corresponding series is the sum $1+2+3+4$ and the value of the series is 10 . Sequence maybe named or referred to by an upper case letter such as 'A' or 'S'. The terms of a sequence are usually named something like ' $a_{i}$ ' or $a_{n}$ with the subscripted letter ' $I$ ' or ' $n$ ' being the 'index' or the counter. Therefore the second term of a sequence might be named " $a_{2}$ " which is pronounced ' ay - sun two and $a_{12}$ will be pronounced as the twelfth term.

The sequence can also be written in terms of its terms. For example, the sequence of term $a_{i}$ ' with the index running from $i=1$ to $i=\wedge$ can be written as:

### 3.1 Sequences as a Function

Let us take an example of $T_{n}=3_{n}-1$, where $T_{n}$ is the nth term and n $=1,2,3$------, this gives us a formular for finding any required term. However, a sequence $T_{1}, T_{2}, T_{3}, \cdots---, T_{n}$, is the set of images given by the function $T_{n}=\mathrm{f}(n)$ of the position integers say $1,2,3,-----$, n . sequence may be finite or infinite. When we talk about the finite sequence, n will have an upper value and $T_{n}$ will be the last term of the sequence. If it is an infinite sequence, there is no last term.

## Example 1

Write down the first $5^{\text {th }}$ terms of each sequences if:
a. $\quad T_{n}=3_{n}$
b. $\quad T_{n}=(-3)^{n}$.
a. $\quad T_{n}=1-3 n$

First term $\Rightarrow \mathrm{n}=1 \Rightarrow T_{1}=1-3(1)$

=1-3=-2
$$

Second term $\Rightarrow \mathrm{n}=2 \Rightarrow T_{2}=1-3(2)$

First term $\Rightarrow \mathrm{n}=1=T_{1}=(-3)^{1}=-3=-3$
Second term $\Rightarrow \mathrm{n}=2,=T_{2}=(-3)^{2}=9$
Third term $\Rightarrow \mathrm{n}=3,=T_{3}=(-3)^{3}=-27$
Fourth term $\Rightarrow \mathrm{n}=4,=T_{4}=(-3)^{4}=81$
Fifth term $\Rightarrow \mathrm{n}=5,=T_{5}=(-3)^{5}=-243$.

## Example 1

Given the nth term of a sequence is given, write down the first terms.

Third term $\Rightarrow T_{3}=a+(3-1) d$

Where a is the first term and d is the common difference.

Therefore, the first 4 term are $a, a+2 d, a+3 d, a+4 d$.

### 3.2 Arithmetic Progression (AP)

In mathematics, an arithmetic progression (AP) or arithmetic sequence is a sequence of numbers such that the difference between the
consecutive terms is constant. Let us take a look at this example, say 2 , $4,6,8,10, \ldots \ldots$ is an arithmetic progression with a common difference of 2 .

The nth term of a AP is given as:

$$
\begin{aligned}
& T_{n} a+(n-1) d \\
& \text { Where } T_{n} \text { nth term } \\
& \qquad \begin{aligned}
\mathrm{a} & =\text { first term } \\
\mathrm{n} & =n v \text { of term } \\
\mathrm{d} & =\text { common difference. }
\end{aligned}
\end{aligned}
$$

## Example 2

What is the $15^{\text {th }}$ term of the sequence $-3,2,4, \ldots \ldots$ ?
$a=-3, d=2-(-3)=2+3=5$

$T_{15}=a+(n-1) d \Rightarrow-3+(15-1) 5$
$T_{15} \Rightarrow-3+(14) 5=-3+70=69$.

### 3.3 Geometric Progression (G.P)

A geometric Progression is also known as a geometric sequence, is a sequence of numbers where each term after the first is found by multiplying the previous one by a fixed, non-zero numbers called the common ration. Let us consider the following $2,6,18,54, \ldots \ldots$ is a geometric progression with common ratio 3 .

The general term of a geometric progression (G.P) is $a, a r, a r^{2}, a r^{3}, a r^{4} \ldots$.

Where $r \neq 0$ is the common ration and $a$ is the first term.
Therefore the nth term of a G.P is given as $T_{n}=G r^{n-1}$

## Example 4

Find (a) the $10^{\text {th }}$ term of the given 128 , by $32, \ldots \ldots$ (b) a formula for the nth term.

## Solution

a. $\quad$ The sequence is a G.P as $r=\frac{64}{128}=\frac{32}{64}=\frac{1}{2}$

$$
a=128 .
$$

$$
\begin{aligned}
T_{10}=a r^{n-1} \Rightarrow T_{10} & =128(1 / 2)^{10-1} \\

$a=1 / 8, r=\frac{1}{4} \div \frac{1}{8}=\frac{1}{4} \times \frac{8}{1}=2, n=10$.

Since $r>1$, we use:
$S_{n}=\frac{a\left(r^{n}-1\right)}{r-1}=S_{10}=\frac{1 / 8\left(2^{10}-1\right)}{2-1}$
$\frac{\frac{1}{8}(1024-1)}{1}=\frac{1}{8}(1023)=\frac{1023}{8}$
$=127^{7} / 8$.

### 3.6 Sum to Infinity of a G.P

The sum to infinity of a G.P is the formula for sum to identify of G.P is given as:

### 1.0 INTRODUCTION

Calculus was a branch of mathematics which was largely established by Newton and Leibnitz in the $17^{\text {th }}$ century. It involves a very important ideas and techniques. Calculus is divided into two parts: Differentiation and integration.

### 2.0 OBJECTIVES

### 3.0 MAIN CONTENTS

### 3.1 Differentiation

Before we can start our discussion on differentiation, we will first take a look at what is GRADIENTS of a straight line. However, the gradient of a straight line is the ratio of increase in y to increase in n in going from one point to another on the line. Let us take an example below to explain further.


Figure1: Showing Gradient of a straight line.
From the graph above, $\operatorname{if}\left(x_{1}, y_{1}\right),\left(x_{2}, y_{2}\right)$ are two points on a line, the gradient will be
$\frac{y_{2}-y_{1}}{x_{2}-x_{1}}$ which is equal to the definition of gradients given above. The gradient will of course constant all along the line and also equal to the tangent of the angle ' $\theta$ ' made with the possible direction of the x -axis.

Therefore we can say that a gradient function will be change in y over change in x .

Note: Differentiation is also called rate of change. The process of finding the gradient function $\frac{d y}{d x}$ or $f^{1}(x)$ is called differentiation and $\frac{d y}{d x}$ will now be called the derivation of y with respective to x and it also sometimes called the differential coefficient y . in the course of our study, we shall use wrt for 'with respect to'. Has a wider meaning to $\frac{d y}{d x}$ which will gradually emerge and this is the idea of instantaneous rate of change $\frac{d y}{d x}$ measures the rate of change of the quantity ' $y$ ' as compared with x .

## Example 1

If $x^{2}, \frac{d y}{d x}=2 x$, we can then say that the rate of change of y as compared with x is 2 x . But it must be noted that this rate of change is not constant but varies with the value of x , bound together by the relation $\mathrm{y}=x^{2}$. It is important here to get this idea that $\frac{d y}{d x}$ measures the rate of change of y as compared with $x$, firmly fixed in one's mind. It was this good idea which made differentiation (the basis of calculus) one of the great inventions of mathematics and this has help us to be able to deal with changing quantities and measures their rates of change accurately.

### 3.1.1 Differentiation from the First Principle

## Example 1

Differentiate $3 x^{2}-x+5$ with respect to x from the first principle.

## Solution

Let $y=3 x^{2}-x+5$, an increment from x to $\mathrm{x}+\mathrm{dx}$ produce corresponding increment in y to $\mathrm{y}+\mathrm{dy}$ (that is a place of x in y put $\mathrm{x}+$ dx).

$$
\begin{aligned}
& \text { Therefore, } y+d y=3(x+d x)^{2}-(x+d x)+5 \\
& d y=3(x+d x)^{2}-(x+d x)+5-\mathrm{y} \\
& d y= 3\left(x^{2}+2 x d x+d x^{2}\right)-(x+d x)+5-\left(3 x^{2}-2 x-5\right) . \\
& d y=3 x^{2}+6 x d x+3 d x^{2}-x-d x+5-3 x^{n}+2 x-5
\end{aligned}
$$

$d y=6 x d x+3 d x^{2}-d x$
Slope $\frac{d y}{d x}=\frac{(6 x d x+3 d x-1) d x}{d x}=6 x+3 d x-1$.
As $d x>03, d x>0$ and $\frac{d y}{d x}=\frac{d y}{d x}$, therefore $\frac{\mathrm{dy}}{\mathrm{dx}}=6 \mathrm{x}+0-1=6 \mathrm{x}-1$

## Example 2

Differentiate $\frac{1}{x^{2}}$ with respect to x from principle.
Note here that any small increase of dx in x produces a corresponding increase of dy in $y$.
$y+d y=\frac{1}{(x+d x)^{2}}$

$$
d y=\frac{1}{(x+d x)^{2}}-y=\frac{1}{(x+d x)^{2}}-\frac{1}{x^{2}}
$$

$d y=\frac{x^{2}-(x+d x)^{2}}{(x+d x)^{2} x^{2}}=\frac{x^{2}-\left(x^{2}+2 x d x+d x^{2}\right)}{(x+d x)^{2} x^{2}}$

$\frac{d y}{d x}=\frac{(2 x+d x)}{(x+d x)^{2}\left(x^{2}\right)}$
$\operatorname{As} d x \rightarrow 0 \frac{d y}{d x}=\frac{d y}{d x}=\frac{-2 x+0}{(x+0)^{2}\left(x^{2}\right)}=\frac{-2 x}{x^{4}}$
$\frac{d y}{d x}=\frac{-2}{x^{3}}=-2 x^{-3}$.
Generally if $\mathrm{y}=a x^{n}$.
$\frac{d y}{d x}=n a x^{n-1}$ where a is a constant

### 3.1.2 Differentiation of a Constant

If $\mathrm{y}=\mathrm{k}$ where K is constant, the $\frac{d y}{d x}=0$. This means that the differentiation of a coefficient of a constant is zero.

## Example 1

$\mathrm{Y}=10$, differentiate wrt x

$$
\frac{d y}{d x}=0 \times 10^{0-1}=0 \times 10 x^{-1}=0
$$

Hence if $y=10, \frac{d y}{d x}=0$

## Example 2

If $y=2 x^{2}, \frac{d y}{d x}=2 \times 2 \times x^{2-1}=4 x^{1}=4 x$
Example 3
If $\mathrm{y}=\frac{1}{x}, \frac{d y}{d x}=x^{-1-1}=-x^{-2}=\frac{-1}{x^{2}}$

## Example 4

### 4.0 CONCLUSION

In this unit, we can conclude that differentiation is a process of finding a function that outputs the rate of change of one variable with respect to
another variable. Informally, in this unit, we can assume that we are tracking the position of a car on a two-lane road with no passing lanes. However, if we assuming the car never pulls off the road, we can abstractly study the car's position by assigning it a variable, x Since the car's position changes as the time changes, we say that x is dependent on time, or $\mathrm{x}=\mathrm{f}(\mathrm{t})$. This tell us where the car is at each specific time. Finally, we can then say that differentiation gives us a function $\mathrm{dx} / \mathrm{dt}$ which represents the car's speed that is the rate of change of its position with respect to time.

### 1.0 INTRODUCTION

Composite function is also called function of a function or the chain rule. That is if $y=u$ and $u$ is a function of say $x$.

Therefore the formular for composite function is:
$\frac{d y}{d x}=\frac{d y}{d u} \times \frac{d u}{d x}$
So the formular above is used in calculating various problem under composite function of differentiation.

### 3.0 MAIN CONTENT

### 3.1 Examples of Composite Function

## Example 1

Differentiate wrt $\mathrm{x} y=\sqrt{2 x+5}$
Let us take $\mathrm{u}=2 x+5$ and y becomes $\mathrm{y}=u^{\frac{1}{2}}$.
$\frac{d y}{d x}=2$ and $\frac{d y}{d x}=\frac{1}{2} u^{-\frac{1}{2}}$
Therefore from the composite function we have
$\frac{d y}{d x}=\frac{d y}{d u} \times \frac{d u}{d x}$
$\frac{d y}{d x}=\frac{1}{2} u^{-\frac{1}{2}} \times 2=u^{-\frac{1}{2}}=\frac{1}{\sqrt{2 x+5}}$

## Example 2

### 3.2 Other Techniques of Differentiation: The Product Rule

Given $y=(2 x-1)^{3}\left(x^{3}+7\right)$ is the product of two expressions $(2 x-1)^{3} \operatorname{and}\left(x^{3}+7\right)$. However, to find $\frac{d y}{d x}$, we can try to expand the product but that will take a greater time and cumbersome to do. So we can just differentiate each expression separately, so we now see how $\frac{d y}{d x}$ can be found from the two derivatives.

Take for example here, let $y=u v$, where is $u$ and $v$ are each function of x . Therefore uv is the product of two functions. For the example given above $u$ will be $(2 x-1)^{3}$, and $v$ will be $\left(x^{3}+7\right)$.

In conclusion the formular for the product rule is given as:

$$
\frac{d y}{d x}=v \frac{d u}{d x}+u \frac{d v}{d x}
$$

## Example 1

Differentiate $\mathrm{y}=(3 x-4)\left(x^{2}+8\right)$ wrt x
Take u as $3 x-4$ and $v=x^{2}+8$
Then $\frac{d u}{d x}=3$ and $\frac{d v}{d x}=2 x$
$\frac{d y}{d x}=v \frac{d u}{d x}+u \frac{d v}{d x}$
$\frac{d y}{d x}=\left(x^{2}+8\right) 3+(3 x-4) 2 x$
$=3 x^{2}+24+\left(6 x^{2}-8 x\right)$
$=3 x^{2}+24+6 x^{2}-8 x$
$\frac{d y}{d x}=3 x^{2}+6 x^{2}-8 x+24$
$\frac{d y}{d x}=9 x^{2}-8 x+24$

## Example 2

Let $\mathrm{u}=x^{2}$ and $v=(2 x-5)^{4}$
$\frac{d y}{d x}$ and $v \frac{d u}{d x}+u \frac{d v}{d x}$
$\frac{d y}{d x}=v \frac{d u}{d x}+u \frac{d v}{d x}$
$\frac{d y}{d x}=2 x(2 x-5)^{3}+x^{2}\left[4(2 x-5)^{3}\right]$

\frac{d y}{d x} & =2 x(2 x-5)^{3}(2 x-5+4 x) \\
& =2 x(2 x-5)^{3}(6 x-5)
\end{aligned}

& \frac{d u}{d x}=\frac{1}{2}(x+1)^{-\frac{1}{2}} \times 1, \frac{d v}{d x}=2(x+3)^{1} \times 1=2(x+3) \\
& \frac{1}{2}(x+1)^{-\frac{1}{2}}
\end{aligned}
$$

$$
\begin{aligned}
\frac{d y}{d x} & =v \frac{d u}{d x}=+u \frac{d v}{d x}=(x+3)^{2}\left[\frac{1}{2}(x+1)^{-\frac{1}{2}}\right]+(x+1)^{\frac{1}{2}}[2(x+3)] \\
& =\left[\frac{1}{2}(x+3)^{2} \times \frac{1}{(x+1)^{\frac{1}{2}}}\right]+2(x+3)(x+1)^{\frac{1}{2}} \\
& =\left[\frac{1}{2} \frac{(x+1)^{2}}{(x+1)^{\frac{1}{2}}}\right]+\left[(2 x+6)(x+1)^{\frac{1}{2}}\right] \\
& =\frac{(x+1)^{2}+2(x+1)^{\frac{1}{2}}(2 x+6)(x+1)^{\frac{1}{2}}}{2(x+1)^{\frac{1}{2}}} \\
& =\frac{\left(x^{2}+6 x+9\right)+2(x+1)(x+1)(2 x+6)}{2(x+1)^{\frac{1}{2}}} \\
= & \frac{x^{2}+6 x+9+2\left(2 x^{2}+2 x+6-6\right)}{2(x+1)^{\frac{1}{2}}} \\
= & \frac{x^{2}+6 x+9+4 x^{2}+16 x+12}{2(x+1)^{\frac{1}{2}}} \\
= & \frac{5 x^{2}+22 x+21}{2(x+1)^{\frac{1}{2}}}
\end{aligned}
$$

### 3.3 Other Techniques of Differentiation: The Quotient Rule

Suppose $y=\frac{u}{v}$ where U and V are each function of x
Then $y=u v^{-1}$ and we can then make use of the product rule to find
$\frac{d y}{d x}$.
Therefore
$\frac{d y}{d x}=\frac{v \frac{d u}{d x}-u \frac{d u}{d x}}{v^{2}}$
Note that you should not use the quotient rule where the denominator is a single term.

## Example 1

Differentiate $y=\frac{x^{2}}{\sqrt{x+1}}$
Let $\mathrm{u}=x^{2}$ and $\frac{d u}{d x}=2 x$
$v=\sqrt{x+1}=(x+1)^{\frac{1}{2}}$
$\frac{d v}{d x}=\frac{1}{2}(x+1)^{-\frac{1}{2}}=\frac{1}{\sqrt[2]{x+1}}$ and $v^{2}=(x+1)$
$\frac{d y}{d x}=\frac{v \frac{d u}{d x}-u \frac{d v}{d x}}{2}$
$\frac{d y}{d x}=\frac{\sqrt{x+1} \times 2 x-\frac{x^{2}}{\sqrt[2]{x+1}}}{(x+1)}$

$$
=\frac{\sqrt[2]{x+1} \times \sqrt{x+1} \times 2 x-x^{2}}{\sqrt[2]{x+1}(x+1)}
$$

Now let us multiply the numerator and denominator by $\sqrt[2]{x+1}$
$\frac{d y}{d x}=\frac{4 x(x+1)-X^{2}}{2(x+1)^{1 / 2}}=\frac{x(3 x+4)}{2(x+1)}$

## Example 2

$y=\frac{2 x+1}{3 x-2}$
Let $u=2 x+1$ and $v=3 x-2$
$\frac{d u}{d x}=2$ and $\frac{d v}{d x}=3$
$\frac{d u}{d x}=\frac{v \frac{d u}{d x}-u \frac{d v}{d x}}{v^{2}}$
$\frac{d y}{d x}=\frac{(3 x-2)(2)-(2 x+1)(3)}{(3 x-2)^{2}}$

$$
\begin{aligned}
& =\frac{6 x-5-6 x-3}{(3 x-2)^{2}} \\
& =\frac{-7}{(3 x-2)^{2}}
\end{aligned}
$$

## Example 3

$y=\sqrt{\frac{x-1}{x+1}}$
Applying the surd rule $\sqrt{\frac{x-1}{x+1}}=\frac{\sqrt{x-1}}{\sqrt{x+1}}$
Therefore $\frac{\sqrt{x-1}}{\sqrt{x+1}}=\frac{(x-1)^{1 / 2}}{(x+1)^{1 / 2}}$
Let $\mathrm{u}=(x-1)^{1 / 2}$ and $\mathrm{v}=(x+1)^{1 / 2}$

$$
\begin{aligned}
& \frac{d u}{d x}=\frac{1}{2}(x-1)^{-1 / 2} \frac{d v}{d x}=\frac{1}{2}(x+1)^{-1 / 2} \\
& \frac{d y}{d x}=\frac{v \frac{d u}{d x}-u \frac{d v}{d x}}{v^{2}}
\end{aligned}
$$

$$
\begin{aligned}
& =\frac{[x+1]^{1 / 2}\left[\frac{1}{2}(x-1)^{-1 / 2}\right]-[x+1]^{1 / 2}\left[\frac{1}{2}(x+1)^{-1 / 2}\right]}{\left[(x+1)^{1 / 2}\right]^{2}} \\
& =\left[\frac{\frac{(x+1)^{1 / 2}}{2(x-1)}-\frac{(x-1)^{1 / 2}}{2(x+1)^{1 / 2}}}{\left((x+1)^{1 / 2}\right)^{2}}\right]=\left(\frac{\frac{(x+1)^{1 / 2}}{2(x-1)}-\frac{(x-1)^{1 / 2}}{2(x+1)^{1 / 2}}}{(x+1)}\right) \\
& =\left(\frac{(x+1)^{1 / 2}}{2(x-1)}-\frac{(x-1)^{1 / 2}}{2(x+1)^{1 / 2}}\right) \div(x+1) \\
& =\left(\frac{(x+1)^{1 / 2}(x+1)^{1 / 2}-(x-1)^{1 / 2}(x-1)^{1 / 2}}{2(x-1)^{1 / 2}}\right) \div(x+1)
\end{aligned}
$$

$$
\begin{aligned}
& =\frac{(x+1)-(x-1)}{2(x-1)^{1 / 2}(x+1)^{1 / 2}} \times \frac{1}{x+1} \\
& =\frac{x+1-x+1}{2(x-1)^{1 / 2}(x+1)^{1 / 2}(x+1)^{1}} \\
& =\frac{2}{2(x-1)^{1 / 2}(x+1)^{1 / 2}(x+1)^{1}} \\
& =\frac{1}{(x-1)^{1 / 2}(x+1)^{3 / 2}}
\end{aligned}
$$

### 3.4 Other Techniques of Differentiation: The Implicit Function

Differentiation by implicit functions is differentiating with respect to a term by term throughout, but using the product rule.

## Example 1

Find $\frac{d y}{d x}$ if $x^{2} y-7 x=3$
To differentiate $x^{2} y$ consider it as uv and use the product rule, then the derivative of $x^{2} y$ is:

$$
\begin{gathered}
x^{2} \frac{d y}{d x}+y \times 2 x \\
\left(u \frac{d v}{d x}+\mathrm{v} \frac{d u}{d x}\right)
\end{gathered}
$$

Therefore $x^{2} y-7 x=3, x^{2} \frac{d y}{d x}+y 2 x-7=0$.
$\frac{d y}{d x}: \frac{d y}{d x}=\frac{7-2 x y}{x^{2}}$.

## Example 2

Find the equation of the tangents where $x=2$ on the curve $x^{2}+y^{2}-2 x+y=6$

Let us find $\frac{d y}{d x}$ by differentiating term by term.

We then have $2 x+2 \mathrm{y} \frac{d y}{d x}-2+\frac{d y}{d x}=0$

$$
\begin{gathered}
\frac{d y}{d x} \Rightarrow \frac{d y}{d x}(2 y+1)=2-2 x \\
\frac{d y}{d x}=\frac{2-2 x}{2 y+1}
\end{gathered}
$$

Let us now substitute $x=2$ in the original equation of the curve:
We have $4+y^{2}-4+y=6$, which can be written as $y^{2}+y-6=0$

$$
\text { either }(y+3)(y-2)=0
$$

$$
y=-3 \text { or } 2 \text {. }
$$

Therefore, we concluded that there are two points on the curve where $x=2$; $(2,-3)$ and $(2,2)$.

## Example 3

If $x^{3}+y^{3}=3 x y$ find $\frac{d y}{d x}$
$\frac{d}{d x}\left(x^{3}\right) \frac{d}{d x}\left(y^{3}\right)=\left[3 y \frac{d}{d x}(x)+3 x \frac{d}{d x}(y)+x y \frac{d}{d x}(3)\right]$
$3 x^{2}+\frac{d}{d x}\left(y^{3}\right) \frac{d y}{d x}=3 y(1)+3 x \frac{d y}{d x}+x y(0)$
At this point it should be noted that we cannot differentiate $y^{s}$, so we have
$\frac{d}{d x}\left(y^{3}\right)=\frac{d}{d x}\left(y^{3}\right) \cdot \frac{d y}{d x}$
$\Rightarrow 3 x^{2}+3 y^{2} \frac{d y}{d x}=3 y+3 y \frac{d y}{d x}+0$
$3 y^{2} \frac{d y}{d x}-3 x \frac{d y}{d x}=3 y-3 x^{2}$
$\left(3 y^{2}-3 x\right) \frac{d y}{d x}=3\left(y-x^{2}\right)$

$$
\begin{aligned}
& \frac{d y}{d x}=\frac{3\left(y-x^{2}\right)}{3 y^{2}-3 x}=\frac{3\left(y-x^{2}\right)}{3\left(y^{2}-x\right)} \\
& \frac{d y}{d x}=\frac{y-x^{2}}{y^{2}-x}
\end{aligned}
$$

Differentiations of exponential, logarithmic and trigonometric functions are further application of differentiation in advanced mathematics.

### 3.0 MAIN CONTENT

### 3.1 Differentiation of Exponential Function

Differentiate of $e^{x}$
If $y=e^{-x} ; \frac{d y}{d x}=-e^{-x}\left(\right.$ Note here that $\left.e^{-x}=1-x+\frac{x^{2}}{2!}-\frac{x^{3}}{3!}+\frac{x^{4}}{4!}-\right)$
However if $y=e^{a x}=\frac{d y}{d x}=a e^{a x}$

## Example 1

Differentiatey $=e^{5-2 x}$ wrt x
Let $u=5-2 x$

$$
\begin{aligned}
& \mathrm{y}=e^{u} \\
& \frac{d y}{d u}=e^{u}, \text { therefore } \frac{d y}{d x}=-2 \\
& \frac{d y}{d x}=\frac{d y}{d u} \times \frac{d u}{d x}=e^{u} \times(-2)=-2 e^{u}=-2 e^{5-2 x}
\end{aligned}
$$

## Example 2

If $y=e^{0.2 x^{2}+5 x+6}$ Differentiatewrt x.
Let $\mathrm{u}=e^{0.2 x^{2}+5 x+6}$
$\frac{d y}{d x}=0.4 x+5$
$y=e^{u} \Rightarrow \frac{d y}{d x}=e^{u}$.
$\frac{d y}{d x}=\frac{d y}{d u} \times \frac{d u}{d x}$
$\frac{d y}{d x}=e^{u}(0.4 x+5)$

$$
(0.4 x+5) e^{u}=(0.4 x+5) e^{0.2 x^{2}+5 x+6}
$$

## Example 3

Differentiate $y=e^{\sqrt{x}}$ wrt x .

We can re-write as $y=e^{x 1 / 2}$
Let $u=x^{\frac{1}{2}}$
$\frac{d u}{d x}=\frac{1}{2} x^{-1 / 2}=\frac{1}{\sqrt[2]{x}}$
But $y=e^{u}$ and dy/du $=e^{u}$
$\frac{d y}{d x}=\frac{d y}{d u}=\frac{d u}{d x}=e^{u} \times \frac{1}{\sqrt[2]{x}}=\frac{e^{u}}{\sqrt[2]{x}}$
$=\frac{e^{x_{1 / 2}}}{\sqrt[2]{x}}=\frac{e^{\sqrt{x}}}{\sqrt[2]{x}}$

## Example 4

Differentiate $y=5^{x} e^{x 5}$ wrt x .
Let $\mathrm{u}^{x}$ and $\mathrm{v}=e^{x 5}$
$\frac{d y}{d x}=5^{x} \log _{\mathrm{e}}^{5}$ and $\frac{d v}{d x}=5 x^{4} e^{x 5}$
$\frac{d y}{d x}=v \frac{d u}{d x}+u \frac{d v}{d x}$.
$=e^{x 5}\left(5^{x} \log \underset{\mathrm{e}}{5}\right)+5^{x}\left(5 x^{4} e^{x 5}\right)$

$$
5^{x} e^{x 4}\left(\log _{\mathrm{e}}^{5}+5 x^{4}\right)
$$

### 3.2 Differentiation of Logarithmic Functions

Let us take a look at $\mathrm{y}=\log _{\mathrm{e}}^{\mathrm{x}}$
$\Rightarrow x=e^{y}$, then $\frac{d x}{d y}=e^{y}$
$\Rightarrow \frac{1}{\frac{d x}{d y}}=\frac{1}{e^{y}} \Rightarrow \frac{d y}{d x}=\frac{1}{e^{y}}=\frac{1}{x}$.
Therefore $\frac{d}{d x}\left(\log _{\mathrm{e}}^{\mathrm{x}}\right)=\frac{1}{x}$.
if $\mathrm{y}=\log \underset{\mathrm{e},}{\mathrm{x}}$ then $\frac{d y}{d x}=\frac{1}{x}$.
Also note that $\log _{e}{ }_{e}^{x}=\operatorname{In} x$ and if the log involve a different base say a, by usual method, it can be change to base $e$.

## Example 1

If $\mathrm{y}=\log \frac{\mathrm{x}}{a}$
$\Rightarrow a^{y}=x$.
$\log a{ }_{\mathrm{e}}^{\mathrm{y}}=\log _{\mathrm{e}}^{\mathrm{x}}$ (i.e. taking $\log$ of both sides to base e$)$.
Therefore: $\mathrm{y} \log { }_{\mathrm{e}}^{a}=\log \frac{\mathrm{x}}{\mathrm{e}}$.
$y=\log _{\mathrm{e}}^{\mathrm{x}}=\log _{\mathrm{e}}^{\mathrm{x}}$
$y=\frac{\log _{e}^{\mathrm{x}}}{\log _{\mathrm{e}}^{\mathrm{a}}}=\log _{\mathrm{e}}^{\mathrm{x}} \times \frac{1}{\log _{\mathrm{e}}^{\mathrm{a}}}$
but $\log _{\mathrm{e}}^{a}=\frac{1}{\log _{a}^{\mathrm{e}}}$ (Note: that is when the base change)
Therefore $y=\log _{\mathrm{e}}^{\mathrm{x}} \times \log \frac{\mathrm{e}}{a}$
$\frac{d y}{d x}=\frac{1}{x} \times \log \frac{\mathrm{e}}{a}$
Special case: if $y=\log \frac{x}{10}$
$\frac{d y}{d x}=\frac{1}{x} \times \log _{10}^{\mathrm{e}}=\frac{1}{\mathrm{x}} \times 0.4343$
Note that $\frac{1}{\log _{a}^{\mathrm{e}}}=\frac{1}{\frac{1}{\log _{a}^{\mathrm{e}}}}=\log _{a}^{\mathrm{e}}$
$\log _{a}^{\mathrm{e}}=\frac{1}{\log _{a}^{\mathrm{e}}}($ why is this so? $)$

Let $\log { }_{e}^{a}=\mathrm{P}$
$e^{P}=a($ take $\log$ of both sides to base $a)$
$\log \frac{\mathrm{e}^{\mathrm{P}}}{a}=\log { }_{e}^{a}$
$\mathrm{Plog}{ }_{a}^{e}=1$
$\mathrm{P}=\frac{1}{\log _{a}^{e}}$
Since $P=\log { }_{e}^{a}$
Therefore $\log _{e}^{a}=\frac{1}{\log _{a}^{e}}$

## Example 2

$$
\begin{aligned}
& \quad \text { Differentiate } \mathrm{y}=\log \frac{x^{2}}{e} \\
& \text { Let } u=x^{2}, \frac{d y}{d x}=2 x \\
& \mathrm{y}=\log e_{e,}^{u} d y / d u=\frac{1}{u} \\
& \frac{d y}{d x}=\frac{d y}{d u} \times \frac{d u}{d x}=\frac{1}{u} \times 2 x=\frac{2 x}{u}=\frac{2 x}{x^{2}}=\frac{2}{x}
\end{aligned}
$$

## Example 3

Differentiate $\log _{e}^{\left(3 x^{2}+5 x-10\right)}$
Let $\mathrm{u}=3 x^{2}+5 x-10, \frac{d u}{d x}=6 x+5$
$\Rightarrow \mathrm{y}=\log \frac{u d y}{e, \frac{d y}{d u}}=\frac{1}{u}$
$\frac{d y}{d x}=\frac{d y}{d u} \times \frac{d u}{d x}=\frac{1}{u} \times(6 x+5)$
$\Rightarrow \frac{(6 x+5)}{u}=\frac{(6 x+5)}{\left(3 x^{2}+5 x+10\right)}$

## Example 4

$y=\log _{e}\left(2 x^{2}+x\right)^{\frac{1}{4}}$
let $\mathrm{u}=\left(2 x^{2}+x\right)^{\frac{1}{4}}$
$\frac{d y}{d x}=\left(2 x^{2}+x\right)^{-\frac{3}{4}} \times\left(6 x^{2}+1\right)=\frac{\left(6 x^{2}+1\right)}{4\left(2 x^{3}+x\right)^{\frac{3}{4}}}$
$y=\log _{e}^{u}, \frac{d y}{d u}=\frac{1}{u}$
$\frac{d y}{d x}=\frac{d y}{d u} \times \frac{d u}{d x}=\frac{1}{u} \times \frac{6 x^{2}+1}{4\left(2 x^{3}-x\right)^{\frac{3}{4}}}$
$=\frac{1}{\left(2 x^{3}+x\right)^{\frac{1}{4}}} \times \frac{\left(6 x^{2}+1\right)}{4\left(2 x^{3}-x\right)^{\frac{3}{4}}}$
$\frac{d y}{d x}=\frac{6 x^{2}+1}{4\left(2 x^{3}+x\right)^{\frac{1}{4}}\left(2 x^{3}+x\right)^{\frac{3}{4}}}$
$=\frac{6 x^{2}+1}{4\left(2 x^{3}+x\right)^{\frac{1}{4}+\frac{3}{4}}}=\frac{6 x^{2}+1}{4\left(2 x^{3}+x\right)}$

### 3.3 Differentiation of Trigonometric Functions

From general mathematic recall the following properties.

1. $\operatorname{cosec} \emptyset=\frac{1}{\sin \emptyset} 2 \cdot \sec \emptyset=\frac{1}{\cos \emptyset}$
2. $\cot \emptyset=\frac{1}{\tan \emptyset}=\frac{\cos \emptyset}{\sin \emptyset} \quad$ 4. $\sin ^{2} \emptyset+\cos ^{2} \emptyset=1$
3. $1+\tan ^{2} \emptyset=\sec ^{2} \emptyset$
4. $\quad 1+\cot ^{2} \emptyset=\operatorname{cosec}^{2} \emptyset$
5. $\operatorname{Sin}(A+B)=\operatorname{Sin} A \operatorname{Cos} B+\operatorname{Cos} A \operatorname{Sin} B$
6. $\operatorname{Sin}(A-B)=\operatorname{Sin} A \operatorname{Cos} B-\operatorname{Cos} A \operatorname{Sin} B$
7. $\operatorname{Cos}(A+B)=\operatorname{Cos} A \operatorname{Cos} B-\operatorname{Sin} A \operatorname{Sin} B$
8. $\operatorname{Cos}(A-B)=\operatorname{Cos} A \operatorname{Cos} B-\operatorname{Sin} A \operatorname{Sin} B$

We can go on and on. So let us now go straight to the derivatives of trigonometric function.

### 3.3.1 Derivatives of $\operatorname{Sin} x$

$\frac{d}{d x}(\operatorname{Sin} x)=\cos x$
Where x is in radians.

## Example 1

Differentiate wrt x $\operatorname{Sin} 3 x$

Let $\mathrm{y}=\operatorname{Sin} 3 x$ and let us take $\mathrm{u}=3 x$
Then $\mathrm{y}=\operatorname{Sin} u$
$\therefore \frac{d y}{d x}=\frac{d y}{d u} \times \frac{d u}{d x}$, but $\frac{d y}{d u}=\operatorname{Cos} u, \frac{d u}{d x}=3$
$\frac{d y}{d x}=\operatorname{Cos} u \times 3=3 \operatorname{Cos} 3 x$.

## Example 2

Differentiate $\mathrm{y}=\operatorname{Sin}(2 x-4)$ wrt x .
$\frac{d y}{d x}=\operatorname{Cos}(2 x-4)($ Note here that we are differentiating Sin to get Cos)
Thereforewe differentiate $2 \mathrm{x}-4$ to get 2 .
$\frac{d y}{d x}=\operatorname{Cos}(2 x-4) \times 2=2 \operatorname{Cos}(2 x-4)$

### 3.2.3 Derivation of $\operatorname{Cos} \boldsymbol{x}$

$\frac{d \operatorname{Cos}}{d x}=-\operatorname{Sin} x$ where $x$ is in radians

## Example 1

Differentiate $\operatorname{Cos} 5 x$, wrt x .
Let $\mathrm{y}=\operatorname{Cos} 5 x$
$\frac{d y}{d x}=-\operatorname{Sin} 5 x \times 5=-5 \operatorname{Sin} 5 x$.

### 3.3.3 Derivation of $\operatorname{Tan} x$

$\frac{d}{d x} \tan x=\sec ^{2} \times$ where $x$ is in radians
Differentiate $\mathrm{y}=\tan 4 x$ wrt x
Let $\mathrm{u}=4 \mathrm{x}$, then $\mathrm{y}=\tan u$

$$

### 3.4 Application of Differentiation To Economics Problem

1. A firm has analysed its operating conditions prices and cost have developed the following functions Revenue ( R ) $=400-4 q^{2}$ (per thousands) and cost (c) $=q^{2}+10 q+30$ (per thousand naira) where q is the number of units produced and sold.

If the firm wishes to maximize profit
a. What quantity should be sold and at what price.
b. What will be the amount of profit.

## Solution

Profit is maximized when $\mathrm{MC}=\mathrm{MR}$.

$$
\begin{aligned}
& \mathrm{R}=400 \mathrm{q}-44 q^{2}, \frac{d R}{d q}=400-8 q \\
& C=q^{2}+10 q+30, \frac{d c}{d q}=2 q+10
\end{aligned}
$$

Then since $M R=M C \Rightarrow 400-8 q=2 q+10$
$400-10=2 q+8 q$
$390=10 q$
$\mathrm{q}=\frac{390}{10}=39=39=39000$ units.
To maximized profit the firm should be able to sell 39 units of it products.
$R=400 q-4 q^{2}$
When $q=39, R=400(39)-4(39)^{2}$
$\Rightarrow R=15600-6084=9516=\mathrm{N} 9516000$.
Hence the price for each unit $=\frac{9516000}{39000}$

$$
=\mathrm{N} 244
$$

To maximize profit, the firm should sell each unit of its product at the rate of $\ddagger 244$.
c. $\quad$ Profit $=$ Revenue - Cost.

$$
\begin{aligned}
\operatorname{Pr} & =400 q-4 q^{2}-\left(q^{2}+10 q+30\right) \\
& =400 \mathrm{q}-4 q^{2}-q^{2}-10 q-30 \\
& =390 q-5 q^{2}-30 \\
& =390(39)-5(39)^{2}-30 \\
& =15210-7605-30=\$ 7575 \text { per thousand } \\
& =\nexists 757500
\end{aligned}
$$

$\therefore$ In maximizing profit, the firm will realize $¥ 757500$ as per profit.
2. The demand for a product is given by $q=72-3 p$.
i. Determine the revenue function
ii. What is the revenue when price is N 2 .
iii. What is the marginal revenue and at what price is the marginal revenue equal to zero.
iv. What is the maximum revenue.

## Solution

i. $\quad$ Revenue $=\mathrm{P} \times \mathrm{q}=(72-3 P) P=72 P-3 P^{2}$

$$
\text { Revenue function is } 72 P-3 P^{2}
$$

ii. When price is $\pm 2, R=72(2)-3(2)^{2}$

$$
=144-12=\mathrm{N} 132
$$

iii. $\quad$ Marginal revenue $(\mathrm{MR})=\frac{d R}{d q}=\frac{d}{d q}\left(72 P-3 P^{2}\right)$

$$
\mathrm{MR}=72-6 P
$$

When MR $=0, \Rightarrow 72-6 P=0$
$72-6 P$

$$
\begin{aligned}
& P=\frac{72}{6} \\
& P=\mathrm{N} 12
\end{aligned}
$$

The marginal revenue is $72-6 P$ and when the marginal revenue is zero the price will be $\# 12$.
iv. $\quad \mathrm{R}=72 P-3 P^{2}$

Maximum revenue $=72(12)-3(12)^{2}$

$$
=864-432=\AA 432 .
$$

3. The demand function for a product is given by $\mathrm{P}=200-4 \mathrm{P}$ and the supply function for the same product is given by $\mathrm{P}=5 \mathrm{P}-40$.
i. Determine the equilibrium price and quantity.
ii. Find the elasticity of demand function when $\mathrm{P}=\mathrm{N} 20$.
iii. Find the elasticity of supply at $\mathrm{P}=\mathrm{N} 25$.

## Solution

1. For equilibrium to be attained; demand = supply

$$
\begin{aligned}
200 & -4 \mathrm{P}=5 \mathrm{P}-40 . \\
& -4 P-5 P=-40-200 \\
& -9 P=-240 \\
& P=\frac{-240}{-9}=\frac{80}{3} \\
& P=\# 26.67 .
\end{aligned}
$$

To determine the equilibrium quantity; substitute for P in $200-4 \mathrm{P}$.

$$
\begin{aligned}
& Q=200-4\left(\frac{80}{3}\right) \\
& Q=200-\frac{320}{3}=200-106.67 \\
& Q=93.33 .
\end{aligned}
$$

ii. $\quad$ The elasticity $=\frac{P}{q}\left(\frac{d q}{d P}\right)$

However the demand function is given by $q=200-4 P$
$\therefore d q / d P-4$.

$$
\begin{gathered}
\text { Elasticity of demand }=\frac{P}{200-4 P} \times(-4) \\
=\frac{4 P}{200-4 P}
\end{gathered}
$$

When $P=20$, elasticity of demand $=\frac{-4(20)}{200-4(20)}$

$$
\frac{-80}{200-80}=\frac{-80}{200-120}=\frac{-2}{3}
$$

Elasticity of demand $=\frac{-2}{3}$ (inelastic demand).
iii. Supply equation is $q=5 P-40$

$$
\frac{d q}{d P}=5
$$

Elasticity of supply $=\frac{P}{q}\left(\frac{d q}{d P}\right) \Rightarrow \frac{P}{5 P-40}(5)$

$$
E^{s}=\frac{\mathrm{P}}{5 \mathrm{P}-40}
$$

If P is given to $25: \frac{5(25)}{5(25)-40}=\frac{125}{125-40}$

$$
\Rightarrow \frac{125}{85}=\frac{25}{17}=1.47 .
$$

$E^{s}=1.47$ (Elastic Supply).
4.(A) The demand and supply function for a product are respectively given as $P=500-4 q$ and $P=200+5 q$, where $P$ is the price and q is the demand in unit.
i. Determine the elasticity of the demand
ii. The elasticity of supply
iii. The equilibrium price and quantity
(B)i. Using the information in (a) above to find the revenue function and hence determine the revenue for a sales of 20 units.
ii. If the cost function for the same product $\mathrm{c}=20+10 \mathrm{q}$, then determine the profit for a sales of 30 units.

## Solution

i. Demand function is given as $\mathrm{P}=500-4 \mathrm{q}$.

$$
\frac{d P}{d q}=-4, \text { but } \frac{d q}{d P}=\frac{1}{-4}
$$

$$
\begin{aligned}
& \text { Elasticity of demand }=\frac{P}{q} \times \frac{d q}{d P} \\
& \Rightarrow \frac{500-4 q}{4 q}=\frac{4 q-500}{4 q}=\frac{4(q-125)}{4 q} . \\
& E_{d}=\frac{q-125}{\mathrm{q}}
\end{aligned}
$$

ii. Supply functions is $P=200+5 q$

$$
\frac{d q}{d P}=5 \text { therefore we can then have } \frac{\mathrm{dq}}{\mathrm{dP}}=\frac{1}{5}
$$

iii. At equilibrium $500-4 q=-200+5 q$

$$
\begin{aligned}
& 500+200=5 q+4 q \\
& 700=9 q \\
& q=700 / 9=77.78=78
\end{aligned}
$$

Therefore $E_{\mathrm{q}}=78$ units.
So if $\mathrm{q}=77.78$ (Note don't use approximation figure).

$$
\begin{aligned}
& P=500-4\left(\frac{700}{9}\right) \\
& P=500-\frac{2800}{9}=\frac{4500-2800}{9} \\
& =\frac{1700}{9}=188.89
\end{aligned}
$$

Equilibrium price $\mathrm{Ep}=\mathrm{\#} 188.89$.
(C)i. Revenue $(R)=P \times q=(500-4 q) \times q$.

$$
\mathrm{R}=500 \mathrm{q}-4 q^{2}
$$

However the revenue function is $500 q-4 q^{2}$.
When $\mathrm{q}=20, \mathrm{R}=500(20)-4(20)^{2}$

$$
=1000-1600= \pm 8400 .
$$

ii. $\quad$ Profit $=$ Revenue - Cost

$$
\begin{aligned}
& =500 q-4 q^{2}-(20+10 q) \\
& =500 q-4 q^{2}-20-10 q \\
& =490 q-4 q^{2}-20
\end{aligned}
$$

When $q=30$.

$$
\begin{aligned}
P= & 490(30)-4(30)^{2}-20 \\
& =14700-3600-20=\# 11080
\end{aligned}
$$

We can then concludes that for the sales of 30 units the profit is \#11080.

### 1.0 INTRODUCTION

Integration is also known to as ante-differentiation. In mathematics, an integral assigns numbers to functions in a way that can describe displacement, area, volume and other concepts what arise by combining infinitesimal data. Integration is one of the two main operations of calculus, with its inverse, differentiation, being the other. Given a function f of a real variable x and an interval $[a, b]$ of the real line, the definite integral.
$\int_{a}^{b} f(x) d x$.This is defined informally as the signed area of the region in the $x y$ - plane that is bounded by the graph of $f$, the $x$-axis and the vertical lines $\mathrm{x}=\mathrm{a}$ and $\mathrm{x}=\mathrm{b}$. the area above the x -axis adds to the total and that below the a-axis subtracts from the total.

However, integration is the reverse of differentiation, and the term integral may also refer to the related notion of the anti derivative, a function F whose derivative is the given function f , therefore it is called indefinite interval and written as:

$$
F(x)=\int f(x) d x
$$

Furthermore, the principles of integration were formulated independently by Isaac Newton and Gottfried Leibniz in the late $19^{\text {th }}$ century, who thought of the integral as an infinite sum of rectangles of infinitesimal width.

### 3.1 Worked Examples on Indefinite Integral

## Example of integration

(1) Integrate $x^{2 / 3} \mathrm{wrt}$. x

$$
\int x^{2 / 3} d x=\frac{x^{\frac{2}{3}+1}}{\frac{2}{3}+1}+c=\frac{x^{5 / 3}}{5 / 3}+c=\frac{3 x^{5 / 3}}{5}+c
$$

(2) Integrate 5 x wrt. X

$$
\int 3 x d x=\int 5 x^{\prime} d x=\frac{5 x^{1+1}}{1+1}+c=\frac{5 x^{2}}{2}+c
$$

(3) Integrate $\sqrt[9]{x}$ wrt. X

$$
\begin{aligned}
& \int \sqrt[9]{x} d x=\int 9 x^{1 / 2} d x=\frac{9 x^{\frac{1}{2}+1}}{\frac{1}{2}+1}+c=\frac{9 x^{3 / 2}}{3 / 2}+c \\
& =\frac{2\left(9 x^{3 / 2}\right)}{3}+c=6 x^{3 / 2}+c \text { or } \sqrt[6]{\mathrm{x}^{3}}+\mathrm{c}
\end{aligned}
$$

(4) Integrate $\frac{4}{\sqrt[3]{x}}$ wrt $x$

$$
\begin{aligned}
& \int \frac{4}{\sqrt[3]{x}} d x=\int \frac{4}{x^{\frac{1}{3}}} d x=\int 4 x^{-\frac{1}{3}} d x=\frac{4 x^{-\frac{1}{3}+1}}{-\frac{1}{3}+1}+c \\
& =\frac{4 x^{2 / 3}}{2 / 3}+c=\frac{3\left(4 x^{2 / 3}\right)}{2}=6 x^{2 / 3}+c \\
& \text { or } \left.6\left(\sqrt[3]{x^{2}}\right)+c\right)
\end{aligned}
$$

(5) Integrate $\frac{x^{3}}{\sqrt{x}}$ wrt x

$$
\begin{aligned}
& \int \frac{x^{3} d x}{\sqrt{x}}=\int \frac{x^{3} d x}{x^{1 / 2}}=\int_{1 / 2}^{x^{3 . x^{-1 / 2 d x}}=\int_{7 / 2}^{x^{5 / 2 d x}}} \\
& =\frac{x^{\frac{5}{2}+1}}{\frac{5}{2}+1}+c=\frac{x}{\frac{7}{2}}+c=\frac{2 x}{7}+c .
\end{aligned}
$$

### 3.2 Integration of a Constant

Let G be a constant, then $\int G d x=G x+c$ where c is the arbitrary constant introduced since it is an indefinite integral. It should be noted here that G can be written as $G x^{0}$ if the integration is with respect to x .

Then: $\int G d x=\int G x^{0} d x=\frac{G x^{0+1}}{0+1}+c$.

$$
=\frac{G x^{1}}{1}+c=G x+c .
$$

Let us take an example on this analysis.

1. Integrate $\int 8 d x$

$$
\int 8 d x=\int 8 x^{0} d x=8 \frac{x^{0+1}}{0+1}+c=8 x+c
$$

2. $\int-2 d x$

$$
\int-2 d x=-2 x+c
$$

3. $\int 10 d x$

$$
\int 10 d x=10 x+c
$$

### 3.3 Integration of a Polynomial

If a given integral function is a polynomial, it can be performed by integrating term by term, with the constant factor brought outside the integral sign.

### 3.4 Definite Integral

Definite integral is when a numeric result as it is the case in the calculation of total revenue between two output levels when the marginal revenue is given, the expression is termed a definite integral and it is written as $\int_{a}^{b} y d x$.

The expression above shows that, ' $a$ ' is a definite value called lower limit or lower bound and ' $b$ ' is also a definite value called upper limit or upper bound. In majority of the cases ' $b$ ' maybe greater than a especially when it is applied to business or economic problems.

Let us consider the curve $\mathrm{y}=\mathrm{f}(x), y>0$ in the range of $\mathrm{x}=a$ to $x=\mathrm{b}$ shown in figure 2 below:

The area A between the curve and the x -axis is given by: A $=\int f(x) d x+c=\mathrm{g}(x)+c$, say, when $\mathrm{x}=\mathrm{a}$, the area $=\mathrm{c}$.



Figure showing the curve $y=f(x)$.
Therefore $\mathrm{g}=(\mathrm{a})+\mathrm{c}$, or $\mathrm{c}=-\mathrm{g}(\mathrm{a})$
Then $A_{a}^{x}=\mathrm{g}(x)-\mathrm{g}(a)$ and So $A_{a}^{b}=\mathrm{g}(\mathrm{b})-\mathrm{g}(\mathrm{a})$
$=($ Value of integral when $x=b)-($ Value of integral when $x=\mathrm{a})$
When it can be written as $\int_{a}^{b} f(x) d x$ and this is called the definite integral of $f(x)$

## Example 1

$$
\begin{aligned}
\text { Evaluate } \int_{1}^{2} x^{2} d x & =\left(\frac{x^{3}}{3}+c\right)^{2} \\
= & \left(\frac{2^{3}}{3}+c\right)-\left(\frac{1^{3}}{3}+c\right) \Rightarrow\left(\frac{8}{3}+c\right)-\left(\frac{1}{3}+c\right) \frac{8}{3}+c-\frac{1}{3}-c=\frac{7}{3}
\end{aligned}
$$

## Example 2

$$
\begin{aligned}
& \int_{-1}^{1} \frac{(x+1)\left(x^{2}-2 x+2\right)}{x^{2}} d x \\
&=\int_{-1}^{1} \frac{\left(x^{3}-2 x^{2}+2 x+x^{2}-2 x+2\right)}{x^{2}} d x \\
&=\int_{-1}^{1}\left(\frac{x 3-x^{2}+2}{x^{2}}\right) d x \int_{-1}^{1}\left(x+1+\frac{2}{x^{2}}\right) d x \\
&=\int_{-1}^{1}\left(x-1+2 x^{-2}\right) d x\left(\frac{x^{2}}{2}-x+\frac{2 x^{-1}}{-1}\right)
\end{aligned}

(You should note here that the constant c has not been included since it will cancel out later).

### 3.1 Worked Examples of Integration of Exponential Function

Therefore $\int e^{5 x+2} d x=\int e^{u} \frac{d u}{5}$

\end{aligned}
$$

2. $\int\left(e^{3 x-2}-e^{-2 x+3}\right) d x \Rightarrow \int e^{3 x-2} d x-\int e^{-2 x+3} d x$.

Let $\mathrm{P}=3 x-2$ and $U=-2 x+3$

& \frac{d p}{d x}=3 \text { and } \frac{d u}{d x}=-2 \\
& d x=\frac{d p}{3} \text { and } d x=-\frac{d u}{2}
\end{aligned}

\Rightarrow \int e^{p} \frac{d p}{3}-\int e^{u}-\frac{d u}{2} \Rightarrow \frac{1}{3} \int e^{p} d p-\left[-\frac{1}{2} \int e^{u} d u\right]
$$

\Rightarrow \frac{1}{3} e^{p}+c-\left(-\frac{1}{2} e^{u}+c\right) \Rightarrow \frac{1}{3} e^{p}+\not \subset+\frac{1}{2} e^{u}-\not \subset
$$

\Rightarrow \frac{1}{3} e^{p}+\frac{1}{2} e^{u} \Rightarrow \frac{1}{3} e^{3 x-2}+\frac{1}{2} e^{-2+3}+c
$$

3. $\int\left(3 x^{2}+1\right) e^{x 3+x+2} d x$

=\frac{1}{6} \operatorname{In}\left(2 x^{3}+3\right)+c \Rightarrow

Recall from logarithmic rule:
$\log _{e}^{x}=\operatorname{In} x$.

### 3.2 Integration of Trigonometric Function

Let us remember that from our knowledge of differentiation, the derivative of $\sin x$ is $\cos x$ while the derivatives of $\cos x$ is $\sin x$.

Let us remember that $\sin x$ integration is the opposite of differentiation, therefore the integral of $\cos x$ is $\sin x$, and that of $\sin x$ is $-\cos x$.

For example $\int \sin x d x=-\cos +c$ and $\int \cos x d x=\sin x+c$ where c is an arbitrary constant.

## Example 1

Integrate $\cos 4 x$ wrt $x$.

1. $\int \cos 4 x d x$

Let $\mathrm{u}=4 x, \frac{d u}{d x}=4 \Rightarrow d x=\frac{d u}{4}$

$$
\therefore \int \cos 4 x d x=\int \cos u \frac{d u}{4} \Rightarrow
$$

$$
\Rightarrow \frac{1}{4} \int \cos u d u
$$

$$
\Rightarrow \frac{1}{4} \sin u+c=\frac{1}{4} \sin 4 x+c
$$

2. $\int \sin 7 x d x$

Let $\mathrm{u}=7 x, \frac{d u}{d x}=7 \Rightarrow d x=\frac{d u}{7}$
$\therefore \int \sin 7 x d x=\int \sin u=\frac{d u}{7}=\frac{1}{7} \int 7 \operatorname{In} u d u$

$$
\begin{aligned}
& =\frac{1}{7}(-\cos u)+c=\frac{-1}{7} \cos u+c \\
& =\frac{1}{7} \cos 7 x+c
\end{aligned}
$$

3. $\int \sin (5 x+2) d x$

Let $\mathrm{u}=5 x+2, \frac{d u}{d x}=5 \Rightarrow d x=\frac{d u}{5}$

\begin{aligned}
& \therefore \int \sin (5 x+2) d x=\int \sin u \cdot \frac{d u}{5} \\
& \Rightarrow \frac{1}{5} \int \sin u d u \Rightarrow \frac{1}{5}(-\cos u)+c \\
& \Rightarrow-\frac{1}{5} \cos (5 x+2)+c .
\end{aligned}
$$

4. $\int\left(5 x^{4}+\cos 4 x-\frac{1}{x}\right) d x$

\begin{aligned}
& =\int 5 x^{4} d x+\int \cos 4 x d x-\int \frac{1}{x} d x \\
& =\frac{5 x^{5}}{5}+\frac{1}{4} \sin 4 x-\log _{e}^{x}+c \\
& =x^{5}+\frac{1}{4} \sin 4 x-\operatorname{In} x+c .
\end{aligned}
$$

5. $\int\left[e^{3} x-3 \cos (6 x-1)\right] d x$

\begin{aligned}
& \int e^{3 x} d x-\int 3 \cos (6 x-1) d x \\
& =\frac{1}{3} e^{3 x} d x-3\left[\frac{1}{4} \sin (6 x-1)\right]+c \\
& =\frac{1}{3} e^{3 x}-\frac{3}{4} \sin (6 x+1)+c
\end{aligned}
$$

6. $\int \tan x d x \Rightarrow \int \frac{\sin x d x}{\cos x}$

\text { Let } \mathrm{u}=x^{3}, \frac{d u}{d x}=3 x^{2} \Rightarrow d x=\frac{d u}{3 x^{2}}
$$

\begin{aligned}
& \therefore \int 3 x^{2} \sin x^{3} d x=\int 3 x^{2} \sin u \cdot \frac{d u}{3 x^{2}} \\
& \quad=\int \sin u d u=-\cos u+c
\end{aligned}
$$

8. $\int e^{2 \cos 3 x} \sin 3 x d x$

Let $\mathrm{u}=2 \cos 3 x, \frac{d u}{d x}=-6 \sin 3 x$

\begin{aligned}
& \Rightarrow d x=\frac{d u}{-6 \sin 3 x} \\
& \therefore \int e^{2 \cos 3 x} \sin 3 x d x=\int e^{u} \sin 3 x \cdot \frac{d u}{-6 \sin 3 x} \\
& =-\frac{1}{6} \int e^{u} d u=-\frac{1}{6} e^{u}+c \\
& =-\frac{1}{6} e^{2 \cos 3 x}+c

### 1.0 INTRODUCTION

In integration some of the function cannot be easily integrated unless the independent variables x is definitely changed to another variable u and given rise to the relationship between x and u to be known.

Integration by substitution is used to change from one integral to another that is easier to solve. The process of integrating by substitution is basically the process of applying the chain rule, but in reverse.

However, integration by parts or partial integration is a theorem that relates the integral of a product of functions to the integral of their
derivatives and antiderivatives. Normally we use it to transform the antiderivative of a product of functions into an antiderivatives for which a solution can be easily found.

### 2.0 OBJECTIVES

### 3.0 MAIN CONTENT

### 3.1 Integration by Substitution

Let us look at two composed functions f and g that are continuous over given interval, let $u=g(x)$ and $d u=g^{1}(x) d x$. Such that $\int f(\mathrm{~g}(x)) \mathrm{g}^{1}(x) d x=\int f(u) d u=f(u)=f(\mathrm{~g}(x))$.

First you determine the substitution $\mathrm{u}=\mathrm{g}(x)$ and differentiate it to obtain $d u=\mathrm{g}^{1}(x)$ and $d x$.

You then substitute $u$ and du into the integral, complete the integration and replace the original functions using the substitutions.
Let us now takes some examples to illustrate our analysis on integration by substitution:

1. $\int 3 \sqrt{4 y-6 d y}=\int 3(4 y-6)^{\frac{1}{2}} d y$

Let $u=4 y-6, \frac{d u}{d y}=4 \Rightarrow d y=\frac{d u}{4}$

$$
\begin{aligned}
& \therefore \int 3 \sqrt{4 y-6}, d y=3 \int \frac{u^{\frac{1}{2}} d u}{4} \\
& \Rightarrow \frac{3}{4} \int u^{\frac{1}{2}} d u \\
& =\frac{3}{4} \frac{u^{\frac{3}{2}}}{\frac{3}{2}}+c=\frac{6}{12} u^{\frac{3}{2}}+c=\frac{1}{2} u^{\frac{3}{2}}+c
\end{aligned}
$$

\text { but } u=4 y-1
$$

\therefore \int \sqrt{4 y-6 d y}=\frac{1}{2}(4 y-6)^{\frac{3}{2}}+c .
$$

=\frac{-1}{9 x-15}+c=\frac{1}{15-9 x}+c .
$$

3. $\int_{0}^{1} \frac{e^{2 x} d x}{3 e^{2 x}+5}$

\text { Let } \mathrm{u}=3 e^{2 x}+5, \frac{d u}{d x}=6 e^{2 x} \Rightarrow d x=\frac{d u}{6 e^{2 x}}
$$

\therefore \int_{0}^{1} \frac{e^{2 x} d x}{3 e^{2 x}+5}=\int_{0}^{1} \frac{e^{2 x}}{u} \cdot \frac{d u}{6 e^{2 x}}
$$

d x=\frac{d u}{6 e^{2 x}}
$$

$$
=\int_{0}^{1} \frac{1}{6 u} d u=\frac{1}{6} \int_{0}^{1} \frac{1}{u} d u
$$

$$
=\frac{1}{6}\left(\log _{e} u\right]_{0}^{1}=\frac{1}{6}\left[\log _{e}\left(3 e^{2 x}+5\right)\right]
$$

$$
=\frac{1}{6}\left[\log _{e}\left(3 e^{2}+5\right)-\log _{e}(3+5)\right]
$$

\begin{aligned}
& =\frac{1}{6}\left[\log _{e}(22.167+5)-\log _{e}^{8}\right] \\

$$

=\frac{1}{10}\left[\frac{u^{-6}}{-6}+c\right]=\frac{-1}{60} u^{-6}+c
$$

=\frac{1}{10}\left(2 x^{5}-11\right)^{-6}+c
$$

$$
=\frac{-}{60\left(2 x^{5}-11\right)^{6}}+c .
$$

5. $\quad \int\left(x^{2}+2 x+3\right)\left(\frac{1}{3} x^{3}+x^{2}+3 x-7\right)^{6} d x$

Let $\mathrm{u}=\frac{1}{3} x^{3}+x^{2}+3 x+7, \frac{d u}{d x}=x^{2}+2 x+3$

\begin{aligned}
& =\int\left(x^{2}+2 x+3\right)\left(\frac{1}{3} x^{3}+x^{2}+3 x-7\right)^{6} d x \\
& =\int\left(x^{2}+2 x+3\right) u^{6} \cdot \frac{d u}{\left(x^{2}+2 x+3\right)} \\
& =\int u^{6} d u=\frac{u^{7}}{7}+c \\
& =\frac{1}{7}\left(\frac{1}{3} x^{3}+x^{2}+3 x-7\right)^{7}+c
\end{aligned}
$$

6. $\int \tan 2 x d x$

$$
=\int \frac{\sin 2 x d x}{\cos 2 x}
$$

Let $\mathrm{u}=\cos 2 x, \frac{d u}{d x}=-2 x \sin 2 x$

$$
\begin{aligned}
& \Rightarrow d x=-\frac{d u}{-2 \sin 2 x} \\
& \therefore \int \frac{\sin 2 x d x}{\cos 2 x}=\int \frac{\sin 2 x}{u} \cdot \frac{d u}{-2 \sin 2 x} \\
& =\frac{1}{-2} \int \frac{1}{2} d u=-\frac{1}{2} \log _{e}^{u}+c \\
& =-\frac{1}{2} \log _{e}^{\cos 2 x}+c
\end{aligned}
$$

### 3.2 Integration by Parts

In calculus and more generally in mathematical analysis, Integration by parts or partial integration is a theorem that relates the integral of a product of functions to the integral of their derivative and antiderivatives. It is used to transform the antiderivatives of a product of functions into an antiderivative for which a solution can be easily found.

## For example

If $\mathrm{u}=u(x)$ and $d u=u^{1}(x) d x$ while $\mathrm{v}=\mathrm{v}(x)$ and $d v=\mathrm{v}^{1}(x) d x$, therefore integration by parts can be written as:

$$
\int_{a}^{b} u(x) v^{1}(x) d x=[u(x) v(x)]_{a}^{b}-\int_{a}^{b} u^{1}(x) \mathrm{v}(x) d x
$$

Or let us consider the derivation of a product say 'uv' where $u$ and $v$ are each a function of $x$.

$$
\frac{d}{d x}(u v)=v \frac{d u}{d x}+u \frac{d v}{d x}
$$

Integrating with respect to x we have

$$
\begin{aligned}
& u v=\int\left(v \frac{d u}{d x}+u \frac{d v}{d x}\right) d x \\
& u v=\int v \frac{d u}{d x} d x+\int u \frac{d v}{d x} d x \\
& u v=\int v d u+\int u d v
\end{aligned}
$$

Therefore: $\int u d v=u v-\int v d u$.
Note that the part to be used here is the dv and it must be readily and also $\int v d u$ should not be complex than the normal $\int u d v$.

## Example 1

Evaluate $\int 2 x e^{x} d x$
Using integration by parts:
Let $u=2 x$ and $d v=e^{x} d x$
Then $\frac{d u}{d x}=2 \Rightarrow d u=2 d x$
Therefore $\int d v=\int e^{x} d x=v=e^{x}$
Recall that $\int v d v=u v-\int v d u$

$$
\int 2 x e^{x} d x=2 x e^{x}-\int e^{x} 2 d x
$$

$$
\begin{aligned}
& \quad=2 x e^{x}-2 \int e^{x} d x \\
& =2 x e^{x}-2 e^{x+c} \\
& =2 x e^{x}(x-1)+c \\
& \text { 2. } \quad \int x^{2} e^{-3 x} d x
\end{aligned}
$$

Using integration by parts
Let us $x^{2}$ and $d v=e^{-3 x} d x$
$\frac{d u}{d x}=2 x$ and $d u=2 x d x$
$=\int d v=\int e^{-3 x} d x \Rightarrow v=\frac{-1}{3} e^{-3 x}$
$=\int v d v=u v-\int v d u$
$\int x^{2} e^{-3 x} d x=x^{2}\left(-\frac{1}{3} e^{-3 x}\right)-\int-\frac{1}{3} e^{-3 x}+.2 x d x$
$=-\frac{1}{3} x^{2}-e^{-3 x}+\frac{2}{3} \int x e^{-3 x} d x$
$=-\frac{1}{3} x^{2} e^{-3 x}+\frac{2}{3} \mathrm{I}$
(Note Here that $\mathrm{I}=\int x e^{-3 x}$, We cannot integrate I easily unless by parts)
Let us now solve I by parts
Let $\mathrm{w}=\mathrm{x}$ and $\mathrm{dz}=x e^{-3 x} d x$
$\frac{d w}{d x}=1 \Rightarrow d w=d x$
Therefore: $\int d z=\int e^{-3 x} d x \Rightarrow z=\frac{-1}{3} e^{-3 x}$
$\int w d z=w z-\int z d w$
so $\Rightarrow \int x e^{-3 x} d x=x\left(\frac{-1}{3} e^{-3 x}\right)-\int-\frac{1}{3} e^{-3 x} d x$
$=\frac{-1}{3} x e^{-3 x}+\frac{1}{3} \int e^{-3 x} d x$
$=\frac{-1}{3} x e^{-3 x}+\frac{1}{3}\left(\frac{-1}{3} e^{-3 x}\right)$
Therefore $\mathrm{I}=\int x e^{-3 x} d x=\frac{-1}{3} x e^{-3 x}-\frac{1}{9} e^{-3 x}$

$$
\begin{aligned}
& \Rightarrow \int x^{2} e^{-3 x} d x=\frac{-1}{3} x^{2} e^{-3 x}+\frac{2}{3} \mathrm{I}=\frac{-1}{3} x^{2} e^{-3 x}+\frac{2}{3}\left(\frac{-1}{3} x e^{-3 x}-\frac{1}{9} e^{-3 x}\right)+c \\
& \quad=\frac{-1}{3} x^{2} e^{-3 x}-\frac{2}{9} x e^{-3 x}-\frac{2}{27} e^{-3 x}+c \\
& \quad=\frac{-1}{3} e^{-3 x}\left(x+\frac{2}{3} x+\frac{2}{9}\right)+c
\end{aligned}
$$

3. $\int x^{2} \ln x d x$

Let $x=\ln x$ and $d v=x^{2} d x$
$\frac{d u}{d x}=\frac{1}{x} \Rightarrow d u=\frac{d x}{x}$
Therefore $\int d v=\int x^{2} d x \Rightarrow v=\frac{x^{3}}{3}$
By parts $\int u d v=u v-\int v d u$
$\int x^{2} \ln x d x=\frac{x^{3}}{3} \ln x-\int \frac{x^{3}}{3} \cdot \frac{d x}{x}$

$$
\begin{aligned}
& =\int x^{2} \ln \frac{x^{3}}{3} \ln x-\int \frac{x^{3}}{3} \cdot \frac{d x}{x} \\
& =\frac{x^{3}}{3} \ln x-\frac{1}{3} \int x^{2} d x
\end{aligned}
$$

$$
\begin{aligned}
& =\frac{1}{3} x^{3} \ln x-\frac{1}{3}\left(\frac{x^{3}}{3}\right)+c \\
& =\frac{1}{3} x^{3} \ln x-\frac{1}{9} x^{3}+c \\
& =\frac{1}{3} x^{3}\left(\ln x-\frac{1}{3}\right)+c \\
& =\frac{1}{3} x^{3}\left(3 \ln \frac{x-1}{3}\right)+c \\
& =\frac{1}{9} x^{3}(3 \ln x-1)+c
\end{aligned}
$$

In this unit, we can conclude that integration by parts is a method for evaluating a difficult integral and we should note that when the integral is a product of functions and the formula will definitely moves the product out of the equation so that the integral can be solved easily while integration by substitution can also be called $U$-substitution and is a method for finding integrals using some fundamental theorem of calculus.

### 1.0 INTRODUCTION

From our previous discussion on differentiation, you will have seen how apply differentiation to economics analysis?

However, the same approach will also be adopted here under application of integration to economics.

Under the analysis of differentiation, when we differentiate total cost we get marginal cost, but when the marginal costs of these functions are given, they can be integrated to obtain the original functions differentiated. It should also be noted that when the marginal cost functions is given, it integrated with respect to the quantity produced to obtain the total cost function. Sometime we can get additional information which it is called initial condition and this is required so as to get a unique total cost function.

### 2.0 OBJECTIVES

### 3.0 MAIN CONTENT

### 3.1 Analysis of Total Cost and Marginal Cost Using

## Integration

As a student of mathematics for Economics, you should note that the constant of integration is in terms of a fixed cost or initial overhead and when there is no production, the total cost will be equal to the fixed cost. Let us take an example of total cost of producing $q$ units is given by:
$C=F(q)$,to get marginal cost $(M C)$.
$C(q)=\frac{d c}{d q}=F^{1}(q)$.
To get the total cost function, given the marginal cost $C=F(q)$.
Therefore $\mathrm{TC}=\int F^{1}(q) d q=d q=F(q)+K$
Where K is a constant of integration.

It is however the same thing when given the marginal revenue function with respect to quantity demanded to get the revenue function, the
integration constant established will be zero value due to the fact that revenue depend on sales and where there is no sales revenue will be zero. This makes the constant too to be zero unless otherwise. Thus, if the total revenue of demanding q units is given by the function $R=$ $F(q)$ therefore, the marginal revenue is $R(q)=\frac{d R}{d q}=F(q)$.

Hence the total revenue function, given marginal revenue becomes:
$R(q)=F(q)$
$R(q)=\int F^{1}(q) d q=R$
Where C is constant and when $q=0, R(0)=R \Rightarrow 0$

$$
R=f(q)
$$

We can also integrated the marginal profit function to get the total product function, integrate marginal price function to get price function and also integrate marginal prosperity to consume function to get the total marginal consumption function.

### 3.2 Application of integration to Economics Problem using Total Cost and Marginal Cost Analysis

1. The marginal cost of a trader has been found to be $M C=3 q^{2}+$ $8 q+400$. Determine the total variable cost of producing 100 units of the trade's product.

## Solution

$M C=3 q^{2}+8 q+400$
Total $\operatorname{cost}(T C)=\int M C d q=\left(4 q^{2} 8 q+400\right) d q$
$T C=\frac{3 q^{3}}{3}+\frac{8^{q}}{2}+400 q+K$.
$T C=q^{3}+4 q^{2}+400 q+K$.
But $T C=T V C+F C$
Where TVC the total variable is cost and $F$ is the fixed cost. Hence $T V C=3^{q}+4 q^{2}+400 q$ and $F C=K$ when $q=100$.

$$
\begin{aligned}
T V C & =100^{3}+4(100)^{2}+400(100) \\
& =1,000000+4(10000)+40000 \\
& =1,000000+40000+40000 \\
& =1,080,000
\end{aligned}
$$

Therefore the total variable cost of producing 100units of the farmer's product is $¥ 1,080,000$.
2. If the fixed cost of manufacturing a product is $¥ 10,000$ and the marginal cost at x units of output is $\#(60+2.5 x)$. Find:
i. The function for the total cost of manufacturing x units.
ii. The total cost of 200 units.

## Solution

Let us start by representing total cost as C.
Marginal cost $(M C)=\frac{d c}{d x=60.2 .5 x}$
Integrating with respect to x .
$\int d c=\int(60+2.5 x) d x$
$C=60 x+\frac{2.5 x^{2}}{2}+K$
Where k is the constant $=$ fixed $\operatorname{cost}=10,000$.
Therefore $C=60 x+1.25 x^{2}+10,000$
When $\mathrm{x}=200$

$$
\begin{aligned}
(200) & =60(200)+1.23(200)^{2}+10000 \\
& =1200+1.25(40000)+10000 \\
& =1200+50000+10000 \\
& =\nexists 61,200 .
\end{aligned}
$$

Therefore, the cost of producing 200 units is $¥ 61,200$
3. The marginal profit of producing $x$ units per day is given by:
$P(x)=200-0.4 x$
$P(0)=0$ where $P(x)$ is the profit in naira. Calculate the profit function and the profit of producing 10 units.

## Solution

$P(x)=200-0.4 x$
To calculate the profit function we need to integrate the marginal profit function with respect to x .
$P(x) \int(200-0.4 x) d x$
$P(x)=200-\frac{0.4 x^{2}}{2}+k$
Where k is the constant
$P(x)=200 x-0.2 x^{2}+k$
$\sin p(0)=0 \Rightarrow 0=200(0)-0.2(0)^{2}+k$
$\Rightarrow P(x)=200 x-0.4 x^{2}$ is the profit function.
When $x=10, p(10)=200(10)-0.2(10)^{2}$

$$
\begin{aligned}
& =2000-0.2(100) \\
& =2000-20 \\
& =\# 1980
\end{aligned}
$$

The profit on production of 10 units is $\$ 1960$
4. If the marginal revenue function for a commodity is $\left(6 q^{2}-\right.$ $12 q+4$ ) naira per units when the level of production is $q$ units, determine the total revenue function and find the total revenue when 40 units are sold.

## Solution

Marginal revenue $=M R$.
$M R=\frac{d R}{d q}=6 q^{2}-12 q+2$
$\int d R=\int\left(6 q^{2}-12 q+2\right) d R$
$R=\frac{6 q^{2}}{3}-\frac{12 q^{2}}{2}+2 q+k$.
$R=2 q^{3}-6 q^{2}+2 q+k$
Where $k$ is a constant.
When $q=0, R=0$ that is when there is no sales, there will be no revenue.

Therefore $k=0$
$R=2 q^{3}-6 q^{2}+2 q \Rightarrow$ This is the total revenue function.
When $q=40$
$R=2(40)^{3}-6(40)^{2}+2(40)$
$R=2(64000)-6(1600)+80$
$R=128000-9600+80$
$R=\# 198,400$
The revenue on sales of 40 units is $\# 198,400$.
5. The marginal propensity to consume (in billions of naira) is given as: $\frac{d c}{d x}=0.8+\frac{0.4}{2 x^{-1 / 2}}$, where c is the consumption and x is the income.
i. Find the consumption function given that when income is zero consumption is 20billion naira.
ii. Find the income when consumption is put at $\pm 60$ billion.
iii. Determine the consumption when income is put at $\pm 50$ billion.
iv. Determine also the saving function when income is zero.
$M P C=\frac{d c}{d x}=0.8+\frac{0.4}{2 x^{-\frac{1}{2}}}$

$$
\begin{gathered}
=0.8+0.8 x^{-\frac{1}{2}} \\
C=\int\left(0.8+0.8 x^{-\frac{1}{2}}\right) d x \\
=0.8 x+0.8 x^{-\frac{1}{2}+1}+k \\
C=0.8+\frac{0.8 x^{\frac{1}{2}}}{\frac{1}{2}} k \\
C=0.8 x+1.6 x^{\frac{1}{2}}+k \\
\text { When } x=0, C=20 \\
20=0.8(0)+1.6(0)^{\frac{1}{2}}+k \\
20=k . \\
\therefore k=20 \\
C
\end{gathered}
$$

Where C is the consumption.
ii. $\quad C=0.8 x+1.6 x^{\frac{1}{2}}+20$

When $C=50$
$\Rightarrow 50=0.8 x+1.6 x^{\frac{1}{2}}+20$

$$
50-20=0.8 x+1.6 x^{\frac{1}{2}}
$$

$30=0.8 x+1.6 x^{\frac{1}{2}}$
$0.8 x+1.6 x^{\frac{1}{2}}-30=0$
Multiply through by 10
$8 x+1.6 x^{\frac{1}{2}}-300=0$.
Let $a=x \Rightarrow x=a$.

$$
\text { Hence } 8 a^{2}+16 a-300=0
$$

$$
\begin{aligned}
& a= \frac{a=8, b=16 c=300=0}{-b \pm \frac{\sqrt{b^{2}-4 a c}}{2 a}} \\
& a=-16 \pm \frac{\sqrt{16^{2}-4(8)(-300)}}{2(8)} \\
&=-16 \pm \frac{\sqrt{256-(-9600)}}{16} \\
&=-16 \pm \frac{\sqrt{9856}}{16} \\
&=\frac{-16 \pm 31.40}{16} \\
& a=\frac{-16 \pm 31.40}{16} \text { or }=\frac{-16-31.40}{16} \\
& a=\frac{15.4}{16} \text { or }=\frac{47.4}{16} \\
& a=0.96 \text { or } 2.96 .
\end{aligned}
$$

From the result, we take the positive value that is $a=0.96$
But $a=0.96$

$$
a=x^{\frac{1}{2}} \Rightarrow x^{2}=0.96
$$

Square both sides

$$
\begin{aligned}
& \left(x^{\frac{1}{2}}\right)^{2}=(0.96)^{2} \\
& x=0.9216 ; x=0.92
\end{aligned}
$$

Multiply by 100

$$
\begin{aligned}
& x=0.92 \times 100 \\
& x=92 .
\end{aligned}
$$

So, when the consumption is at $£ 60$ billion, income will be $£ 92$ billion.
iii. $\quad C=0.8 x+1.6 x^{\frac{1}{2}}+20$

When $x=50$

$$
\begin{aligned}
C & =0.8(50)+1.6(50)^{\frac{1}{2}}+20 \\
& =40+16(\sqrt{50})+20 \\
& =40+16(7.07)+20 \\
& =40+113.12+20 \\
& =173.12
\end{aligned}
$$

When income is at $£ 50$ billion, consumption will be $¥ 173.12$ billion.
iv. Recall that marginal propensity to save $M P S=1-M P C$.

$$
\begin{aligned}
M P S & =1-\left(0.8+\frac{0.4}{2 x^{-1 / 2}}\right) \\
& =0.2-\frac{0.4}{2 x^{1 / 2}}=0.2-0.8 x^{1 / 2} \\
& \int=\int\left(0.2-0.8 x^{1 / 2}\right) d x \\
& =0.2 x-\frac{0.8 x^{\frac{1}{2}}}{\frac{1}{2}}+k
\end{aligned}
$$

Where $\mathrm{k}=$ constant

$$
\begin{aligned}
& S=0.2 x-1.6 x^{\frac{1}{2}}+k \\
& k=0 .
\end{aligned}
$$

Therefore saving function:

$$
S=0.2 x-1.6 x^{\frac{1}{2}}
$$

## UNIT ONE DIFFERENTIAL EQUATION

## Introduction

A differential equation is any equation which derivate, either ordinary derivatives or partial derivatives. However, a differential equation containing one or more functions of one independent variable and its derivatives. Various differentials and functions become related to each other via equations, and thus a differential equation is a result that describes dynamically changing phenomena, evolution and variation. Furthermore, quantities are defined as the rate of change of other quantities such as derivatives of displacement with respect to time or gradients of quantities which is how they enter differential equations.

### 2.0 OBJECTIVES

### 3.0 MAIN CONTENT

### 3.1 Work Examples of Differential Equation

Ex1: To solv3 the differential equation $y(t)=7$ for all the functions $y(t)$ which satisfy the equation.

$$
y(t)=\int 7 d t=7+c_{1}
$$

Here we integrate both sides of the equations to find the integrals.
Therefore $y(t)=\int\left(7 d t=7+c_{1}\right) d t=3.5 t^{2}+c_{1} t+c$
The above solution is called a general solution which indicates that when c is unspecified, a differential equation has an infinite number of possible solutions. If c is specified, then the differential equation has a particular or definite solution which alone gives rise to all the possible solution.

Ex.2: The order and degree of a differential equations is given below:

1. $\frac{d y}{d t}=2 x+6 \Rightarrow$ This is a first-order, first degree
2. $\frac{d y}{d t}=3 x+10 \Rightarrow$ This is also a first-order, first degree
3. $\left(\frac{d y}{d t}\right)^{4}-7 t^{5}=0 \Rightarrow$
$\Rightarrow$ This is a first order, fourth - degree.
4. $\left(\frac{d y}{d t}\right)^{4}-11 t^{5}=0 \Rightarrow$ This is also a first order, fourth - degree.
5. $\frac{d^{2} y}{d t^{2}}+\left(\frac{d y}{d t}\right)^{3}+2 x^{5}=0 \Rightarrow$ This is a second order, first degree.
6. $\frac{d^{2} y}{d t^{2}}+\left(\frac{d y}{d t}\right)^{3}+6 x^{2}=0 \Rightarrow$ This is a second order, first degree.
7. $\left(\frac{d^{2} y}{d t^{2}}\right)^{7}+\left(\frac{d^{3} y}{d t^{3}}\right)^{5}+75 y \Rightarrow$ This is a third, fifth - degree.
8. $\left(\frac{d^{2} y}{d t^{2}}\right)^{7}+\left(\frac{d^{3} y}{d t^{3}}\right)^{5}+15 y \Rightarrow$ This is a third, fifth - degree.

### 3.2 General Formular For First - Order Linear Differential Equation

In the first-order linear differential equations of 5ay dy/dt, where y must be of the first degree and there may no product $y(d y / d t)$.

Let us take a look at the equation below:

$$
\frac{d y}{d t}+v y=z
$$

Where v and z maybe constants or functions of time. Therefore the formular for a general solution is given as:

$$
\begin{equation*}
y(t)=e^{-\int v d t}\left(A+z e^{-\int v d t} d t\right) \tag{1}
\end{equation*}
$$

Let us called the above equation one, where A is an arbitrary constant. But it should be noted here that a solution is composed of two parts: $e^{-\int v d t} \mathrm{~A}$.

This is called the complementary function and $e^{-\int v d t} \mathrm{dt}$ is called the particular integral. However, the particular integral $y_{p}$ equals the
intertemporal equilibrium level of $y(t)$ while the complementary function $y$, is the derivation from the equilibrium. In this analysis, we should take note that for $y(t)$ to be stable dynamically, $y_{c}$ must tends to zero as t tends to infinity, which means K in the analysis of $e^{k t}$ must be negative. Finally, we can check the solution of a differential equation by differentiation.

Ex 1: Find the general solution for the differential equation $d y / d t+$ $4 y=12$ given that $v=4$ and $z=12$.

## SOLUTION

The equation becomes:
$y(t)=e^{-\int v d t}\left(A+\int 12 e^{-\int 4 d t} d t\right)$
Let then set $\int 4 d t=4 t+c$, but c is always ignored and subsumed under A .

The equation becomes:
$y(t)=e^{-4 t}\left(A+\int 12 e^{-4 t} d t\right)$
After integrating the remaining integral we have: $12 e^{4 t} d t=3 e^{4 t}+c$.
When we ignored the constant again we have: $y(t)=e^{-4 t}\left(A+3 e^{4 t}\right)=$ $A e^{-4 t}+3$.

Recall $e^{-4 t} e^{4 t}=e^{\circ}=1$ and as $t$ tends to infinity, $y_{c}=A e^{-4 t} \Rightarrow 0$ and $y(t)$ tends to $y_{p}=3$ and we can say here that the intertemporal equilibrium level $y(t)$ is dynamically stable.

Ex 2: Given $d y / d t+3 t^{2} y=t^{2}$.
Where $v=+3 t^{2}$ and $z=t^{2}$. Find the general solution
$y(t)=e^{-\int 3 t^{2} d t}\left(A+\int t^{2} e^{\int 3 t^{2} d t} d t\right)$
Let us now integrate the exponents $\int 3 t^{2} d t=t^{3}$. Then let us substitute back in the above equation.
$y(t)=e^{-\int 3 t^{2} d t}\left(A+\int t^{2} e^{\int 3 t^{2} d t} d t\right)$

Then, we integrate the remaining integral:
Let $u=t^{3}, d u / d t=3 t^{2}$ and $d t=d u / 3 t^{2}$
$\int t^{2} e^{\int t^{3}} d t=\int t^{2} e^{u} \frac{d u}{3 t^{2}}=\frac{1}{3} \int e^{u} d u=\frac{1}{3} e^{u}=\frac{1}{3} e^{t 3}$.
Therefore let us substitutes into $y(t)=e^{-t^{3}}\left(A+\int t^{2} e t^{3 d t} d t\right)$
We have:
$y(t)=e^{-t 3}\left(A+\frac{1}{3} e^{t 3}\right)=A e^{-t 3}+\frac{1}{3}$
Therefore we can calculate that $\mathrm{t} \rightarrow \infty$ (infinity), $y_{c}=A e^{-t 3} \rightarrow 0$ and $y(t)$ tends to $1 / 3$. We say here that the equilibrium id dynamically stable.

Ex 3: Given $\frac{d y}{d t}=3 y$

$$
\frac{d y}{d t}-3 y=0
$$

From the equation above $v=-3, z=0$
$y(t)=e^{-\int-3 d t}\left(A+\int o e^{\int-3 d t} d t\right)$
Let substitute $\int-3 d t=-3 t$ and $y(t)=e^{3 t}\left(A+\int o d t\right)=A e^{3 t}$, where $t=0, y=2$. Therefore $2=A e^{3(o)} \Rightarrow A=2$.

### 3.3 Exact Differential Equations and Partial Integration

When there is more than one independent variable, such as $f(y, t)$ where $M=d F / d y$ and $N=d F / d t$, then the total differentiation is given as: $d F(y, t)=M d t+N d t$ $\qquad$
From the above equation, F is a function of more than one independent variable, M and N are partial derivatives and equation one above is called a partial differential equation and in a situation where the differential is et equal to zero, so that $M d y+N d t=0$, this is called an exact differential equation because the left side exactly equal the differential of the primitive function $F(y, t)$. Moreover, if we have an exact differential equation $\frac{d M}{d t}$ must equal to $\frac{d N}{d y}$, that is $\partial^{2} F(d t / d y)=$ $\partial^{2} F(d y / d t)$.

If we want to perform a solution of an exact differential equation, it calls for successive integration with respect to one independent variable at a time while we hold the other independent variables constant.

Ex1: Solve the exact non linear differential equation

$$
\left(6 y t+9 y^{2}\right) d y+\left(3 y^{2}+8 t\right) d t=0
$$

Step 1:See whether the equation is an exact differential equation

Let $\mathrm{M}=6 \mathrm{yt}+9 y^{2}$ and $\mathrm{N}=3 y^{2}+8 t$
$\frac{d M}{d t}=6 y$ and $\frac{d N}{d y}=6 y$.
Therefore $\frac{d M}{d t} \neq \frac{d N}{d y}$, so the equation is not an exact differential equation.
Step 2: So, the equation is a partial derivative, so we will integrate $M$ partially with respect to $y$ by treating $t$ as a constant and try to add a different/new function say $Q(t)$ for any additive term of $t$ which would have been eliminated by the original differentiation with respect to $y$. Note in this process that $d y$ is replaces $d y$ in partial integration.

$$
\begin{aligned}
& F(y, t)=\int\left(6 y t+6 y \mathrm{t}+9 y^{2}\right) d y+Q(t)=3 y^{2} t+3 y^{2}+Q(t) \\
& 3 y^{2} t+3 y^{2}+Q(t) \\
& \frac{d F}{d t}=3 y^{2}+Q(t)
\end{aligned}
$$

Since $\frac{\mathrm{dF}}{\mathrm{dt}}=\mathrm{N}$ and $\mathrm{N}=3 y^{2}+8 t$
Substitute $d F / d t=3 y^{2}+8 t$
$3 y^{2}+8 t=3 y^{2}+Q(t)$
But $Q(t)=8 t$.
Let us now integrate $Q(t)$ with respect to $t$ :
$Q(t)=\int Q^{\prime}(t) d t=\int 8 t d t=4 t^{2}$
Therefore: $F(y, t)=3 y^{2} t+3 y^{2} t 4 t^{2}+c$

Ex 2: Given $(12 y+7 t+6) d y+(7 y+4 t-9) d t=0$
$\frac{d M}{d t}=7=\frac{d N}{d y}$, so this is an exact differential equation.
$F(y, t)=\int(12 y+7 t+6) d y+Q(t)=6 y^{2}+7 y t++6 y+Q(t)$
$d F / d t=7 y+Q^{\prime}(t)$,
$\frac{d F}{d t}=N=7 y+4 t-9$
Therefore: $7 y+Q^{\prime(t)}=7 y+4 t-9$
$Q^{\prime}(t)=4 t-9$
$Q(t)=\int(4 t-9) d t=2 t^{2}-9 t$
$F(y, t)=6 y^{2}+7 t+6 y+2 t^{2}-9 t+c$.

### 3.4 Integrating Factors

In this analysis, we are talking about some exact differential equation that are not exact, because we have seen in unit 3.2above that not all differential equations are exact but we can make some to be exact by means of an integrating factor and it is called a multiplier that permits the equation to be integrated.

Ex 1: Testing the nonlinear differential equation $5 y t d y+$ $\left(5 y^{2}+8 t\right) d t=0$ shows that it is not exact. With $M=5 y t$ and $N=5 y^{2}+8 t, d m / d t=5 y \neq d N / d y=10 y$.

We then multiply by an integrating factor of $t$, which makes it exact:
$5 y t^{2}+d y+\left(5 y^{2} t+8 t^{2}\right)=0$. From this equation $d m / d t=10 y t=$ $d N / d y$.

### 3.4.1 Rules for the Integrating Factor

The two rules below will help us to find the integrating factor for a nonlinear first-order differential equation, and if such factor exists. Assuming $d m / d t \neq d N / d y$.

Rule One: If $\frac{1}{N}\left(\frac{d M}{d t}-\frac{d N}{d y}\right)=f(y)$ alone,
then $e^{\int f(y) d y}$ is an integrating factor.
Rule Two: If $\frac{1}{M}\left(\frac{d N}{d y}-\frac{d M}{d t}\right)=\mathrm{g}(t)$ alone,
then $e^{\int \mathrm{g}(t) d t}$ is an integrating factor.
Ex 2: To illustrate the rule above, find the integrating factor where
$5 y t d y+\left(5 y^{2}+8 t\right) d t=0 M=5 y t N=5 y^{2}+8 t$
$\frac{d M}{d t}=5 y \neq \frac{d N}{d y}=10 y$
Let us now apply rule one:
$\frac{1}{5 y^{2}+8 t}(5 y-10 y)=\frac{-5 y}{5 y^{2}+8 t} \Rightarrow$
Which is not a function of $y$ alone and will not supply an integrating factor for the equation. Therefore we apply the second rule:
$\frac{1}{5 y t}(10 y-5 y)=\frac{5 y}{5 y t}=\frac{1}{t} \Rightarrow$
Which is a function of t alone and the integrating factor, therefore is
$e^{\int(1 / t) d t}=e^{I n t}=t$.
Ex 3: Given $\frac{d y}{d t}=\frac{y}{t}:\left(\frac{1}{t y}\right)$
Let us rearrange the equation:
$t d y=y d t: t d y-y d t=0$

1. $d M / d t=1 \neq d N / d y=-1$,

Multiplying by $1 /($ ty $)$

$$
\frac{d y}{y}-\frac{d t}{t}=0
$$

Therefore $d M / d t=0 \neq d N / d y$ and since neither of the function contains the variables with respect to which it is being partially differentiated.
2. $F(y, t)=\int \frac{1}{y}(d y t Q(t)=\operatorname{In} y+Q(t))$
3. $d F / d t=Q^{1}(t)$, but $d F / d t=N=-1 / t$, so $Q^{1}(t)=-1 / t$
4. $Q(t)=\int-\frac{1}{t} d t=-\operatorname{In} t$
5. $\quad F(y, t)=\operatorname{In} y-\operatorname{In} t+C$ which can be expressed in different ways. However, since C is an arbitrary constant, we can then write $\operatorname{In} y-\operatorname{In} t=c$, thus:

In $(y c t)=c$ and the expression of each side of the equation as exponents of e and reality that $e^{\operatorname{In} x}=x$

$$
\begin{aligned}
& e^{\operatorname{In}(y / t)}=e^{c} \\
& \frac{y}{t}=e^{c} \text { or } y=t e^{c}
\end{aligned}
$$

### 3.5 Separation of Variables

In this case, we will try to perform some mathematical analysis of separating variables in an equation. But solution of nonlinear firstdegree differential equations is complex and a first-order first degree differential equation is one in which the highest derivative is the first derivative $d y / d t$ and that derivative is raised to power of 1 . It is nonlinear if it contains a product of $y$ and $d y / d t$ or $y$ raised to a power other than 1 . Therefore if equation is written in the form of separated variables such that $M(y) d y+N(t) d t=0$, where $M$ and $N$ are function of $y$ and $t$ above, the equation can then be solved by ordinary integration.

Ex 1: Give the nonlinear differential equation

$$
t^{2} d y+y^{3} d t=0
$$

Where $M \neq F(y)$ and $N \neq F(t)$
Let us the multiply $1 /\left(t^{2} y^{3}\right)$ by

$$
t^{2} d y+y^{3} d t=0 \text { to separate the variables: }
$$

we have: $\frac{1}{y^{3}} d y+\frac{1}{t^{3}} d t=0$
Let us now integrate the separated variable,

$$
\begin{aligned}
& \int y^{-3} d y+\int t^{-2} d t=\frac{-1}{2} y^{-2}-t^{-1}+c \\
& F(y, t)=\frac{-1}{2} y^{-2}-t^{-1}+c \\
& =\frac{-1}{2 y^{2}}-\frac{-1}{2}+c
\end{aligned}
$$

Ex 2: Let us separate the variable

$$
y d y=-5 t d t-y d y+5 t d t=0
$$

Now let integrate each of the term separately

$$
\begin{aligned}
& \frac{y^{2}}{2}+\frac{5 t^{2}}{2}=c_{1} \\
& y^{2}+5 t^{2}=2 c_{1} \\
& y^{2}+5 t^{2}=c
\end{aligned}
$$

### 3.6 Economic Applications

In analyzing application of differential equation in economics, some worked examples will be examined.

Ex 1: Find the demand function $Q=F(p)$ if point elasticity $\epsilon$ is -1 for all $P$ greater than 0 .

## Solution

$$
\begin{aligned}
\epsilon=\frac{d Q}{d P} & =-\frac{\left(5 P+2 P^{2}\right)}{Q} \times \frac{Q}{P} \\
& =-(5+2 P)
\end{aligned}
$$

We can now separate the variables
$d Q+\left(5 P+2 P^{2}\right) d P=0$
Let us then integrate $Q+5 P+P^{2}=C$
$Q=-P^{2}-5 P+C$
Given $Q=500$ and $P=10$

Substitute for $Q$ and $P$ in the equation above
$500=-100-50+c$

$$
\begin{aligned}
C & =650 \\
\therefore Q & =650-5 P-P^{2}
\end{aligned}
$$

2) Find the demand function $Q=f(P)$

If $\epsilon=-k$, a Constant.
$\epsilon=\frac{d Q}{d P} \times \frac{P}{Q}=-k$
Therefore $\frac{d Q}{d P}=\frac{K Q}{P}$
Let us separate the variables:
$\frac{d Q}{Q}+\frac{K}{P} d P=0$
$\operatorname{In} Q+K \operatorname{In} P=C$
$Q P^{K}=C$.
Therefore $Q=c P^{-K}$
3) Find the demand function
$Q=f(P)$ If $\epsilon=-\left(5 P+2 P^{2}\right) / Q$
and $Q=500$ when $P=10$.
$\epsilon=\frac{d Q}{d P} \times \frac{P}{Q}=\frac{-\left(5 P+2 P^{2}\right)}{Q}$
$\frac{d Q}{d P}=-\frac{\left(5 P+2 P^{2}\right)}{Q} \times \frac{Q}{P}$

$$
=-(5+2 P)
$$

We can now separate the variables
$d Q+\left(5 P+2 P^{2}\right) d P=0$

Let us then integrate $Q+5 P+P^{2}=C$
$Q=-P^{2}-5 P+C$
Given $Q=500$ and $P=10$.

Substitute for $Q$ and $P$ in the equation above
$500=-100-50+c$

$$
\begin{aligned}
C & =650 \\
\therefore Q & =650-5 P-P^{2}
\end{aligned}
$$

4. The Solow model examines equilibrium growth paths with full employment of both capital and labour. However, base on the assumption that:
a. Output is a linearly homogeneous function of capital and labour exhibiting constant returns to scale.
b. A constant proportion $s$ of output is saved and invested.
c. The supply of labour is growing at a constant rate r .

Therefore assumption a to c gives $y=F(K, L), \frac{d K}{d t}=k=5 y$ and $L=L_{0} e^{r t}$

You are required to derive the differential equation in terms of the single variable K/L which serves as the basis of the model.

## Solution

Let us substitute for 4 into $\frac{d K}{d t}=k=s y$
We then have $\frac{d K}{d t}=s f(K, L)$
Substituting L in $L=L_{0} e^{r t}$ into equation (1) above.

$$
\begin{equation*}
\frac{d K}{d t}=s f\left(K, L_{0} e^{r t}\right) \tag{ii}
\end{equation*}
$$

This is the time path capital function $(d K / d t)$ must follow for full employment of a growing labour force.

To then convert to a function of
$K / L$, let $Z=k / L$, then $K=Z L$
Let us now make use of $L=L_{0} e^{r t}$
$\therefore K=Z L_{0} e^{r t}$ $\qquad$ (iii)

Take the derivate of the equations above and use the product rule since $z$ is a function of $t$.
$\frac{d K}{d t}=z\left(r L_{0} e^{r t}\right)+L_{0} e^{r t} \frac{d z}{d t}$
$\Rightarrow\left(z r+\frac{d z}{d t}\right) L_{0} e^{r t}$ $\qquad$
Let us now equated equation (ii) and equation (iv)
$S f\left(K, L_{0} e^{r t}\right)=\left(z r+\frac{d z}{d t}\right) L_{0} e^{r t}$ $\qquad$
From equation (v) above, we can see that the left hand side is a linearly homogenous production function, we may divide both inputs by $L_{0} e^{r t}$ and multiply the function itself by $L_{0} e^{r t}$ without changing its value. Thus:
$S f\left(K, L_{0} e^{r t}\right)=s L_{0} e^{r t} f \frac{k}{L_{0} e^{r t}} \times 1$
Substituting equation (vi) into equation (v) and dividing both into sides by $L_{0} e^{r t}$.
$s f\left(\frac{k}{L_{0} e^{r t}} \times 1\right)=z r+\frac{d z}{d t}$
We can then substitute $z$ for $k / L_{0} e^{r t}$ and substituting $z r$ from both sides $\frac{d z}{d t} S f(z, 1)-z r$

Which is a differential equation in terms of the single variable $z$ and two parameters $r$ and $s$, where $z=k / L, r=$ the rate of growth of the labour force and $s=$ the savings rate.

### 1.0. Introduction

A difference equation is a mathematical equation that relates some function with its derivatives. In applications, the functions usually represent physical quantities, the derivatives represent their rates of change, and the equation defines a relationship between the two.

However it's also shows a relationship between a dependent variable and a lagged independent variable or variables which changes at discrete intervals of time for example $I_{t}=F\left(y_{t-1}\right)$ where I and Y are measured at the end of each year. But it should be noted here that the order of a difference equation is determined by the greatest number of periods lagged. For instance a first-order difference equation express a time log of one period while a second-order two periods; therefore the change in $y$ as $t$ changes from $t$ to $t 1$ is called the first difference of $y$.

$$
\frac{\Delta y}{\Delta t}=\Delta y_{t}=y_{t+1}-y_{t}
$$

Where $\Delta$ is an operator replacing $d / d t$ that is used to measure continuous change in differential equations.

However, let us take the order of a difference equation:

$$
\begin{gathered}
I_{t}=a\left(y_{t+1}-y_{t-2}\right) \Rightarrow \text { order } 2 \\
Q_{s}=x+y P_{t, 1} \Rightarrow \text { order } 1 \\
y_{t+1}+3-9 y_{t+2}+2 y_{t+1}+6 y_{t}=8 \Rightarrow \text { order } 3 \\
\Delta y_{t}=5 y_{t} \Rightarrow \text { order } 1
\end{gathered}
$$

### 3.0 Main Content

### 3.1 General FormulaDifferences Equations

Assuming we have a first-order difference equation where the linear that is all the variables are raised to the first power and there are no cross products.

$$
\begin{equation*}
y_{t}=b y_{t-1}+a \tag{1}
\end{equation*}
$$

Where b and a are constants, the general formula therefore for a definite solution to this problem is given as:

$$
y_{t}=\left(y_{0}-\frac{a}{1-b}\right) b^{t}+\frac{a}{1-b}
$$

When $b \neq 1$

$$
y_{r}=y_{0}+a t \text { when } b=1
$$

Ex 1: Consider the difference equation $y_{t}=7 y_{t-1}+16$ and $y_{0}=5$.
In the equation $b=-7$ and $a=16$.

## Solution

Since $b \neq 1$ we have: using the general formula

$$
\begin{gathered}
y_{t}=\left(5-\frac{16}{1+7}\right)(-7)^{t}+\frac{16}{1+7} \\
=3(-7)^{t}+2 \\
y_{0}=3(-7)^{0}+2=5, \text { since }(-7)^{0}=1 \\
y_{r}=3(-7)^{1}+2=-19
\end{gathered}
$$

Then let us substitute $y_{1}=-19$ for $y_{t}$ and $y_{0}=5$ for $y_{t-1}$ in the original equation.

$$
-19=-7(1=5)+16=-35+16
$$

### 3.2 Lagged Income Determination Model

In our normal income determination model in macroeconomics: there may be no lags in the model but here we assume that consumption is a function of the previous period's income, that is:

$$
c_{t}=c_{0}+c y_{t-1}, y_{t}=c_{t}+I_{t}
$$

Where $I_{t}=I_{0}$, thus,
$y_{t}=c_{0}+c y_{t-1}+I_{0}$
$y_{t}=c y_{t-1}+c_{0}+I_{0}$
Where $b=c$ and $a=c_{0}+I_{0}$. Let us substitute these values in the general formula we discuss in Unit One. Moreso, since the marginal propensity to consume c cannot equal to 1 and assuming $y_{t}=y_{0}$ at $t=$ 0

### 3.3 The Cobweb Model

This is an economic model that explains why prices might be subject to periodic fluctuations in certain types of markets. It also describes the cyclical supply and demand in a market where the amount produced
must be chosen before prices are observed. The model is based on a time lag between supply and demand decisions.

Agricultural markets are a context where the cobweb model might apply, since there is a lag between planting and harvesting. Suppose for example that as a result of unexpectedly bad weather, farmers go to market with an unusually small crop of strawberries.

This shortage, equivalent to a leftward shift in the market's supply curve, the result is high prices. If the farmers expect these high process conditions to continue, then in the following year, they will raise their producing of strawberries relative to other crops.

Therefore, when they go to market the supply will be high, resulting in low prices. If they then expect low prices to continue, they will decrease their production of strawberries for the next year, which will result to a high price again. Therefore many products, such as that of agricultural commodities discussed earlier which are planted a year before marketing current supply depends on last year's price. This poses interesting stability question.

### 3.4 The Harrod Domar Model

The Harrod-Domar model is a classical Keynesian model of economic growth. It is used in development economics to explain an economy's growth rate in terms of the levels of saving and productivity of capital. It suggests that there is no natural reason for an economy to have balanced growth. The model was developed independently by Roy .F. Harrod in 1939, and Evsey Domar in 1946, although a similar model had been proposed by Gustav Cassel in 1924. The Harrod-Domar model was precursor to the exogenous growth model.

The Harrod model attempts to explain the dynamics of growth in the economy. It assumes:

Where $s$ is a constant equal to both the MPS and APs. It also assumes the acceleration principle that is investment is proportional to the rate of change of national income overtime.

Dividing through by $a-s$ to conform to $y_{t}=[a \mid(a-s)] y_{t-1}$. Since $a \mid(a-s) \neq 1$.
$y_{t}=\left(y_{0}-0\right)\left(\frac{a}{a-s}\right)+0=\left(\frac{a}{a-s}\right) y_{0}$.

The stability of the time path thus depends on $a \mid(a-s)$. Since $a=$ the capital-output ratio, which is normally larger than 1 and since $\mathrm{s}=$ MPS which is larger than 0 and less than 1 , the base $a \mid(a-s)$ will be larger than 0 and usually larger than

1. Therefore, $y_{t}$ is explosive but nonoscillating. Income will expand indefinitely, which means it has no bounds.

Ex 1: The warranted rate of growth that is the path the economy must follow to have equilibrium between saving and investment each year can be found as follows in the Harrod model.

### 1.0. Introduction

Economics is both a positive as well as a normative social science. It helps in explaining why the various economic units behave the way they do, it guides the decision makers regarding what it must do given its objectives and constraints, if any. For example, positive economics would offer rationalization as to why a particular household buys a particular consumption basket or why a producer produces a given quantity of its output.

In contrast, normative economics would help in determining the most appropriate consumption basket for the household, given its objective that is maximization of utility or satisfaction and the budget (expenditure or income) constraint and in determining the most appropriate production level for the entrepreneur, given its objective of profit maximization and the constraints such as technology, raw material and availability. Therefore these roles of economics are referred to as the one dealing with economic optimization.

### 3.0 MAIN CONTENT <br> 3.1 Meaning and Types of Optimization Problems

Optimization deals with the determination of extreme values which could be maximum or minimum for the goal (objective) variable. The goal variable could be just one unique or more multiple. For example, a private firm might pursue profit maximization as it is single goal. If so, the optimization technique must determine the value of the variables,
which are under the firm's control, called choice variables, so that they ensure the achievement of maximum possible profit to the firm. Moreover, a manufacturing company might aim at minimizing its average cost of production as the sole objective. In that case, the role of optimization techniques would be to find out the values of the variables under the firm's control that are consistent with the minimum possible value for its average cost. Thus if project depends only on the level of production, the profit maximizing problem is a single variable optimization problem. More so, if the profit depends on the level of output as well as the advertisement budget or in addition on some other variables as well, there is a multiple variable optimization.

The optimization problem facing a decision - making unit is further classified into unconstrained and constrained problems. In the former, the decision maker optimizes subject to no constraint, internal or external. In the latter, it has one or more constraints also called side conditions, imposed either by itself (Internal) or by outside agencies (external) such as government and or market conditions. An example of unconstrained optimization would be one where the firm aims at the maximum possible profit subject to one or more constraints such as a fixed production cost budget, a fixed quantity of output to be availability of scare raw - materials in fixed quantity, employment of minimum number of unskilled labor etc.

The constrained optimization problems are further classified into equality and inequality constrained problems. For examples, a profitmaximizing firm might be required to produce a specific quantity of output of all of its multiple products, or if it is single product firm, it might be faced with a fixed production cost budget or a fixed quantity of a particular scare raw-material. Under these conditions, the optimizing firm must strictly adhere to the given number of the constrained variable. An example of optimization subject is inequality constraints would be the one where the firm is seeking maximum possible profits but there is a fixed quantity of skilled labour available in the market: the firm can employ all the skilled labour, any quantity less than it but it no more.

### 1.0. Introduction

Since the end of the nineteenth century, economic analysis has been fairly rigidly compartmentalized into statics and dynamics. Various, sometimes conflicting definitions of these terms have appeared in the literature; some have based the distinction on the nature of the subject matter studied, while others have emphasized the difference in analytic approach. Utilizing the first of these viewpoints, we may distinguish between a stationary economic phenomenonthat is, one that does not change with the passage of time and a developing or changing phenomenon. But no matter which type of phenomenon we study, we may focus upon it an analytic apparatus which we describe as dynamic; that is, one that takes explicit account of the role of the passage of time in the structure of the subject; or we can subject it to a static analysis, which deals with its mechanism at a given moment and abstracts from the effect of past events on the present and future. For example, an investigation of the determination of the level of employment at a given moment and its dependence on current consumption, investment, and governmental demand may be considered static in character, but a discussion of the same problem that considers how the relationship between today's supply of capital equipment and its growth affects tomorrow's investment demand and how this process can generate a time path of investment demand can be considered a dynamic analysis.

### 3.0 MAIN CONTENT

### 3.1. Concept of Dynamic Economics

The concept of dynamics is derived from Physics. It refers to a state where there is a change such as movement. However, tides of the sea, a bird flying in the sky are examples of dynamics. But the word 'dynamic' has a different meaning in economics. It is known from the dynamics study that there is movement in statics also but this movement is certain, regular and expected. While dynamics refers to that movement which is uncertain, unexpected and irregular.

Moreover, let us look at an aeroplane flying in the sky, we say is in a dynamic state only if its direction, height and speed are uncertain. We know from day to day experience that fluctuations occur in the economy quite often. And it is not possible to make correct predictions about such fluctuations. The concept of dynamics is nearer to reality. In dynamic economics we study the economic variables like consumption function, income and investment in a dynamic state.

However, according to Prof. Harrod, "Economic dynamics is the study of an economy in which rates of output are changing." In the real world, economic variables like population, capital, techniques of production, fashions, habits, etc. do not change at a constant rate. The rate of change is different at different times. For example, the population of a country may increase at a rate of $3 \%$ in the first year; $5 \%$ in the second year and $7 \%$ in the third year, if the other economic variables change at unequal rates, the rate of output will also change at different times. In a dynamic state, there is uncertainty of every change. So, it is not possible to make correct predictions.

According to Prof. Hicks, "Economic dynamics refers to that part of economic theory in which all quantities must be dated." From Prof. Hicks's definition, we come to know that time element occupies great importance in dynamic economics. Here economic variables are related to different points of time. According to Baumol, "Economic dynamics is the study of economic phenomenon in preceding and succeeding events."

Comparative economic statics does not show the path of change of the old to new equilibrium. But in dynamic economics we also study the path of change or the movement towards equilibrium.

Recently the concept of dynamics has been applied to the economy as a whole, Prof Clark has pointed out the following features of a dynamic economy:
(i) In a dynamic economy, population grows;
(ii) Quantity of capital grows;
(iii) Modes of production improve;
(iv) Industrial institutions undergo changes. Inefficient organizations are replaced by efficient organisations.
(v) Habits of the people, fashions and customs change, as wants of the people increase.

We can conclude by saying that dynamic economics relates to a dynamic economy where uncertainty and expectations play their part.

### 3.2. Scope and Importance of Dynamic Economics:

Dynamic economics is becoming more and more popular since 1925. Though the principles advocated by Clark and Aftalian were dynamic in nature yet their main purpose was to explain the business fluctuations. After 1925, dynamic economics became popular not only in business fluctuations but also in the determination of income and growth models.

The following points explain the scope and importance of dynamic economics:

## 1. Study of Time Element:

Time element occupies an important role in dynamic economics. Economic problems concerning continuous change of economic variables and path of change can be studied only in dynamic economics.

## 2. Trade Cycles:

Theories of trade cycles have been advocated only through the introduction of dynamic economics. Theories of trade cycles are based on dynamic economics as they refer to the fluctuations of the different time periods.

## 3. Basis of many Economic Theories:

Dynamic economics has an important place in economics because many economic theories are based on it. For example, saving and investment theory, theory of interest, effect of time element in price determination, etc. are based on dynamic economics.

## 4. More Flexible Approach:

Dynamic analysis is more flexible. Models regarding the possibilities of economic change can be development in dynamic analysis. That is why it has been found a useful mode of study. Dynamic economics is also useful in solving the problems of economic planning, economic growth and trade cycles.

## 5. Realistic Approach:

Dynamic economic analysis is nearer to the reality. In a real world, economic variables like national income, consumption, etc. change irregularly and uncertainly. Moreover, economic variables of the previous period also affect the present economy. And time clement occupies an important role in economic analysis.

### 3.3. Limitations of Dynamic Economics:

Dynamic economic analysis has its shortcomings too. It is difficult to understand.

Its main limitations are the following:

## 1. Complex Approach:

Dynamic economic analysis is a complex approach for the study of economic variables because it is based on time element. To find solutions of various problems, we have to make use of mathematics and economics which is beyond the understanding of a common man.

## 2. Not Fully Developed:

Many economists like Samuelson and Harrod, have developed dynamic approach of economic analysis. They have developed their theories through dynamic analysis. But this mode of economic analysis has not been fully developed. The reason is that factors affecting economic variables change very soon. Dynamic approach is not developing at the speed at which economic factors change.
