1. The Government of *Rapuokwu* has been generally hailed for infrastructural and human capital development since its inception in 2017. In fact, the road network in *Oshegbe* State has been dramatically changed for good. *Oshegbe* is now the envy of other neighbouring States on developmental and infrastructural matters. However, the key leaders of the major opposition party do not seem to appreciate the popularity Governor *Rapuokwu* is gaining as they are making serious plans to topple him in the next election. Recently, *Rapuokwu* government has embarked on a very huge and strategic road project which impacted heavily on the State's finance. To recoup part of the expenses, the government has decided to build a toll gate for motorists within the State, a situation which the opponent saw as an opportunity to attack. They have leveled accusation against the State government over what they call introduction of new tax system. They have called on the citizens to resist the tax and have threatened to sue the government. As a Taxation Lawyer, you are expected to discuss the issues involved and advise the parties accordingly.

2. Mrs. Aisha Abiola is a successful businesswoman and a faithful taxpayer. As at 2016, her total profit from her various businesses was Six Million Five Hundred Thousand Naira (N6,500,000) only and her tax was One Hundred and Sixty Two Thousand Five Hundred Naira (N162,500) only. In 2017 her total profit was Seven Million Four Hundred Thousand Naira (N7,400,000) only and her tax was One Hundred and Eighty Five Thousand Naira (N185,000) only. In 2018, due to Nigerian Economic downturn, her total profit was Five Million Six Hundred Thousand Naira (N5,600,000) only and she paid tax of One Hundred and Fifteen Thousand Naira (N115,000) only.
