On March 17, 2020 (two days after the robbery incident), Miss Grace went back to the insurance company to pay the second instalment of N300, 000 to complete the payment of the premium. Was there a valid and enforceable contract of insurance between the parties or not? Support your answer with relevant judicial authorities.**25marks**
