 - i. A patented invention
 - ii. A popular but easily copied restaurant recipe
 - iii. An industry where economies of scale are very small compared to the size of demand in the market
 - iv. A well-established reputation for slashing prices in response to new entry
 - v. A well-respected brand name that has been carefully built up over many years
 - vi. A city passes a law on how many licenses it will issue for taxicabs
 - vii. A city passes a law that all taxicab drivers must pass a driving safety test and have insurance
 - viii. A well-known trademark
 - ix. Owning a spring that offers very pure water
 - x. An industry where economies of scale are very large compared to the size of demand in the market
