1.0. Introduction: A large class of ordinary differential equations possesses solution expressible, over a certain interval, in terms of power series. In this unit we are going to investigate methods of obtaining such solutions.
2.0. Objectives: At the end of this unit you should be able to - determine radius of convergence of series

- apply series solution method to solving differential equation
- determine ordinary point, and singular points of the differential equation


### 3.0 MAIN CONTENT

### 3.1. Series Solution of Ordinary Differential Equation

An expression of the form

$$
\begin{equation*}
A_{0}+A_{1}\left(x-x_{0}\right)+\ldots A_{n}\left(x-x_{0}\right)^{n}+\ldots=\sum_{n=0}^{\infty} A_{n}\left(x-x_{y}\right)^{n}+\ldots \tag{1}
\end{equation*}
$$

is called the power series.
To determine for what values of $x$ the series (1) converges we use ratio test

$$
\rho=\lim _{n \rightarrow \infty}\left|\frac{A_{n+1}\left(x-x_{0}\right)^{n+1}}{A_{n}\left(x-x_{0}\right)^{n}}\right|=\lim _{n \rightarrow \infty}\left|\frac{T_{n+1}}{T_{n}}\right|=L\left|x-x_{0}\right|
$$

Where $L=\lim _{n \rightarrow \infty}\left|\frac{A_{n+1}}{A_{n}}\right|$

The series is convergent when $\rho<1$, divergent when $\rho>1$. The test fails if $\rho=1 . \quad \rho=\frac{1}{L}$ is called the radius of convergence
The series converges when
$\left|x-x_{0}\right|<\frac{1}{L}=R \quad$ (radius of convergence)
diverges when
$\left|x-x_{0}\right|>\frac{1}{L}=R$
(i) If $L$ is zero, the series converges for all Values of $x$
(ii) If $L$ is infinite, the series converges only at the point $x=x_{0}$
(iii) If $L$ is finite, then the series converges, when
$\left|x-x_{0}\right|<\frac{1}{L}=R \quad$ (radius of convergence) and diverges if $\left|x-x_{0}\right|>\frac{1}{L}$
If $\quad \sum_{n=0}^{\infty} a_{n}\left(x-x_{y}\right)^{n} \quad$ and $\quad \sum_{n=0}^{\infty} b_{n}\left(x-x_{y}\right)^{n}$
Converge to $f(x)$ and $g(x)$ respectively, for $\left|x-x_{0}\right|<\rho_{1}$ (radius of convergence) $\rho_{1}>0$, then the following are true for $\left|x-x_{0}\right|<\rho_{1}$.
(i)Two series can be added and subtracted term wise, and
$f(x) \pm g(x)=\sum_{n=0}^{\infty}\left(a_{n}+b_{n}\right)\left(x-x_{y}\right)^{n}$
(ii) The series can be multiplied and
$f(x) g(x)=\sum_{n=0}^{\infty} a_{n}\left(x-x_{y}\right)^{n} \sum_{n=0}^{\infty} b_{n}\left(x-x_{0}\right)^{n}=\sum_{n=0}^{\infty} C_{n}\left(x-x_{0}\right)^{n}$
Where $C_{n}=a_{0} b_{n}+a_{1} b_{n-1}+a_{2} b_{n-2}+\ldots+a_{n} b_{0}$
If $g\left(x_{0}\right) \neq 0$, the series
$\frac{f(x)}{g(x)}=\sum_{n=0}^{\infty} d_{n}\left(x-x_{y}\right)^{n}$
although formula for $d_{n}$ is complicated if $f(x)=\sum_{n=0}^{\infty} a_{n}\left(x-x_{y}\right)^{n}$, then $f(x)$ is continuous
has derivates of all orders for $\left|x-x_{0}\right|<\rho_{1}$. and $f^{\prime}, f^{\prime \prime}, f^{\prime \prime \prime} \ldots$ can be computed by differentiating the series. Thus
$a_{n}=\frac{f^{n}\left(x_{0}\right)}{n!}$ or $f(x)=\sum_{n=0}^{\infty} \frac{f^{n}\left(x_{0}\right)}{n!}\left(x-x_{y}\right)^{n}$
(3) is called the Taylor series for function $f$ at $x=x_{0}$

A function $f$ that has Taylor series expansion about $x=x_{0}$
$f(x)=\sum_{n=0}^{\infty} \frac{f^{n}\left(x_{0}\right)}{L n}\left(x-x_{y}\right)^{n}$
With a radius of convergence $\rho>0$ is said to be analytic at $x=x_{0}$.
The polynomial is analytic at every point, thus sums, differences, products, quotients (excepts at the zeroes of the denominator) of polynomials are analytic at every point.
(i) Determine the radius of convergence of the power series
(i) $\sum_{n=0}^{\infty} 2^{n} x^{n}$
(ii) $f(x)=\sum_{n=0}^{\infty} \frac{(2 x+1)^{n}}{n^{2}}$
(iii) $\rho=\lim _{n \rightarrow \infty}\left|\frac{2^{n}}{2^{n+1}}\right|=\frac{1}{2}$
(iv) $\rho=\lim _{n \rightarrow \infty}\left|\frac{A_{n}}{A_{n+1}}\right|=\frac{1}{2}$
(v) $\rho=\lim _{n \rightarrow \infty}\left|\frac{2^{n}}{n^{2}} \frac{(n+1)^{2}}{2^{n+1}}\right|=\lim _{n \rightarrow 0}\left|\frac{1}{2}\left(1+\frac{1}{n}\right)^{2}\right|=\frac{1}{2}$

### 3.2. Determining the Radius of Convergence

If we obtain the Taylor series of a function $f(x)$ about a point $x_{0}$, then the radius of convergence of the series is equal to the distance of the point $x_{0}$ from the nearest singularity.

## Remark about a change in the index of summation

(a) $\sum_{n=2}^{\infty} a_{n} x^{n}=\sum_{n=0}^{\infty} a_{n+2} x^{n+2}=\sum_{k=0}^{\infty} a_{k+2} 2^{k+2}$
(b) $\sum_{n=2}^{\infty} n(n-1) a_{n} x^{n-2}=\sum_{n=0}^{\infty}(n+2)(n+1) a_{n+2} x^{n}$
(c) $\sum_{n=0}^{\infty} a_{n} x^{n+2}=\sum_{n=2}^{\infty} a_{n-2} x^{n}$
(d) $\sum_{n=k}^{\infty} a_{n+m} x^{n+p}=\sum_{n=0}^{\infty} a_{n+k+m} x^{n+p+k}$
3.3 Ordinary Points and Singular Points of the Differential Equations

We consider the differential equation

$$
\begin{equation*}
P(x) \frac{d^{2} y}{d x^{2}}+Q(x) \frac{d y}{d x}+R(x) y=0 \tag{4}
\end{equation*}
$$

(we assume that $P(x), Q(x)$ and $R(x)$ are polynomials)
(a) if $P\left(x_{0}\right) \neq 0$, then $x_{0}$ is an ordinary point of the equation (1), or

$$
P=\frac{Q(x)}{R(x)} \quad, \quad Q=\frac{R(x)}{P(x)}
$$

$y, P, Q$ are analytic at the point $x=x_{0}$, then $x_{0}$ is the ordinary point of the equation.
(b) If the functions $P(x), Q(x)$ and $R(x)$ are polynomials having no common factors, the singular points of equation (1) are the points for which

$$
\begin{equation*}
P(x)=0 \tag{5}
\end{equation*}
$$

(c) If $\lim _{x \rightarrow x_{0}}\left(x-x_{0}\right) \frac{Q(x)}{P(x)} \quad$ is finite
and $\quad \lim _{x \rightarrow x_{0}}\left(x-x_{0}\right)^{2} \frac{Q(x)}{P(x)} \quad$ is finite
Then the point $x=x_{0}$ is called the REGULAR SINGULAR POINT of equation (3)
(d) Any singular point of equation (3) that is not regular singular point is called an irregular singular point.

### 3.3.1 Solution Near An Ordinary Point

Let us consider the equation

$$
\begin{equation*}
P(x) y^{\prime \prime}+Q(x) y^{\prime}+R(x) y=0 \tag{6}
\end{equation*}
$$

Where $P(x), Q(x)$ and $R(x)$ are polynomials. $x_{0}$ is the ordinary point of the equation (6).
Assuming that $y=\phi(x)$ is a solution of (6) and $\phi(x)$ has a Taylor Series
$y=\phi(x)=\sum_{n=0}^{\infty} a_{n}\left(x-x_{y}\right)^{n}$
Now we know that

$$
\begin{equation*}
a_{m}=\frac{\phi^{m}(x)}{m!} \tag{8}
\end{equation*}
$$

We can write (1)
$y^{\prime \prime}+P(x) y^{\prime}+q(x) y=0$
where $\quad P=\frac{Q(x)}{R(x)} \quad, \quad q=\frac{R(x)}{P(x)}$
$\therefore \quad y^{\prime \prime}=-P y^{\prime}-q y$
or

$$
y^{\prime \prime \prime}=-p^{\prime} y^{\prime \prime}-P^{\prime} y^{\prime}-q^{\prime} y-q y^{\prime}
$$

(It is natural to assume that $y=y(x), y^{\prime}=y^{\prime}(x) \quad$ at $x=x_{0}$ and $y(0)=a_{1}$, $y^{\prime}(0)=a_{2}$, we can easily calculate the coefficient $a_{n}$ a, provided that we could compute infinitely many derivatives of $p$ and $q$ existing at $x_{0}$. Thus $p$ and $q$ must have some condition for line calculation of $a_{n}$. It has been proved that.
$P=\frac{Q(x)}{R(x)} \quad, \quad q=\frac{R(x)}{P(x)} \quad$ are analytic at $x_{0 .}$, then the general solution of (6) is $y=\sum_{n=0}^{\infty} a_{n}\left(x-x_{0}\right)^{n}=a_{0} y_{1}(x)+a_{1} y_{2}(x)$
Where $a_{n}$ and $a_{1}$ are arbitrary $y_{1}$ and $y_{2}$ are linearly independent series solutions which are analytic at $x_{0}$.

We shall illustrate the method by examples.
Example 1. Solve the equation
$y^{\prime \prime}+4 y=0$
near the ordinary point $x=0$
Solution: we assume the solution as

$$
\begin{align*}
y & =\sum_{n=0}^{\infty} a_{n} x^{n}  \tag{1}\\
y^{\prime \prime} & =\sum_{n=0}^{\infty} n(n-1) a_{n} x^{n-2} \tag{2}
\end{align*}
$$

Substituting these values in the equation yields

$$
\begin{equation*}
\sum_{n=0}^{\infty} n(n-1) a_{n} x^{n-2}+4 \sum_{n=0}^{\infty} a_{n} x^{n}=0 \tag{3}
\end{equation*}
$$

or $\sum_{n=0}^{\infty} n(n-1) a_{n} x^{n-2}+4 \sum_{n=2}^{\infty} a_{n-2} x^{n-2}=0$
or $\sum_{n=0}^{\infty}\left[n(n-1) a_{n}+4 \sum_{n=2}^{\infty} a_{n-2}\right] x^{n-2}=0$
Because the first two terms of the first sum in (4) are zero.
We now use the fact that for a power series to vanish identically over any interval, each coefficient in the series must be zero
Recurrence relation :
$n(n-1) a_{n}+4 a_{n-2}=0 \quad$ or $a_{n}=\frac{-4 a_{n-2}}{n(n-1)} \quad, n \geq 2$
Now we calculate in coefficients
$a_{2}=\frac{-4 a_{0}}{2.1} \quad, \quad a_{3}=\frac{-4 a_{1}}{3.2}, \quad a_{4}=\frac{-4 a_{2}}{4.3}, \quad a_{5}=\frac{-4 a_{3}}{5.4}$
$a_{2 k}=\frac{-4 a_{2 k-2}}{2 k(2 k-1)}, \quad a_{2 k+1}=\frac{-4 a_{2 k-1}}{(2 k+1)(2 k)}$
From above we have
$a_{2} \cdot a_{n . .} a_{2 k}=\frac{(-1)^{k} 4^{k}}{2 k!} a_{0} \cdot a_{2} \ldots a_{2 k-2}$
$a_{2 k}=\frac{(-1)^{k} 4^{k}}{2 k!} a_{0}, \quad a_{2 k+1}=\frac{(-1)^{k} 4^{k}}{(2 k+1)!} a_{1}$
Hence we can write in solution

$$
\begin{aligned}
& y=\sum_{n=0}^{\infty} a_{n} x^{n}=a_{0}+\sum_{k=1}^{\infty} a_{2 k} x^{2 k}+a_{1} x+\sum_{k=1}^{\infty} a_{2 k+1} x^{2 k+1} \\
& =a_{0}+\sum_{k=1}^{\infty} \frac{(-1)^{k} 4^{k}}{2 k!} a_{0} x^{2 k}+a_{1} x+\sum_{k=0}^{\infty} \frac{(-1)^{k} 4^{k}}{(2 k+1)!} a_{1} x^{2 k+1} \\
& =a_{0}\left[1+\sum_{k=1}^{\infty} \frac{(-1)^{k}}{2 k!}(2 x)^{2 k}\right]+\frac{1}{2} a_{1}\left[2 k+\sum_{k=0}^{\infty} \frac{(-1)^{k}}{(2 k+1)!}(2 x)^{2 k+1}\right] \\
& =a_{0} \operatorname{Cos} 2 x+\frac{1}{2} a_{1} \operatorname{Sin} 2 x
\end{aligned}
$$

Example 2: Solve the equation
$\left(1-x^{2}\right) y^{\prime \prime}-6 x y^{\prime}-4 y=0$
near the ordinary point $x=0$
Solution: we assume the solution
$y=\sum_{n=0}^{\infty} a_{n} x^{n}$
The only singular points of the equation in the finite plane are $x=1$ and $x=-1$. Hence we show that the solution is valid in $|x|<1$ with $a_{0}$ and $a_{1}$ arbitrary coefficients
$\sum_{n=0}^{\infty} n(n-1) a_{n} x^{n-2}-\sum_{n=0}^{\infty} n(n-1) a_{n} x^{n}-\sum_{n=0}^{\infty} 6 n a_{n} x^{n}-\sum_{n=0}^{\infty} 4 a_{n} x^{n}=0$
or $\sum_{n=0}^{\infty} n(n-1) a_{n} x^{n-2}-\sum_{n=0}^{\infty}\left(n^{2}+5 n+4\right) a_{n} x^{n}$
or $\left.\sum_{n=0}^{\infty} n(n-1) a_{n} x^{n-2}-\sum_{n=0}^{\infty}(n+1)(n+4)\right) a_{n} x^{n}$
Let us shift the index the second series.
$\left.\sum_{n=0}^{\infty} n(n-1) a_{n} x^{n-2}-\sum_{n=2}^{\infty}(n-1)(n+2)\right) a_{n-2} x^{n-2}=0$
In equation (2), the coefficient of each power of $x$ must the zero.
$a_{n}=\frac{n+2}{n} a_{n-2}, \quad$ for $n \geq 2$
(3) is called recurrence relation. A recurrence relation is a special kind of difference equation.
$n=2,4,6, \ldots$
and $n=3,5,7, \ldots$
$a_{2}=\frac{4}{2} a_{0}$,

$$
a_{3}=\frac{5}{3} a_{1}
$$

$a_{4}=\frac{6}{4} a_{2}$

$$
a_{5}=\frac{7}{5} a_{3}
$$

$a_{2 k}=\frac{2 k+1}{2 k} a_{2 k-2} \quad a_{2 k+1}=\frac{2 k+3}{2 k+1} a_{2 k-1}$
$k \geq 1$
$a_{2 k}=(k+1) a_{0}$
Similarly, $k \geq 1$
$a_{2 k+1}=\frac{2 k+3}{3} a_{1}$
Hence the solution $y=\sum_{n=0}^{\infty} a_{n} x^{n}$
$y=a_{0}+\sum_{k=1}^{\infty} a_{2 k} x^{2 k}+a_{1} x+\sum_{k=1}^{\infty} a_{2 k+1} x^{2 k+1}$
$=a_{0}\left[1+\sum_{k=1}^{\infty}(k+1) x^{2 k}\right]+a_{1}\left[x+\sum_{k=1}^{\infty} \frac{2 k+3}{3} x^{2 k+1}\right]$
$=\frac{a_{0}}{\left(1-x^{2}\right)}+\frac{a_{1}\left(3 x-x^{3}\right)}{3\left(1-x^{2}\right)^{2}}$
Example 3. Solve the equation
$y^{\prime \prime}+(x-1)^{2} y^{\prime}-4(x-1) y=0$
about the ordinary point $x=1$
Solution: we assume the solution

$$
\begin{equation*}
y=\sum_{n=0}^{\infty} a_{n}(x-1)^{n} \tag{1}
\end{equation*}
$$

We first translate the axes, putting
$x-1=u, \frac{d y}{d u} \cdot \frac{d u}{d x}=\frac{d y}{d x}$
$\frac{d y}{d u} \cdot 1=\frac{d y}{d x} \quad$ The equation becomes
$\frac{d^{2} y}{d u^{2}}+u^{2} \frac{d y}{d u}-4 u y=0$
Then we assume the solution

$$
\begin{aligned}
& y=\sum_{n=0}^{\infty} a_{n} u^{n} \\
& \sum_{n=0}^{\infty} n(n-1) a_{n} u^{n-2}+\sum_{n=0}^{\infty} n a_{n} u^{n+1}-\sum_{n=0}^{\infty} 4 a_{n} u^{n+1}=0
\end{aligned}
$$

Collecting the terms

$$
\sum_{n=0}^{\infty} n(n-1) a_{n} u^{n-2}+\sum_{n=0}^{\infty}(n-4) a_{n} u^{n+1}=0
$$

Shifting the index from $n$ to $n-3$ in the second series
$\sum_{n=0}^{\infty} n(n-1) a_{n} u^{n-2}+\sum_{n=3}^{\infty}(n-7) a_{n-3} u^{n-21}=0$
Therefore $a_{0}$ and $a_{1}$ are arbitrary and for remainder, we have
$2 a_{2}=0$
$n \geq 3$
$a_{n}=\frac{n-7}{n(n-1)} a_{n-3}$
$a_{01}$ arbitrary $\quad a_{11}$ arbitrary $\quad a_{01}=0$
$a_{3}=\frac{-4}{3.2} a_{0} \quad a_{4}=\frac{-3}{4.3} a_{1}$
$a_{5}=\frac{-2}{5.4} a_{2}=0$
$a_{6}=\frac{-1}{6.5} a_{3} \quad a_{7}=\frac{0}{7(6)} a_{4}=0$
$a_{8}=() a_{5}=0$
$a_{9}=\frac{-2}{9.8} a_{6} \quad a_{10}=\frac{-3}{10.9} a_{7}=0$
$a_{1}=0$
$a_{3 k}=\frac{3 k-7}{3 k(3 k-1)} a_{3 k-3} \quad a_{3 k+1}=0, k \geq 2$
$a_{2 k+2}=0, k \geq 1$
$k \geq 1: \quad a_{3 k}=\frac{(-1)^{k}[(-4)(-1) \ldots 2 \ldots(3 k-7)]}{[3.6 .9 \ldots . .(3 k)][2.5 . .8 \ldots(3 k-1)]} a_{6}$
$y=a_{0}\left[1+\sum_{k=1}^{\infty} \frac{(-1)^{k}[(-4)(-1) \ldots 2 \ldots(3 k-7)]}{[3.6 .9 \ldots . .(3 k)][2.5 .8 \ldots . .(3 k-1)]} u^{3 k}+a_{1}\left(u+\frac{1}{4} u^{4}\right)\right.$
Now substitute $u=x-1$

$$
y=a_{0}\left[1+\sum_{k=1}^{\infty} \frac{(-1)^{k}[(-4)(-1) \ldots 2 \ldots(3 k-7)]}{[3.6 .9 \ldots . .(3 k)][2.5 . .8 \ldots(3 k-1)]} u^{3 k}+a_{1}\left(u+\frac{1}{4} u^{4}\right)\right.
$$

4.0 Conclusion: In this unit we have attempted the series solution method to Ordinary Differential Equations. In the subsequent unit we are going to discuss more about this method in greater details. You are supposed to master this unit properly to be well equipped for the next unit.

1.0 Introduction: In this unit we deal with a class of differential equation normally refer to as Euler Equation. This type of equation usually possesses solutions that are classified as regular singular points of the differential equations. Series solution of this class of equation must be attempted with different approach. We shall see this in our treatment of this system of equation in this unit.

### 3.0. MAIN CONTENT

### 3.1. Euler Equation

$L(y)=x^{2} \frac{d^{2} y}{d x^{2}}+\alpha x \frac{d y}{d x}+\beta y=0$
is known as Euler equation.
It is easy to see that $x=0$ is a regular singular point of (1)
In any interval not including the origin, (1) has a general solution of the form.
$y=c_{1} y_{1}(x)+c_{2} y_{2}(x) \quad$,
$y_{1}$ and $y_{2}$ are linear, independent solution.
Here we assume that (1) has a solution of the form
$y=x^{2}$
$L\left(x^{2}\right)=x^{2}\left(x^{2}\right)^{\prime \prime}+\alpha x\left(x^{2}\right)^{\prime}+\beta x^{2}=x^{2} F(r)$
Where
$F(r)=r(r-1)+\alpha r+\beta$
If $r \mathrm{r}$ is a root of the equation

$r_{2}=\frac{-(\alpha-1)-\sqrt{(\alpha-1)^{2}-u \beta}}{2}$
$\therefore F(r)=\left(r-r_{1}\right)\left(r-r_{2}\right)$
Case I $(\alpha-1)^{2}-4 \beta>0$, then the roots are real and unequal and $W\left(x^{r_{1}}, x^{r_{2}}\right)$ is non-vanishing for $r_{1} \neq r_{2}$ ) and $x>0$. Thus the general solution is
$y=c_{1} x^{r_{1}}+c_{2} x^{r_{2}} \quad x>0$
case ll $(\alpha-1)^{2}-4 \beta=0$, then $r_{1}=r_{2}=-\frac{(\alpha-1)}{2}$
and we have only one solution
$y_{1}(x)=x^{r_{1}}$
of the differential equation. We can obtain the second solution by the method of reduction. We consider a different approach to obtain the solution.
$L\left(x^{r}\right)=x^{r} F(r)$
If $r=r_{1}$, then
$L\left(x^{r_{1}}\right)=x^{r_{1}} F\left(r_{1}\right)=0$
Now $F(r)=\left(r-r_{1}\right)^{2}$, if we differentiate
$F(r)$ i.e $\therefore F^{\prime}(r)=2\left(r-r_{1}\right)$ and then set $r=r_{1}$, if given $F^{\prime}(r)=0$, it suggest that
$\frac{\partial}{\partial r} L\left(x^{r}\right)=\frac{\partial}{\partial r}\left[x^{r} F(r)\right]$
$L\left(x^{r} \log x\right)=x^{r} \log x F(r)+r\left(r-r_{1}\right) x^{r}$
We set $r=r_{1}$, thus
$L\left(x^{r_{1}} \log x\right)=0$
$\therefore y_{2}=x^{r_{1}} \log x \quad x>0$
is the second solution of (1)
Thus the general solution is
$y_{2}=\left(c_{1}+c_{2} \log x\right) x^{r_{1}}, \quad x>0$
Case III $\left.(\alpha-1)^{2}-4 \beta<0\right)$, in this case, the root are complex, say

r_{1}=\lambda+i \mu, \quad r=\lambda+i \mu
$$

Thus the general solution is

\begin{aligned}
& y_{2}=\left(c_{1} x^{\lambda+i \mu}+c_{2} x^{\lambda-}\right) x^{r i \mu} \\
& =x^{\lambda}\left[c_{1} x^{i \mu}+c_{2} x^{-i \mu}\right] \\
& =x^{\lambda}\left[c_{1} e^{i \mu \log x}+c_{2} e^{-i \mu \log x}\right] \\
& =x^{\lambda}\left[c_{1} \cos (\mu \log x)+c_{2} \sin (\mu \log x]\right.
\end{aligned}
$$

It is always possible to obtain a real valued solution of Euler equation (1) in the interval, by making the following changes
$\frac{d}{d x}=(-1) \frac{d}{\xi}, \frac{d^{2}}{d x^{2}}=\frac{d^{2}}{d \xi^{2}}$
in the equation, we have
$\xi^{2} \frac{d^{2} u}{d \xi^{2}}=\xi^{2} \frac{d u}{d \xi}+\beta u=0, \xi^{2} \quad \xi^{2}>0$
It is obtained as above. Since

$$
\begin{aligned}
|x| x & \text { for } x>0 \\
-x=\xi & \text { for } x>0
\end{aligned}
$$

It follows that we read one, to replace for $x$ by $|x|$ in the above solution to obtain real valued solution valid in any interval not containing the origin To solve the Euler equation (1) $x^{2} y^{\prime \prime}+x \alpha y^{\prime}+\beta y=0$
in any interval not containing the origin substitute $y=x^{r}$ and compute the root $r^{1}$ and $r^{2}$ of the equation
$F(r)=r^{2}+(\alpha-1) r+\beta=0$
If the roots are real and unequal
$y=c_{1}|x|^{r_{1}}+c_{2}|x|^{r_{2}}$

If the roots are real and equal

$$
y=\left(c_{1}+c_{2} \log |x| x\right)|x|^{r_{1}}
$$

If the roots are complex
$y=|x|^{\lambda}\left(c_{1} \cos \left(\mu \log |x|+c_{2} \sin (\mu \log |x|\right.\right.$
For an Euler equation of the form
$\left(x-x_{0}\right)^{2} y^{\prime \prime}+\alpha\left(x-x_{0}\right) y^{\prime}+\beta y=0$
Change the independent variable by
$t=x-x o)^{r}$
or suppose the solution
$y=(x-x o)^{r}$
Note: The situation for a general second order differential equation with a regular singular point is similar to that for an Euler equation.
2. Another method of obtaining the solution of Euler Equation

$$
x^{2} y^{\prime \prime}+\alpha x y^{\prime}+\beta y=0
$$

Solution: We make the change of variable $x=e^{z}$ or $z=\log x$ and $x>0$.
$\frac{d y}{d x}=\frac{d y}{d z} \frac{d z}{d x}=\frac{1}{x} \frac{d y}{d z}$
$\frac{d^{2} y}{d x^{2}}=\frac{1}{x} \frac{d^{2} y}{d z} \frac{d z}{d x}-\frac{1}{x^{2}}=\frac{d y}{d z}$

Substituting there value in the equation

$$
\frac{d^{2} y}{d x^{2}}+(\alpha-1) \frac{d z}{d x}+\beta y=0
$$

This is an equation with constants coefficients
The auxiliary equation is
$r^{2}+(\alpha-1) r+\beta y=0$
(i) If $r_{1}$ and $r_{2}$ are real and unequal. $y=c_{1} e^{z r 1}+c_{2} e^{z r_{2}}=c_{1} x^{r_{1}}+c_{2} x^{r_{2}}$
(ii) If the roots are equal i.e $\therefore y=\left(c_{1}+c_{2} z\right) e^{z r}$.

$$
=\left(c_{1}+c_{2} \log x\right) \alpha^{r_{1}}
$$

(iii) If the roots are complex

$$
\begin{aligned}
& y=e^{\lambda z}\left(c_{1} \cos \mu z+c_{2} \sinh z\right) \\
& =x^{\lambda}\left(c_{1} \cos (\mu+\log x)+c_{2} \sin (\mu \log x)\right.
\end{aligned}
$$

### 3.2 Series solution near a regular singular point

Consider the equation
$P(x) y^{\prime \prime}+Q(x) y^{\prime}+R(x) y=0$

Assume that $x=0$ is a regular singular point of (1) means that $x P(x)=\frac{x Q(x)}{P(x)}=$ and $x^{2} q(x)=\frac{x^{2} R(x)}{P(x)}$ have finite limits as $x \rightarrow 0$ and are analytics at $x=x_{0}$ for some interval about the origin
(i) can be written

$$
x^{2} y^{\prime \prime}+x[x p(x)] y^{\prime}+\left[x^{2} q(x)\right] y=0
$$

But $x p(x)=\sum_{n=0}^{\infty} P_{n} x^{n}$
$x^{2} q(x)=\sum_{n=0}^{\infty} q_{n} x^{n}$
$x^{2} y^{\prime \prime}+x\left[p_{o}+p_{1} x+\ldots . . p_{n} x+\ldots \ldots.\right] y^{\prime}+\left[q_{0}+q_{1} x+\ldots \ldots . .+q_{x} x^{n}+\ldots \ldots \ldots ..\right] y=0(2)$
If all the coefficient use zeros, except $P 0$ and $q_{n}$, then (2) reduces to Euler equation, which was discussed previously.
If some of the $P_{n}$ and $q_{n}$. $n \geq$ will not be zero. However the essential character of the solution remains the same. It is natural to seek the solution of the form of "Euler Solution" the power series.

$$
\begin{equation*}
y=x^{r} \sum_{n=0}^{\infty} a_{n} x^{n} \tag{3}
\end{equation*}
$$

As part of our problem we have to determine
(1) The values of $r$ for which equation (1) has a solution of the form (3)
(2) The recurrence relation for the $a_{n}$
(3) The radius of convergence of the series $\sum_{n=0}^{\infty} a_{n} x^{n}$

We shall illustrate the method by example
Example I: Find the series solution of the equation

$$
\begin{equation*}
2 x y^{\prime \prime}+(1+x) y^{\prime}-2 y=0 \tag{1}
\end{equation*}
$$

Solution: $x=0$ is the regular singular point of the equation.
We assume line solution
$y=\sum_{n=0}^{\infty} a_{n} x^{n+r}$
Direct substitution of $y$ in (2) given
$\sum_{n=0}^{\infty} 2(n+r)(n+r-1) a_{n} x^{n+r}+\sum_{n=0}^{\infty}(n+r) a_{n} x^{n+r-1}+\sum_{n=0}^{\infty}(n+r) a_{n} x^{n+z}-2 \sum_{n=0}^{\infty} a_{n} x^{n+r}=0$

Now we shift the index of the second series in (3). We get

$$
\begin{equation*}
\sum_{n=0}^{\infty}(n+r)(2 n+2 r-1) a_{n} x^{n+r-l}+\sum_{n=0}^{\infty}(n+r-2) a_{n} x^{n+r}=0 \tag{3}
\end{equation*}
$$

Once more we reason that the total coefficient of each power of $x$ in the left member of (4) must vanish. The second summation does start the contribution, until $n=1$. Hence the equation determinants $c$ and an are given by
$n=0 \quad r(2 r-1) a_{0}=0$, but $a_{0} \neq 0$
$\therefore r(2 r-1)=0$
(6) is called the indicial equation.
$\begin{array}{lr}\therefore r_{1}=\frac{1}{2}, r_{2}=0 & n \geq 1 \\ n+r)(2 n+2 r-1) a_{n}+(v+r-3) a_{n-1}=0 & \end{array}$
Recurrence relation
$\therefore a_{n}=-\frac{n+r-3}{(n+r)(2 n+2 r-1)} a_{n-1}$
(i) Take $r=\frac{1}{2}$

& a_{1}=\frac{(-3) a_{0}}{2.3} \\
& a_{2}=\frac{(-1) a_{1}}{4.5} \\
& a_{3}=\frac{(-1) a_{2}}{6.7}
\end{aligned}
$$

$$
a_{n}=-\frac{(2 n-5) a_{n-1}}{2 . n(2 n+1}
$$

$$
a_{n}=\frac{\left.(-1)^{n}[(-3])(-1)(1) \ldots(2 n-5)\right] a_{0}}{[2.4 .6 \ldots \ldots . .(2 n)][3.5 .7 \ldots . .(2 n+1)]}
$$

Omitting the constant $a_{0}$, we may write the particular solution as
$y_{1} x^{y z}+\sum_{n=1}^{\infty} \frac{(-1)^{n} 3 x^{n+\frac{1}{2}}}{2^{n} n 1(2 n-3)(2 n-1)(2 n+1)}$
Next task is to find the solution corresponding to the root $c_{2}=0$.

The recurrence relation becomes $n \geq 1$.
$n(2 n-1) b_{n}+(n-3) b_{n-1}=0$
Or $\quad b_{n}=\frac{(n-3)}{n(2 n-1)} b_{n-1}=0$
$b_{1}=\frac{(-2) b_{0}}{1.1}$
$b_{2}=\frac{(-1) b_{1}}{2.3}$
$b_{2}=\frac{(-1) b_{2}}{3.5}$
$b_{n}=\frac{(0) b_{n-1}}{n(2 n-1)}$
$\therefore b_{n}=0$ if $b_{n}=-\frac{(n-3) b_{n-1}}{n(2 n-1)}$
$\therefore b_{n}=0$ if $n \geq 3$
$\therefore b_{1}=b_{0}, \therefore b_{2}=\frac{1}{6} b_{1}=\frac{1}{6} b_{0}$
The solution is
$y_{2}=b_{0}\left[1+2 x+\frac{1}{3} x^{2}\right]$
The general solution is
$y=A y_{1}+B y_{2}$
Note: The roots of indicial equation are unequal and do not differ by integer
3.3 Indicial equation with equal roots

Example 2. Solve the equation
$x^{2} y^{\prime \prime}+3 x y^{\prime}+(1-2 x) y=0$
Solution: $x=0$ is regular singular point of (i)
We assume the solution
$y=\sum_{n=0}^{\infty} a_{n} x^{n+r}$

Substituting this value in (2), we have $\sum_{n=0}^{\infty}(n+r)(n+r-1) a_{n} x^{n+r}+3 \sum_{n=0}^{\infty}(n+r) x^{n+r}+\sum_{n=0}^{\infty} a_{n} x^{n+r}-2 \sum_{n=0}^{\infty} a_{n} x^{n+r+1}=0$
Shifting the index
$\sum_{n=0}^{\infty}\left[(n+r)^{2}+2(n+r)+1\right] a_{n} x^{n+r}-2 \sum_{n=1}^{\infty} a_{n-1} x^{n+r}=0$
The indicial equation
$r^{2}+2 r+1=0$
$\therefore r=-1$
The recurrence relation is
$a_{n}=\frac{2 a_{n-1}}{(n+r+1)^{2}}$
$n \geq 1$,
In which
$n \geq 1, a_{n}=\frac{2^{n} a_{0}}{[(r+2)(2+3) \ldots \ldots . .(2+n+1)]^{2}}$
$\therefore y(x, r)=x^{2}+\sum_{n=1}^{\infty} a_{n}(r) x^{n+r}$,
in which
$n \geq 1, a_{n}(r)=\frac{2^{n}}{[(r+2)(2+3) \ldots \ldots . .(r+n+1)]^{2}}$
Let as write
$L(y)=x^{2} y^{\prime \prime}+3 x y^{\prime}+(1-2 x) y$
The $y$ of equation (6) has been so determined that for that $y$ the Eight member of (8) reduced to a single term the $n=0$.
Thus

$$
\begin{equation*}
L(y)=x^{2} y^{\prime \prime}+3 x y^{\prime}+(1-2 x) y \tag{8}
\end{equation*}
$$

A solution of the original differential equation is a function $y$ for which $L(y)=0$. Now taking $r=-l$ makes $L[y(x,-1)]=0$

Now differentiate each member of (9) with respect to
$\frac{\partial}{d r}[y(x, r)]=\frac{\partial}{\partial r}\left[(r+1)^{2} x^{2}\right]$
$l\left[\frac{\partial}{d r} y(x, r)\right]=2(r+1) x^{2}+(r+1)^{2} x^{2} \log x$

From (9) and 10, it can be seen early that the two solution of the equation $L(y)=0$ are
$y_{1}=[y(x, r)] \quad y=[y(x,-1)$
and $y_{2}=\left[\frac{\partial}{\partial r} y(x, r)\right]_{r=-1}$
$y(x, r)=x^{r}+\sum_{n=1}^{\infty} a_{n}(r) x^{n+r}$
$\left.\frac{\partial}{d r} y(x, r)\right]=x^{2} \log x+\sum_{n=1}^{\infty} a_{n}^{\prime}(r) x^{n+r}+\sum_{n=1}^{\infty} a_{n}(2) x^{n+r} \log x$
$=y(x, r) \log x+\sum_{n=1}^{\infty} a_{n}^{\prime}(r) x^{n+r}$
$\therefore=y_{1} \log x+\sum_{n=1}^{\infty} a_{n}(-1) x^{n-r}$
$\therefore=y_{1} x^{-1}+\sum_{n=1}^{\infty} a_{n}^{\prime}(-1) x^{n-r}$
$a_{n}(r) \frac{2^{n}}{\left.[(r+2)(r+3) \ldots(2+n+1)]^{2}\right)}$
$\log a_{n}(r)=\log 2^{n}+2[\log (r+2)+\ldots \ldots . \log (2+n+r)]$
$a_{n}^{\prime \prime}(r)=2 a_{n}(r)\left[\frac{1}{r+2}+\frac{1}{r+3}+\ldots \ldots \ldots . \frac{1}{r+n+1}\right]$
$r=-1$, we obtain

$$
\begin{aligned}
& a_{n}(-1)=\frac{2^{n}}{(n 1)^{2}} \\
& \therefore a_{n}^{\prime}(-1)=-2 \frac{2^{n}}{(n 1)^{2}}\left[1+\frac{1}{2}+\frac{1}{3}+\ldots \ldots . \frac{1}{n}\right]
\end{aligned}
$$

We write

$$
H_{n}=\frac{1}{2} 1+\ldots \ldots . \frac{1}{n}
$$

The solutions are
$=y_{1} x^{-1}+\sum_{n=1}^{\infty} \frac{2^{n} x^{n-1}}{(n!)^{2}}$
$=y_{2} x_{1} \log x-\sum_{n=1}^{\infty} \frac{2^{n+1} H_{n} x^{n-1}}{(n!)^{2}}$
The general solution, valid for all finite $x \neq 0$ is $y=A y_{1}+B y_{2}$.

## 3.3: Indicial Equation with difference of Roots a Positive Integer, non Logarithmic case

Solve line equation

$$
\begin{equation*}
x y^{\prime \prime}-(4+x) y^{\prime}+2 y=0 \tag{1}
\end{equation*}
$$

Solution: We assume the solution

$$
\begin{align*}
& y=\sum_{n=0}^{\infty} a^{n} x^{n+r}  \tag{2}\\
\therefore L(y)= & \sum_{n=0}^{\infty}(n+r)(n+r-6) a_{n} x^{n+r-1} \sum_{n=1}^{\infty}(n+r-3) a_{n-1} x^{n+r-1} \tag{3}
\end{align*}
$$

The Indicial equation is
$c(c-5)=0$
$\therefore c_{2}=0, \quad c_{1}=5$
$\therefore s=5-0=5$
We reason that we hope for two power series solutions, one starting with an $x^{0}$ and term, one with an $x^{5}$ term.

If we use the longer root $c=5$, then the $x^{0}$ term would never enter. Thus we use the smaller roots $c=0$, then the trial solution of the form.

y=\sum_{n=0}^{\infty} a^{n} x^{n} \tag{4}
\end{equation*}
$$

has a chance of picking up both solutions because the $n=5 n=s$ term does contain $x^{5}$

$n=2$
$-6 a_{2}+a_{1}=0$
$a_{2}=\frac{1}{12} a_{o}$
$n=3$
$-6 a_{3}+0 a_{1}=0$
$a_{3}=0$
$n=4$
$n=5$
$-4 a_{4}+a_{3}=0$
$a_{4}=0$
$n \geq 6$
$a_{6}=\frac{3 a_{6}}{6.1}$
$a_{7}=\frac{4 a_{6}}{7.2}$
$a_{n}=\frac{(n-3)\left(a_{n-1}\right)}{n(n-5)}$
$a_{n}=\frac{3.4 .5 \ldots . .(n-3) a_{5}}{[6.7 .8 \ldots . . n](n-5) 1}$
$a_{n}=\frac{3.4 .5 a_{5}}{(n-2)(n-1) n(n-5) 1}$
Therefore, with $a_{0}$ and $a^{5}$ arbitrary, the general solution may be written $y=a_{0}\left(1+\frac{1}{2} x+\frac{1}{12} x^{2}\right)$
$a_{5}\left[x^{5}+\sum_{n=6}^{\infty} \frac{60 x^{n}}{(n-5) \ln \left(n-1 \_(n-2)\right.}\right.$
$a_{0}=\left(1+\frac{1}{2} x+x^{2}\right)$
$a_{5}=\left[x^{5}+\sum_{n=0}^{\infty} \frac{60 x^{n+5}}{n 1(n+5)(n+4)(n+3)}\right]$
Example 2 Solve the equation

x y^{\prime \prime}+(4+3 x) y^{\prime}+3 y=0 \tag{1}
\end{equation*}
$$

Solution $x=0$ is the regular singular point of (1).
We assume the solution

& y=\sum_{n=0}^{\infty} a_{n} x^{n+r}  \tag{2}\\
& \therefore L(y)=\sum_{n=0}^{\infty}(n+r)(n+r-1) a_{n} x^{n+r-1} \\
& 4 \sum_{n=0}^{\infty} a_{n} x^{n+r-1}+3 \sum_{n=0}^{\infty}(n+r)\left(a_{n}+r-1\right) a_{n} x^{n+r} \\
& +3 \sum_{n=0}^{\infty} a_{n} x^{n+r} \\
& L(y) \sum_{n=0}^{\infty} a_{n}(n+r)\left(a_{n}+r+3\right) x^{n+r-1} \\
& +\sum_{n=0}^{\infty} 3 a_{n}(n+r+1) x^{n+r} \tag{3}
\end{align*}
$$

$n=0$, we get the indicial equation
$r(r+3)=0$
$r=0,-3$

L(y) \sum_{n=0}^{\infty} a_{n}(n+r)(a+r+3) x^{n+r-1}
$$

$+\sum_{n=1}^{\infty} 3 a_{n-1}(n+r) x^{n+r-1}$
Using the smaller root $r_{1}=-3$
$L(y) \sum_{n=0}^{\infty} a_{n}(n-3) n^{n-4}$
Recurrence relation is

a_{n}(n-3) n=-3(n-3) a_{n-1} \\
n=1 & a_{1}(-2)(1)=(-3)(-2) a_{o} \\
n=2 & a_{2}(-1)(2)=(-3)(-1) a_{1} \\
n=3 & a_{3}(0)(3)=(-3)(0) a_{2} \\
n>4 & a_{n}=\frac{-3}{n} a_{n-1} \\
& a_{4}=\frac{-3}{4} a_{3} \\
& a_{5}=\frac{-3}{5} a_{4} \\
& \ldots \ldots \ldots \ldots \ldots . . \\
& a_{n}=\frac{-3}{n} a_{n-1} \\
& \therefore a_{n}=\frac{(-3)}{n l} 6 a_{3}
\end{array}
$$

y=\left(a_{0} x t^{-3} a_{1} x^{-2}+a_{2} x^{-1}\right.
$$

$$
a_{0}\left(x^{-3}-3 x^{2}+a_{2}+\frac{9}{2} x^{-1}\right)+6 a_{3} \sum_{n=3}^{\infty} \frac{(-1)^{n-3} x^{n-3}}{n 1}
$$

This is the required solution

3.1. Indicial Equation with Difference of roots a positive integer, logarithmic case.

We illustrate this method by an example
Solve the equation

Orthogonality is a property widely encountered in certain branches of mathematics. Much use is made of the representation of functions in series of the form

In which the $c_{n}$ are numerical coefficients and $\left\{f_{n}(x)\right\}$ is an orthogonal set is

### 3.3 Orthogonality of a set of series and cosines:

We shall consider the set of function
$\operatorname{Sin}\left(\frac{n \pi x}{c}\right)$,
$n=1,2,3 \ldots \ldots . . .$.
$\operatorname{Cos}\left(\frac{n \pi x}{c}\right)$,
$n=0,1,2,3 \ldots \ldots \ldots$.

$\operatorname{Sin}\left(\frac{\pi x}{c}\right), \quad \operatorname{Sin}\left(\frac{2 \pi x}{c}\right), \quad \operatorname{Sin}\left(\frac{3 \pi x}{c}\right), \ldots \ldots \ldots \ldots . \operatorname{Sin}\left(\frac{n \pi x}{c}\right)$
$1, \operatorname{Cos}\left(\frac{n \pi x}{c}\right), \operatorname{Cos}\left(\frac{2 \pi x}{c}\right), \quad \operatorname{Cos}\left(\frac{3 \pi x}{c}\right), \ldots \ldots \ldots \ldots \ldots \operatorname{Cos}\left(\frac{n \pi x}{c}\right)$
is orthogonal with respect to the weight function $w(x)=1$ over the interval $-c \leq x \leq c$
i.e.
$\int_{-c}^{c} \operatorname{Sin} \frac{n \pi x}{c} \operatorname{Cos} \frac{k \pi x}{c} d x=0, \quad$ where $k \neq n$.
: Before we prove the result, we give some definition to shorten the proof.
(a) Even function: A function $y=g(x)$ is said to be even y
$g(-x)=g(x)$
For all $x$.
(b) Odd function: A function $y=h(x)$ is odd if $y=h(x)=-h(-x)$

For all $x$.

Example: $\operatorname{Sin} x$ is an odd function

## $\operatorname{Cos} x$ is an even function

(c) Most function are neither even or odd example x . (is in one function $f(x)=0$
(d) If $g(x)$ is an even function then as well as even)

$I_{4}=\int_{-c}^{c} \operatorname{Sin}^{2} \frac{n \pi x}{c} d x=\int_{-c}^{c} \operatorname{Sin}^{2} \frac{n x}{c} d x$
let $f(x)$ the continuous and differentiable at every point in an interval $-c \leq x \leq c$ except for a most finite number of points and at more points, let $f(x)$ and $f^{\prime}(x)$ have right and left-hand limits

## Note:

The notation $f(c+0)$ is used to denote line right-hand limit of $x \rightarrow c$ as $f(x)$ from alone, i.e.
$f(c+0)$ and $=\lim _{n \rightarrow c^{+}} f(x)$
Similarly
$f(c-0)==\lim _{n \rightarrow c^{-}} f(x)$
Denotes, the limit of $f(x)$ as approaches $c$.
Since Fourier series for $f(x)$ may not converge to the value $f(x)$ every where. It is customary to replace the equals sign in equation (8) by the symbol $\sim$ which may be read "has for its Fourier Series" we write
$f(x) \sim \frac{1}{2} a_{0}+\sum_{n=1}^{\infty}\left(a_{n} \cos \frac{n \pi x}{c}+b_{n} \sin \frac{n \pi x}{c}\right.$,
Where $a_{n}$ and $b_{n}$ are given by (a) and (10)
Example: Construct the Fourier series, over the interval $-2 \leq x \leq 0$, for the function defined by

$$
\begin{array}{ll}
f(x)=2, & -2 \leq x \leq 0, \\
x=2, & 0<x<2
\end{array}
$$

Solution: Now $f(x) \sim \frac{1}{2} a_{0}+\sum_{n=1}^{\infty}\left(a_{n} \cos \frac{n \pi x}{2}+b_{n} \sin \frac{n \pi x}{2}\right)$

$a_{n}=\frac{1}{2} \int_{-2}^{2} f(x) \cos \frac{n \pi x}{2} d x ; \quad n=0,1, \ldots \ldots .2$

$b_{n}=\frac{1}{2} \int_{-2}^{2} f(x) \sin \frac{n \pi x}{2} d x ; n=, 1, \ldots \ldots . .2$
$\therefore a_{n}=\frac{1}{2} \int_{-2}^{0} \cos \frac{n \pi x}{2} d x+\frac{1}{2} \int_{0}^{2} x \cos \frac{n \pi x}{2} d x$

$a_{n}=\frac{1}{\pi} \int_{-\pi}^{\pi} x^{2} \cos n x d x ; \quad n=, 1,2, \ldots \ldots$.
$b_{n}=\frac{1}{\pi} \int_{-\pi}^{\pi} x^{2} \sin n x d x ; \quad n=1,2, \ldots \ldots$.
$x^{2}$ is an even function, $\sin n x$ is an odd function, thus $x^{2} \sin n x$ is an odd function Hence.
$b_{n}=0$. for every $n$.
$a_{n}=\frac{2}{\pi}\left[\int_{-\pi}^{\pi} \frac{x^{2} \sin n x}{n}+\frac{2 x \cos x}{n^{2}}-\frac{2 \sin n x}{n^{3}}\right]^{\pi}$ o for $n \neq 0$
From which
$a_{n}=\frac{2}{\pi}\left[\frac{2 \pi \cos n \pi}{n^{2}}\right]=\frac{4(-1)}{n^{2}}$,

$$
n=1,2, \ldots \ldots . .
$$

$a_{n}=\frac{2}{\pi}\left[\frac{2 \cos \pi}{n}\right]=\frac{4(-1)^{\pi}}{n^{2}} \quad n=1,2, \ldots \ldots$.
for $n=0$
$a_{0}=\frac{2}{\pi}\left[\int_{0}^{\pi} x^{2} d x=\frac{2}{\pi} \frac{\pi^{3}}{3}=2 \frac{\pi^{2}}{3}\right.$
Therefore, in the interval; $-\pi<x<\pi$
$x^{2} \sim \frac{\pi^{2}}{3}+4 \sum_{n=1}^{\infty}=\frac{(-1)^{n} \cos n x}{n^{2}}$
Indeed, because of condition of line function involved, we write $x^{2} \sim \frac{\pi^{2}}{3}+4 \sum_{n=1}^{\infty}=\frac{(-1)^{n} \cos n x}{n^{2}}$, for $-\pi \leq x \leq \pi$.
2. Fourier Sine Series: Sometimes it is desirable to expand the function $f(x)$ in a series involving Sine function only.
In order to get a Sine series for $f(x)$ we introduced a function $g(x)$ defined as follows
$g(x)=f(x) \quad 0<x<c$
$=-f(-x)$
$-c<x<0$

Thus $g(x)$ is an odd function over the interval $-c<x<0$.
Hence
$g(x) \sim \frac{1}{2} a_{0}+\sum_{n=1}^{\infty}\left(a_{n} \cos \frac{n \pi x}{c} d x=0, \quad n=0,1, \ldots \ldots\right.$.

It follows that
$a_{n} \frac{1}{c_{0}} \int_{-c}^{c} g(x) \cos \frac{n \pi x}{c} d x=0 \quad n=0,1, \ldots \ldots$
(Note integrand is an odd function) and that
$b_{n}=\frac{1}{c} \int_{-c}^{c} g(x) \sin \frac{n \pi x}{c} d x$
$=\frac{2}{c} \int_{-c}^{c} f(x) \sin \frac{n \pi x}{c}$
Thus
$f(x) \sim+\sum_{n=1}^{\infty} b_{n} \sin \frac{n \pi x}{c}$ $o<x<c$
$f(x)$ Where $b_{n}=\frac{2}{c_{0}} \int_{-c}^{c} f(x) \sin \frac{n \pi x}{c} d x$
$n=1,2$, $\qquad$

Example: Expand $f(x)=x^{2}=$ in a Fourier Sine Series over the interval $0<x<1$
Solution: At once we write, for $0<x<10$
$x^{2} \sim \sum_{n=1}^{\infty} b_{n} \sin n \pi x$
In which
$b_{n}=\int_{-c}^{c} x^{2} \sin n \pi x d x$
$=2 \int_{0}^{1} x^{2} \frac{\cos n \pi x}{n \pi}+\frac{2 x \sin n \pi x}{(n \pi)^{2}}+\frac{2 \cos n \pi x}{(n \pi)^{3}}$
$=2\left[-\frac{\cos n \pi}{n \pi}+\frac{2 \cos \pi x}{n^{3} \pi^{3}}+\frac{2 \cos n \pi x}{n^{3} \pi^{3}}\right.$

Hence the Fourier Sine Series, over $0<x<1$ for is $x^{2}$
$=2\left[-\frac{\cos n \pi}{n \pi}+\frac{2(-1)^{n}}{n^{3} \pi^{3}} \frac{2}{n^{3} \pi^{3}}\right]$
3. Fourier Cosine Series: In order to expand the function $f(x)$ in a series involving cosine function only, such series is called Fourier Cosine Series. We define

$$
\begin{array}{ll}
h(x)=f(x) & 0<x<c \\
=f(-x) & -c<x<0
\end{array}
$$

It follows that $h(x)$ is an even function of $x$.
$h(x) \sim \frac{1}{2} a_{0}+\sum_{n=1}^{\infty}\left(a_{n} \cos \frac{n \pi x}{c}+b_{n} \sin \frac{n \pi x}{c}\right.$
$a_{n} \frac{1}{c} \int_{-c}^{c} h(x) \cos \frac{n \pi x}{c} d x=\frac{2}{c} \int_{0}^{c} f(x) \cos \frac{n \pi x}{c} d x$
$0<x<c$
But $b_{n}=\frac{i}{c} \int_{-c}^{c} h(x) \sin \frac{n \pi x}{c} d x=0$

Thus we have
$f(x) \sim \frac{1}{2} a_{0}+\int_{0}^{c}\left(f(x) \cos \frac{n \pi x}{c} d x\right.$
in which
$a_{n}=\frac{2}{c} \int_{-c}^{c} f(x) \cos \frac{n \pi x}{c} d x$
Example:
Solution: At once we have
$f(x) \sim \frac{1}{2} a_{0}+\sum_{n=1}^{\infty} a_{n} \cos \frac{n \pi x}{c}$ in which
in which
$a_{n} \frac{2}{c} \int_{0}^{c} \cos \frac{n \pi x}{c} d x$
$=\frac{2}{c}\left[\frac{c}{n \pi} x \sin \frac{n \pi x}{c}+\left(\frac{c}{n \pi}\right)^{2} \cos \frac{n \pi x}{c}\right]_{0}{ }^{c}$
$=\frac{2}{c}\left[\left(\frac{c .}{n \pi}\right)^{2} \cos n \pi-\frac{n \pi x}{c}\right]_{0}{ }^{c}$
$=\frac{-2}{n^{2} \pi^{2}}(1-\cos n \pi), n \neq 0$
The coefficient $a_{0}$ is readily obtained
$a_{n} \frac{2}{c} \int_{-c}^{c} x d x=\frac{2}{c} \frac{c^{2}}{2}=c$

Thus the Fourier Cosine Series over the interval $0<x<c$ the function $f(x)=x$ is
$f(x) \sim \frac{1}{2} c-\frac{u c}{\pi^{2}} \sum_{k=1}^{\infty} \frac{1-(-1)}{n^{2}} \cos \frac{n \pi x}{c}$

### 1.0 Introduction

In this unit, we will discuss some of the properties of boundary valve problems for linear second order equation. This class of differential equations is very useful for practical applications. We shall devote some time in studying them in this unit.

### 3.0 MAIN CONTENT

3.1 Boundary Value Problems

The linear differential equation

$$
\begin{equation*}
P(x) y^{\prime \prime}+Q(x) y^{\prime}+R(x) y=g(x) \tag{1}
\end{equation*}
$$

was classified homogeneous if, $g(x)=0$, and non-homogeneous otherwise.
Similarly, a linear boundary condition

$$
\begin{equation*}
a_{1} y(0)+a_{2} y^{\prime \prime}(0)=c \tag{2}
\end{equation*}
$$

A boundary value problem is homogeneous if both its differential equation and in boundary conditions are homogeneous. If not then it is nonhomogeneous.

A typical linear homogeneous second order boundary value problem is of the form.

$$
\begin{align*}
& P(x) y^{\prime \prime}+Q(x) y^{\prime}+R(x) y=0  \tag{3}\\
& 0<x<1, \\
& a_{1} y(0)+a_{2} y^{\prime \prime}(0)=0  \tag{4}\\
& b_{1} y(I)+b_{2} y^{\prime}(0)=0 \tag{5}
\end{align*}
$$

Most of the problems, we will discuss are of the form given by (3) to (5).

### 3.2. Eigen Values and Eigen Functions

## Consider the differential equation

$$
\begin{equation*}
y^{\prime \prime}+p(x, \lambda) y^{\prime}+q(x, \lambda) y=0 \quad 0<x<1 \tag{1}
\end{equation*}
$$

The boundary conditions

$$
\begin{align*}
& a_{1} y(0)+a_{2} y^{\prime}(0)=0  \tag{2}\\
& b_{1} y(I)+b_{2} y^{\prime}(0)=0 \tag{3}

### 1.0. Introduction

We solved some partial differential equations by the method of separation of variables. In the last step we expanded a certain function in a Fourier series, i.e. as the sum of an infinite series of sine and cosine functions. It is of fundamental importance that the eigen functions of a more general class of boundary values problems can be used as a basis for series expansions, which have properties similar to Fourier Series.

Such eigen- functions series are useful in extending the method of separation of values to a larger class of problems in partial differential equation.
The class of boundary value problem we will discuss is associated with the names of Sturm and Liouville.

### 3.0 MAIN CONTENT

3.1. Sturm and Liouville Problem

We introduce the operator

$$
\begin{align*}
& L[y]=-\left[p(x) y^{\prime}\right]+q(x) y  \tag{1}\\
& L[y]=\lambda r(x) y \tag{2}
\end{align*}
$$

$\left[P(x) y^{\prime}\right]^{\prime}-q(x) y+\lambda r(x) y=0$
on the interval $0<x<1$, together with the boundary condition
$a_{1} y(0)+a_{2} y^{\prime}(0)=0$
$b_{1} y(I)+b_{2} y^{\prime}(1)=0$
We shall assume that $p, q$ and $r$ are continuous functions in the interval [0,1]. $P(x)>0, r(x)>0$ for all $x$ in $0 \leq x \leq 1$.
(i) Lagrange's identity: let $u$ and $v$ be functions having continuous second derivatives on the interval $0 \leq x \leq 1$. Then

$$
\begin{align*}
& \int_{0}^{1}(U L[U]-U L[u]) d x \\
& =-p(x)\left[u^{\prime}(x) u(x)-u(x) u^{\prime}(x)\right] \tag{6}
\end{align*}
$$

## Solution 1:

$\int_{0}^{1}(u u-u u) d x=0$
(ii) $\left.\int_{0}^{1}\left(u^{\prime \prime} u\right)-U\left(\mu^{\prime \prime}\right) d x\right]$
$=\int_{0}^{1}\left(u u^{\prime \prime}-u^{\prime \prime} u\right) d x$
$=u u^{\prime}-u u^{\prime}$
$=\left[u(1) u^{\prime}(1)-u(1) u^{\prime}(1)\right.$
$-\left[u(1) u(0)-u(1) u^{\prime}(0)\right]$
$=[u(1) u(0)-u(I) u(0)$
The right side is not zero. Hence it is not self-adjoint.
Problem 3 Consider the differential equation
$y^{\prime \prime}+\lambda y+2 y=0$
With boundary conditions

y=(0)-y(I)=0, \quad y^{\prime}=(0)-y^{\prime}(1)=0
$$

(a) Show that the problem is self-adjoint even though it is not a SturmLiouville problem.
(b) Find all eigenvalues and eigenfunctions of the given problem

Solution: $\quad L(y)=y^{\prime \prime}$

$$
M(y)=-y
$$

(i)

$$
\begin{aligned}
& \int_{0}^{1}[U M(u)-u(-u) d x]=0 \\
& \int_{0}^{1}[U(-u)-u(-u)] d x=0
\end{aligned}
$$

(ii) $\int_{0}^{1}\left[u\left(u u^{\prime \prime}-u u^{\prime \prime}\right] d x\right.$

$$
\begin{aligned}
& =\left(u u^{\prime}\right)-\int_{0}^{1}\left(u^{\prime} u^{\prime} d x-u^{\prime} u+\int_{0}^{1} u^{\prime} u^{\prime} d x\right. \\
& =\left[(1) u^{\prime}(I)-u^{\prime}(I) u(I)\right] \\
& -\left[(0) u^{\prime}(0)-u^{\prime}(0) u(0)\right] \\
& -\left[(0) u^{\prime}(0)-u^{\prime}(0) u(0)\right] \\
& -\left[(0) u^{\prime}(0)-u^{\prime}(0) u(0)\right]=0
\end{aligned}
$$

Hence it is self-adjoint
The solution of the equation is
$y=c_{1} \cos \sqrt{x}+c_{2} \sin \sqrt{\lambda} x$
Applying the boundary conditions, we have

$$
\begin{aligned}
& c_{1} \sqrt{\lambda} \sin \sqrt{\lambda}+c_{2} \sin \sqrt{\lambda}(1-\cos \sqrt{\lambda}=0 \\
& c_{1}\left(\cos \sqrt{\lambda}-1+c_{2} \sin \sqrt{\lambda}=0\right.
\end{aligned}
$$

Thus

| $\sqrt{\lambda} \sin \sqrt{\lambda}$ | $\sqrt{\lambda}(1-\cos \sqrt{\lambda}$ |
| :--- | :--- |
| $\cos \sqrt{\lambda}-1$ | $\sin \sqrt{\lambda}$ |$|=0$

Or
$\sqrt{\lambda}(1-\cos \sqrt{\lambda}=0 \Rightarrow$

$W\left(y_{1} y_{2)}=\left|\begin{array}{cc}\cos 2 n \pi x & \sin 2 n \pi x \\ -2 n \pi \sin n \pi x & 2 n \pi \cos 2 n \pi x\end{array}\right|\right.$
$2 n \pi x \cos ^{2} 2 n \pi x+2 n \pi \sin ^{2} n \pi x$
$2 n \pi \neq 0 \quad 0 \leftarrow x$

Between $0 \leq x \leq 1$

Thus the eigen functions are lining independent.

\end{aligned}
$$

Where $\mathrm{p}, \mathrm{q}$ and z continuous function in the interval $0 \leq x \leq 1$.
(a) show that if $\lambda$ is an eigen-value and $\varphi$ a corresponding eigen function, then
$\lambda \int_{0}^{1} e Q^{2} d x=\int_{0}^{1}\left(p \phi^{\prime 2}+q \phi^{2}\right) d x+\frac{b_{1}}{b_{2}} p(1) \phi^{2}(1)-\frac{a_{1}}{a_{2}} p(0) \phi^{2}(0)$
Provided that $a_{2} \neq 0$ and $b_{2} \neq 0$ How this result be modified if $a_{2}=0$ or $b_{2}=0$
(b) Show that if $q(x) \geq 0$ and if $\frac{b_{1}}{b_{2}}$. and $\frac{-a_{2}}{a_{1}}$ are non-negative, then the eigen-value $\lambda$ Is non negative
(c) Show that the eigen-value $\lambda$ is strictly $0 \leq x \leq 1$ under $\mathrm{q}(\mathrm{x})=0$ for each $x$ in $0, x, 1$

## Solution

$$
\lambda r(x) Q^{2}=-\left[p(x) Q^{\prime}\right]^{\prime} Q+q(r) Q^{2}
$$

Thus
$\left.\lambda \int_{0}^{1} r(x) Q^{2} d x=\int_{0}^{1}\left(q Q^{2}-p(x) Q^{\prime}\right) Q\right) d x$
Integrating by parts, we have
$\int_{0}^{1} q Q^{2} d x-Q\left[p\left(Q^{\prime}\right]+\int_{0}^{1} p Q^{\prime 2}\right) d x$

From boundary condition, we have obtain the result
$Q^{\prime}(1)=\frac{b_{1}}{b_{2}} Q^{\prime}(1)$
$Q^{\prime}(0)=-\frac{a_{1}}{a_{2}} Q^{\prime}(0)$
Putting these values on the right side and we obtain the result if or $a_{2}=0$ or $b_{2}=0$, then the first boundary condition reduces to
$y=0$
$\Rightarrow Q(1)=0$ or $\Rightarrow Q(o)=0$

The result reduces to
$\lambda \int_{0}^{1} r Q^{2} d x=\int_{0}^{1}\left(q Q^{2}+p Q^{\prime} d x \frac{b_{1}}{b_{2}} p(1) Q^{2}(I)\right.$
or
$\lambda \int_{0}^{1} r Q^{2} d x=\int_{0}^{1}\left(q Q^{2}+p Q^{\prime 2} d x \frac{a_{1}}{a_{2}} Q^{2}(0) Q^{2}(I)\right.$
(b) In a Sturm Lioville problem, we always assume that $p(x)>0, r(x)>0$,

By given condition $r(x)>0$ for all x in $0 \leq x \leq 1 Q^{2}>0$ for all $0 \leq x \leq 1$.
Now we impose condition, so that right side of the equation in (a) is $+v e$ The second and third term are + ve y $\frac{b_{1}}{b_{2}}$ and $\frac{-a_{1}}{a_{2}}$ are non-negatives

Now
$\int_{0}^{1} q Q^{2} d x$ is $+v e$ in order that
(c) If $q(x)=0$ for all $\mathrm{x} 0 \leq x \leq 1$ then $\lambda$ is strictly.
