## PREREQUISITES

The main prerequisites for understanding the content of this book is a knowledge of elementary algebra, set theory, mathematical induction, differentiation and integration.

## Set

A set is any well-defined list or collection of objectives. The objectives comprising the set are called its elements or members.

A set will be denoted by capital letters or symbols such as $X, Y, A, B, \ldots$. and its elements will be denoted by lower case letters $\mathrm{x}, \mathrm{y}, \mathrm{a}, \mathrm{b}, \ldots .$.

Example 1.1 Toss a cubical die once. There are six possible numbers that can appear. We can write

$$
\Omega=\{1,2,3,4,5,6\}
$$

Where $\Omega$ is a set consisting of six elements $1,2,3,4,5,6$ called the element of the set $\Omega$.
There are essentially two ways of specify a particular set. One way if possible is by listing its elements as in example1.1 above. The other way is by stating properties which characterize the elements in the set. The above set $\Omega$ can be written as:

$$
\Omega-\{\mathrm{x}: \text { is an integer, } 1 \leq \mathrm{x} \leq 6\}
$$

If x is an element $\Omega$, the notation $\mathrm{x} € \Omega$ means that x belongs to $\Omega$. The negation of this assertion i.e. the statement that x does not belong to $\Omega$ will be denoted by

$$
\mathrm{x} € \Omega
$$

thus, for the above example $2 € \Omega$ but $8 € \Omega$.

## Definition 1.2

Subset: A set A is a subset of a set if each element in A also belongs to $\Omega$.
In example 1.1 above, the set

$$
\mathrm{A}=\{1,3,5\}=(\mathrm{x}: \mathrm{x} € \Omega \text { and } \mathrm{x} \text { is odd }\}
$$

Is a subset of $\Omega$, that is each element of A is in $\Omega$.
Two sets A and B are called equal if and only if they contain exactly the same elements.

Throughout this book, whenever the word set is used, itwill be interpreted to mean a subset of a given set denoted by $\Omega$. The set which contains no elements is called the Null set.

## Definition

Let A be a set. The elements which are not included in A also constitute a subset. This is known as the complement of A and is denoted by $\mathrm{A}^{\mathrm{c}}$.

In example 1,1 if $\mathrm{A}\{1,3,5\}$

$$
\mathrm{A}^{\mathrm{c}}=\{2,4,6\}=\{\mathrm{x}: \mathrm{x} \Omega, \mathrm{x} \text { even }\} .
$$

## Definition:

Two sets A, B define two related sets. One of these is the set of all elements which belongs to both sets A and B. this is called the intersection of A and B and is denoted by $A \cap B$. the other is the set of all the elements which occur in either $A$ or $B$ or both. This is called the union of A and B denoted by A B.

## Example 1.2

Let $\Omega=\{1,2,3,4,5,6\}, \mathrm{A}=\{1,3,5\}$ and $\mathrm{B}=\{2,3,5\}$
Then

$$
\begin{aligned}
& \mathrm{A} \cap \mathrm{~B}=\{3,5\} \\
& \mathrm{A} \cap \mathrm{~B}=\{1,2,3,5\}
\end{aligned}
$$

$A$ and $B$ contain 3 element each while $A \cap B$ contains 2 elements and $A \cap B$ contains 4 laments.

Note that the number of elements in $\mathrm{A} \cap \mathrm{B}$ is not the sum of the number of elements in A and $B$.

Definition: Difference of Two sets
The different of $A$ and $B$ is the set of elements which belong to $A$ but not to $B$ and is denoted by A/B

In example 1.2 above $\quad \mathrm{A} / \mathrm{B}=\{\mathrm{x}: \mathrm{x} € \mathrm{~A}, \mathrm{x} € \mathrm{~B}\} \Omega$
$\mathrm{A} / \mathrm{B}=\{1\}$
$B / A=\{2\}$
The union of two sets A B can be divided into three disjoint sets
$\mathrm{A} / \mathrm{B}, \mathrm{A} \cap \mathrm{B}, \mathrm{B} / \mathrm{A}$.
That is

$$
\mathrm{A} \cap \mathrm{~B}=(\mathrm{A} / \mathrm{B}) \cap(\mathrm{A} \cap \mathrm{~B}) \cap(\mathrm{B} / \mathrm{A})
$$

The number of element in a set will be denoted by nA. Thus,

$$
\mathrm{n}(\mathrm{~A} \cap \mathrm{~B})=\mathrm{n}(\mathrm{~A} / \mathrm{B})+\mathrm{n}(\mathrm{~A} \cap \mathrm{~B}) \cap(\mathrm{B} / \mathrm{A})
$$

Since
$(A / B),(A \cap B),(B / A)$ are disjoint sets

$$
\begin{aligned}
& \mathrm{nA}=\mathrm{n}(\mathrm{~A} / \mathrm{B})+\mathrm{n}(\mathrm{~A} \cap \mathrm{~B}) \\
& \mathrm{nB}=\mathrm{n}(\mathrm{~B} / \mathrm{A})+\mathrm{n}(\mathrm{~A} \cap \mathrm{~B}) \\
& \mathrm{n}(\mathrm{~A} / \mathrm{B}-=\mathrm{nA}-\mathrm{n}(\mathrm{~A} \cap \mathrm{~B}) \\
& \mathrm{n}(\mathrm{~B} / \mathrm{A})=\mathrm{nB}-\mathrm{n}(\mathrm{~A} \cap \mathrm{~B})
\end{aligned}
$$

hence,
$\mathrm{n}(\mathrm{A} \cap \mathrm{B})=\mathrm{nA}-\mathrm{n}(\mathrm{A} \cap \mathrm{B})+\mathrm{n}(\mathrm{A} \cap \mathrm{B})+\mathrm{nB}-\mathrm{n}(\mathrm{A} \cap \mathrm{B})=\mathrm{nA}+\mathrm{nB}-\mathrm{n}(\mathrm{A} \cap \mathrm{B})$
note: $\mathrm{A} / \mathrm{B}=\mathrm{A} \cap \mathrm{B}^{\mathrm{c}}, \mathrm{B} / \mathrm{A}=\mathrm{B} \cap \mathrm{A}^{\mathrm{c}}$
for any set A,

$$
\mathrm{A} \cap \mathrm{~A}^{\mathrm{c}}=\Phi, \mathrm{A} \cap \mathrm{~A}^{\mathrm{c}}=\Omega
$$

For any two sets A and B , we have the following decomposition:

$$
\mathrm{B}=\mathrm{B} \cap \Omega=\mathrm{B} \cap\left(\mathrm{~A} \cap \mathrm{~A}^{\mathrm{c}}\right)=(\mathrm{B} \cap \mathrm{~A}) \cap\left(\mathrm{B} \cap \mathrm{~A}^{\mathrm{c}}\right),
$$

Since $A \cap B$ and $A^{c} \cap B$ are disjoints, we have

$$
\mathrm{nB}=\mathrm{n}(\mathrm{~A} \cap \mathrm{~B})+\mathrm{n}\left(\mathrm{~A}^{\mathrm{c}} \cap \mathrm{~B}\right)
$$

## de Morgan's Law

(i) For any two sets A and B

$$
(A \cap B)^{c}=A^{c} \cap B^{c}
$$

## Proof:

\mathrm{A}^{\mathrm{c}}=(\mathrm{A} \cap \mathrm{~B})^{\mathrm{c}} \cap(\mathrm{~B} / \mathrm{A}),
$$



Thus,

A^{c} \cap B^{c}=(A \cap B)^{c}
$$

Since $\mathrm{B} / \mathrm{A}$ and $\mathrm{A} / \mathrm{B}$ are disjoint, Alternatively,

(A B)^{c}=\{x: x A \text { and } X B\}=A^{c} \cap B^{c}
$$

In general, if $A_{1}, A_{2}, \ldots . A_{n}$ are any $n$ sets

## Series

A sequence is a set of numbers occurring in order, and there is a simple rule by which the terms are obtained. For example, $1, x, x^{2} \ldots$ is a sequence. If the terms of a sequence are considered as a sum, for instance, $1+\mathrm{x}+\mathrm{x}^{2}+\ldots$. The expression is called a series. A series with a finite number of terms is called a finite series otherwise it is called a finite series otherwise it is called an infinite series. The summation is shown by the symbol.

When the sum is taken from the first term $(r=1)$ to thee $n$th term $(r=n)$.

## Exponential series

The function $\mathrm{y}=\mathrm{e}^{\mathrm{x}}$ is called an exponential function. This function is one of the special functions of analysis and can be defined as the sum of an infinite series. It is defined by
$\mathrm{E}^{\mathrm{x}}=1+\mathrm{x}+\underline{\mathrm{x}^{2}}+\ldots+\underline{\mathrm{x}^{\mathrm{n}}}+\ldots=\underline{\mathrm{x}^{\mathrm{r}}}$

$$

The notation r ! is called factorial r and is defined as

$$
R!=r(r-1)(r-2) \ldots \ldots
$$

For example

Where $0!=1$ and $1!=1 . \mathrm{R}!$ defined above has no meaning unless $r$ itself is a positive integer.

The factorial of any negative integer is infinite.

## UNIT TWO

## MATHEMATICS OF COUNTING

Probability had its origin in games of chance such as disc and card games. The number of definitions you can find for it is limited only by the number of books you may wish to consult. Probability can be defined as a measure put on occurrence of a random phenomenon. probability theory is developed as study of the outcomes of trail of an experiment.

## Definition

An experiment is a phenomenon to be observed according to a clearly defined procedure. Probabilities are numbers between 0 and 1 , inclusive that reflect the chances of a particular physical events occurring. If a die is tossed once, the possible outcomes are $1,2,3,4,5,6$, let $\Omega=\{1,2,3,4,5,6\}$. Then $\Omega$ is a set consisting of all possible outcome of tossing a die once. This set is given a name, it is called a sample space.

## Example 1.1

Write down the staple space for each of the following experiments
(i) Toss a coin 3 times and observe the total number of heads
(ii) A box contains 6 items of which 2 are defectives. One item is chosen one after the other without replacement until the last defective items is chosen. We observe the total number of items removed from the box.

## Solution

(i) Possible outcomes are: number of heads is 0 when we have TTT, number of heads is 1 when we have HTT or THT or TTH, number of heads is 2 when we have HHT, THH, HTH and number of heads are $0,1,2,3$. Hence the sample space $\Omega$ $=\{0,1,2,3)$
(ii) Total number of items removed is 2 if we have "the first is defective (D) and the second is defective D (Note that the total number of items removed can not be 0 or 1 ) denoted by DD. The total number of items removed is 3 if we have

GDD or DGD (where G denoted good item), and so on. Thus, the sample space $\Omega=\{2,3,4,5,6\}$

Definition 1.2 Event
Any subset A of a sample space $\Omega$ is called an event, where $\mathrm{A}<\Omega$.

## Example 1.2

The following are examples of events
(i) An odd number occurs when a die is rolled once

$$
\Omega=\{1,2,3,4,5,6\}, A=\{1,3,5\}
$$

(ii) Toss a coin 3 times, the total number of heads observed is even

$$
\Omega=\{0,1,2,3\} \mathrm{A}=\{0,2\}
$$

Definition 1.3 Trial of an Experiment
A trial is a single performance of an experiment
There are basically two methods for assigning probabilities to events. These are
(i) Relative frequency approach
(ii) Classical approach
(i) Relative Frequency Approach

If we are interested in the occurrence of an event A , we could perform a large number of trials and define the relative frequency of A as

$$
\mathrm{RF}(\mathrm{a})=\frac{\text { Number of trials in which A occurs }}{\text { Total number of trials }}
$$

The ratio $\operatorname{RF}(\mathrm{A})$ is called the empirical probability. If the number of trials is very large $\operatorname{RF}(\mathrm{A})$ will (in most cases0 tend to a particular value called the probability that the event A will occur, that is $R F(A)$ is an estimate of $\mathrm{P}(\mathrm{A})$. the probability that A will occur.

## Example 1.3

Suppose we are interested in the occurrence of a " 6 " when we roll a well balanced die (fair die) the die is then rolled 100 times and " 6 " appeared 15 times. The relative frequency of " 6 " is thus $\underline{15}$ which is the empirical probability of getting 6

$$
100
$$

## (ii) Classical Approach:

In the above example, there are six ways the die can fall when it is rolled once.
So we can define a theoretical probability by

$$
\begin{aligned}
\mathrm{P}(6)= & \underline{\text { number of ways of getting a " } 6 \text { " when rolled once }}=\underline{1} \\
& \text { Total number of possible outcomes when rolled once } 6
\end{aligned}
$$

The classical approach to probability gives

$$
\mathrm{P}(\mathrm{~A})=\underline{\mathrm{nA}}
$$

This definition is valid only when outcomes are equally likely.

## Example 1.4

A coin is rolled thrice. The possible outcomes assumed to be equally likely are

$$
\Omega=\{\mathrm{HHH}, \mathrm{HHT}, \mathrm{HTH}, \mathrm{HTT}, \mathrm{TTT}, \mathrm{TTH}, \text { THT, THH }\}
$$

Let A be the event that 2 heads occur. Then

$$
\begin{gathered}
\mathrm{A}=\{\mathrm{HHT}, \mathrm{HTH}, \mathrm{THH}\} \\
\mathrm{n} \Omega=8, \mathrm{nA}=3
\end{gathered}
$$

hence

$$
\mathrm{P}(\mathrm{~A})=\underline{3}
$$

This classifiableapproach when applicable (the possible outcomes are equally likely) has the advantage of being exact. Thus to compute a probability by using the above definition one must be able to count.
(i) $\mathrm{n} \Omega$ the total number of possible outcomes in the sample space and
(ii) nA , the number of ways in which event A can occur
equally like outcomes are also called equally probable outcomes. If an event cannot occur its probability is 0 , if it must occur its probability is .
the computation of nA and $\mathrm{n} \Omega$ is easy if $\Omega$ has only a few possible outcome, as the number of possible outcomes becomes large, this method of counting all possible outcomes are cumbersome and time consuming.

Alternative methods of counting must therefore be developed. For example if one asks for the probability of getting sum of numbers showing to be 30 when 7 dice are rolled
one must determine how many different ways are possible to get the sum to be 30 . Such possible ways include

$$
(6,6,6,6,2,1,3)(2,5,2,6,6,3),(4,4,4,4,4,4,6)
$$

In this chapter weintroduce nontechnical discussion of techniques of mathematics of counting frequently needed in problems of finding nA and $\mathrm{n} \Omega$

## Fundamental Principle of Counting

## First Law of Counting

If an event $A_{1}$ can occur in $n_{1}$ ways and thereafter an event $A_{2}$ can occur in $n_{2}$ ways, "both $A_{1}$ and $A_{2}$ can occur in this order in $n_{1} n_{2}$ ways.

## Example 1.5

Roll a die first and then a con
$\mathrm{A}_{1}$ can occur in 6 ways ( $1,2,3,4,5$, or 6 ) and $\mathrm{A}_{2}$ can occur in 2 ways (H or T ).
Thus, by the above law, there are

$$
6 \times 2=12
$$

Possible ways for the outcomes
The outcomes are

| $(1, \mathrm{H})(1, \mathrm{~T})$ | $(5, \mathrm{H})(5, \mathrm{~T})$ |
| :--- | :--- |
| $(2, \mathrm{H})(2, \mathrm{~T})$ | $(6, \mathrm{H})(6, \mathrm{~T})$ |
| $(3, \mathrm{H})(3, \mathrm{~T})$ | $(4, \mathrm{H})(4, \mathrm{~T})$ |

In general, if an event $\mathrm{A}_{1}$ can occur in $\mathrm{n}_{1}$ in different ways and if following this an event $A_{2}$ can occur in $n_{2}$ different ways, and if following this second event, an event $A_{3}$ can
occur in $\mathrm{n}_{3}$ different ways and so forth, then the events $\mathrm{A}_{1}$ and $\mathrm{A}_{2}$ and $\mathrm{A}_{3} \ldots$. And $\mathrm{A}_{\mathrm{k}}$ can occur in this order in $\mathrm{n}_{1} \mathrm{n}_{2 \ldots} \ldots \mathrm{n}_{\mathrm{k}}$ ways.

## Example 1.6

If a die is rolled 10 times. Let $\mathrm{A}_{1}$ denote the outcome of the roll, $\mathrm{i}=1,2, \ldots .10 . \mathrm{A}_{1}$ can occur in 6 ways.
Thus thenumber of ways $\mathrm{A}_{1}, \mathrm{~A}_{2}, \ldots$. And $\mathrm{A}_{10}$ can occur is $6^{10}$ possible outcome.
That is

$$
\mathrm{N} \Omega=6^{10}
$$

## Second Law of Counting

If an event $A_{1}$ can occur in $n_{1}$ different ways and an event $A_{2}$ can occur in $n_{2}$ ways then either $\mathrm{A}_{1}$ or $\mathrm{A}_{2}$ can occur in $\mathrm{n}_{1}+\mathrm{n}_{2}$ different ways.

## Example 1.7

Let us toss a die or a coin once. let $a_{1}$ ne the event "the die shows an even number and $a_{2}$ be the event "the coin lands heads". $\mathrm{a}_{1}$ can occur in 3 ways (2, 4or6) and $\mathrm{a}_{2}$ can occur only ocne.
\the number of ways in which an even number or a head be obtain is

$$
3+1=4
$$

$\mathrm{A}_{1}$ can occur in 3 ways $\mathrm{A}_{2}$ can occur in 1 way
Therefore $A_{1}$ or $A_{2}$ can occur in 4 ways
In general, if events $\mathrm{A}_{1}, \mathrm{~A}_{2} \ldots, \mathrm{~A}_{\mathrm{k}}$ can occur in $\mathrm{n}_{1} \ldots \mathrm{n}_{\mathrm{k}}$ different ways, then either or $\mathrm{A}_{1}$ $+\mathrm{n}_{2}+\ldots+\mathrm{n}_{\mathrm{k}}$ different ways

## Example 1.8

Four people enter a restaurant for lunch in which there are six chars. In how many ways can they be seated.
Let $\mathrm{A}_{1}, \mathrm{~A}_{2}, \mathrm{~A}_{3}, \mathrm{~A}_{4}$ denote the events "choice of chair by the four people", the suffix denoting order of seating. The first person to sit down has six choices. He can decide tosit on any of the six vacant chairs. Therefore, there are 6 different ways $A_{1}$ can occur, after
the first person has seated, the second person can sit on any of the remaining 5 chairs. Thereafter the third person can sit on the remaining 4 chairs.

Thus, using the notation of law of counting

$$
\begin{aligned}
& N_{1}=6, n_{2}=5, n_{3}=4, n_{4}=3 \\
& 6 \times 5 \times 4 \times 3=360 \text { ways }
\end{aligned}
$$

They can be seated .

## Example 1.9

How many 4 digits numbers can be formed from the digits $0,1,2,3,4,5$ if the first digit must not be 0 and repetition of digits are not allowed.

Let $A_{1}, A_{2}, A_{3}, A_{4}$, denote mthe events: select the first second, third and fourth digits respectively.since the first digits can not be 0 , the first digit can e either $1,2,3,4$, or 5 therefore $\mathrm{A}_{1}$ can occur in 5 ways, having chosen the first digit the second digit can be selected from the remaining 5 digits. there the first and second digits have been chosen, there remains 4 digits. The third digit can be chosen from the remaining 4 digits and the fourth can be chosen from the remaining 3 digits. Therefore, $\mathrm{A}_{1}, \mathrm{~A}_{2}, \mathrm{~A}_{3}$ and $\mathrm{A}_{4}$ can occur in $5,5,4,3$ ways respectively

Thus there
$5 \times 5 \times 4 \times 3=300$ numbers

## Example 1.10

Ten candidates are eligible to fill 4 vacant position. How many ways are there of filling them?

Let $\mathrm{A}_{1}, \mathrm{~A}_{2}, \mathrm{~A}_{3}, \mathrm{~A}_{4}$ be the events denoting candidates that fill positions 1,2,3,4 respectively. Candidate filling position 1 can be any of the tend candidates, therefore $\mathrm{A}_{1}$ can occur in 10 ways. Following this, the next position 2 can be filled by any of the remaining 9 candidates since position 1 had been filled by one candidate. Therefore $\mathrm{A}_{2}$ can occur in ways. Similarly, $A_{3}$ and $A_{4}$ can occur in 8 and 7 ways respectively. Thus there are $10 \mathrm{x} 9 \mathrm{x} 8 \mathrm{x} 7=5040$ ways

## Permutation and Combination

A permutation is an arrangement of objects in a definite order (called ordered sample). A combination is a selection of objects without regard to order (unordered sample)

A group of objects, with regard to permutation and combination has three characteristics:

1. The way the objects in a group are arranged
2. The kind of objects in the group
3. The number of objects of each kind in the group

## 1.2 permutations:

Suppose that a set contain $n$ objects. We are often interested in arranging the objects in a definite order.

Two groups containing n object are said to form different permutations if they differ in arrangements

Consider groups of letters $\mathrm{a}, \mathrm{b}, \mathrm{c}, \mathrm{d}$.

$$
(a, b, c, d):(b, c, d, a):(c, a, d, b)
$$

They are all different permutations because the arrangement of the letters is different in each group.

## Example 1.11

How many permutations of four letters can be formed from the letter $a, b, c, d$.
To answer this question we reason as follows:
Since are permuting 4 letters, four events are involved. Let $\mathrm{A}_{1}$ be the events denoting the letter to occupy the ith position. $\mathrm{A}_{1}$ can occur in 4 ways, that is the first letter can be either $\mathrm{a}, \mathrm{b}, \mathrm{c}$, or d . after this event has taken place, $\mathrm{A}_{2}$ can occur in three ways (that is, after having chosen the first letter, the letter occupying the second position can be chosen from the remaining three letters. After the second event, there remains only two letters from which one is to be chosen tooccupy the third position. So $\mathrm{A}_{3}$ is 2 and it remains only one letter.
$A_{4}$ can occur only in one way. Thus, there are $4 \times 3 \times 2 \times 1=24$ permutation of the four letters. Permutation of four objects from four objects is called permutation 4 and is denoted by ${ }^{4} \mathrm{P}_{4}$

## Permutation of $\mathbf{n}$ Distinct Objects

Consider a set consisting of $n$ district objects. permutation of this set consist of $n$ events $\mathrm{A}_{1}, \mathrm{~A}_{2}, \ldots . \mathrm{A}_{\mathrm{n}}$, where the object occupying the ith position is the outcome of $\mathrm{A}_{1}, \mathrm{I}=1$, $2, \ldots .$. . $\mathrm{A}_{1}$ can occur in $\mathrm{n}_{1}$ ways, $\mathrm{A}_{2}$ can occur in $\mathrm{n}-1$ ways and so on.

Thus there are $n(n-1)(n-2) \ldots \times 3 \times 2 \times 1$ permutation of the $n$ objects. The number of permutations of $n$ distinct objects is $n!$.

## Example 1.12

If $n$ balls are distributed at random into $r$ boxes, in how many ways can this be done if
(i) Each of the balls can go into any of the $r$ boxes
(ii) No box has more than one ball.

## Solution

(i) Let $\mathrm{A}_{1}, \mathrm{~A}_{2} \ldots \mathrm{~A}_{\mathrm{n}}$ where the object occupying the ith position is the outcome of $\mathrm{A}_{1} \mathrm{I}$ $=1,2, \ldots . . \mathrm{n}$. $\mathrm{A}_{1}$ can occur in $\mathrm{n}_{1}$ way, $\mathrm{A}_{2}$ can occur in $\mathrm{n}-1$ ways and so on.
(ii) The first ball can go into any of the $r$ boxes, the second any one of the remaining $(r-1)$ boxes etc, so in all there are $r(r-1)(r-2) \ldots(r-n+1)$ different ways $(n \leq r)$.

## Example 1.13

How many permutation of three letters can be formed from the letters $a, b, c, d, e . a b c$, bae, cba, cdb,..... are few of the required permutation. Since the permutation consist of 3 letters, 3 events are involved, $\mathrm{A}_{1}, \mathrm{~A}_{2} \mathrm{~A}_{3}$. The first letter can be any of the 5 letters, therefore $A_{1}$ can occur in 5 ways. Similarly $A_{3}$ can occur in 3 ways. Thus, there are

$$
5 \times 4 \times 3=60
$$

Permutation of three letters from 5 letters. This is denoted by ${ }^{5} \mathrm{P}_{3}$ ( 5 permutation 3).

## Definition 1.4

The number of permutation of $\mathrm{r}(\mathrm{r} \leq \mathrm{n})$ objects from n district objects is called ${ }^{\mathrm{n}} \mathrm{n}$ permutation $r$ and is denoted by ${ }^{n} p_{r}$

It can easily be shown that

$$
{ }^{n} P_{r}=n(n-1)(n-2) \ldots(n-r+1)
$$

to see this we can argue as follows. Since we are permuting r objects, there are $r$ events $\mathrm{A}_{1}, \mathrm{~A}_{2} \ldots . . \mathrm{A}_{3}$ involved.

The first position can be occupied by any of the n objects, following this the second position can be occupied by any of the remaining $n-1$ objects and so on. Therefore $\mathrm{A}_{1}$, $\mathrm{A}_{2, \ldots}, \mathrm{~A}_{\mathrm{r}}$ can occur in $\mathrm{n}, \mathrm{n}-1, \mathrm{n}-2, \ldots \mathrm{n}$-(r-1) ways respectively. thus the number ofpermutation is

$$
\mathrm{n}(\mathrm{n}-1)(\mathrm{n}-20 \ldots(\mathrm{n}-\mathrm{r}+1)
$$

But

$$
\begin{align*}
& \mathrm{n}!=\mathrm{n}(\mathrm{n}-1)(\mathrm{n}-2) \ldots(\mathrm{n}-\mathrm{r}+1)(\mathrm{n}-\mathrm{r})(\mathrm{n}-\mathrm{r}-1) \ldots 1  \tag{3.2.1}\\
& \quad(\mathrm{n}-\mathrm{r})!=(\mathrm{n}-\mathrm{r})(\mathrm{n}-\mathrm{r}-1) \ldots 2.1 \\
& \frac{\mathrm{n}!}{(\mathrm{n}-\mathrm{r})!}=\mathrm{n}(\mathrm{n}-1)(\mathrm{n}-2) \ldots(\mathrm{n}-\mathrm{r}+1)
\end{align*}
$$

Therefore

$$
\begin{aligned}
& { }^{n} P_{r}=n(n-1)(n-2) \ldots(n-r+1) \\
& { }^{n} P_{r}=\frac{n!}{(n-r)!}
\end{aligned}
$$

In example 1.13 above, $\mathrm{n}=5, \mathrm{r}=3$

$$
{ }^{5} \mathrm{P}_{3}=\frac{5!}{(5-3)}=\underline{5!}=5 \times 4 \times 3=60
$$

## Example 1.14

A group of students consist of 5 men and 3 women. The students are ranked according to their performance in a quiz competition. Assuming no two students obtain the same score
(i) How many different ranking are possible?
(ii) If the men are ranked just among themselves and the women among themselves, how many different rankings are possible?

## Solution

(i) A possible ranking corresponds to a permutation of the students. The number of possible permutation of the 8 students gives the number of different ranking possible. Thus the answer is

$$
\begin{equation*}
{ }^{8} \mathrm{P}_{8}=\underline{8!}=8!=40320 \tag{8-8}
\end{equation*}
$$

(ii) There are ${ }^{5} \mathrm{P}_{5}=5!=120$ possible rankings of the men and ${ }^{3} \mathrm{P}_{3}=3!=6$ possible rankings of the women. It follows from the fundamental principle of counting that there are

$$
{ }^{5} \mathrm{P}_{5} \times{ }^{3} \mathrm{P}_{3}=5!\mathrm{X} 3!=72 \text { - possible rankings }
$$

## Example 1.15

Four digits numbers are to be formed using any of the digits $1,2,3,4,5,6$, (No repetition of digit is allowed).
(i) How many four digit number can be formed
(ii) How many 4 digit numbers greater than 3000 can be formed?
(iii) How many 4-digit even numbers can be formed?
(iv) How many of these even 4-digit numbers are greater than 3000 ?

## Solution

(i) This is permutation of 4 digits from 6 digits. Therefore the different permutation is

$$
{ }^{6} \mathrm{P}_{4}=\frac{6!}{2!}=360
$$

Alternatively, we can reason as follow:
The first digit to be selected can be any of the six given digits, so $\mathrm{n}_{1}=6$. The second digits to be select can be any of the remaining 5 digits (since no reparation is allowed) so $\mathrm{n}_{2}=5$. Similarly, $\mathrm{n}_{3}=4$ and $\mathrm{n}_{4}=3$. Thus, the answer is

$$
\mathrm{N}_{1} \times \mathrm{n}_{2} \times \mathrm{n}_{3} \times \mathrm{n}_{4}=6 \times 5 \times 4 \times 3=360
$$

(ii) Since the number must be greater than 3000 , the first digit must be chosen room 3, 4,5 or 6 so $n_{1}=4$. The second digit can be any of the remaining 5 digits, so $n_{2}$ $=5$ similarly, $\mathrm{n}_{3}=4, \mathrm{n}_{4}=3$. Thus, there are

$$
4 \times 5 \times 4 \times 3=240
$$

4 digit numbers greater than 3000 that can be formed using the digits $1,2,3,4,5,6$,
(iii) A number can be defined to be an even number of the last digit of the number is even. Going by this definition, we see that the required number is even if the last digit is 2,4 , or 6 . Since there is a restriction on the last digit. We have to select the last digit first. The last digit can be selected from 2,4 or 6 , so we have 3 choices. Having chosen the last digit, we can now select the first, second and third digit. After chosen the last digits there remains 5 digits, so $n_{1}$ $=5$ similarly, $\mathrm{n}_{2}=4, \mathrm{n}_{3}=3$. Thus, the answer is $\quad 5 \times 4 \times 3 \times 3=180$
(iv) The last digit must be 2,4 or 6 and the first digit must be $3,4,5$ or 6 . If the last digits is 2 , then the number of ways of selecting the first digit is 4 . However, if the last digit is selected is 2 or 6 the number of ways of selecting the first digit is 3 (that is 3,5 or $6,3,4$ or 5 )

Case 1: $\quad n_{4}=1 n_{1}=4 n_{2}=4, n_{3}=3$
The number of 4 digits numbers that can be formed in this case is

$$
4 \times 4 \times 3 \times 1=48
$$

Case II: $\quad n_{4}=2, n_{1}=3 n_{2}=4, n_{3}=3$

The number of 4 digit numbers that can be formed in this case is

$$
3 \times 4 \times 3 \times 2=72
$$

Hence, the total numbers of even 4 digit numbers greater than 3000 that can be formed is $48+72=120$.

## Example 1.16

The letters $\mathrm{A}, \mathrm{B}, \mathrm{C}, \mathrm{D}$ and E are placed at random to form a five letters word (without repetition). How many ways can a word be formed such that
(i) D directly follows A .
(ii) A and D follow each other
(iii) $\mathrm{A}, \mathrm{D}$ and E follow each other

## Solution

(i) For D to directly follow A , we must always have AD appearing in the word so formed AD can be regarded as a letter so that we now have the letters B, C E and AD . The number of ways of rearranging tehse new four letters is 4 ! Thus there are $4!=24$ ways of forming a word such that D directly follows A
(ii) A and D follow each other; either we have AD or Da each having 4! Ways. Thus there are 2 x 4 ! Ways of forming a word such that A and follow each other
(iii) ADE can be regarded as a letter so that we now have the letters B.C ADE. There are 3! Permutation of the new 3 letters. ADE can also be permuted in 3! Ways, that is
ADE, AED, DAE, DEA, EAD, EDA.

Thus there are

$$
3!\times 3!=36 \text { ways }
$$

## Permutation of Indistinguishable Objects

Consider $n$ objects where $n_{1}$ are of type 1 , of type $2, \ldots . \mathrm{N}_{\mathrm{k}}$ of type k . , in shown many ways can the $n$ object be arranged.

For example in how many ways can the letters of the word book be arranged. here $n=4, k$ $=3, n_{1}=1, n_{2}=2, n_{3}=1$. First give the two O's suffixes $\mathrm{bo}_{1} \mathrm{O}_{2} \mathrm{k}$. then treating the O's as different, the 4 letters may be arranged in 4! Ways. In every distinct arrangement, the

2O's may be rearranged amongst themselves in 2 ! Ways without altering the permutation for instance $\mathrm{o}_{1} \mathrm{bo}_{2} \mathrm{k}$ are the same when the suffixes are removed.

Therefore, the number of permutations of the letters of the word book is

$$
\begin{aligned}
& \underline{4!}=6 \\
& 2!
\end{aligned}
$$

Book, ookb, oobk, obok, okob, koob.
In general, the number of ways in which $n$ objects where $n_{1}$ are of type $1, n_{2}$ of type $2 \ldots$, $\mathrm{n}_{\mathrm{k}}$ of type k can be arranged is given by

$$
\frac{\mathrm{n}!: ~}{\mathrm{n}_{+} \mathrm{n}^{2}+\ldots+\mathrm{n}^{\mathrm{k}}}
$$

## Example 1.17

How many distinct permutations are there of the letters of the word Television?
The ten letters to be permuted consist of 2 e 's, 2 i 's,IT, I, v, $s, o$, n. thus the number of distinct permutation is

$$
\frac{10!}{2!2!1!1!1!1!1!1!}=\underline{10!} 2!2!
$$

### 1.3 Combinations

## Definition 1.5

Two groups are said to form different "combination" if they differ in the number of any kind of object in the groups. Consider a group of 4 letters a, b, c, d. the combination abcd, bcda, cadb are identical combinations each of them contains the same number of $\mathrm{a}, \mathrm{b}, \mathrm{c}, \mathrm{d}$ : one b , one c and one d .
The combinations of the 4 letters taken 3 at a time are:
Abc, acd, abd, cbd
Therefore, there are 4 distinct combination for three letters from the four letters. Each of tehse combinations has $3!=6$ permutation. For instance.

| abc | $=$ | abc, | acb | cab | cba | bac | bca |
| :--- | :--- | :--- | :--- | :--- | :--- | :--- | :--- |
| acd | $=$ | acd | adc | cad | cda | dac | dca |
| abd | $=$ | abd | adb | bad | bda | dab | dba |

$$
\mathrm{cdb}=\mathrm{cbd} \mathrm{cdb} \quad \mathrm{bcd} \quad \mathrm{bdc} \quad \mathrm{dbc} \quad \mathrm{dcb}
$$

The number of distinct permutation is ${ }^{4} \mathrm{P}_{3}=24$
The number of distinct combinations is 4 .
Therefore.

$$
\text { Number of combinations }=\underline{\text { number of permutations }}
$$

$3!$
The number of distinct combination of 4 objects takn 3 at a time is denoted by ${ }^{4} \mathrm{C}_{3}$. Thus,

$$
{ }^{4} \mathrm{C}_{3}={ }^{4} \mathrm{P}_{3 / 3} 3!
$$

In general,

$$
{ }^{\mathrm{n}} \mathrm{C}_{\mathrm{r}}={ }^{\mathrm{n}} \mathrm{P}_{\mathrm{r}} / \mathrm{r}!=\frac{\mathrm{n}!}{(\mathrm{n}-\mathrm{r})!\mathrm{r}}
$$

## Theorem 1.1

The number of distinct combinations of $n$ objects taken $r$ at a time (that is the number of ways of choosing r objects out of $n$, disregarding order and without replacement) is given by

## Proof:

There are ${ }^{n} \mathrm{P}_{\mathrm{r}}=$ $\qquad$
( $\mathrm{n}-\mathrm{r}$ )! permutations of n objects taken r at a time. If we disregard order among the r objects, there are r ! permutation that will give the same combination. Therefore the number of combinations is the number of permutation divided by r ! thus.

## Example 1.18

A club consist of 15 members. In how many ways can a committee of 3 to be chosen?

## Solution

This can be done in ${ }^{15} \mathrm{C}_{3}$ ways

{ }^{15} \mathrm{C}_{3}=\underline{15!}=\underline{15 \times 7 \times 13} \quad=455 \text { ways }
$$

## Example 1.19

A club consist of 10 men and 5 women, in how many ways can a committee of 6 consisting of 4 men and 2 women be chosen. The 4 men can be chosen from the 10 men in ${ }^{10} \mathrm{C}_{4}$ ways, the 2 women can be chosen from the 5 women in ${ }^{5} \mathrm{C}_{2}$ ways. Hence the committee can be chosen in (by the fundamental principle f counting)

$$
{ }^{10} \mathrm{C}_{4} \times{ }^{5} \mathrm{C}_{2}=\frac{10!}{6!4!} \quad \mathrm{X} \quad \frac{15!}{2!3!} \quad=2,100 \text { ways }
$$

## Exmaple1.20

Suppose we have a box containing $n$ balls of which $r$ are black and the remaining white. A random sample of size k is selected without replacement. In how many ways can the sample be selected such that it contains x black balls

The x black balls can be selected in ${ }^{\mathrm{r}} \mathrm{C}_{\mathrm{x}}$ ways and k - x white balls n be selected from n $r$ white balls. Thus, there are

$$
{ }^{r} C_{x} X^{n-r} C_{k-r}
$$

ways of selecting a sample such that it contains x black balls and $\mathrm{k}-\mathrm{x}$ white balls

## Example 1.21

A committee of 4 men and 2 women is selected from 10 men and 5women. If two of the men are feuding and will not serve on the committee together, in how many ways can the committee be selected

## Solution

The number of ways of selecting 4 men and 2 women is

$$
{ }^{10} \mathrm{C}_{4} \times{ }^{5} \mathrm{C}_{2}=2100
$$

The number of ways of selecting the committee such that the two men are in the committee is

$$
{ }^{8} \mathrm{C}_{2} \mathrm{x}{ }^{5} \mathrm{C}_{2}=280
$$

Hence, the number of different committees that can be formed such that the two men are not in the committee together is

$$
2100-280=1820
$$

Another method is to consider 3 cases
Case I: The two men say, A and B are not in the committee

$$
{ }^{8} \mathrm{C}_{4} \times{ }^{5} \mathrm{C}_{2}=700
$$

Case II: A is the committee but not B:

$$
{ }^{8} \mathrm{C}_{4} \times{ }^{5} \mathrm{C}_{2}=560
$$

Case III: B is the committee but not A

$$
{ }^{8} \mathrm{C}_{4} \mathrm{x}{ }^{5} \mathrm{C}_{2}=560
$$

Thus, the total number of ways the committee can be selected is

$$
700+560+560=1,820
$$

## Example 1.23

A student is to answer 5 out of 8 question in an examination. How many if he must answer at least 2 of the first for 4 questions?

## Solution

(i) By the combination law the answer of ${ }^{8} \mathrm{C}_{5}=56$
(ii) Possible choices are $(2,3)(3,2)(4,1)$ where $(2,3)$ means answer 2 questions from the first 4 questions and 3 from the remaining 4 questions. The number of ways of doing this is ${ }^{4} \mathrm{C}_{2} \mathrm{x}{ }^{4} \mathrm{C}_{3}$.

Thus the answer is

$$
\left({ }^{4} \mathrm{C}_{2} \mathrm{x}{ }^{4} \mathrm{C}_{3}\right)+\left({ }^{4} \mathrm{C}_{3} \mathrm{x}{ }^{4} \mathrm{C}_{2}\right)+\left({ }^{4} \mathrm{C}_{4} \mathrm{x}^{4} \mathrm{C}_{1}\right)=52
$$

### 1.4Partitioning

Dividing a population or a sample of n objects into k ordered parts of which the first contain $r$ object, the second $r_{2}$ objects and so on is called ordered partition. If the division is into k unordered parts, then the partition is said to be unordered. For example suppose a class contains 15 students and we want to divide the class into 3 tutorial groups of 5 each. Three lecturers are available and each is to take each group. In otherwise, we want to divide the 15 students into 3 ordered groups $(A, B, C)$ this is an ordered partition since there are

$$
3!=6 \text { ways }
$$

The lecturers can be assigned to take any partition, for instance groups (A, B, C) can be taken by

$$
\begin{array}{r}
\left(\mathrm{L}_{1}, \mathrm{~L}_{2}, \mathrm{~L}_{3}\right) \text { or }\left(\mathrm{L}_{2}, \mathrm{~L}_{1}, \mathrm{~L}_{3}\right) \text { or }\left(\mathrm{L}_{1}, \mathrm{~L}_{3}, \mathrm{~L}_{2}\right) \\

In how many ways can 9 toys be divided among three children if each gets 3 toys If the toys are numbered 1 through 9 , the partition $\{(1,2,3),(4,5,6),(7,8,9\})$ means child A gets toys $1,2,3$ child $B$ gets toys $(4,5,6)$ while child $C$ gets toys $8,8,9$. We distinguish between $\{(1,2,3),(4,5,6)(7,8,9)\}$ and $\{(4,5,6),(1,2,3),(7,8,9)$ so these are ordered partitions. Thus there are

$$
9!=1680 \text { ways }
$$

$3!3!3$ !
When $r_{1}=r_{j}$ for $\mathrm{I}=\mathrm{j}$, we can distinguish between ordered and unordered partition for example partition a set consisting of 8 objects numbered 1 to 8 into 3 parts of which the first contains 2 objects, the second 4 objects and the third 2 objects. A partition is

### 1.5 Selection of Non distinct Objects

## ELEMENTARY PRINCIPLE OF THE THEORY OF PROBABILITY

In chapter 1, we considered some elementary methods of mathematics of counting essential for determining probabilities of events. In this chapter, we continue our study by discussing how to apply the knowledge gained in chapter 1 to determine probabilities of events and general properties of probabilities. We present some theorems and definitions that are basic to the understanding of commonly encountered problems.

## Example 2.1

Suppose a fair die is rolled once. There are six possible outcomes. The sample space is

$$
\Omega=\{1,2,3,4,5,6\} .
$$

let $\mathrm{A}_{1}, \mathrm{~A}_{2}$ and $\mathrm{A}_{3}$, represent the following events

$$
\mathrm{A}_{1}=\text { "an even number occurs" }
$$

$\mathrm{A}_{2}=$ "an odd number occurs
$\mathrm{A}_{3}=$ a prime number occurs"
The six possible outcomes in $\Omega$ are equally likely. The probability that A occurs is denoted by $\mathrm{P}(\mathrm{A})$ and the probability that A does not occur by $\mathrm{P}\left(\mathrm{A}^{\mathrm{C}}\right)$. if we let $\mathrm{n}_{\mathrm{A}}$ be the number of outcomes that have attribute A , then

$$
\begin{aligned}
& A_{1}=\{2,4,6\} \\
& A_{2}=\{1,3,5\} \\
& A_{3}=\{2,3,5\}
\end{aligned}
$$

Thus,

$$
P\left(A_{1}\right)=\frac{n A_{1}}{n \Omega}=3 / 6=1 / 2, p\left(A_{2}\right)=\frac{3}{6}, P\left(A_{3}\right)=\frac{3}{6}
$$

## Example 2.2

Suppose that a box contains 10 items of which are defective. Two items are selected at random without replacement. Find the probabilities that:
(i) both items are non-defective
(ii) only one item is defective
(iii) both items are defective:
(iv) at least one item is defective

Let $\mathrm{A}_{1}, \mathrm{~A}_{2}, \mathrm{~A}_{3}, \mathrm{~A}_{4}$, denote the events

> "both items are non-defective
> "only one item is defective"
> "both items are defective" "at least one item is defective"
respectively. The number of ways of selecting 2 items from 10 is

$$
{ }^{10} C_{2}=45 \text { ways. }
$$

So there are 45 elements in the sample space.
(i) The number of ways of selecting 2 items from the non-defective items is ${ }^{6} \mathrm{C}_{2}=15$. That is $\mathrm{A}_{1}$ can occur in 15 ways. Thus.

$$
\mathrm{P}\left(\mathrm{~A}_{1}\right)=\frac{{ }^{6} C_{2}}{{ }^{10} C_{2}}=\frac{n A_{1}}{n \Omega}=\frac{15}{45}=1 / 3
$$

(ii) The number of ways of selecting 1 item from the 4 defective items and 1 item from the 6 non-defective items is ${ }^{4} \mathrm{C}_{1} \times{ }^{6} \mathrm{C}_{1}=24$ so, $\mathrm{A}_{2}$ can occur in 2 ways. Thus,

$$
\mathrm{P}\left(\mathrm{~A}_{2}\right)=\frac{{ }^{4} C_{1} \times{ }^{6} C_{1}}{{ }^{10} C_{2}}=\frac{24}{45}=\frac{8}{15}
$$

Similarly
(iii) $\mathrm{P}\left(\mathrm{A}_{3}\right)=\frac{{ }^{4} C_{2}}{{ }^{10} C_{2}}=\frac{6}{45}=\frac{2}{15}$
(iv) At least one defective means 1 or 2 defective items. So,
$\mathrm{P}\left(\mathrm{A}_{4}\right)=\mathrm{P}(1$ defective item $)+\mathrm{P}(2$ defective items $)=P\left(\mathrm{~A}_{2}\right)+\mathrm{P}\left(\mathrm{A}_{3}\right)=\frac{8}{15}+\frac{2}{15}=2 / 3$.

## Example 2.3

Suppose a fair die is rolled twice. Find the probability that the sum of the numbers on the two faces is (i) even, (ii) less than 5.

The sample space $\Omega$, consists of 36 elements.
(i) Let A be the event "the sum of the two faces is even". Possible outcome are:
$(1,1)(1,3)(1,5)(2,2)(2,4) \quad(2,6), \ldots$
$(3,1)(5,1)(4,2)(6,2), \ldots$

A can occur in 18 ways. Thus,

$$
\mathrm{P}(\mathrm{~A})=\frac{18}{36}=1 / 2
$$

(ii) Let B be the event "the sum is less than 5". B occurs if the sum is 2,3 , or 4 . The sum is 2 if the outcome is $(1,1)$ the sum is 3 if the outcome is $(1,2)$ or $(2,1)$ and the sum is four if the outcome is $(3,1),(1,3)$ or $(2,2)$. Therefore B can occur in

$$
1+2+3=6 \text { ways }
$$

Thus

$$
P(B)=\frac{6}{36}=1 / 6 .
$$

Example 2.4
3 balls are drawn at random with replacement from a box containing 8 red and 3 white balls. Find the probability that (i) all 3 are red; (ii) 1 is red and 2 are white.

The sample space consists of $11^{3}$ possible outcomes. Let A be "the evet all 3 are red" and B the event " 1 is red and 2 white"

$$
\mathrm{P}(\mathrm{~A})=\frac{n A}{n \Omega}=\frac{8^{3}}{11^{3}}
$$

(The first red can be chosen in 8 ways the second in 8 ways and the third Red in 8 ways).

$$
\mathrm{P}(\mathrm{~B})=\frac{n B}{n \Omega}, \mathrm{nB}=8,3 \cdot 3+3 \cdot 8 \cdot 3+3 \cdot 3 \cdot 8
$$

$(8 \times 3 \times 3)=$ number of ways of picking the first to be red, second white and third white (RWW), $3 \times 8 \times 3$ is for WRW and $3 \times 3 \times 8$ is for WWR). Thus

$$
\mathrm{P}(\mathrm{~B})=\frac{3 \cdot 8.3 \cdot 3}{11^{3}} .
$$

### 2.1 Properties of Probability

Definition 2.1: Mutually Exclusive events

Two events $\mathrm{A}_{1}$ and $\mathrm{A}_{2}$ are mutually exclusive if an only if

$$
\mathrm{A}_{1} \cap \mathrm{~A}_{\mathrm{j}}=\phi \text { for every } \mathrm{i} \neq \mathrm{j} .
$$

That is, two or more events are mutually exclusive if no two of them have points in common. In example 2.1

$$
\begin{aligned}
& \mathrm{A}_{1}=\{2,4,6\} \\
& \mathrm{A}_{2}=\{1,3,5\} \\
& \mathrm{A}_{1} \cap \mathrm{~A}_{2}=\phi,
\end{aligned}
$$

Therefore $\mathrm{A}_{1}$ and $\mathrm{A}_{2}$ are mutually exclusive events.

Definition 2.1

If $\mathrm{A}_{1}$ and $\mathrm{A}_{2}$ are any two events, $\mathrm{A}_{1} \cap \mathrm{~A}_{2}$ is the event that occurs if and only if both $\mathrm{A}_{1}$ and $A_{2}$ occur. In general, if $A_{1}, A_{2}, \ldots, A_{n}$ occur.

In example 2.1. $\mathrm{A}_{1} \cap \mathrm{~A}_{2} \cap \mathrm{~A}_{3}$ is the event that an even prime occurs.

$$
\mathrm{A}_{1} \cap \mathrm{~A}_{3}=\{2\}
$$

Thus

$$
P\left(A_{1} \cap \mathrm{~A}_{3}\right)=\frac{1}{6}
$$

The event $\mathrm{A}_{2} \cap \mathrm{~A}_{3}$ is the event that an odd prime occurs $\mathrm{A}_{2} \cap \mathrm{~A}_{3}=\{3,5\}$.

Thus

$$
\mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{2}\right)=\frac{2}{6}=\frac{1}{3}
$$

## Complementary Event

The event "A occurs" and "A does not occur" are mutually exclusive. The event "A does nt occur" is called the complement of A and is denoted by $\mathrm{A}^{\mathrm{C}}$.

## Theorem 2.1

If $\mathrm{A}^{\mathrm{C}}$ is the complement of an event A , then $\mathrm{P}\left(\mathrm{A}^{\mathrm{c}}\right)=1-\mathrm{P}(\mathrm{A})$. This theorem states that the probability that an event will not occur is equal to 1 minus the probability that it will occur.

In example 2.2 (iv); The event "no defective item" is the same as the event both items are non-defective".

From Theorem 2.1, we have

$$
\mathrm{P}\left(\mathrm{~A}_{4}\right)=1-\mathrm{P}\left(A_{4}^{\mathrm{c}}\right)=1-P\left(A_{1}\right)=1-\frac{1}{3}=\frac{2}{3}
$$

$\mathrm{A}_{4}{ }^{\mathrm{c}}=\mathrm{A}_{1}$ since the event "no defective item" is the same as the event" both items are nondefective.

The following events are complementary events
(i) at most 2 and greater than 2
(ii) at least 4 and less than 4 .

## Definition 2.2

If $\mathrm{A}_{1}$ and $\mathrm{A}_{2}$ are any two events, $\mathrm{A}_{1} \cup \mathrm{~A}_{2}$ is the event that occurs if $t$ least one of $\mathrm{A}_{1}$ and $\mathrm{A}_{2}$ occurs.

In general, if $\mathrm{A}_{1}, \mathrm{~A}_{2}, \ldots, \mathrm{~A}_{\mathrm{n}}$ are any events, $\mathrm{A}_{1} \cup \mathrm{~A}_{2}$ is the event that occurs if at least one of $A_{1} i=1,2, \ldots, n$, occurs.

In example 2.1, the event $\mathrm{A}_{1} \cup \mathrm{~A}_{3}$ is the event that an even or a prime number occurs.

$$
\mathrm{A}_{1} \cup \mathrm{~A}_{3}=\{2,3,4,5,6\} .
$$

Thus

$$
\mathrm{P}\left(\mathrm{~A}_{1} \cup \mathrm{~A}_{2}\right)=\frac{n\left(\mathrm{~A}_{1} \cup A_{2}\right)}{n \Omega}=\frac{5}{6}
$$

The event $\mathrm{A}_{1} \cup \mathrm{~A}_{2}$ is the event that an event or an odd number occurs.

$$
\mathrm{A}_{1} \cup \mathrm{~A}_{2}=\{1,2,3,4,5,6\}=\Omega,
$$

thus

$$
\mathrm{P}\left(\mathrm{~A}_{1} \cup \mathrm{~A}_{2}\right)=\mathrm{P}(\Omega)=\frac{6}{6}=1 .
$$

Theorem 2.2

If $\mathrm{A}_{1}$ and $\mathrm{A}_{2}$ are any events, then

$$
\mathrm{P}\left(\mathrm{~A}_{1} \cup \mathrm{~A}_{2}\right)=\mathrm{P}\left(\mathrm{~A}_{1}\right)+\mathrm{P}\left(\mathrm{~A}_{2}\right)-\mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{2}\right) .
$$

The proof of this theorem follows directly from the definition

$$
\begin{aligned}
& P\left(A_{1} \cup A_{2}\right)=\frac{n\left(A_{1} \cup A_{2}\right)}{n \Omega} \\
& n\left(A_{1} \cup A_{2}\right)=n A_{1}+n A_{2}-n\left(A_{1} \cap A_{2}\right)
\end{aligned}
$$

dividing through by $\mathrm{n} \Omega$ the result follows.

## Corollary

(i) If $\mathrm{A}_{1}$ and $\mathrm{A}_{2}$ are mutually exclusive event then

$$
\mathrm{P}\left(\mathrm{~A}_{1} \cup \mathrm{~A}_{2}\right)=\mathrm{P}\left(\mathrm{~A}_{1}\right)+\mathrm{P}\left(\mathrm{~A}_{2}\right)
$$

since $\mathrm{A}_{1}$ and $\mathrm{A}_{2}$ are mutually exclusive,

$$
\mathrm{A}_{1} \cap \mathrm{~A}_{2}=\phi
$$

hence

$$
\mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{2}\right)=0
$$

(ii) If $\mathrm{A}_{1}$ and $\mathrm{A}_{2}$ are any two events

$$
\mathrm{P}\left(\mathrm{~A}_{1} \cup \mathrm{~A}_{2}\right) \leq \mathrm{P}\left(\mathrm{~A}_{1}\right)+\mathrm{P}\left(\mathrm{~A}_{2}\right)
$$

In Example 2.1 above,

$$
\mathrm{P}\left(\mathrm{~A}_{1} \cup \mathrm{~A}_{3}\right)=\mathrm{P}\left(\mathrm{~A}_{1}\right)+\mathrm{P}\left(\mathrm{~A}_{3}\right)-\mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{3}\right)=\frac{1}{2}+\frac{1}{2}-\frac{1}{6}=\frac{5}{6} .
$$

(iii) If A and B are any two events defined on the sample space then

$$
\begin{aligned}
& \mathrm{P}(\mathrm{~A})=\mathrm{P}(\mathrm{~A} \cap \mathrm{~B})+\mathrm{P}\left(\mathrm{~A} \cap \mathrm{~B}^{\mathrm{c}}\right) \\
& \mathrm{P}(\mathrm{~B})=\mathrm{P}(\mathrm{~A} \cap \mathrm{~B})+\mathrm{P}\left(\mathrm{~A}^{\mathrm{c}} \cap \mathrm{~B}\right)
\end{aligned}
$$

In general, if $\mathrm{A}_{1}, \mathrm{~A}_{2}, \ldots \mathrm{~A}_{\mathrm{n}}$ are any n mutually exclusive events, then

$$
\mathrm{P}\left(\mathrm{~A}_{1} \cup \mathrm{~A}_{2} \cup \ldots \cup \mathrm{~A}_{\mathrm{n}}\right)=\mathrm{P}\left(\mathrm{~A}_{1}\right)+\ldots+\mathrm{P}\left(\mathrm{~A}_{\mathrm{n}}\right) .
$$

Theorem 2.2 can be generalized for $n>2$ events. It can easily be shown that for any 3 events $\mathrm{A}_{1}, \mathrm{~A}_{2}, \mathrm{~A}_{3}$
$\mathrm{P}\left(\mathrm{A}_{1} \cup \mathrm{~A}_{2} \cup \mathrm{~A}_{3}\right)=\mathrm{P}\left(\mathrm{A}_{1}\right)+\mathrm{P}\left(\mathrm{A}_{2}\right)+\mathrm{P}\left(\mathrm{A}_{3}\right)-\mathrm{P}\left(\mathrm{A}_{1} \cap \mathrm{~A}_{2}\right)$

$$
-\mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{3}\right)-\mathrm{P}\left(\mathrm{~A}_{2} \cap \mathrm{~A}_{3}\right)+\ldots+\mathrm{P}\left(\mathrm{~A}_{3}\right) .
$$

To see this, let $B=A_{1} \cup A_{2}$, then

$$
\begin{gathered}
\mathrm{P}\left(\mathrm{~A}_{1} \cup \mathrm{~A}_{2} \cup \mathrm{~A}_{3}\right)=\mathrm{P}\left(\mathrm{~B} \cup \mathrm{~A}_{3}\right)=\mathrm{P}(\mathrm{~B})+\mathrm{P}\left(\mathrm{~A}_{3}\right)-\mathrm{P}\left(\mathrm{~B} \cap \mathrm{~A}_{3}\right) \\
\mathrm{P}(\mathrm{~B})=\mathrm{P}\left(\mathrm{~A}_{1}\right)+\mathrm{P}\left(\mathrm{~A}_{1}\right)+\mathrm{P}\left(\mathrm{~A}_{2}\right)-\mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{2}\right)
\end{gathered}
$$

$\mathrm{P}\left(\mathrm{B} \cap \mathrm{A}_{3}\right)=\mathrm{P}\left(\mathrm{A}_{3} \cap \mathrm{~B}\right)=\mathrm{P}\left\{\left(\mathrm{A}_{3} \cap\left(\mathrm{~A}_{1} \cup \mathrm{~A}_{2}\right)\right\}=\mathrm{P}\left\{\left(\mathrm{A}_{3} \cap \mathrm{~A}_{1}\right) \cup\left(\mathrm{A}_{3} \cap \mathrm{~A}_{2}\right)\right\}\right.$

$$
=\mathrm{P}\left(\mathrm{~A}_{3} \cap \mathrm{~A}_{1}\right)+\mathrm{P}\left(\mathrm{~A}_{3} \cap \mathrm{~A}_{1}\right)+\mathrm{P}\left(\mathrm{~A}_{3} \cap \mathrm{~A}_{2}\right)-\mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{2} \cap \mathrm{~A}_{3}\right)
$$

(by theorem 2.2). thus

$$
\begin{aligned}
\mathrm{P}\left(\mathrm{~A}_{1} \cup \mathrm{~A}_{2} \cup \mathrm{~A}_{3}\right) & =\mathrm{P}\left(\mathrm{~A}_{1}\right)+\mathrm{P}\left(\mathrm{~A}_{2}\right)-\mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{2}\right)+\mathrm{P}\left(\mathrm{~A}_{3}\right) \\
- & \mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{3}\right)-\mathrm{P}\left(\mathrm{~A}_{2} \cap \mathrm{~A}_{3}\right)+\mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{2} \cap \mathrm{~A}_{3}\right)
\end{aligned}
$$

## Note:

$A_{1} \cup A_{2} \cup A_{3}$ is the event that at least one of them will occur.

## Definition 2.3

Two or more events are said to be exhaustive if their union equals the whole sample space. In other words, $\mathrm{A}_{1}, \mathrm{~A}_{2}, \ldots, \mathrm{~A}_{\mathrm{n}}$ are exhaustive events if

$$
P\left(A_{1} \cup A_{2} \cup \ldots \cup A_{n}\right)=1
$$

In other words it is certain that at least one of them will occur.

## Note:

1. $0 \leq \mathrm{P}(\mathrm{A}) \leq 1$
2. $P(\Omega)=1$.
3. For an sequence of mutually excusive events $\mathrm{A}_{1}, \mathrm{~A}_{2}, \ldots$

$$
P\left(\cup_{i=1}^{\infty} A_{i}\right)=\sum_{i=1}^{\infty} P\left(A_{i}\right) .
$$

## Examples:

2.5 A box contains 6 balls numbered 1 to 6 . A ball was drawn from the box at random. Find the probability that the number on the ball drawn was either 1,2 , or 6 .

## Solution

Let $A_{1}, A_{2}, A_{3}$ denote the events that the ball drawn was 1,2 and 6 respectively. $A_{1} \cup A_{2} \cup A_{3}$ denote the event the number on the ball drawn was either 1,2 or 6 . $\mathrm{A}_{1}, \mathrm{~A}_{2}$ and $\mathrm{A}_{3}$ are mutually exclusive events. Thus

$$
\begin{gathered}
\mathrm{P}\left(\mathrm{~A}_{1} \cup \mathrm{~A}_{2} \cup \mathrm{~A}_{3}\right)=\mathrm{P}\left(\mathrm{~A}_{1}\right)+\mathrm{P}\left(\mathrm{~A}_{2}\right)+\mathrm{P}\left(\mathrm{~A}_{3}\right) \\
=1 / 6+1 / 6+1 / 6=12 .
\end{gathered}
$$

2.6 Four fair dice are tossed once, what is the probability that the sum of the numbers on the four dice is 23 ?

## Solution

The possible outcomes to get 23 are

$$
(6,6,6,5),(5,6,6,6),(6,5,6,6),(6,6,5,6)
$$

The sample space $\Omega$ consists of $6^{4}$ elements.
Therefore, the probability that the sum of the numbers on the four dice is 23 is $4 / 6^{4}$.
2.7 If $\mathrm{P}\left(\mathrm{A}_{1}\right)=2 / 3, \mathrm{P}\left(\mathrm{A}_{1} \cap \mathrm{~A}_{2}\right)=1 / 4$ and $\mathrm{P}\left(\mathrm{A}_{1} \cup \mathrm{~A}_{2}\right)=5 / 6$, find $\mathrm{P}\left(\mathrm{A}_{2}\right)$.

## Solution

From the addition law of probability

$$
\mathrm{P}\left(\mathrm{~A}_{1} \cup \mathrm{~A}_{2}\right)=\mathrm{P}\left(\mathrm{~A}_{1}\right)+\mathrm{P}\left(\mathrm{~A}_{2}\right)-\mathrm{P}\left(\mathrm{~A}_{1} \mathrm{n}_{2}\right)
$$

We have
$\mathrm{P}\left(\mathrm{A}_{2}\right)=\mathrm{P}\left(\mathrm{A}_{1} \cup \mathrm{~A}_{2}\right) \mathrm{P}\left(\mathrm{A}_{1} \mathrm{nA}_{2}\right)-\mathrm{P}\left(\mathrm{A}_{1}\right)=5 / 6+1 / 4-2 / 3=5 / 12$.
2.8 Suppose a fair on is tossed three times, what is the probability that at least one head occurs?

## Solution

Let $\mathrm{A}_{1}$ be the event that the first toss lands heads, $\mathrm{A}_{2}$ the event that the second toss lands, and $\mathrm{A}_{3}$ the event that the third toss lands heads.
$A_{1} \cup A_{2} \cup A_{3}$ is the event that at least one head occurs.
We are required to compute $P\left(A_{1} \cup A_{2} \cup A_{3}\right)$ The complement of $A_{1} \cup A_{2} \cup A_{3}$ is $\mathrm{A}_{1}{ }^{\mathrm{c}} \mathrm{n}_{2}{ }^{\mathrm{c}} \mathrm{n}_{3}{ }^{\mathrm{c}}$. That is, the first does not land heads, the second does not and the third does not.

$$
\mathrm{A}_{1}{ }^{\mathrm{c}} \mathrm{n}_{2}{ }^{\mathrm{c}} \mathrm{nA}_{3}{ }^{\mathrm{c}}=\{\mathrm{T}, \mathrm{~T}, \mathrm{~T}\} .
$$

Thus

$$
\mathrm{P}\left(\mathrm{~A}_{1}{ }^{\mathrm{c}} \mathrm{n}_{2}{ }^{\mathrm{c}} \mathrm{nA}_{3}{ }^{\mathrm{c}}\right)=1 / 8
$$

Hence

$$
\mathrm{P}\left(\mathrm{~A}_{1} \cup \mathrm{~A}_{2} \cup \mathrm{~A}_{3}\right)=1-1 / 8=7 / 8
$$

2.9 If $\mathrm{A}_{1} \mathrm{CA}_{2}$, then $\mathrm{P}\left(\mathrm{A}_{1}\right) \leq \mathrm{P}\left(\mathrm{A}_{2}\right)$

$$
\mathrm{A}_{2}=\mathrm{A}_{1} \mathrm{U}\left(\mathrm{~A}_{2} / \mathrm{A}_{1}\right) .
$$

Since $A_{1}$ and $A_{2} / A_{1}$ are mutually exclusive, we have

$$
\mathrm{P}\left(\mathrm{~A}_{2}\right)=\mathrm{P}\left(\mathrm{~A}_{1}\right)+\mathrm{P}\left(\mathrm{~A}_{2} / \mathrm{A}_{1}\right) \geq \mathrm{P}\left(\mathrm{~A}_{1}\right)
$$

Since $P\left(A_{2} / A_{1}\right) \geq 0$.
2.9 If $\mathrm{A}_{1}, \mathrm{~A}_{2}, \ldots, \mathrm{~A}_{\mathrm{n}}$ are n events, then

$$
P\left(\cup_{i=1}^{n} A_{1}\right)^{c}=P\left(\cup_{i=1}^{n} A_{1}^{c}\right)
$$

From de Morgan's law, we have

$$
\left(\cup_{i=1}^{n} A_{1}\right)^{c}=\cap_{i=1}^{n} A_{1}^{c}
$$

hence

$$
P\left(\cup_{i=1}^{n} A_{1}\right)^{c}=P\left(\cup_{i=1}^{n} A_{1}^{c}\right)
$$

### 2.2 Conditional Probability

The conditional probability of an event A given that an event B has occurred is denoted as $\mathrm{P}(\mathrm{A} \mid \mathrm{B})$. the word "given" is represented by the upright stroke. We wish to determine
the probability that an event A will occur "conditional on" the knowledge that another event B has occurred.

Suppose a fair die is rolled and it is known that an even number appeared uppermost. Let A be the event that the number was greater than 3 and $B$ the event that the number that appeared was even. The problem is to find the conditional probability that the event A occurred given that the event B has occurred, $\mathrm{P}(\mathrm{A} \mid \mathrm{B})$. since we know that the number was even, the number must be either 2,4 or 6 . Therefore, the conditional sample space contains 3 elements. The event $A$ occurs if the number showing is 4 or 6 , thus

$$
\mathrm{P}(\mathrm{~A} \mid \mathrm{B})=2 / 3 .
$$

We can therefore define conditional probability of A given Bas the number of ways AnB can occur divided by number of elements in the conditional sample space. That is,

$$
P(A \mid B)=\frac{n(A \cap B}{n \Omega_{B}},
$$

Where $n \Omega_{B} \neq 0$, where $\Omega_{\mathrm{B}}$ is the condtional sample space given that B has occurred.
Divide the numerator and denominator by $\mathrm{n} \Omega$
$P(A \mid B)=\frac{\frac{n(A \cap B)}{m \Omega_{B}}}{\frac{n B}{m \Omega_{B}}}=\frac{P(A \cap B}{P(B)}$.
In the above example,

$$
\begin{aligned}
& \mathrm{n}(\mathrm{~A} \cap \mathrm{~B})=2 \\
& \mathrm{n}(\mathrm{~B})=3
\end{aligned}
$$

## Definition 2.4

Let $A$ and $B$ be two events such that $\mathrm{P}(\mathrm{B})>0$. Then the conditional probability of A given $B$, denoted by $P(A \mid B)$ is defined to be $P(A \mid B)=\frac{P(A \cap B)}{P(B)} \quad 2.2$

## Examples

2.11 Suppose a box contains 4 red balls and 3 black balls. Compute the probability that
(i) the second ball drawn is red if the first ball drawn was red; without replacement,
(ii) the second ball drawn is red if the first ball drawn was black

## Solution

If the first ball drawn is red, there remains 6 balls, 3 red balls and 3 black balls. The probability of the second ball being red is $\frac{3}{6}=\frac{1}{2}$. But if the first ball is black, the box is left with 4 red and 2 black so the probability of the second ball being red is then $4 / 6=2 / 3$. Thus

$$
\begin{aligned}
& \mathrm{P}\left(2^{\text {nd }} \text { is re/first was red }\right)=3 / 6 /=1 / 2 \\
& \mathrm{P}\left(2^{\text {nd }} \text { is red } / \text { first was black }\right)=4 / 6=2 / 3 .
\end{aligned}
$$

This shows that the probability of the event "the second ball drawn is red" depends on the colour of the first ball drawn.
2.12 Suppose two fair dice are rolled. If the sum of the numbers appearing is 6 , what is the probability that one of the number is 2 ?

## Solution

Let $A$ be the event "one of the numbers is and $B$ the sum is 6 . there are five ways for the event B to occur: $(3,3),(2,4),(4,2),(5,1)$ and $(1,5)$ and there are two ways for the event AnB to occur: $(2,4)$ and $(4,2)$.

Thus,

$$
P(A \cap B)=2 / 36, P(B)=5 / 36
$$

Hence,

$$
P(A I B)=\frac{P(A \cap B)}{P(B)}=2 / 5 .
$$

2.13 There are two children in a family. If there is at least a girl in this family, what is the conditional probability that both are girls.

## Solution

The sample space is

$$
\Omega=\{B B, G B, B G, G G\}
$$

Let A be the event "both children are girls and B "a least a girl in the family.

$$
\begin{gathered}
\mathrm{B}=\{\mathrm{GB}, \mathrm{BG}, \mathrm{GG}\}, \mathrm{A}=\{\mathrm{GG}\}, \mathrm{A} \cap \mathrm{~B}=\{\mathrm{GG}\} . \\
\mathrm{P}(\mathrm{~A} \mid \mathrm{B})=\frac{P(A n B)}{P(B)}=\frac{1 / 4}{3 / 4}=\frac{1}{3} .
\end{gathered}
$$

2.14 There are three children in a family. If there is at least one boy and at most two boys in this family. What is the conditional probability that there are exactly two boys in this family.

The sample space is

$$
\Omega=\{\mathrm{BBB}, \mathrm{BBG}, \mathrm{BGG}, \mathrm{BGB}, \mathrm{GBB}, \mathrm{GBG}, \mathrm{GGB}, \mathrm{GGG}\}
$$

Let B be the event "at least one boy and at most 2 boys in the family" and let A be the event "exactly two boys in the family". Then

$$
\begin{gathered}
B=\{B B G, B G G, B G B, G B B, G B G . G G B\} \\
A \cap B=\{B B G, B G B, G B B\} .
\end{gathered}
$$

Therefore

$$
\mathrm{P}(\mathrm{~A} \mathrm{I} \mathrm{~B})=\frac{P(A n B)}{P(B)}=\frac{3 / 8}{6 / 8}=\frac{3}{6}=\frac{1}{2} .
$$

## Exercises 2.1

1. A fair die is thrown twice.
(i) If it is known that the sum of the numbers appearing was 8 , what is the probability that the difference between the two numbers was 2 .
(ii) If it is known that the difference the two numbers was 3 , what is the probability that the sum of the two numbers was 7 ?
2. Two unbiased dice are thrown once. What is the probability that
(i) at least one 5 is thrown.
(ii) the sum is 10
(iii) the sum is 10 given that no 5 is thrown?
3. $\quad$ Suppose events A and B are sun that $\mathrm{P}(\mathrm{A})=1 / 5, \mathrm{P}(\mathrm{AnB})=1 / 6$.

### 2.3 Bayes Theorem

suppose a box contains r red balls and b black balls. Two balls are drawn at random without replacement. Assume that the probability of drawing any particular ball is $\frac{1}{r+b}$. Let $A_{1}$ be the event "the first ball drawn is red and let $A_{2}$ be the event" the second ball drawn is red. Then

$$
\begin{gathered}
P\left(A_{1}\right)=\frac{r}{r+b}, P\left(A_{2} \mathrm{I} A_{1}\right)=\frac{r-1}{r+b-1} \\
P\left(A_{2} \mathrm{I} A_{1}^{c}\right)=\frac{r}{r+b-1}
\end{gathered}
$$

The probability of the event $\mathrm{A}_{2}$ depends on $\mathrm{A}_{1}$ and $\mathrm{A}_{1}{ }^{\mathrm{c}}$.
That is $\mathrm{A}_{2}$ is equivalent to $\mathrm{A}_{2} \mathrm{nA} \mathrm{A}_{1} \cap \mathrm{~A}_{1}{ }^{\mathrm{C}}$

$$
\mathrm{A}_{2}=\mathrm{A}_{1} \cap \mathrm{~A}_{2} \text { or } \mathrm{A}_{1}^{\mathrm{c}} \cap \mathrm{~A}_{2}
$$

Therefore,

$$
\mathrm{P}\left(\mathrm{~A}_{2}\right)=\mathrm{P}\left(\mathrm{~A}_{2} \cap \mathrm{~A}_{1}\right)+\mathrm{P}\left(\mathrm{~A}_{2} \cap \mathrm{~A}_{1}^{\mathrm{c}}\right)=\mathrm{P}\left(\mathrm{~A}_{1}\right) \mathrm{P}\left(\mathrm{~A}_{1}\right) \mathrm{P}\left(\mathrm{~A}_{2} \mathrm{I} \mathrm{~A}_{1}\right)+\mathrm{P}\left(\mathrm{~A}_{1}{ }^{\mathrm{c}}\right) \mathrm{P}\left(\mathrm{~A}_{2} \mathrm{I} \mathrm{~A}_{1}{ }^{\mathrm{c}}\right) .
$$

Theorem 2.3

If the probability of an event B , depends on k mutually exclusive and exhaustive events $A_{1}, A_{2}+\ldots+A_{k}$, then

$$
\begin{aligned}
\mathrm{P}(\mathrm{~B})= & \mathrm{P}\left(\mathrm{~B} \cap \mathrm{~A}_{1}\right)+\mathrm{P}\left(\mathrm{~B} \cap \mathrm{~A}_{2}\right)+\ldots+\mathrm{P}\left(\mathrm{~B} \cap \mathrm{~A}_{\mathrm{k}}\right) \\
& =\sum_{i=1}^{k} P\left(B \cap \mathrm{~A}_{1}\right)=\sum_{i=1}^{k} P\left(A_{1}\right) P\left(B \mathrm{I} A_{1}\right)
\end{aligned}
$$

## Example 2.15

Suppose a box contains 3 red balls, 2 black balls and 5 green balls. Two balls are drawn at random without replacement. Find the probability that the second ball drawn is red. Let $A_{1}$ be the event "the first ball drawn is red $\mathrm{A}_{2}$ the event the first ball drawn is black and
$A_{3}$, the event "the first ball drawn is green. Let B be the event "the second ball drawn is red. The event $B$ occurs if
(i) the first ball is red and the second is red or
(ii) the first ball is black and the second is red or
(iii) the first ball is green and the second is red.

Thus

$$
\left.\begin{array}{c}
\mathrm{B}=\mathrm{B} \cap \mathrm{~A}_{1} \text { or } \mathrm{B} \cap \mathrm{~A}_{2} \text { or } \mathrm{B} \cap \mathrm{~A}_{3}, \mathrm{P}\left(\mathrm{~B} \mathrm{I} \mathrm{~A} \mathrm{~A}_{1}\right)=2 / 9, \mathrm{P}\left(\mathrm{~B} \mathrm{I} \mathrm{~A}_{2}\right)=3 / 9, \\
\mathrm{P}(\mathrm{~B} \mathrm{I} \mathrm{~A}
\end{array}\right)=3 / 9 .
$$

$\mathrm{P}(\mathrm{B})$ depends on $\mathrm{A}_{1}, \mathrm{~A}_{2}, \mathrm{~A}_{3}$ which are mutually and exhaustive events. Therefore,

$$
\left.\begin{array}{rl}
\mathrm{P}(\mathrm{~B})= & \mathrm{P}\left(\mathrm{~B} \cap \mathrm{~A}_{1}\right)+\mathrm{P}\left(\mathrm{~B} \cap \mathrm{~A}_{2}\right)+\mathrm{P}\left(\mathrm{~B} \cap \mathrm{~A}_{3}\right) \\
& =\mathrm{P}\left(\mathrm{~A}_{1}\right) \mathrm{P}(\mathrm{BI} \mathrm{~A}
\end{array}\right)+\mathrm{P}\left(\mathrm{~A}_{2}\right) \mathrm{P}\left(\mathrm{BI} \mathrm{~A} \mathrm{~A}_{2}\right)+\mathrm{P}\left(\mathrm{~A}_{3}\right) \mathrm{P}\left(\mathrm{BI} \mathrm{~A} \mathrm{~A}_{3}\right)=3 / 10.2 / 9+2 / 10.3 / 9+
$$

5/10.3/9
since $\mathrm{P}\left(\mathrm{A}_{1}\right)=3 / 10, \mathrm{P}\left(\mathrm{A}_{2}\right)=2 / 10, \mathrm{P}\left(\mathrm{A}_{3}\right)=5 / 10$.

Thus

$$
P(B)=1 / 90(6+6+15)=27 / 90=3 / 10
$$

## Example 2.16

Suppose a factory has three machines $\mathrm{M}_{1}, \mathrm{M}_{2}, \mathrm{M}_{3}$ which produce $60 \%, 30 \%$ and $10 \%$ of the total production respectively. Of their output, machine $\mathrm{M}_{1}$ produces $2 \%$ defective items, machine $\mathrm{M}_{2}$ produce $3 \%$ defective items while machine $\mathrm{M}_{3}$ produces $4 \%$ defective items. Find the probability that a part selected at random is defective.

Let B be the event "a part selected at random is defective". A defective item could have been produced by either machine $\mathrm{M}_{1}, \mathrm{M}_{2}$ or $\mathrm{M}_{3}$. Thus

$$
B=\left(B \cap M_{1}\right) U\left(B \cap M_{2}\right) U\left(B \cap M_{3}\right)
$$

Since ( $B \cap M_{1}$ ), ( $B \cap M_{2}$ ), ( $B \cap M_{3}$ ) are mutually exclusive events. The following information is contained din the equation.

$$
\begin{aligned}
& \mathrm{P}\left(\mathrm{M}_{1}\right)=60 \%=0.6, \mathrm{P}\left(\mathrm{M}_{2}\right)=0.3, \mathrm{P}\left(\mathrm{M}_{3}\right)=0.1 \\
& \mathrm{P}\left(\mathrm{~B} \mid \mathrm{M}_{1}\right)=0.02, \mathrm{P}\left(\mathrm{~B} \mid \mathrm{M}_{2}\right)=0.03, \mathrm{P}\left(\mathrm{~B} \mid \mathrm{M}_{3}\right)=0.04
\end{aligned}
$$

Hence

$$
\begin{aligned}
\mathrm{P}(\mathrm{~B})= & \mathrm{P}\left(\mathrm{M}_{1}\right) \mathrm{P}\left(\mathrm{~B} \mid \mathrm{M}_{1}\right)+\mathrm{P}\left(\mathrm{M}_{2}\right) \mathrm{P}\left(\mathrm{~B} \mid \mathrm{M}_{2}\right)+\mathrm{P}\left(\mathrm{~B} \mid \mathrm{M}_{3}\right) \mathrm{P}\left(\mathrm{M}_{3}\right) \\
& =(0.6 \times 0.02)+(0.3 \times 0.03)+(0.1 \times 0.04)=0.002+0.009+0.004=0.025 .
\end{aligned}
$$

suppose you are now asked, what is the probability that a given defective part was produced by machine $M_{1}$. that is, you are to find $P\left(M_{1} \mid B\right)=P$ (a part was produced by machine $\mathrm{M}_{1}$ given that the part was defective).

NOTE:

1. $\quad P\left(M_{1} \mid B\right) \neq P\left(B \mid M_{1}\right)$, but
2. $P\left(\mathrm{M}_{1} \mathrm{nB}\right)=\mathrm{P}\left(\mathrm{BnM}_{1}\right)$

$$
\mathrm{P}(\mathrm{~B})=\sum_{i=1}^{3} P\left(M_{1} n B\right)
$$

hence,

$$
\mathrm{P}\left(\mathrm{M}_{1} \mid \mathrm{B}\right)=\frac{P\left(M_{i} n B\right)}{\sum_{i=1}^{3} P\left(M_{i} n B\right)}=\frac{P\left(M_{i}\right) P\left(B \mid \mathrm{M}_{\mathrm{i}}\right)}{\sum_{i=1}^{3} P\left(M_{i}\right) P\left(B \mid \mathrm{M}_{\mathrm{i}}\right)}
$$

Thus,

$$
\begin{aligned}
& \mathrm{P}\left(\mathrm{M}_{1} \mid \mathrm{B}\right)=\frac{0.6 \times 0.02}{0.025}=\frac{0.012}{0.025}=0.48 \\
& \mathrm{P}\left(\mathrm{M}_{2} \mid \mathrm{B}\right)=\frac{0.3 \times 0.03}{0.025}=\frac{0.009}{0.025}=0.36 \\
& \mathrm{P}\left(\mathrm{M}_{3} \mid \mathrm{B}\right)=\frac{0.1 \times 0.04}{0.025}=\frac{0.004}{0.025}=0.16
\end{aligned}
$$

Equation (2.4) is an example of Bayes theorem which may be stated as follows.

Bayes Theorem

If $\mathrm{A}_{1}, \mathrm{~A}_{2}, \ldots \mathrm{~A}_{\mathrm{k}}$ are set of mutual exclusive and exhaustive events in a sample space $\Omega$ and $B$ is any other event in $\Omega$ such that $\mathrm{P}(\mathrm{B})>0$, then

$$
\mathrm{P}\left(\mathrm{~A}_{\mathrm{i}} \mid \mathrm{B}\right)=\frac{P\left(A_{i}\right) P\left(B \mid \mathrm{A}_{\mathrm{i}}\right)}{\sum_{i=1}^{k} P\left(A_{i}\right) P\left(B \mid \mathrm{A}_{\mathrm{i}}\right)} ; i=1,2, \ldots, k
$$

Example 2.17

Suppose a college is composed of $70 \%$ male and $30 \%$ female students. It is known that $40 \%$ of the male students and $20 \%$ of the female students smoke cigarette. Find the probability that a student observed smoking a cigarette is male?

Let M,F denote male and female respectively and S denotes smoker. The above problem contains the following information.
$\mathrm{P}(\mathrm{M})=\mathrm{P}(\mathrm{A}$ student selected at random is male $)=0.7$
$\mathrm{P}(\mathrm{F})=\mathrm{P}(\mathrm{A}$ student selected at random is female $)=0.3$
$\mathrm{P}(\mathrm{S} \mid \mathrm{M})=\mathrm{P}($ a student selected at random smokes given that the selected student is male $)=$ 0.4
$P(S \mid F)=P(a$ student selected at random smokes given that the selected student is female $)$
$=0.2$

By Bayes theorem, we have
$\mathrm{P}(\mathrm{M} \mid \mathrm{S})=\mathrm{P}($ a student observed smoking is male $)$
$=\mathrm{P}(\mathrm{A}$ student selected at random is male given that the selected student is a smoker)

$$
=\frac{P(M n S)}{P(S)}
$$

Where $\mathrm{P}(\mathrm{S})=\mathrm{P}($ a student selected at random is a smoker $)$

$$
\begin{aligned}
& =P(S \cap M)+P(S \cap F)=P(M) P(S \mid F) \\
& =(0.7 \times 0.4)+(0.3 \times 0.2)=0.28+0.06=0.34
\end{aligned}
$$

Thus

$$
\mathrm{P}(\mathrm{M} \mid \mathrm{S})=\frac{P(M) P(S \mid \mathrm{M})}{P(S)}=\frac{0.7 \times 0.4}{0.34}=\frac{0.28}{0.34}=\frac{14}{17} .
$$

Example 2.18
A table has drawers. Drawer 1 contains two red and five black biros, drawer II contains four red and three black biros and drawer III contains one red and six black biros. A drawer is chosen at random and a biro is chosen from the drawer. Find the probability that
(i) the biro chosen is black
(ii) the biro chosen is from drawer I if the chosen biro is black.

Solution

Let $\mathrm{P}(\mathrm{i})$ denote the probability that drawer I is selected ( $\mathrm{I}-1,2,3$ ) and R and B representing red and black biros respectively.

Then

$$
\begin{array}{r}
\mathrm{P}(1)=1 / 3, \mathrm{P}(2)=1 / 3, \mathrm{P}(3),=1 / 3 \\
\mathrm{P}(\mathrm{~B} \mid 1)=5 / 7, \mathrm{P}(\mathrm{~B} \mid 2)=3 / 7, \mathrm{p}(\mathrm{~B} \mid 3)=6 / 7
\end{array}
$$

From equation (2.3)
(i) $\quad \mathrm{P}(\mathrm{B})=\mathrm{P}(\mathrm{Bn} 1)+\mathrm{P}(\mathrm{Bn} 2)+\mathrm{P}(\mathrm{Bn} 3)=\mathrm{P}(1) \mathrm{P}(\mathrm{B} \mid 1)+\mathrm{P}(2) \mathrm{P}(\mathrm{B} \mid 2)+\mathrm{P}(3) \mathrm{P}(\mathrm{B} \mid 3)$

$$
=1 / 3 \cdot 5 / 7+1 / 3 \cdot 3 / 7+1 / 3 \cdot 6 / 7=1 / 3(5 / 7+3 / 7+6 / 7)=2 / 3 .
$$

(ii) $\quad \mathrm{P}(1 \mid \mathrm{B})=\mathrm{P}($ the biro chosen came from drawer 1 given that the chosen biro is black).

$$
=\frac{P(1 \cap B)}{P(B)}=\frac{P(B \cap 1)}{P(B)}=\frac{P(1) P(B \mathrm{I} 1)}{P(B)}=\frac{\frac{1}{3} \cdot \frac{5}{7}}{\frac{2}{3}}=\frac{5}{14}
$$

## Definition 2.5

Let $\mathrm{A}, \mathrm{B}$ and C be three events such that $\mathrm{P}(\mathrm{C})>0$. then the conditional probability of A $\cup B$ given $C$ is defined by

$$
\mathrm{P}(\mathrm{~A} \cup \mathrm{~B} \mid \mathrm{C})=\mathrm{P}(\mathrm{~A} \mid \mathrm{C})+\mathrm{P}(\mathrm{~B} \mid \mathrm{C})-\mathrm{P}(\mathrm{~A} \cap \mathrm{~B} \mid \mathrm{C}) .
$$

## Exercise 2.2

1. Suppose that a box contains 5 balls labeled 1 to 5 . two balls are drawn at random (one after the other without replacement).

What is the probability that
(i) the sum of the numbers on the two balls selected is even?
(ii) The number on the first ball drawn is even if it is know that the sum of the two numbers is even.
2. In a large population, it is observed that 30 percent of the people that are black have caner and 25 percent of the people are not black have cancer. Assume that 10 percent of the population is black. What is the probability that a person selected at random and found to have cancer is not black.
3. A vaccine produces immunity against smallpox in 98 percent of cases.

Suppose that, in a large population, 20 percent have been vaccinated. Find the probability that a person who contracts smallpox has been vaccinated, assuming that a vaccinated person without immunity has the same probability of contracting smallpox as an unvaccinated person.
4. In a factory machines $A, B, C$ produce respectively 20,30 and 50 percent of the total production. Of their output $3,4,5$ percent respectively are defective items. An item is drawn at random from the total production and is found defective. What are the probability that it was produced by machine $\mathrm{A}, \mathrm{B}, \mathrm{C}$ ?
5. In a faculty of a certain college, $60 \%$ of the students are female: $20 \%$ of the females and $50 \%$ of the male are studying mathematics. If a student data card is selected at random and the student is found to be studying mathematics, what is the probability that the selected student is a male?
6. In JAMB examination each question has 5 possible answers, exactly one of which is correct. If a student knows the answer he selects the correct answer. Otherwise he selects one answer at random from the 5 possible answers. Suppose that the student knows the answer to $70 \%$ of the questions.
(i) What is the probability that on a given question the student gets the correct answer?
(ii) If the student gets the correct answer to a question, what is the probability that he knows the answer?
(iii) what is the expected score of the student in the examination?
7. A television set retailer finds out that $80 \%$ of this customers buy coloured T.V., and that 4 out of every 20 customers who buy coloured T.V set also buy antenna. Calculate the probability that:
(i) a randomly selected customer buys antenna
(ii) a randomly selected customers who buys antenna has bought a colored T.V
(iii) a randomly selected customer who has not bought an antenna has bought a colored T.V set.
8. In a factory, machines $\mathrm{A}, \mathrm{B}$ and C produce 20,30 and 40 percent of the total output, respectively. Of their output 5,4 and 3 percent respectively are defective bolts. A bolt is chosen at random and found to be defective. What is the probability that the bolt came from machine (i) A (ii) B (iii) C?
9. Four percent of an article manufactured by a company are defective. All the articles produced are regularly inspected and those found defective are rejected. It is found that one out of every eight of defective article produced is missed by the inspector, while every good article passes inspection. What is the probability that a customer buys a defective article produced by the company?

### 2.4 Independence

The notion of independence is a basic tool of probability theory. Consider tossing a die twice, and let $A_{1}$ be the event that the first toss gives an even number and $A_{2}$ the event that the second toss gives an even number. The event $A_{1} \cap A_{2}$ is the event that both tosses give even numbers. The occurrence of $\mathrm{A}_{1}$ does affect the probability of $\mathrm{A}_{2}$ occurring.

Therefore

$$
\mathrm{P}\left(\mathrm{~A}_{2} \mid \mathrm{A}_{1}\right)=\mathrm{P}\left(\mathrm{~A}_{2}\right) \text { and } \mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{2}\right)=\mathrm{P}\left(\mathrm{~A}_{1}\right) \mathrm{P}\left(\mathrm{~A}_{2} \mid \mathrm{A}_{1}\right)=\mathrm{P}\left(\mathrm{~A}_{1}\right) \mathrm{P}\left(\mathrm{~A}_{2}\right) .
$$

Hence, we say that two events $\mathrm{A}_{1}$ and $\mathrm{A}_{2}$ are independent if

$$
\mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{2}\right)=\mathrm{P}\left(\mathrm{~A}_{1}\right) \mathrm{P}\left(\mathrm{~A}_{2}\right) .
$$

## Example 1.19

Toss a fair die twice and let A be the event "the first toss shows 3 " and B be the event the sum of the two numbers showing is 7 .

$$
\begin{gathered}
\mathrm{P}(\mathrm{~A})=\frac{1}{6^{2}} \\
\mathrm{~B} \equiv\{(1,6),(6,1),(2,5),(3,4),(4,3),(5,2)\} \\
\mathrm{P}(\mathrm{~B})=\frac{3}{36}=\frac{1}{6} \\
A \cap B \equiv(\text { the first is } 3 \text { and sum is } 7)=\{(3,4)\}
\end{gathered}
$$

Therefore,

$$
\mathrm{P}(\mathrm{~A} \cap \mathrm{~B})=\frac{1}{36}
$$

Thus $\mathrm{P}(\mathrm{A} \cap \mathrm{B})=\mathrm{P}(\mathrm{A}) \mathrm{P}(\mathrm{B})$ hence, A and B are independent events.
In general case of $n$ events, we have the following definition.

## Definition 2.6

The events $\mathrm{A}_{1}, \mathrm{~A}_{2}, \ldots \mathrm{~A}_{\mathrm{n}}$ are independent if
(i) $P\left(A_{i} \cap A_{j}\right)=P\left(A_{i}\right) P\left(A_{j}\right)$ for all $I \neq j$
(ii) $P\left(A_{i} \cap A_{j} \cap A_{k}\right)=P\left(A_{i}\right) P\left(A_{j}\right) P\left(A_{k}\right)$ for all $I, j$, $k$ such that $i \neq j \neq k$ (2.7)
$(\mathrm{n}-1) \mathrm{P}\left(\mathrm{A}_{1} \cap \mathrm{~A}_{2} \cap \mathrm{~A}_{3} \ldots \mathrm{~A}_{\mathrm{n}}\right)=\mathrm{P}\left(\mathrm{A}_{1} \mathrm{P}\left(\mathrm{A}_{2}\right) \mathrm{P}\left(\mathrm{A}_{3}\right) \ldots \mathrm{P}\left(\mathrm{A}_{\mathrm{n}}\right)\right.$
That is, the events $A_{1}, A_{2}, \ldots A_{n}$ are said to be mutually independent if

$$
\mathrm{P}\left(\mathrm{~A}_{\mathrm{n} 1} \mathrm{~A}_{\mathrm{n} 2} \ldots \mathrm{~A}_{\mathrm{nk}}\right)=\mathrm{P}\left(\mathrm{~A}_{\mathrm{n} 1}\right) \mathrm{P}\left(\mathrm{~A}_{\mathrm{n} 2}\right) \ldots \mathrm{P}\left(\mathrm{~A}_{\mathrm{nk}}\right)
$$

For every subsequence of two or more events.
$A_{n 1}, A_{n 2} \ldots A_{n k}$ is a subsequence of $A_{1}, A_{2} \ldots A_{n}$ if the subscript integers satisfy
$1 \leq \mathrm{n}_{1}<\mathrm{n}_{2} \ldots \mathrm{n}_{\mathrm{k}} \leq \mathrm{n}$.
If $\mathrm{n}=3$, we have, $\mathrm{A}_{1}, \mathrm{~A}_{2}, \mathrm{~A}_{3}$ are independent if
(i) $\quad \mathrm{P}\left(\mathrm{A}_{1} \cap \mathrm{~A}_{2}\right)=\mathrm{P}\left(\mathrm{A}_{1}\right) \mathrm{P}\left(\mathrm{A}_{2}\right)$
$\mathrm{P}\left(\mathrm{A}_{1} \cap \mathrm{~A}_{3}\right)=\mathrm{P}\left(\mathrm{A}_{1}\right) \mathrm{P}\left(\mathrm{A}_{3}\right)$
$\mathrm{P}\left(\mathrm{A}_{2} \cap \mathrm{~A}_{3}\right)=\mathrm{P}\left(\mathrm{A}_{2}\right) \mathrm{P}\left(\mathrm{A}_{3}\right)$
(ii) $\quad \mathrm{P}\left(\mathrm{A}_{1} \cap \mathrm{~A}_{2} \cap \mathrm{~A}_{3}\right)=\mathrm{P}\left(\mathrm{A}_{1}\right) \mathrm{P}\left(\mathrm{A}_{2}\right) \mathrm{P}\left(\mathrm{A}_{3}\right)$

Condition (i) is called pairwise independent. We might think that pairwise independence always implies independence. But this is not necessarily so, as illustrated by the following example.

Example 2.20
Let a pair of fair dice be rolled once. Consider the events. $\mathrm{A}_{1}$ number appearing on the first die is even, $\mathrm{A}_{2}=$ the number appearing on the second die is odd $=\{1,3,5\}$ and $\mathrm{A}_{3}=$ the difference of the two numbers is even

$$
\begin{aligned}
\mathrm{A}_{1} \equiv & \{(2,1),(2,2),(2,3),(2,4),(2,5),(2,6),(4,1),(4,2), \ldots,(6,1),(6,2), \ldots\} \\
\mathrm{A}_{2} \equiv & \{(1,1),(1,3),(1,5),(2,1),(2,3),(2,5),(3,1), \ldots\} \\
\mathrm{A}_{3} \equiv & \{(1,1),(1,3),(1,5),(2,2),(2,4),(2,6),(3,1),(3,3),(3,5),(4,2),(4,4), \\
& (4,6),(5,1),(5,3),(5,5),(6,2),(6,4),(5,6)\}
\end{aligned}
$$

$$
A_{1} \cap A_{2} \equiv\{(2,1),(2,3),(2,5),(4,1),(4,3),(4,5),(6,1),(6,3),(6,5)\}
$$

$$
A_{2} \cap A_{3} \equiv\{(1,1),(1,3),(1,5),(3,1),(3,3),(3,5),(5,1),(5,3),(5,5)
$$

$$
\mathrm{A}_{1} \cap \mathrm{~A}_{2} \cap \mathrm{~A}_{3}=\Phi .
$$

Thus

$$
\begin{gathered}
\mathrm{P}\left(\mathrm{~A}_{1}\right)=1 / 2, \mathrm{P}\left(\mathrm{~A}_{2}\right)=1 / 2,\left(\mathrm{P}\left(\mathrm{~A}_{3}\right)=1 / 2\right. \\
\mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{2}\right)=\frac{9}{36}=\frac{1}{4}, \mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{2}\right)=\frac{1}{4}, \mathrm{P}\left(\mathrm{~A}_{2} \cap \mathrm{~A}_{3}\right)=\frac{1}{4}
\end{gathered}
$$

$$
\mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{2}\right)=\mathrm{P}\left(\mathrm{~A}_{1}\right) \mathrm{P}\left(\mathrm{~A}_{2} ; \mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{3}\right)=\mathrm{P}\left(\mathrm{~A}_{1}\right) \mathrm{P}\left(\mathrm{~A}_{3}\right) ; \mathrm{P}\left(\mathrm{~A}_{2} \cap \mathrm{~A}_{3}\right)=\mathrm{P}\left(\mathrm{~A}_{2}\right) \mathrm{P}\left(\mathrm{~A}_{3}\right)\right.
$$

That is, $\mathrm{A}_{1}, \mathrm{~A}_{2}, \mathrm{~A}_{3}$ are pairwise independent but

$$
\mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{2} \cap \mathrm{~A}_{3}\right)=0 \neq \mathrm{P}\left(\mathrm{~A}_{1}\right) \mathrm{P}\left(\mathrm{~A}_{2}\right) \mathrm{P}\left(\mathrm{~A}_{3}\right)=\frac{1}{8}
$$

Since condition (ii) is not satisfied, we conclude that $\mathrm{A}_{1}, \mathrm{~A}_{2}$ and $\mathrm{A}_{3}$ are not independent.

## Definition 2.7

If the events $A_{1}, A_{2, \ldots} . . A_{n}$ are independent then

\end{equation*}
$$

Example 2.21
A man fires 10 shots independently at a target. What is the probability that he hits the target (i) 10times; (ii) at least once

If he has probability $1 / 3$ of hitting the target on any given shot.
(i) Let $\mathrm{A}_{i}$ be the event "he hits the target at the ith shot" $(\mathrm{I}=1,2,3, \ldots 10)$

$$
\mathrm{A}_{1} \cap \mathrm{~A}_{2} \cap \ldots \cap \mathrm{~A}_{10} \text { is the event he hits the target } 10 \text { times } \mathrm{A}_{1}, \mathrm{~A}_{2}, \ldots \mathrm{~A}_{10} \text { are }
$$ independent events.

Therefore, the probability of hitting the target 10 times is

$$
\mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{2} \cap \ldots, \cap \mathrm{~A}_{10}\right)=\mathrm{P}\left(\mathrm{~A}_{1}\right) \mathrm{P}\left(\mathrm{~A}_{2}\right) \ldots \mathrm{p}\left(\mathrm{~A}_{10}\right)=\frac{1}{3}, \frac{1}{3} \ldots \frac{1}{3}=\left(\frac{1}{3}\right)^{10}
$$

(ii) $\quad \mathrm{P}$ (hitting the target at least once $)=1-\mathrm{P}($ not hitting the target at all $)$.
$\mathrm{P}($ not hitting the target at all $)=\mathrm{P}\left(\mathrm{A}_{1} \cap \mathrm{~A}_{2} \cap \ldots \cap \mathrm{~A}_{10}\right)$
Where, $\mathrm{A}_{\mathrm{i}} \equiv$ not hitting the target at the ith shot. $\mathrm{A}_{1}, \mathrm{~A}_{2}, \ldots, \mathrm{~A}_{10}$ are independent events and $P\left(A_{i}\right)=1-\frac{1}{3}=\frac{2}{3}$.

Hence

$$
\mathrm{P}\left(\overline{\mathrm{~A}}_{1} \cap \overline{\mathrm{~A}}_{2} \cap \ldots \cap \overline{\mathrm{~A}}_{10}\right)=\mathrm{P}\left(\overline{\mathrm{~A}}_{1}\right) \mathrm{P}\left(\overline{\mathrm{~A}}_{2}\right) \ldots \mathrm{P}\left(\overline{\mathrm{~A}}_{10}\right)=\frac{2}{3} \cdot \frac{2}{3} \ldots \frac{2}{3}=\left(\frac{2}{3}\right)^{10} .
$$

Examples
2.22 Suppose a box contains 5 red and 3 black balls. A ball is chosen at random from the box and then a second ball is drawn at random from the remaining balls in the box. Find the probability that
(i) both balls are black
(ii) both balls are red
(iii) the first ball is black and the second is red
(iv) the second is red
(v) the second is black.

## Solution

Let $\mathrm{A}_{1}$ be the event "the first ball is red
$\overline{\mathrm{A}}_{1}$ be the event "the first ball is black
$\overline{\mathrm{A}}_{2}$ be the event "the second ball is red
$\overline{\mathrm{A}}_{2}$ be the event "the second ball is black
(i) $\quad \mathrm{P}($ both balls are black $)=\mathrm{P}\left(\overline{\mathrm{A}}_{1} \cap \overline{\mathrm{~A}}_{2}\right)$

$$
\begin{aligned}
& \left.\mathrm{P}\left(\overline{\mathrm{~A}}_{1} \cap \overline{\mathrm{~A}}_{2}\right)=\mathrm{P}\left(\overline{\mathrm{~A}}_{1}\right) \mathrm{P}\left(\overline{\mathrm{~A}}_{2}\right) \mid \overline{\mathrm{A}}_{1}\right) \\
& \mathrm{P}\left(\overline{\mathrm{~A}}_{1}\right)=\frac{3}{8^{2}} \mathrm{P}\left(\overline{\mathrm{~A}}_{2} \mid \overline{\mathrm{A}}_{1}\right)=\frac{2}{7}
\end{aligned}
$$

Thus

$$
\mathrm{P}\left(\overline{\mathrm{~A}}_{1} \cap \overline{\mathrm{~A}}_{2}\right)=\frac{3}{8} \times \frac{2}{7}=\frac{3}{28}
$$

(ii) $\quad \mathrm{P}($ both balls are red $)=\mathrm{P}\left(\mathrm{A}_{1} \cap \mathrm{~A}_{2}\right)$

$$
\begin{aligned}
& \left.\mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{2}\right)=\left.\mathrm{P}\left(\mathrm{~A}_{1}\right) \mathrm{P}\left(\mathrm{~A}_{2}\right)\right|_{\mathrm{A}_{1}}\right) \\
& \mathrm{P}\left(\mathrm{~A}_{1}\right)=\frac{5}{8^{\prime}} \mathrm{P}\left(\mathrm{~A}_{2} \mid \mathrm{A}_{1}\right)=\frac{4}{7}
\end{aligned}
$$

Thus

$$
\mathrm{P}\left(\mathrm{~A}_{1} \cap \mathrm{~A}_{2}\right)=\frac{5}{8} \times \frac{4}{7}=\frac{5}{14}
$$

(iii) $\quad \mathrm{P}\left(\mathrm{A}_{1} \cap \mathrm{~A}_{2}\right)=\mathrm{P}($ first ball is black and the second ball is red $\left.)=\mathrm{P}\left(\overline{\mathrm{A}}_{1}\right) \mathrm{P}\left(\overline{\mathrm{A}}_{2}\right) \overline{\mathrm{A}}_{1}\right)$

$$
\mathrm{P}\left(\overline{\mathrm{~A}}_{1}\right)=\frac{3}{g^{\prime}} \mathrm{P}\left(\mathrm{~A}_{2} \mid \overline{\mathrm{A}}_{1}\right)=\frac{5}{7}
$$

Thus

$$
\mathrm{P}\left(\overline{\mathrm{~A}}_{1} \cap \mathrm{~A}_{2}\right)=\frac{3}{8} \times \frac{5}{7}=\frac{15}{56} .
$$

(iv) $\quad \mathrm{P}\left(\mathrm{A}_{2}\right)=\mathrm{P}\left(\mathrm{A}_{2} \cap \mathrm{~A}_{1}\right)+\mathrm{P}\left(\mathrm{A}_{2} \cap \overline{\mathrm{~A}}_{1}\right)$

From (ii) and (iii) we have

\frac{5}{14}+\frac{15}{56}=\frac{35}{56}=\frac{5}{8}
$$

(v) $\mathrm{P}\left(\overline{\mathrm{A}}_{2}\right)=\mathrm{P}\left(\mathrm{A}_{1} \cap \overline{\mathrm{~A}}_{2}\right)+\mathrm{P}\left(\overline{\mathrm{A}}_{1} \cap \overline{\mathrm{~A}}_{2}\right)=\frac{5}{8} \cdot \frac{3}{7}+\frac{3}{28}=\frac{3}{8}$.
2.23 Two fair dice are rolled. Given that the dice show different numbers, what is the probability that at least one die shows a 6 ?

## Solution

Let A be the event: the dice show different numbers.
$\mathrm{A} \equiv\{(1,2),(2,1),(1,3),(3,1),(1,4),(4,1),(1,5),(5,1),(1,6),(6,1)$,

$$
(2,3), \ldots(5,6),(6,5)
$$

$B \equiv$ At least one die show a 6 .

$$
\equiv\{(1,6),(6,1),(2,6),(6,2),(3,6),(6,3),(4,6),(6,4),(5,6),(6,5)\}
$$

$A \cap B=\{(1,6),(6,1),(2,6),(6,2),(3,6),(6,3),(4,6),(6,4),(5,6),(6,5)\}$

$$
\mathrm{P}(\mathrm{~B} \mid \mathrm{A})=\frac{10}{30}=\frac{1}{3}
$$

2.24 Let A and B be any two events defined on the same sample space. Suppose $\mathrm{P}(\mathrm{A})=$ 0.3 and $P(A \cup B)=0.6$. Find $P(B)$ such that
(i) A and B are independent
(ii) A and B are mutually exclusive.

## Solution

(i) If A and B are independent, then $\mathrm{P}(\mathrm{A} \cap \mathrm{B})=\mathrm{P}(\mathrm{A}) \mathrm{P}(\mathrm{B})$

Thus

$$
\mathrm{P}(\mathrm{~A} \cup \mathrm{~B})=\mathrm{P}(\mathrm{~A})+\mathrm{P}(\mathrm{~B})-\mathrm{P}(\mathrm{~A}) \mathrm{P}(\mathrm{~B})
$$

We have

$$
0.6=0.3+\mathrm{P}(\mathrm{~B})-0.3 \mathrm{P}(\mathrm{~B})=0.3+0.7 \mathrm{P}(\mathrm{~B})
$$

$$
\mathrm{P}(\mathrm{~B})=\frac{0.3}{0.7}=0.43
$$

(ii) If A and B are mutually exclusive, then

$$
\mathrm{P}(\mathrm{~A} \cap \mathrm{~B})=0
$$

Thus

$$
\begin{array}{r}
\mathrm{P}(\mathrm{~A} \cup \mathrm{~B})=\mathrm{P}(\mathrm{~A})+\mathrm{P}(\mathrm{~B}) \\
0.6=0.3+\mathrm{P}(\mathrm{~B}) \\
\mathrm{P}(\mathrm{~B})=0.3
\end{array}
$$

2.25 Two women A, and B share an office with a single telephone. The probability that any call will be for A is $\frac{2}{3}$. Suppose that A is out of her office during the office hours half of the time and B one third. Find the probability that forany call during the working hours
(i) no one is in to answer the call
(ii) A call can be answered by the person being called
(iii) Two successive calls are for the same woman
(iv) A caller who wants A has to try more than two times to get her.

## Solution

(i) $\mathrm{P}(\mathrm{A}$ and B are not in the office $)=\frac{1}{2} \cdot \frac{1}{3}=\frac{1}{6}$.
(ii) $\mathrm{P}(\mathrm{A}$ call can be answered by the person being called)
$=\mathrm{P}($ call for A and A is in the office $)+\mathrm{P}($ call for B and B is in the office $)$
$=\frac{2}{3} \cdot \frac{1}{2}+\frac{1}{3} \cdot \frac{2}{3}=\frac{5}{9}$
(iii) $\mathrm{P}($ for AA$)+\mathrm{P}($ for BB$)=\frac{2}{3} \cdot \frac{2}{3}+\frac{1}{3} \cdot \frac{1}{3}=\frac{5}{9}$.
(iv) $\quad \mathrm{P}(\mathrm{X}>2)=1-\mathrm{P}(\mathrm{X}=1)-\mathrm{P}(\mathrm{X}=2)$.

Where X number of time for a caller who wants A has to try to get her. Thus,

$$
P(X>2)=1-\left(\frac{2}{3} \cdot \frac{1}{2}\right)-\left(1-\frac{2}{3} \cdot \frac{1}{2}\right)\left(\frac{2}{3} \cdot \frac{1}{2}\right)=1-\frac{1}{3}-\frac{2}{9}=\frac{4}{9} .
$$

## UNIT THREE DISCRETE RANDOM VARIABLES

### 3.1 Introduction

This chapter introduces idea of a random variable and its probability density function. A random variable is a variable whose actual numerical value is determined by chance. There are two easily identifiable types of random variables, discrete and continuous. A discrete variable is one that takes only a limited number of possible values, otherwise the variable is called continuous. This chapter is devoted to discrete random variables.

Section 3.2-3.4 are devoted to some special discrete random variables. Bernoulli, Binomial Poisson, uniform,Geometric and negative bionmial.

## Example 3.1

Consider variable X , the number of heads in three tosses of a coin. There are four possible values ( $0,1,2,3$, of X .

The actual value assumed is due to chance therefore X is a random variable. The sample space for this experiment is

$$
\Omega=\{\text { HHH, HHT }, \text { HTH, THH, HTT, THT, TTH, TTT }\}
$$

$\mathrm{X}=0$ if the outcome is TTT
$\mathrm{X}=1$ if the outcomes is HTT, or THT, or TTH
$\mathrm{X}=2$ if the outcome is HHT or HTH or THH
$\mathrm{X}=3$ if the outcome is HHH
Let $p$ be the probability of the con landing tail. Since landing tail and landing head are exhaustive events the probability of the coin landing head is 1-p.

$$
\mathrm{P}(\mathrm{~T} \cap \mathrm{~T} \cap \mathrm{~T})=\mathrm{P}(\mathrm{~T}) \mathrm{P}(\mathrm{~T}) \mathrm{P}(\mathrm{~T})
$$

Since the outcome at each trials are independent.

$$
\mathrm{P}(\mathrm{TTT})=\mathrm{p} \cdot \mathrm{p} \cdot \mathrm{p}=\mathrm{P}^{3}
$$

$$
\begin{aligned}
& \mathrm{P}(\mathrm{HTH})=\mathrm{P}(\mathrm{~T}) \mathrm{P}(\mathrm{H}) \mathrm{P}(\mathrm{H})=\mathrm{p}(1-\mathrm{P})(1-\mathrm{P})=(1-\mathrm{P})^{2} \\
& \mathrm{P}(\mathrm{HTH})=\mathrm{P}(\mathrm{H}) \mathrm{P}(\mathrm{H}) \mathrm{P}(\mathrm{H})=(1-\mathrm{P})(1-\mathrm{P})=\mathrm{P}(1-\mathrm{P})^{2} \\
& \mathrm{P}(\mathrm{HHT})=\mathrm{P}(\mathrm{H}) \mathrm{P}(\mathrm{H}) \mathrm{P}(\mathrm{~T})=(1-\mathrm{P})(1-\mathrm{P}) \mathrm{P}==(1-\mathrm{P})^{2}
\end{aligned}
$$

The probability of getting two heads $=P($ THH $)+\mathrm{P}(\mathrm{HTH})+\mathrm{P}($ HHT $)=3 \mathrm{P}(1-\mathrm{p})^{2}$ Similarly we have

& \mathrm{P}(\mathrm{o} \text { head })=\mathrm{P}(\text { TTT })=\mathrm{p}^{3} \\

The random variable X defined above is an example of what is called a discrete random variable. A random variable is denoted by a capital letter such as $\mathrm{X} . \mathrm{Y}, \mathrm{Z} .$. and the values that the random variable takes on is denoted by a lower case letter $\mathrm{x}, \mathrm{y}, \mathrm{z} \ldots$
The notation $(P(X=x)$ means the probability that the random variable $X$ takes on the value x .

## Definition 3.1

A random variable X on a sample space $\Omega$ is a function assigns to each element $\Omega$ one and only one real number X()$=\mathrm{x}$, the space of X is the set of real number

$$
\Phi=\{\mathrm{x}: \mathrm{x}=\mathrm{x}(\mathrm{O}, \text { we } \Omega) .
$$

## Definition 3.2

A random variable x is discrete if t can assume at most a finite or a countable infinite number of possible values.

In the above example,

## Definition 3.3

The real valued function $f$ defined on $R$ by $f(x)=p(X=x)$ is called the discrete probability density function of X .
Let X be a discrete random variable and suppose that the values it can assume are $\mathrm{x}_{1}$, $\mathrm{X}_{2} \ldots, \mathrm{X}_{\mathrm{n}}$

The probability can be written as
$P\left(X=x_{1}\right)=f\left(x_{1}\right),=P\left(X=x_{2}\right)=f\left(x_{2}\right) \ldots, P\left(X=x_{n}\right)=f\left(x_{n}\right)$
Such that
$F(x)$ is calledprobability density function of $X$
For an illustration, let us consider the following examples.

## Example 3.2

Suppose a pair of fair dice is tossed onc, Let $\mathrm{X}, \mathrm{Y}, \mathrm{Z}$ represent the sum, maximum and minimum respectively of the two numbers appearing find the probability density function of
(i) X , (ii) Y , (iii) Z .

## Solution

The sample space $\Omega=\{(1,1),(1,2), \ldots,(6,6)\}$ consist of 36 elements
(i) $\quad \mathrm{P}(\mathrm{X}=2)=\mathrm{P}\{(1,1)\}=\frac{1}{36}$
$P(X=3)=P\{(1,2),(2,1)=\underline{2}$
$P(X=4)=P\{(1,3),(3,1),(2,2)\}=\underline{3}$

$$
P(X=12)=P\{(6,6)\}=\underline{1}
$$

Thus,

F(2)=\underline{1}, f(3)=\underline{2}, f(4)=\underline{3}--
$$

In tabular form we have

The probability density function of a discrete random variable X has the following properties
(i) $\mathrm{O} \leq \mathrm{f}(\mathrm{x}) \leq 1, \mathrm{x}$ ER
(ii) $\{X: f(x)=0\}$ is a finite or countable infinite subset of $R$
(iii) $\quad \sum \mathrm{f}\left(\mathrm{x}_{\mathrm{i}}\right)=1$

The above densities can be represented in terms of a diagram as illustrated in figure (a), (b) (c)



## Example 3.3

Let $\mathrm{X}, \mathrm{Y}, \mathrm{Z}$ be the random viable introduced in example 3.1 above
The above three properties are satisfied, properties (i) \& (ii) are immediate from definition of probabilities. To check (iii) we have

## Example3.5

A box contains 6 balls labeled 1, 2, 3, 4, 5, 6 two balls are drawn at random one after the other. Let X denote the larger of the two numbers on the balls selected, obtain the probability density function of $X$ if
(i) Sampling is without replacement (ii) Sampling is with replacement

## Solution

(i) The possible values of X are $2,3,4,5,6$. The larger of the two numbers can not be 1 since sampling is without replacement and we can not get same number twice.

$$
\begin{gathered}
\mathrm{P}(\mathrm{X}=2)=\mathrm{P}\{(1,2),(2,1)\}=\frac{4}{6.5} \\
\mathrm{P}(\mathrm{X}=3)=\mathrm{P}\{(1,3),(3,1),(2,3),(3,2)\}=\frac{4}{6.5} \\
\mathrm{P}(\mathrm{X}=5)=\mathrm{P}\{(1,5),(5,1),(2,5),(5,2),(3,5),(5,3),(5,4),(4,5)\}=\frac{8}{6.5}
\end{gathered}
$$

Similarly,

3.6 A couple decides that they will continue to have children until either they have a boy and a girl in the family or they have four children. Assuming that boys and girls are equally likely to be born. Let X denote the number of children in the family. Find the probability density function of X.

The number of children in the family can either be 2,3 , or 4 .

\mathrm{P}(\mathrm{X}=2)=\mathrm{P}\{(\mathrm{~B}, \mathrm{G}),(\mathrm{G}, \mathrm{~B})\}
$$

That is, the couple will stop having more children if the first child is a boy and the second of girl or the first is a girl and the second a boy.

Thus,

\left(\frac{1}{2} \times \frac{1}{2}\right)+\left(\frac{1}{2} \times \frac{1}{2}\right)=\frac{1}{2} .
\end{gathered}
$$

Similarly,

Probability Distribution function. Let X be a random variable with probability density function $f(x)$. The probability distribution function of $X$ denoted $f(x)$ is defined by

& =\Sigma_{y \leq x} f(y)
\end{aligned}
$$

## Properties of the Probability distribution function

1. $F$ is a non decreasing function, that is if $a<b$, then
$\mathrm{F}(\mathrm{a})<\mathrm{F}(\mathrm{b})$.
2. $\quad \lim \mathrm{F}(\mathrm{b})=1$.
b- -
$\lim F(b)=0$
b- $\infty$
3. $F$ is right continuous. That is $F(b+)=F(b)$.

Let $A$ be any subset of $R$ and let $f(x)$ be the probability density function of $X$. ew can compute $\mathrm{P}(\mathrm{X} \varepsilon \mathrm{A})$ by noting that $\{\mathrm{w}: \mathrm{X}(\mathrm{w}) \varepsilon \mathrm{A}\}$ is an event and that

Consider the random variable X the sum of the two numbers appearing when a fair die is tossed twice of Example 3.2. The probability distribution function for X is given by

Suppose we wish to find the probability that X is between 4 and 9 (4 and 9 inclusive) we write it as

& =\frac{3}{36}+\frac{4}{36}+\frac{5}{36}+\frac{6}{36}+\frac{5}{36}+\frac{4}{36}=\frac{27}{36}=\frac{3}{4}
\end{aligned}
$$

This can also be written as $\mathrm{P}(\mathrm{X} \leq 9)-\mathrm{P}(\mathrm{X} \leq 3)=\frac{30}{36}-\frac{3}{36}=\frac{27}{36}=\frac{27}{36}=\frac{3}{4}=\mathrm{F}(9)-\mathrm{F}(3)$

### 3.2 SPECIAL DISCRETE RANDOM VARIABLES

3.2.1 In Section 3.1 we introduced discrete random variables and the probability density function of some random variables were determined. Some variables are so common and important that names are given to them.

In this section we shall consider in considerable detail a number of important discrete random variables.

## Bernoulli Random variables

## Definition 3.4

## Bernoulli Trail:

A random trail or experiment is which the outcome can be classified into one of two mutually exclusive and exhaustive ways usually called success or failure is called a Bernoulli trail. The random variable associated with Bernoulli trail is called a Bernoulli random variable ( X ).let $\mathrm{X}=0$ if outcome is a failure and $\mathrm{X}=1$ if the outcome is a success. That is any variable assuming only two values is called a Bernoulli random variable.
Suppose that we toss a coin once. Let the probability of it landing head be $\mathrm{p} . \mathrm{p}=\frac{1}{2}$, if the coin is fair and let denote the outcome of the toss. Then there are two possible values for X, Heads or tails. These two values are mutually, exclusive and exhaustive and we may associate the two possible outcomes of the toss with values 1,0 of the random variables $X$. That $\mathrm{X}=1$ when a head appears and $\mathrm{X}=0$ when a tail appears.

$$
\mathrm{P}(\mathrm{X}=1)=\mathrm{p}, \mathrm{P}(\mathrm{X}=0)=1-\mathrm{p}
$$

The p.d.f. of X is

| X | 0 | 1 |
| :---: | :---: | :---: |
| $\mathrm{f}(\mathrm{x})$ | $1-\mathrm{p}$ | P |

Or in functional form

$$
\mathrm{F}(\mathrm{x})=\mathrm{p}^{\mathrm{x}}(1-\mathrm{p})^{1-\mathrm{x}}, \quad \mathrm{x}=0,1
$$

$0 \quad$ elsewhere
$f(x)$ as defined above is called the Bernoulli probability density function and any variable X having (3.1) has its probability density function is called a Bernoulli random variable and is said to have the Bernoulli distribution.

### 3.2.2 The Binomial Random Variable

This is one of the most important random variables in statistics and the most important discrete random variable. Consider n independent repetitions of Bernoulli trails. Let $\mathrm{X}_{\mathrm{i}}$, I $=1,2, \ldots, n$ be Bernoulli random variables associated with the trails. The random
variables $X_{1}, X_{2}, \ldots X_{n}$ are independent Bernoulli random variables. Let us assume the probability of success is p and failure 1-p and

$$
\mathrm{P}\left(\mathrm{x}_{1}=1\right)=\mathrm{p}
$$

Then, sum $S_{n}=+x_{2}+--+X_{n}$ is the number of successes in $n$ Bemoulli trials. That is, $S_{n}$ is a counting- variable counting the number of successes in n repeated trials. This random variable $S_{n}$ is called the Binomial random variable. The possible values of $S_{n}$ are $0,1,2$, $3,4,---$, $n$.
$\mathrm{P}\left(\mathrm{S}_{\mathrm{n}}=0\right)=\mathrm{p}($ no success $)$
$=\mathrm{p}(1$ sttrail is a failure $) \mathrm{P}\left(2^{\text {nd }}\right.$ trail is a failure $) \ldots \mathrm{P}($ nth trail is a failure $)$.
$=P\left(X_{1}=0\right) P\left(X_{2}=0\right) P\left(X_{3}=0\right) \ldots P\left(X_{n}=0\right)$
$=(!-p)(1-p)(1-p) \ldots(1-p)=(1-p)^{n}$.
$S_{n}$ is 1 if the sequence of outcome is

=\mathrm{P}\left(\mathrm{X}_{1}=1\right) \mathrm{P}\left(\mathrm{X}_{2}=0\right) \ldots \mathrm{P}\left(\mathrm{X}_{\mathrm{n}}=0\right)+\mathrm{P}\left(\mathrm{X}_{1}=0\right) \mathrm{P}\left(\mathrm{X}_{2}=1\right) \ldots \mathrm{P}\left(\mathrm{X}_{\mathrm{n}}=0\right)+\ldots+
$$

$$
+\mathrm{P}\left(\mathrm{X}_{1}=0\right) \ldots \mathrm{P}\left(\mathrm{X}_{\mathrm{n}}=1\right)
$$

$$
=P(1-p) \ldots(1-p)+(1-1) P(1-p) \ldots(1-p) \ldots(1-p)+(1-p)(1-p)
$$

$$
=P(1-p)^{n-1}+P(1-p)^{n-1}+\ldots+P(1-p)^{n-1}=n p(1-p)^{n-1}
$$

Similarly,

$$
P\left(S_{n}=2\right)={ }^{n} C_{2} P^{2}(1-p)^{n-2}
$$

Where ${ }^{n} C_{2}$ is the number of sequences in which exactly 2 have value 1 and the others 0 e.g. $(1,1,0,0,0,0,0, \ldots, 0),(1,0,1,0, \ldots, 0) \ldots$

In general, it can easily be seen that

$$
P\left(S_{n}=k\right)={ }^{n} C_{2} p^{k}(1-p)^{n-k}, k=0,1, \ldots, n
$$

Where ${ }^{n} C_{2}$ is the number of sequences in which exactly $k$ have value 1 and others 0 .
For example when $n=4$, possible sequences of outcomes are given below.

& \mathrm{P}\left(\mathrm{~S}_{\mathrm{n}}=0\right)=(1-\mathrm{p})^{4} \\
& \mathrm{P}\left(\mathrm{~S}_{\mathrm{n}}=1\right)=4 \mathrm{p}(1-\mathrm{p})^{3} \\
& \mathrm{P}\left(\mathrm{~S}_{\mathrm{n}}=2\right)=6 \mathrm{p}^{2}(1-\mathrm{p})^{2} \\
& \mathrm{P}\left(\mathrm{~S}_{\mathrm{n}}=3\right)=4 \mathrm{p}^{3}(1-\mathrm{p}) \\
& \mathrm{P}\left(\mathrm{~S}_{\mathrm{n}}=4\right)=\mathrm{p}^{4}
\end{aligned}
$$

Theorem 3.1
Let $\mathrm{S}_{\mathrm{n}}$ denote number of successes in n repeated Bernoulli trails, with probability of success $p$. the probability density function of $S_{n}$ is given by

\mathrm{f}(\mathrm{x})=\mathrm{P}\left(\mathrm{~S}_{\mathrm{n}}=\mathrm{x}\right)={ }^{\mathrm{n}} \mathrm{C}_{\mathrm{x}} \mathrm{p}^{\mathrm{x}}(1-\mathrm{p})^{\mathrm{n}-\mathrm{x}} \quad \mathrm{x}=0,1, \ldots, \mathrm{n} \tag{3.2}
\end{equation*}
$$

## Definition 3.5

A discrete random variable X denoting total number of successes in n trails is said to have the binomial distribution if

$$
\begin{gathered}
\mathrm{P}(\mathrm{X}=\mathrm{x})={ }^{\mathrm{n}} \mathrm{C}_{\mathrm{x}} \mathrm{p}^{\mathrm{x}}(1-\mathrm{p})^{\mathrm{n}-\mathrm{x}} ; \mathrm{x}=0,1,2, \ldots, \mathrm{n} \\
0 \leq \mathrm{p} \leq 1
\end{gathered}
$$

The conditions under which binomial distribution will arise are
(i) The number of trails is fixed
(ii) There are only two possible outcome 'success' or 'failure' at each trial.
(iii) The trails are independent
(iv) The probability p of success at each trail is constant
(v) The variable is the total number of successes in n trails.

Example 3.8
A soldier fires 10 independently at a target. Find the probability that he hits the target.
(i) once
(ii) at least 9 times
(iii) at most two times.

If he has probability 0.8 of hitting the target at any given time? Let X denote the number of times he hits the target. Then X is a binomial variable with $\mathrm{n}=10$ and $\mathrm{p}=0.8$
From equation (3.2), we have

$$
\mathrm{P}(\mathrm{X}=\mathrm{x})={ }^{10} \mathrm{C}_{\mathrm{x}}(0.8)^{\mathrm{x}}(0.2)^{10-\mathrm{x}}
$$

(i) $\quad \mathrm{P}(\mathrm{X}=1)={ }^{10} \mathrm{C}_{\mathrm{x}} 0.8(0.2)^{9}=8(0.2)^{9}$
(ii) $\quad \mathrm{P}($ He hits the target at least 9 times $)=\mathrm{P}(\mathrm{X} \geq 9)$

$$
\begin{gathered}
=\mathrm{P}(\mathrm{X}=9)+\mathrm{P}(\mathrm{X}=10) \\
\mathrm{P}(\mathrm{X}=9)={ }^{10} \mathrm{C}_{9}(0.8)^{9}(0.2)=10 \times(0.8)^{9} \times 0.2=2(0.8)^{9} \\
\mathrm{P}(\mathrm{X}=10)={ }^{10} \mathrm{C}_{10}(0.8)^{10}=(0.8)^{10}
\end{gathered}
$$

Hence,

$$
\mathrm{P}(\mathrm{X} \geq 9)=2(0.8)^{9}+(0.8)^{10}=(0.8)^{9}(2+0.8)=(0.8)^{9}(2.8)=0.3758
$$

(iii) $\mathrm{P}($ at most twice $)=\mathrm{P}(\mathrm{X} \leq 2)=\mathrm{P}(\mathrm{X}=1)+\mathrm{P}(\mathrm{X}=2)$

$$
\begin{aligned}
& \mathrm{P}(\mathrm{X}=0)=(0.2)^{10} ; \\
& \mathrm{P}(\mathrm{X}=1)=8(0.2)^{9} ; \\
& \mathrm{P}(\mathrm{X}=2)=45(0.8)^{2}(0.2)^{8}
\end{aligned}
$$

Thus,

$$
\mathrm{P}(\mathrm{X} \leq 2)=(0.2)^{10}+8(0.2)^{9}+45(0.8)^{2}(0.2)^{8}=0.00008
$$

## Example 3.9

A fair die is rolled four times. Find the probability of getting 2 sixes. Let us call a six a success on a toss of a die and let X be number of sixes (successes) in 4 trails. X is binomial random variable with $n=4$ and $p=1 / 6$. Thus,

$$
\mathrm{P}(\mathrm{X}=2)={ }^{4} \mathrm{C}_{2}\left(\frac{1}{6}\right)^{2}\left(\frac{5}{6}\right)^{2}=\frac{25}{216} .
$$

## Example 3.10

Suppose that a certain type of electric bulb has a probability of 0.3 of functioning more than 800 hours. Out of 50 bulbs, what is probability that less than 3 will function more than 800 hours. Let X be the number of bulbs functioning more than 800 hours. Assuming that X has a Binomial distribution,

$$
\begin{gathered}
\mathrm{P}(\mathrm{X}=\mathrm{x})=50 \mathrm{C}_{\mathrm{x}}(0.3)^{\mathrm{x}}(0.7)^{50-\mathrm{x}} \\
\mathrm{P}(\mathrm{X}<3)=\mathrm{P}(\mathrm{X}=0)+\mathrm{P}(\mathrm{X}=1)+\mathrm{P}(\mathrm{X}=2) \\
\mathrm{P}(\mathrm{X}=0)=(0.7)^{50} ; \mathrm{P}(\mathrm{X}=1)=50 .(0.3)(0.7)^{49} \\
\mathrm{P}(\mathrm{X}=2)={ }^{50} \mathrm{C}_{2}(0.3)^{2}(0.7)^{48} .
\end{gathered}
$$

Thus,

$$
\mathrm{P}(\mathrm{X}<3)=(0.7)^{50}+15(0.7)^{49}+110.25(0.7)^{48}=0.0000046
$$

### 3.3 Geometric Random Variable

Consider a Bernoulli trail with probability p of a success on one trail. The trail is continued until a success occurs. Let X denote number of trails before the first success. For example, a student decides to continue taking JAMB examination until he passes. X in this case denote number of times he takes the examination before the first success.
The probability that the first $\mathrm{x}-1$ trails are failures and the $\mathrm{x}^{\text {th }}$ trail is a success is given by

$$
(1-\mathrm{p})^{\mathrm{x}=1} \mathrm{p}
$$

To see this, the required probability is

$$
\mathrm{P}(\mathrm{~F} \mathrm{~F} \mathrm{~F} \ldots \mathrm{~F} S)=\mathrm{P}(\mathrm{~F}) \mathrm{P}(\mathrm{~F}) \ldots \mathrm{P}(\mathrm{~F}) \mathrm{P}(\mathrm{~S})=(1-\mathrm{p})(1-\mathrm{p})(1-\mathrm{p}) \ldots(1-\mathrm{p}) \mathrm{P}=(1-
$$ $\mathrm{p})^{\mathrm{x}-1} \mathrm{p}$.

The probability that $x$ trails are needed for the first success is the same as the probability that the first $\mathrm{x}-1$ trails are failures and the $\mathrm{x}^{\text {th }}$ is a success. Thus,

$$
P(X=x)=\left\{\begin{array}{cl}
P(1-p)^{x-1,} & x=1,2 \ldots \\
0 & \text { otherwise }
\end{array}\right.
$$

Where X is the number of trials before the first success and if we define Y as the number of failures preceding the first success, we have

$$
P(Y=y)=\begin{aligned}
&\left\{\begin{array}{rl} 
& \\
P(1-p)^{y} & y=0,1,2 \ldots
\end{array}\right. \\
& 0 \text { otherwise }
\end{aligned}
$$

Definition 3.6
A discrete random variable $X$ is called a $\left\{\begin{array}{l}\text { geometric random variable if its probability } \\ \text { density function is given by }\end{array}\right.$

$$
\mathrm{F}(\mathrm{x})=\mathrm{p}(\mathrm{X}=\mathrm{x})=\begin{gather*}
(1-\mathrm{p})^{\mathrm{x}-1} \mathrm{p} \\
0
\end{gather*} \begin{aligned}
& \mathrm{x}=1,2,3 \ldots \\
& 0  \tag{3.3}\\
& \\
& \\
& \\
& \\
& \\
&
\end{aligned}
$$

Where X is the number of independent Bernouilli trials taken for the first success to occur (the successful trial is included in the count). To see that ( $\mathrm{f}(\mathrm{x})$ is a probability density function, all that needed to be checked is that

$$
\sum_{x=1}^{\infty} \quad(1-\mathrm{p})^{\mathrm{x}=1}=1=\mathrm{P}\left[1+(1-\mathrm{p})+(1-\mathrm{p})^{2}+\ldots\right]
$$

From geometric series,

$$
\sum_{x=1}^{\infty} \quad(1-p)^{\mathrm{x}=1}=\frac{1}{1-(1-p)}=\frac{1}{p} .
$$

## Example 3.11

A fair is tossed until a head appears (a) What is the probability that three tosses are needed? (b) What is the probability that at most three tosses are needed?

## Solution

Let X denote the number of tosses until a success (a head) occurs. Since the coin is fair, $p=\frac{1}{2}$.

$$
\mathrm{P}(\mathrm{X}=3)=(1-\mathrm{p})^{3-1} p\left(\frac{1}{2}\right)^{2} \frac{1}{2}=\left(\frac{1}{2}\right)^{3}
$$

$\mathrm{P}($ at most three tosses are needed $)=\mathrm{P}(\mathrm{X} \leq 3)$

$$
\begin{aligned}
& =\mathrm{P}(\mathrm{X}=1)+\mathrm{P}(\mathrm{X}=2)+\mathrm{P}(\mathrm{X}=3) \\
& =\frac{1}{2}+\frac{1}{2} \cdot \frac{1}{2}+\left(\frac{1}{2}\right)^{2} \cdot \frac{1}{2}=\frac{1}{2}+\left(\frac{1}{2}\right)^{2}+\left(\frac{1}{2}\right)^{3}=\frac{7}{8} .
\end{aligned}
$$

3.12 A fair die is rolled until a six appears.

What is the probability that (i) at most 4 rolls are needed. (ii) at least 3 rolls are needed?

## Solution

(i) $\mathrm{P}($ at most 4 rolls are needed $)=\mathrm{P}(\mathrm{X} \leq 4)$

$$
=\mathrm{P}(\mathrm{X}=1)+\mathrm{P}(\mathrm{X}=2)+\mathrm{P}(\mathrm{X}=3)+\mathrm{P}(\mathrm{X}=4)
$$

X is a geometric random variable with $\mathrm{P}=\frac{1}{6}$

$$
\begin{gathered}
\mathrm{P}(\mathrm{X}=\mathrm{x})=\left(\frac{5}{6}\right)^{x 1} \frac{1}{6} \\
\mathrm{P}(\mathrm{X}=1)=\frac{1}{6}, \mathrm{P}(\mathrm{X}=2)=\frac{5}{6}, \frac{1}{6}, P(X=3)=\left(\frac{5}{6}\right)^{2} \cdot \frac{1}{6} \\
\mathrm{P}(\mathrm{X}=4)=\left(\frac{5}{6}\right)^{3} \cdot \frac{1}{6}
\end{gathered}
$$

Thus

$$
\begin{aligned}
\mathrm{P}(\mathrm{X} \leq 4) & =\frac{1}{6}+\frac{5}{6} \cdot \frac{1}{6}+\left(\frac{5}{6}\right)^{2} \cdot \frac{1}{6}+\left(\frac{5}{6}\right)^{3} \cdot \frac{1}{6} \\
& =\frac{1}{6} \sum_{x=1}^{4}\left(\frac{5}{6}\right)^{x=1}=\frac{1}{6} \cdot \frac{1-(5 / 6)^{4}}{1-5 / 6}=1-(5 / 6)^{4}
\end{aligned}
$$

(ii) $P($ at least 3 rolls are needed $)=P(X \geq 3)=P(X=3)+P(X=4)+\ldots$

$$
\mathrm{P}(\mathrm{X} \geq 3)=\sum_{x=3}^{\infty} f(x)=\sum_{x=3}^{\infty}\left(\frac{5}{6}\right)^{x=1} \frac{1}{6}=\frac{1}{6} \sum_{x=3}^{\infty}\left(\frac{5}{6}\right)^{x=1}=\frac{1}{6} \cdot \frac{1-(5 / 6)^{2}}{1-5 / 6}=\left(\frac{5}{6}\right)^{2}=\frac{25}{36}
$$

or

$$
\mathrm{P}(\mathrm{X} \geq 3)=1-\{\mathrm{P}(\mathrm{X}=1)+\mathrm{P}(\mathrm{X}=2)\}=1-\frac{11}{36}=\frac{25}{36}
$$

Example 3.13
The probability that a certain test yields a "positive" reaction is 0.6 . what is the probability that not more than 4 negative reactions occur before the first positive one?

## Solution

Let X denote the number of negative reactions before the first positive one, then

$$
\mathrm{P}(\mathrm{X}=\mathrm{x})=(0.4)^{\mathrm{x}}(0.6) ; \mathrm{x}=0,1,2, \ldots
$$

Thus,
$\mathrm{P}(\mathrm{X} \leq 4)=\sum_{0}^{4} P(X=x)=\sum_{x=0}^{4}(0.4)^{X}(0.6)=(0.6) \sum_{x=0}^{4}(0.4)^{x}=\left(1-(0.4)^{5}\right)=0.9898$
The geometric random variable has an interesting property which is summarized in the following theorem.

Theorem: 3.2
Suppose that X is a geometric random variable. Then for any given two positive integers s and t ,

$$
P(X>s+t \mid X>s)=P(X>t) .
$$

Proof:

$$
\begin{aligned}
& \mathrm{P}(\mathrm{X}>\mathrm{s}+\mathrm{t} \mid \mathrm{X}>\mathrm{s})=\frac{P(X>s+t \text { and } X>s)}{P(X>s)}=\frac{P(X>s+t}{P(X>s)} \\
& \mathrm{P}(\mathrm{X}=\mathrm{x})=\mathrm{p}(1-\mathrm{p})^{\mathrm{x}-1}, \mathrm{x}=1,2,3, \ldots \\
& \mathrm{P}(\mathrm{X}>\mathrm{s}+\mathrm{t})=\mathrm{P} \sum_{X=S+t+1}^{\infty}(1-p)^{X-1}=P \frac{(1-p)^{s+t}}{1-(1-p)}=(1-p)^{s+t} \\
& \mathrm{P}(\mathrm{X}>\mathrm{s}+\mathrm{t})=\mathrm{P} \sum_{S+1}^{\infty}(1-p)^{X-1}=\frac{P(1-p)^{s}}{1-(1-p)}=(1-p)^{s}
\end{aligned}
$$

Thus,

$$
\begin{array}{r}
\mathrm{P}(\mathrm{X}>\mathrm{s}+\mathrm{t} \mid \mathrm{X}>\mathrm{s})=\frac{(1-p)^{s+t}}{(1-p)^{s}}=(1-p)^{t} \\
\mathrm{P}(\mathrm{X}>\mathrm{t})=\sum_{t+1}^{\infty} p(1-p)^{X-1}=\frac{p(1-p)^{t}}{p}=(1-p)^{t} .
\end{array}
$$

Hence,

$$
P(X>s+t \mid X>s)=P(X>t) .
$$

The above theorem states that if a success has not occurred during the first s repetitions of Bernouli trails, then the probability that it will not occur during the next t repetitions is the same as the probability that it will not occur during the first t repetitions of Bernoulli trails. Therefore the distribution is said to have "no memory".

## Exercise 3.3

1. On a certain road the probability of an accident on any day is 0.05 (assuming not more than one accident can occur on any day). Assuming independence of accidents from day to day on this road, what is the probability that the first accident of the year occurs in the month of March.
2. A fair die is rolled until a six appears. Calculate the probability that he has to throw the die more than three times before he gets a six.
3. Let X be a geometric random variable with $\mathrm{p}=0.2$. Calculate the following probabilities. (i) $\mathrm{P}(3<\mathrm{x} \leq 6)$ (ii) $\mathrm{P}(2 \leq \mathrm{X} \leq 4)$ (iii) $\mathrm{P}(\mathrm{X} \leq 2)$.

### 3.13 Pascal or Negative Binomial Random variable

A probability distribution closely related to the geometric distribution is the Pascal or negative binomial distribution.
Suppose that independent repetition of Bernoulli trail needed to have "success" occurs exactly r times.
$X=x$ if and only if success occurs on the $x^{\text {th }}$ trail and success occurs exactly $(r-1)$ times in the previous $\mathrm{x}-1$ trails. The probability of this event is determined as follows:

The probability of $r-1$ successes in $x-1$ trails is given by the binomial formula

$$
{ }^{\mathrm{X}=1} \mathrm{C}_{\mathrm{r}-1} \mathrm{p}^{\mathrm{r}-1}(1-\mathrm{p})^{\mathrm{X}=1-(\mathrm{r}-1)=\mathrm{x}-1} \mathrm{C}_{\mathrm{r}-1}{ }^{\mathrm{r}-1}{ }_{(1-\mathrm{p})}^{\mathrm{x}-\mathrm{r}}
$$

Therefore, the probability of this event is

$$
\text { P. }{ }^{\mathrm{x}-1} \mathrm{C}_{\mathrm{r}-1} \mathrm{p}^{\mathrm{r}-1}(11-\mathrm{p})^{\mathrm{x}-\mathrm{r}+}
$$

hence,

$$
\begin{equation*}
f(x)=P(X=x)={ }^{x-1} C_{r-1} p^{r}(1-p)^{x-r}, x=r, r+1, \ldots \tag{3.4}
\end{equation*}
$$

Similarly, if we let $Y$ be the number of failures before the $r^{\text {th }}$ success we have

$$
\begin{gathered}
\mathrm{P}(\mathrm{Y}=\mathrm{y})=\mathrm{p} \cdot\left({ }^{\mathrm{y}+\mathrm{r}-1} \mathrm{C}_{\mathrm{y}} \mathrm{p}^{\mathrm{r}-1}(1-\mathrm{p})^{\mathrm{y}}\right. \\
\mathrm{F}_{\mathrm{Y}}(\mathrm{y})={ }^{\mathrm{y}+\mathrm{r}-1} \mathrm{C}_{\mathrm{y}}^{\mathrm{r}}(1-\mathrm{p})^{\mathrm{y}}, \mathrm{y}=0,1,2, \ldots
\end{gathered}
$$

## Definition 3.7

A random variable having its probability density function given by (3.4) or (3.5) is said to gave a Negative Binomial or Pascal distribution.

## Example 3.14

Show that $\sum_{X=r}^{\infty} \quad{ }^{x-1} C_{r-1} P^{r}(1-P)^{x-r}=1$.

## Solution

By Binomial theorem,

$$
\begin{gathered}
P^{-n}=\left(1-(1-p)^{-n}=\left\{1+n(1-p)+\frac{n(n+1)}{2!}(1-P)^{2}+\ldots\right\}\right. \\
\sum_{X=r}^{\infty} \quad{ }^{x-1} C_{r-1} P^{r}(1-P)^{x-r}=P^{r}(1-p)^{-r} \sum_{X=r}^{\infty} \quad(x-1) \\
C_{r-1}(1-P)^{x} \\
=p^{r}(1-p)^{-r}\left\{(1-p)^{r}+r(1-p)^{r+1}+\frac{r(r+1)}{2!}(1-p)^{r+2}+\cdots\right\} \\
=p^{r}\left\{1+r(1-p)+\frac{r(r+1)}{2!}(1-p)^{2}+\cdots\right\}=p^{r} p^{-r}=1 .
\end{gathered}
$$

## Example 3.15

A fair die is rolled until two sixes occurs, find the probability that
(i) exactly 5 tosses are needed
(ii) at most 5 tosses are needed.

## Solution

Let X be the number of tosses needed to get two sixes. X is a Pascal random variable with pdf:

$$
f(x)={ }^{x-1} C_{1} p^{2}(1-p)^{x-2}, x=2,3, . .
$$

Where $\mathrm{p}=1 / 2, \mathrm{r}=1$.

$$
f(x)=(x-1)\left(\frac{1}{2}\right)^{x}
$$

(i) $\quad P(X=5)-4\left(\frac{1}{2}\right)^{5}=0.125$
(ii) $\quad P(X \leq 5)=\sum_{x=2}^{5} f(x)=P(X=2)+P(X=3)+P(X=4)+P(X=5)$

$$
P(X=2)=\left(\frac{1}{2}\right)^{2}, P(X=3)=2\left(\frac{1}{2}\right)^{3}, P(X=4)=3\left(\frac{1}{2}\right)^{4}
$$

Thus,

$$
P(X \leq 5)=\frac{1}{4}+\frac{1}{4}+\frac{3}{16}+\frac{1}{8}=\frac{13}{16}=0.8125
$$

### 3.3.2 The Hyper geometric Random Variable

Suppose that we have a box containing $n$ items of which $\mathrm{n}_{1}$ are defective and $\mathrm{n}-\mathrm{n}_{1}$ are non-defective. Suppose that we choose at random k items from the box without replacement. Let X denote the number of defective items in the k items selected. Then

$$
\begin{equation*}
P(X=x)=\frac{n_{1} C_{x}{ }^{n-n_{1} C_{k}-x}}{{ }^{n} C_{x}}, x=0,1,2,3, \ldots k \tag{3.4}
\end{equation*}
$$

The reader will notice that $\mathrm{X}=\mathrm{x}$ if and only if we obtain x defective items from $\mathrm{n}_{1}$ defective items in the box ( ${ }_{1} \mathrm{C}_{\mathrm{x}}$ ways of doing this).
Any random variable having its probability density function as given by (3.5) is called hyper geometric random variable and is said to have hyper geometric distribution.

### 3.4 The Poisson Random Variable

## Definition: Rare Event

An event is said to be rare if the probability p of observing the event is very small.
Consider $n$ repeated Bernoulli trails, where $n$ is very large and $P$ very small, let $X$ be be the number of successes in $n$ trials. Then

$$
\mathrm{P}(\mathrm{X}=\mathrm{x})={ }^{\mathrm{n}} \mathrm{C}_{\mathrm{x}} \mathrm{p}^{\mathrm{x}}(1-\mathrm{p})^{\mathrm{n}-\mathrm{x}} .
$$

Setting $\lambda=\mathrm{n} \mathrm{p}$, we have

$$
\begin{aligned}
& P(X=x)={ }^{n} C_{x}\left(\frac{\lambda}{n}\right)^{x}\left(1-\frac{\lambda}{n}\right)^{n-x}=\frac{n(n-1) \ldots(n-x+1)}{x!} \cdot\left(\frac{\lambda}{n}\right)^{x}\left(1-\frac{\lambda}{n}\right)^{n-x} \\
& =\frac{n}{n} \cdot \frac{n-1}{n} \frac{(n-2)}{n} \ldots \frac{n-x+1}{n} \cdot \frac{\lambda^{X}}{X!}\left(1-\frac{\lambda}{n}\right)^{n-X}
\end{aligned}
$$

Now as n $\infty$.

1. $\left(1-\frac{\lambda}{n}\right)^{n} \rightarrow e^{-\lambda}$
2. $\left(1-\frac{\lambda}{n}\right)^{-x} \rightarrow 1$
3. $\frac{n-x+1}{n} \rightarrow 1$

Consequently,

$$
\lim _{n \rightarrow \infty} \quad{ }^{\mathrm{n}} \mathrm{C}_{\mathrm{x}} \mathrm{p}^{\mathrm{x}}(1-\mathrm{p})^{\mathrm{n}-\mathrm{x}}=\frac{\lambda}{x!} e^{-\lambda}
$$

(3.5) gives an approximation to the binomial distribution with $\lambda=\mathrm{np}$, when n is large and p is small, where $\mathrm{e}=2.71828$ is the base of natural logarithms.

Definition:
A random variable X is called a Poisson random variable if its probability density function is given by

$$
f(x)=\left\{\begin{array}{cc}
\overbrace{}^{\lambda t}(\lambda t)^{x}  \tag{3.8}\\
x! & x=0,1,2, \ldots \\
0 \text { otherwise } & (\lambda>0)
\end{array}\right.
$$

$X$ represents the total number of events which have occurred up to time $t$. When $t=1$ then $f(x)$ corresponds to the probability density function of number of events in a unit interval. For examples, the number of calls that come into a telephone exchange in a unit time interval, the number of vehicles passing through a designated point in a unit time interval. In order to motivate our discussion, let us consider the following examples.

Example 3.16
Suppose a rare disease occurs in 2 percent of a large population. A random sample of 10,000 people are chosen at random from this population and tested for the disease. Calculate the probability that at least two people have the rate disease.

## Solution

The probability p of having the disease is 0.02 and $\mathrm{n}=10,000$. Let X be the number of people having the disease. X is a binomial random variable with parameters $\mathrm{n}=10,000$ and $p=0.02$. we shall apply the result (3.5) since $n$ is large and $p$ very small.
Hence,

$$
\mathrm{Np}=0.02 \times 10,000=20,
$$

Thus,

$$
\begin{aligned}
& \mathrm{P}(\mathrm{X}=\mathrm{x})=\frac{e^{-200}(200)^{X}}{X!} \\
& \mathrm{P}(\mathrm{X}=)=\mathrm{e}^{-200} \\
& \mathrm{P}(\mathrm{X}=1)=200 \mathrm{e}^{-200}
\end{aligned}
$$

Hence

$$
P(X \geq 2)=1-P(X<2)=1-e^{-200}(1+200)=1-201 \mathrm{e}^{-200}
$$

## Example 3.17

On a given road, an average of five accidents occur every month. Calculate the probability that over a year period there will be (i) no accident (ii) at most 2 accidents.

## Solution

In this case, $\lambda=5, \mathrm{t}=12$. From (3.8) we have

$$
\begin{aligned}
& f(x)=\frac{e^{-\lambda t}(\lambda t)^{X}}{X!} \\
& f(0)=e^{-\lambda t}=\mathrm{e}^{-60} \\
& f(1)=\frac{e^{-\lambda t}(\lambda t)^{1}}{e^{-11}}=60 \mathrm{e}^{-60} \\
& f(2)=\frac{e^{-\lambda t}(\lambda t)^{2}}{2!}=\frac{60^{2}}{2} \mathrm{e}^{-60}
\end{aligned}
$$

thus,

$$
\mathrm{P}(\text { no accident })=\mathrm{f}(0)=\mathrm{e}^{-60}
$$

$P($ at most two accidents $)=f(0)+f(1)+f(2)=e^{-60}+60 e^{-60}+\frac{60^{2}}{2} e^{-60}$

$$
=\mathrm{e}^{-60}(1+60+1800)=1861 \mathrm{e}^{-60} .
$$

Tables for the Poisson distribution are available and brief abulation is given in the Appendix.

## UNIT FOUR

## EXPECTATION OF DISCRETE RANDOM VARIABLE

In this chapter we introduce the concept of the mean value of a random variable. It is closely related to the notion of weighted average. The moment and probability generating functions of a random variable are also introduced.

## 4.1

Let X be a random variable having possible values $\mathrm{x}_{1}, \mathrm{x}_{2}, \ldots, \mathrm{x}_{\mathrm{n}}$, and let the experiment on $X$ be performed $n$ times. For example let $X$ be the outcome of rolling a die. There are six possible values $x_{1}=1, x_{2}=2, x_{3}=3, x_{4}=4 . x_{5}=5$ and $x_{6}=6$. Suppose the die is rolled n times. The successive rolls constitute independent repetitions of the same experiment. Let $X_{1}, X_{2}, \ldots, X_{n}$ denote the outcomes of the experiment of rolling a die $n$ times (that is $X_{i}$ denote the outcome of the $\mathrm{i}^{\text {th }}$ toss). Then

$$
\bar{X}=\frac{X_{2}+X_{2}+\cdots+X_{n}}{n}
$$

Is the average of the numbers that appeared. Let $f_{i}$ denote the number of times $x_{i}$ occur. Then we have

$$
\frac{1}{n}\left(X_{1}+X_{2}+\cdots+X_{n}\right)=\frac{1}{n} \sum_{i=1}^{k} x_{i} f_{i}=\sum_{i=1}^{k} x_{i} \frac{f_{1}}{n}
$$

We know that $\lim _{n \rightarrow \infty} \frac{f_{i}}{n}=P\left(X=x_{i}\right)=f\left(x_{i}\right)$. When $\frac{f_{i}}{n}$ is replaced by $f\left(x_{i}\right)$, the sum $\sum x_{i} f\left(x_{i}\right)$ is called the expectation of the random variable X . thus the expected value of a random variable X is the long-run theoretical average value of X .

## Definition 1

Mathematical Expectation. Let X be a random variable with probability density function as follows:

| Value of $X, x$ | $x_{1}$ | $x_{2}$ | $x_{3}$ | $\ldots$. | $x_{k}$ |
| :--- | :--- | :--- | :--- | :--- | :--- |
| Probability | $f\left(x_{1}\right)$ | $f\left(x_{2}\right)$ | $f\left(x_{3}\right)$ |  | $f\left(x_{k}\right)$ |

The mathematical expectation of X , denoted by $\mathrm{E}(\mathrm{X})$, is defined to be

$$
\begin{array}{r}
\mathrm{E}(\mathrm{X})=\mathrm{x}_{1} \mathrm{f}\left(\mathrm{x}_{2}\right)+\mathrm{x}_{2} \mathrm{f}\left(\mathrm{x}_{2}\right)+\ldots+\mathrm{x}_{\mathrm{k}} \mathrm{f}\left(\mathrm{x}_{\mathrm{k}}\right) \\
\mathrm{E}(\mathrm{X})=\sum_{i=1}^{k} x_{i} f\left(x_{i}\right) .
\end{array}
$$

$\mathrm{E}(\mathrm{X})$ is weighted average of possible values of x , the weight attached to the value xi is its probability $\mathrm{f}\left(\mathrm{x}_{\mathrm{i}}\right) . \mathrm{E}(\mathrm{X})$ is also called the mean of X or the population mean.
We may express the result of (1) in words.
To compute the expected value or mean of a random variable, multiply each possible value of the variable by its probability and add these products.

## Examples

4.1 A fair coin is tossed three times. Let $X$ denote the number of heads obtained. Find the mathematical expectation of X.

## Solution

The probability density function of X is as follows.

| $X$ | 0 | 1 | 2 | 3 |
| :--- | :--- | :--- | :--- | :--- |
| $\mathrm{f}(\mathrm{x})$ | $\frac{1}{8}$ | $\frac{3}{8}$ | $\frac{3}{8}$ | $\frac{1}{8}$ |

Hence,

$$
\begin{aligned}
\mathrm{E}(\mathrm{X})= & (1 \times 1 / 8)+(1 \times 3 / 8)+(2 \times 3 / 8)+(3 \times 1 / 8) \\
= & 0+3 / 8+6 / 8+3 / 8=12 / 8=1.5
\end{aligned}
$$

4.2 What ate the mathematical expectations of the variables $\mathrm{X}, \mathrm{Y}$ and Z as defined in example 3.1.1 of chapter 3.

## Solution

The probability density function of X is

| X | 2 | 3 | 4 | 5 | 6 | 7 | 8 | 9 | 10 | 11 | 12 |
| :--- | :--- | :--- | :--- | :--- | :--- | :--- | :--- | :--- | :--- | :--- | :--- |
| $\mathrm{f}(\mathrm{x})$ | $1 / 36$ | $2 / 36$ | $3 / 36$ | $4 / 36$ | $5 / 36$ | $6 / 36$ | $5 / 36$ | $4 / 36$ | $3 / 36$ | $2 / 36$ | $1 / 36$ |

$$
E(X)=(2 \times 1 / 36)+(3 \times 2 / 36)+(4 \times 3 / 36)+(5 \times 4 / 36)+(6 \times 5 / 36)+(7 \times 6 / 36)+
$$

$$
\begin{aligned}
& (8 \times 5 / 36)+(9 \times 4 / 36)+(10 \times 3 / 36)+(11 \times 2 / 36)+(12 \times 1 / 36) \\
& =7.0
\end{aligned}
$$

The p.d.f of $Y$ is

| Y | 1 | 2 | 3 | 4 | 5 | 6 |
| :--- | :--- | :--- | :--- | :--- | :--- | :--- |
| $\mathrm{~g}(\mathrm{y})$ | $1 / 36$ | $3 / 36$ | $5 / 36$ | $7 / 36$ | $9 / 36$ | $11 / 36$ |

$$
\begin{aligned}
\mathrm{E}(\mathrm{Y})= & (1 \times 1 / 36)+(2 \times 3 / 36)+(3 \times 5 / 36)+(4 \times 7 / 36)+(5 \times 9 / 36)+(6 \times 11 / 36) \\
= & 4.47
\end{aligned}
$$

The p.d.f of Z is

| $Z$ | 1 | 2 | 3 | 4 | 5 | 6 |
| :--- | :--- | :--- | :--- | :--- | :--- | :--- |
| $h(Z)$ | $11 / 36$ | $9 / 36$ | $7 / 36$ | $5 / 36$ | $3 / 36$ | $1 / 36$ |

$$
\begin{aligned}
\mathrm{E}(\mathrm{Z})= & (1 \times 11 / 36)+(2 \times 9 / 36)+(3 \times 7 / 36)+(4 \times 5 / 36)+(5 \times 3 / 36)+(6 \times 1 / 36) \\
= & 2.53 .
\end{aligned}
$$

## Exercises 4.1

1. Suppose a box contains 10 balls of which 4 are red and 6 are black. A random sample of size 3 is selected. Let X denote the number of red balls selected. Find ( $\mathrm{E}(\mathrm{X})$ if
(i) Sampling is with replacement.
(ii) Sampling is without replacement.
2. A box contains 6 balls labeled 1, 2, 3, 4, 5, 6 . Two balls are drawn at random one after the other. Let X denote the larger of the two numbers on the balls selected. Compute $\mathrm{E}(\mathrm{X})$ if (i) Sampling is with replacement, (ii) Sampling is without replacement.
3. A box contains 3 balls and 2 white balls. A ball is without replacement one after the other until a white ball is drawn. Find the Expected number of draws required.

## Expectation of a Binomial Random Variable

The probability density function of a binomial variable X is defined by

$$
\mathrm{f}(\mathrm{x})={ }^{\mathrm{n}} \mathrm{C}_{\mathrm{x}} \mathrm{p}^{\mathrm{x}}(1-\mathrm{p})^{\mathrm{n}-\mathrm{x}} ; \mathrm{x}=0,1,2, \ldots, \mathrm{n} .
$$

the mean or expected value of $X$ is

$$
\mathrm{E}(\mathrm{X})=\sum_{x=0}^{n} x \quad{ }^{n} C_{x} p^{x}(1-p)^{n-x}=\sum_{x=0}^{n} x \cdot \frac{n!}{x!(n-x)!} p^{x}(1-p)^{n-x}
$$

and since the term of $x=0$ is zero,

$$
\mathrm{E}(\mathrm{X})=\sum_{x=1}^{n} \frac{n!}{(x-1)(n-X)!} p^{X}(1-p)^{n-x}=n p \sum_{x=1}^{n} \frac{(n-1)!}{(x-1)(n-X)!} p^{X-1}(1-p)^{n-x}
$$

Using the binomial theorem, we have

$$
\begin{gathered}
\sum_{x=1}^{n} \frac{(n-1)!}{(x-1)!(n-X)!} p^{X-1}(1-p)^{n-x}=\sum_{x=0}^{n-1}{ }^{n-1} C_{x} p^{x-1}(1-p)^{n-x} \\
=(p+(1-P))^{n-1}=1 \\
\text { since } \mathrm{p}+1-\mathrm{p}=1 . \text { Hence } \\
\mathrm{E}(\mathrm{X})=\mathrm{np} .
\end{gathered}
$$

## Example 4.3

A fair die is rolled 12 times, what is the expected number of six appear?

## Solution

Let X be the number of sixes that appear. X is a binomial random variable with $\mathrm{n}=12$ and $\mathrm{P}=1 / 6$ (probability of a six). Hence

$$
\mathrm{E}(\mathrm{X})=\mathrm{np}=12 \times 1 / 6=2
$$

That is, we expected to get 2 sixes when a die is rolled 12 times.

## Definition 2

Let X be a discrete random variable having probability density function $\mathrm{f}(\mathrm{x})$.
$\sum_{l=1}^{\infty} \mid X_{2} f\left(x_{i}\right)<\infty$, then we say that X has finite expectation otherwise we say that X does not have finite expectation.

## Examples

### 4.4 The Random Variables $X$ has Probability

| $X$ | -2 | -1 | 0 | 3 | 5 |
| :--- | :--- | :--- | :--- | :--- | :--- |
| $f(x)$ | $1 / 4$ | $1 / 8$ | $1 / 8$ | $1 / 4$ | $1 / 4$ |

Compute the expected value of the following random variables.
(i) X ,
(ii) 3 X ,
(iii) $\mathrm{X}+5$,
(iv) $\mathrm{X}^{2}$

## Solution

(ii) $\quad E x=\left(-2 x \frac{1}{4}\right)+\left(-1 x \frac{1}{8}\right)+\left(0 \times \frac{1}{8}\right)+\left(3 x \frac{1}{4}\right)+\left(5 x \frac{1}{4}\right)$

$$
=-2 / 4-1 / 8+3 / 4+5 / 4=11 / 8=1 \frac{3}{8}
$$

(iii) The possible values of 3 x are $-6,-3,0,9,15$.

The probability density function of $3 x$ is

| $3 x$ | -6 | -3 | 0 | 9 | 15 |
| :--- | :--- | :--- | :--- | :--- | :--- |
| $f(x)$ | $1 / 4$ | $1 / 8$ | $1 / 8$ | $1 / 4$ | $1 / 4$ |

$$
\begin{aligned}
\mathrm{E}(3 \mathrm{X}) & =(-6 \times 1 / 4)+(-3 \times 1 / 8)+(0 \times 1 / 8)+(9 \times 1 / 4)+(5 \times 1 / 4) \\
& =-6 / 4-3 / 8+9 / 4+15 / 4=33 / 8
\end{aligned}
$$

Note that

$$
P(3 X=-6)=P(X=-2,
$$

And so on and
$\mathrm{E}(3 \mathrm{X})=33 / 8=3 \times 11 / 8=3 \mathrm{E}(\mathrm{X})$
(iii)

| $x+5$ | 3 | 4 | 5 | 8 | 10 |
| :--- | :--- | :--- | :--- | :--- | :--- |
| $f(x)$ | $1 / 4$ | $1 / 8$ | $1 / 8$ | $1 / 4$ | $1 / 4$ |

Note that $P(X+5)=3=P(X=3-5)=P(X=-2)$
$\mathrm{E}(\mathrm{X}+5)=(3 \times 1 / 4)+(4 \times 1 / 8)+(5 \times 1 / 8)+(8 \times 1 / 4)+(10 \times 1 / 4)$
$=3 / 4+4 / 8+5 / 8+8 / 4+10 / 4+51 / 8=6 \frac{3}{8}=5+1 \frac{3}{8}=5+\mathrm{E}(\mathrm{X})$.
(iv)

| $X^{2}$ | 4 | 1 | 0 | 9 | 25 |
| :--- | :--- | :--- | :--- | :--- | :--- |
| $f(x)$ | $1 / 4$ | $1 / 8$ | $1 / 8$ | $1 / 4$ | $1 / 4$ |

$$
\begin{aligned}
\mathrm{E}\left(\mathrm{X}^{2}\right) & =(4 \times 1 / 4)+(1 \times 1 / 8)+(0 \times 1 / 8)+(9 \times 1 / 4)+(25 \times 1 / 4) \\
& =1+1 / 8+9 / 4+25 / 4=77 / 8=9 \frac{5}{8}
\end{aligned}
$$

Note that $\mathrm{E}\left(\mathrm{X}^{2}\right) \neq[\mathrm{E}(\mathrm{X})]^{2}$.

## Definition 3

Let X be a random variable whose probability density function is given by

| $x$ | $x_{1}$ | $x_{2}$ | $\ldots \ldots \ldots \ldots$ | $x_{k}$ |
| :--- | :--- | :--- | :--- | :--- |
| $f(x)$ | $f\left(x_{1}\right)$ | $f\left(x_{2}\right)$ |  | $f\left(x_{k}\right)$ |

Let $\psi(\mathrm{X})$ be a function of X . then the mean or expected value of the new random $\psi(\mathrm{X})$ is given by

$$
\mathrm{E}[\psi(\mathrm{X})]=\psi\left(\mathrm{x}_{1}\right) \mathrm{f}\left(\mathrm{x}_{1}\right)+\psi\left(\mathrm{x}_{2}\right) \mathrm{f}\left(\mathrm{x}_{2}\right)+\ldots+\psi\left(\mathrm{x}_{\mathrm{k}}\right) \mathrm{f}\left(\mathrm{x}_{\mathrm{k}}\right)
$$

That is

$$
\mathrm{E}[\psi(\mathrm{X})]=\sum_{i=1}^{k} \quad \psi\left(\mathrm{x}_{\mathrm{i}}\right) \mathrm{f}\left(\mathrm{x}_{\mathrm{i}}\right)
$$

Theorem 1
Let X be a random variable and let $\psi(\mathrm{X})=\mathrm{a} \mathrm{X}+\mathrm{b}$ where $\mathrm{a}, \mathrm{b}$ are constants, then

$$
\mathrm{E}(\psi(\mathrm{X}))=\mathrm{aE}(\mathrm{X})+\mathrm{b}
$$

## Proof:

Suppose the probability density function of X is

$$
\left\{\mathrm{x}_{\mathrm{i}}, \mathrm{f}\left(\mathrm{X}_{\mathrm{i}}\right), \mathrm{I}=1,2, \ldots, \mathrm{k}\right)
$$

From the above definition we have

$$
\begin{gathered}
\mathrm{E}(\mathrm{aX}+\mathrm{b})=\left(\mathrm{ax}_{1}+\mathrm{b}\right) \mathrm{f}\left(\mathrm{x}_{1}\right)+\left(\mathrm{ax}_{2}+\mathrm{b}\right) \mathrm{f}\left(\mathrm{x}_{2}\right)+\ldots+\left(\mathrm{ax}_{\mathrm{k}}+\mathrm{b}\right) \mathrm{f}\left(\mathrm{x}_{\mathrm{k}}\right)+\mathrm{bf}\left(\mathrm{x}_{1}\right)+\ldots+\mathrm{bf}\left(\mathrm{x}_{\mathrm{k}}\right) \\
=\mathrm{a}\left[\mathrm{x}_{1} \mathrm{f}\left(\mathrm{x}_{1}\right)+\mathrm{x}_{2} \mathrm{f}\left(\mathrm{x}_{2}\right)+\ldots \mathrm{x}_{\mathrm{k}} \mathrm{f}\left(\mathrm{x}_{\mathrm{k}}\right)\right]+\mathrm{b}\left[\mathrm{f}\left(\mathrm{x}_{1}\right)+\mathrm{f}\left(\mathrm{x}_{2}\right)+\ldots+\right. \\
\left.\mathrm{f}\left(\mathrm{x}_{\mathrm{k}}\right)\right]=\sum_{i=1}^{k} x_{i} f\left(x_{i}\right)+b \sum_{i=1}^{k} f\left(x_{i}\right)=a E(x)+b
\end{gathered}
$$

since $\left\{\mathrm{E}(\mathrm{X})=\Sigma x f(x), \Sigma f\left(x_{i}\right)=1\right\}$

## Properties of Excitations

1. If c is a constant and $\mathrm{P}(\mathrm{X}=\mathrm{c})=1$, then $\mathrm{E}(\mathrm{X})=\mathrm{c}$.
2. If $a$ and $b$ are constants and $X$ has a finite expectation, then $a X$ has finite expectation and
(i) $\mathrm{E}(\mathrm{aX})=\mathrm{aE}(\mathrm{X})+\mathrm{b}$.
(ii) $E(a X+b)=a E(X)+b$.
3. If X and Y are two random variables having finite expectations, then
(i) $\mathrm{X}+\mathrm{Y}$ has random finite expectation and $\mathrm{E}(\mathrm{X}+\mathrm{Y})=\mathrm{E}(\mathrm{X})+\mathrm{E}(\mathrm{Y})$
(ii) $\quad \mathrm{E}(\mathrm{X}) \geq \mathrm{E}(\mathrm{Y})$ if $\mathrm{P}(\mathrm{X} \geq \mathrm{Y})=1$.
(iii) $|\mathrm{EX}| \leq \mathrm{E}|\mathrm{X}|$.
4. A bounded random variable has a finite expectation. That is if $\mathrm{P}(\mathrm{X} \leq \mathrm{M})=1$, then X has a finite expectation and $|\mathrm{EX}| \leq \mathrm{M}$.

## Definition 4

Variable. Let $X$ be a random variable with mean $E(X)=\mu$.
The variance of X , denoted by $\operatorname{Var}(\mathrm{X})$ is defined by

$$
\left.\operatorname{Ver}(\mathrm{X})=\mathrm{E}\{\mathrm{X}-\mu)^{2}\right\}=\sum\left(x_{i}-\mu\right)^{2} \mathrm{f}\left(\mathrm{x}_{\mathrm{i}}\right)
$$

A general formula that is usually simple for computing the variable is given below

$$
\begin{aligned}
\operatorname{Var}(\mathrm{X}) & =\mathrm{E}\left\{(\mathrm{X}-\mu)^{2}\right\}=\mathrm{E}\left\{\mathrm{X}^{2}-2 \mathrm{X} \mu+\mu^{2}\right\} \\
& =\mathrm{E}\left(\mathrm{X}^{2}\right)-\mathrm{E}(2 \mu \mathrm{X})+\mathrm{E}\left(\mu^{2}\right)=\mathrm{E}\left(\mathrm{X}^{2}\right)-2 \mu \mathrm{E}(\mathrm{X})+\mu^{2}(\text { property } 2) \\
& =\mathrm{E}\left(\mathrm{X}^{2}\right)-2 \mu^{2}+\mu^{2}=\mathrm{E}\left(\mathrm{X}^{2}\right)-\mu^{2} .
\end{aligned}
$$

Thus, the computing definition of variance is

$$
\begin{equation*}
\operatorname{Var}(\mathrm{X})=\mathrm{E}\left(\mathrm{X}^{2}\right)-[\mathrm{E}(\mathrm{X})]^{2} \tag{7}
\end{equation*}
$$

The variance of X is interpreted as a numerical measure of spread or dispersion about its mean.

## Example 4.5

1. Find the variance of a random variable having the following probability density function.

| $x$ | 1 | 2 | 3 | 4 | 5 | 6 |
| :--- | :--- | :--- | :--- | :--- | :--- | :--- |


| $f(x)$ | $1 / 6$ | $1 / 6$ | $1 / 6$ | $1 / 6$ | $1 / 6$ | $1 / 6$ |
| :--- | :--- | :--- | :--- | :--- | :--- | :--- |

$$
\begin{aligned}
\mathrm{E}(\mathrm{X})= & (1 \times 1 / 6)+(2 \times 1 / 6)+(3 \times 1 / 6)+(4 \times 1 / 6)+(5 \times 1 / 6)+(6 \times 1 / 6) \\
& =1 / 6+2 / 6+3 / 6+4 / 6+5 / 6+6 / 6=21 / 6 \\
\mathrm{E}\left(\mathrm{X}^{2}\right) & =\left(1^{2} \times 1 / 6\right)+\left(2^{2} \times 1 / 6\right)+\left(3^{2} \times 1 / 6\right)+\left(4^{2} \times 1 / 6\right)+\left(5^{2} \times 1 / 6\right)+\left(6^{2} \times 1 / 6\right) \\
& =1 / 6+4 / 6+9 / 16+16 / 6+25 / 6+36 / 6=91 / 6 .
\end{aligned}
$$

Hence from (7) we have

$$
\operatorname{Var}(X)=91 / 6-(21 / 6)^{2}=105 / 36=2(11 / 12)
$$

## Example 4.6

Find the variance of a Bernoulli random variable with parameter $p$. that is X has the following p.d.f.

| $X$ | 0 | 1 |
| :--- | :--- | :--- |
| $f(x)$ | $1-p$ | $P$ |

$$
\begin{aligned}
& \mathrm{E}(\mathrm{X})-0 \times(1-\mathrm{p})+(1 \times \mathrm{P})=\mathrm{p} \\
& \mathrm{E}\left(\mathrm{X}^{2}\right)=0^{2} \times(1-\mathrm{p})+\left(1^{2} \times \mathrm{p}\right)=\mathrm{p}
\end{aligned}
$$

Hence,

$$
\operatorname{Var}(\mathrm{X})=\mathrm{p}-\mathrm{p}^{2}=\mathrm{p}(1-\mathrm{p})
$$

## Properties of Variance

1. If c is a constant and $\mathrm{P}(\mathrm{X})=\mathrm{c})=1$, then $\operatorname{Var}(\mathrm{X})=0$.
2. If $a$ and $b$ are contents, then
(i) $\operatorname{Var}(\mathrm{aX})=\mathrm{a}^{2} \operatorname{Var}(\mathrm{X})$
(ii) $\operatorname{Var}(a X+b)=a^{2} \operatorname{Var}(X)$
(iii) $\operatorname{Var}(\mathrm{X}) \geq 0$

The proof of property (1) is very trivial and this is left as an exercise to the reader, we shall now give a proof of (ii). From (7),

$$
\begin{aligned}
& \operatorname{Var}(\mathrm{aX})=\mathrm{E}\left[\mathrm{aX} \mathrm{X}^{2}\right]-[\mathrm{E}(\mathrm{aX})]^{2} \\
&=\mathrm{E} \mathrm{a}^{2} \mathrm{X}^{2}-[\mathrm{aE}(\mathrm{X})]^{2} \\
&=\mathrm{a}^{2} \mathrm{E}\left(\mathrm{X}^{2}\right)-\mathrm{a}^{2}[\mathrm{E}(\mathrm{X})]^{2}
\end{aligned}=\mathrm{a}^{2}\left\{\left(\mathrm{E}\left(\mathrm{X}^{2}\right)\right]^{2}\right\}=\mathrm{a}^{2} \operatorname{Var}(\mathrm{X}) . ~ \$
$$

## Definition 5

Standard deviation. Let X be a random variable with mean $\mu$.
The standard deviation is the positive square root of the variance, and is given by

$$
\sqrt{\operatorname{Var}(X)}=\sqrt{E\left(X^{2}\right)-(E(X))^{2}}
$$

The variance of the binomial random variable.

To calculate the variable of $X$, we need $E(X)$ and $E\left(X^{2}\right)$.

$$
\operatorname{Var}(X)=(E(X))^{2}
$$

From (3) we have

$$
\mathrm{E}(\mathrm{X})=\mathrm{np} .
$$

$\mathrm{E}[\mathrm{X}(\mathrm{X}-1)]=\sum_{x=0}^{n} \mathrm{x}(\mathrm{x}-1)^{\mathrm{n}}{ }_{\mathrm{x}} \mathrm{p}^{\mathrm{x}}(1-\mathrm{p})^{\mathrm{n}-\mathrm{x}}=\sum_{k=o}^{n} x(x-1) \frac{n!}{x!(n-x)!} \mathrm{p}^{\mathrm{x}}(1-\mathrm{p})^{\mathrm{n}-\mathrm{x}}$
( $\mathrm{w} 2 \mathrm{hen} \mathrm{x}=1$ or 1 the expression is zero)

$$
\begin{aligned}
& =\sum_{x=2}^{n} \frac{\mathrm{n}}{(\mathrm{x}-2)(\mathrm{n}-\mathrm{x}} \mathrm{p}^{\mathrm{x}}(1-\mathrm{p})^{\mathrm{n}-\mathrm{x}} \\
& =\mathrm{n}(\mathrm{n}-1) \mathrm{p}^{2} \sum_{x=2}^{n} \frac{(\mathrm{n}-2)!}{(\mathrm{xn}-2)(\mathrm{n}-\mathrm{x})!} \mathrm{p}^{\mathrm{x}-2}(1-\mathrm{p})^{\mathrm{n}-\mathrm{x}}
\end{aligned}
$$

Let $\mathrm{y}=\mathrm{x}-2=\mathrm{n}(\mathrm{n}-1) \mathrm{p}^{2} \sum_{y=0}^{n-2} n-2\left(\mathrm{y} \mathrm{p}^{\mathrm{y}}(1-\mathrm{p})^{\mathrm{n}-2-\mathrm{y}}=\mathrm{n}(\mathrm{n}-1) \mathrm{p}^{2}[\mathrm{P}+(1-\mathrm{p})]^{\mathrm{n}-1}\right.$
Hence

$$
\begin{gathered}
E\left(X(X-1)=n(n-1) p^{2}\right. \\
E(X(X-1))=E\left(X^{2}\right)-E(X)=n(n-1) p^{2} \\
E\left(X^{2}\right)=n(n-1) p^{2}+E(X)=n(n-1) p^{2}+n p .
\end{gathered}
$$

Thus,

$$
\operatorname{Var}(X)=N(n-1) p^{2}+n p-n^{2} p^{2}=n^{2} p^{2}-n p^{2}+n p-n^{2} p^{2}=n p(1-p)
$$

## The Variance of a Geometric Random Variable

The probability density function of X is given by

$$
\begin{aligned}
& \mathrm{f}(\mathrm{x})=\mathrm{p}(1-\mathrm{p})^{\mathrm{x}-1}, \mathrm{x}=1,2, \ldots \\
& \mathrm{E}(\mathrm{X})=\sum_{x=1}^{\infty} x p(1-p)^{x-1}=\frac{1}{\mathrm{p}}
\end{aligned}
$$

$\mathrm{E}(\mathrm{X})=\mathrm{P}+2 \mathrm{p}(1-\mathrm{p})+3 \mathrm{p}(1-\mathrm{p})^{2}+\ldots=\mathrm{P}\left\{1+2(1+\mathrm{p})+3(1-\mathrm{p})^{2}+\ldots\right\}$.
From the Binomial theorem

$$
(1-a)^{-2}=1+2 a+3 a^{2}+\ldots|a|<\mid
$$

Putting $\mathrm{a}=(1-\mathrm{p})$, we obtain1

$$
\mathrm{E}(\mathrm{X})=\mathrm{P} \cdot(1-(1-\mathrm{p}))^{-2}=\frac{1}{p}
$$

$$
\begin{aligned}
\mathrm{E}[\mathrm{X}(\mathrm{X}-1)]= & \sum_{x=2}^{\infty} x(x-1) P(1-p)^{x-1} \\
& =\mathrm{p}\left[2.1(1-\mathrm{p})+3.2(1-\mathrm{p})^{2}+\ldots+\mathrm{r}(\mathrm{r}-1)(1-\mathrm{p})^{\mathrm{r}-1}+\ldots\right]
\end{aligned}
$$

Multiply both sides by 1-p,

$$
\begin{gathered}
(1-p) E[X(X-1)]=p\left(2.1(1-p)^{2}+\left(3.2(1-p)^{3}+\ldots+r(r-1)(1-p)^{r}+\ldots+\right]\right. \\
E(X(X-1)]-(1-p) E[X(X-1)]=p\left[2(1-p)+4(1-p)^{2}+6(1-p)^{3}+\ldots+2 r(1-p)^{r}+\ldots\right] \\
=2 p(1-p)\left[+2(1-p)+3(1-p)^{2}+\ldots\right]=2 p(1-p) \cdot \frac{1}{p^{2}}=\frac{2(1-p)}{p}
\end{gathered}
$$

Hence

$$
\begin{aligned}
& \mathrm{E}[\mathrm{X}(\mathrm{X})]-(1-\mathrm{p}) \mathrm{E}[\mathrm{X}(\mathrm{X}-1)]=\frac{2(1-p)}{p} \\
& \mathrm{E}[\mathrm{X}(\mathrm{X}-1)]\{1-(1-\mathrm{p})\}=\frac{2(1-p)}{p}
\end{aligned}
$$

which implies that

$$
\begin{gathered}
\mathrm{E}[\mathrm{X}(\mathrm{X}-1)]=\frac{2(1-p)}{p^{2}} \\
\mathrm{E}\left(\mathrm{X}^{2}\right)=\frac{2(1-p)}{p^{2}}+\mathrm{E}(\mathrm{X})=\frac{2(1-p)}{p^{2}}+\frac{1}{\mathrm{p}}
\end{gathered}
$$

Thus

$$
\operatorname{Var}(\mathrm{X})=\frac{2(1-p)}{p^{2}}+\frac{1}{\mathrm{p}}-\frac{1}{\mathrm{p}^{2}}=\frac{2(1-p)+p-1}{p^{2}}=\frac{1-p}{p^{2}}
$$

## The Variance of a Poisson Random Variable

Let $X$ be a poisson random variable with parament $\lambda$.

$$
\begin{gathered}
\mathrm{E}(\mathrm{X})=\sum_{x=0}^{\infty} x e^{-\lambda} \frac{\lambda^{2}}{x!}=\sum_{\mathrm{x}=1}^{\infty} \mathrm{e}^{-\lambda} \frac{\lambda^{\mathrm{x}}}{(\mathrm{x}-1)!}=\lambda \mathrm{e}^{-\lambda} \sum_{\mathrm{x}=1}^{\infty} \frac{\lambda^{x-1}}{(\mathrm{~s}-1)!} \\
=\lambda \mathrm{e}^{-\lambda} \sum_{\mathrm{y}=0}^{\infty} \frac{\lambda^{y}}{\mathrm{y}!}=\lambda \mathrm{e}^{-\lambda} \mathrm{e}^{\lambda}=\lambda \\
\mathrm{E}[\mathrm{X}(\mathrm{X}-1)]=\sum_{x=0}^{\infty} x(x-1) e^{-\lambda} \frac{\lambda^{x}}{\mathrm{x}!}=\sum_{x=2}^{\infty} x(x-1) \frac{\mathrm{e}^{-\lambda} \lambda^{x}}{x!} \\
=\mathrm{e}^{-\lambda} \lambda^{2} \sum_{x=2}^{\infty} \frac{\lambda^{x-2}}{(x-2)!}=e^{-\lambda} \lambda^{2} \sum_{y=0}^{\infty} \frac{\lambda^{y}}{\mathrm{y!}}=\lambda^{2} \\
\mathrm{E}\left(\mathrm{X}^{2}\right)-\mathrm{E}(\mathrm{X})=\lambda^{2} \\
\mathrm{E}\left(\mathrm{X}^{2}\right)=\lambda^{2}+\mathrm{E}(\mathrm{X})=\lambda^{2}+\lambda
\end{gathered}
$$

Hence,

$$
\operatorname{Var}(\mathrm{X})=\lambda^{2}+\lambda-\lambda^{2}=\lambda .
$$

This shows that the mean and variance of a passion random variable are both equal.

### 4.3 Probability Generating Function

In this section we shall introduce important mathematical concepts in probability theory. The rth moment of a random variable $X$ is defined by $E\left(X^{r}\right)$, where $E\left(X^{r}\right)$ and $E(X-\mu)^{r}$ are called the rth moment of $X$ about 0 and $\mu$ respectively.
From (2)

$$
\mathrm{E}\left(\mathrm{X}^{\mathrm{r}}\right)=\sum_{i=1}^{\infty} x_{i}^{r} f(x) \text { and } E(X-\mu)^{r}=\sum\left(x_{i}-\mu\right)^{r} f\left(x_{i}\right)
$$

Note that the second moment of $X$ about $\mu$ is the variance of $X$. an indirect way of calculating expectation is the use of probability generating function or moment generating function. it is a mathematical device to simplify the calculations of moments of X . its more general usefulness will not be apparent until we get to chapter 6 .

## Definition 6

The probability generating function of a non-negative, integer-valued random variable X is defined by

$$
\begin{equation*}
\mathrm{E}\left(\mathrm{~S}^{\mathrm{x}}\right)=\mathrm{P}(\mathrm{~S})=\sum_{x=0}^{\infty} S^{x} f(x) ;-1 \leq s \leq 1 ;-s_{0}<s<s_{0} \tag{8}
\end{equation*}
$$

From (6), we see that

$$
\mathrm{P}(\mathrm{~S})=\mathrm{E}\left(\mathrm{~S}^{x}\right)
$$

By differentiating with respect to $s$ we have

$$
\begin{gathered}
\mathrm{P}^{\prime}(\mathrm{s})=\mathrm{E}\left(\mathrm{XS}^{\mathrm{X}-1}\right) \\
\mathrm{P}^{\prime \prime}(\mathrm{s})=\mathrm{E}\left[\mathrm{X}(\mathrm{X}-1) \mathrm{S}^{\mathrm{X}-2}\right] \\
\mathrm{P}^{(\mathrm{r})}(\mathrm{s})=\mathrm{E}\left(\mathrm{X}(\mathrm{X}-1)(\mathrm{X}-2) \ldots(\mathrm{X}-\mathrm{r}+1) \mathrm{s}^{\mathrm{X}-1}\right)
\end{gathered}
$$

Putting $s=1$ in the above derivatives, we have

$$
\begin{gathered}
\mathrm{P}^{\prime}(1)=\mathrm{E}(\mathrm{X}) \\
\mathrm{P}^{\prime} ’(1)=\mathrm{E}[\mathrm{X}(\mathrm{X}-1)]=\mathrm{E}\left(\mathrm{X}^{2}\right)-\mathrm{E}(\mathrm{X}) \\
\mathrm{P}^{(\mathrm{r})}(1)=\mathrm{E}[\mathrm{X}(\mathrm{X}-1)(\mathrm{X}-2) \ldots(\mathrm{X}-+1 \mathrm{r})] .
\end{gathered}
$$

Thus the mean and variance of $X$ can be obtained from $\mathrm{P}(\mathrm{s})$ by the following formulas.

$$
\begin{gathered}
\mathrm{E}(\mathrm{X})=\mathrm{P}^{\prime}(1) \\
\mathrm{E}\left(\mathrm{X}^{2}\right)-\mathrm{E}(\mathrm{X})=\mathrm{P}^{\prime}(!) \\
\mathrm{E}\left(\mathrm{X}^{2}\right)=\mathrm{P}^{\prime}(1)+\mathrm{E}(\mathrm{X})=\mathrm{P}^{\prime}(1)+\mathrm{P}^{\prime}(1)
\end{gathered}
$$

And

$$
\operatorname{Var}(\mathrm{X})=\mathrm{E}\left(\mathrm{X}^{2}\right)-[\mathrm{E}(\mathrm{X})]^{2}=\mathrm{P}^{\prime}(1)+\mathrm{P}^{\prime}(1)-\left[\mathrm{P}^{\prime}(1)\right]^{2}
$$

We now illustrate the use of these formulas with the following examples.

## Examples 4.7

Let $X$ be a poisson random variable wit parameter $\lambda$. Find the mean variance of $X$

$$
\mathrm{f}(\mathrm{x})=\frac{e^{-\mathrm{h}_{2} \mathrm{x}}}{x!}, x=0,1,2, \ldots
$$

The probability generating function is defined by

$$
\mathrm{P}(\mathrm{~S})=\mathrm{E}\left(\mathrm{~S}^{\mathrm{X}}\right)=\sum_{x=0}^{\infty} s^{x}{ }^{n}\left({ }_{x} \mathrm{p}^{\mathrm{X}}(1-\mathrm{p})^{\mathrm{n}-\mathrm{x}}=\sum_{x=0}^{\infty} \quad{ }^{\mathrm{n}}\left(\mathrm{x}(\mathrm{sp})^{\mathrm{x}}(1-\mathrm{p})^{\mathrm{n}-\mathrm{x}} .\right.\right.
$$

By the Binomial theorem

$$
=[\mathrm{sp}+(1-\mathrm{p})]^{\mathrm{n}}
$$

Thus,

$$
\begin{equation*}
\mathrm{P}(\mathrm{~S})=[\mathrm{sp}+(1-\mathrm{p})]^{\mathrm{n}} \tag{12}
\end{equation*}
$$

Differentiating, we have

$$
\begin{gathered}
P^{\prime}(s)=n p[s p+(1-p)]^{n-1} \\
P^{\prime}(s)=n(n-1) p^{2}[s p+1-p]^{n-2} \\
\operatorname{Var}(X)=p^{\prime} \quad(1)+-\left[p^{\prime}(1)-\left[p^{\prime}(1)\right]^{2}=n(n-1) p^{2}+n p-(n p)^{2}=n p(1-p) .\right.
\end{gathered}
$$

The Moment Generating Function
Definition 7
Let $X$ be a discrete random variable with $\operatorname{pdf} f(x)$. the moment generating function denoted by $\mathrm{M}_{\mathrm{x}}(\mathrm{t})$ is defined by

$$
\begin{equation*}
\mathrm{M}_{\mathrm{X}}(\mathrm{t})=\mathrm{E}\left(\mathrm{e}^{\mathrm{tX}}\right) \tag{13}
\end{equation*}
$$

Where $t$ is any real constant for which the expectation exists.

$$
\begin{array}{r}
\mathrm{M}_{\mathrm{X}}(\mathrm{t})=\sum_{V x} e^{t x} f(x) \\
\mathrm{R}^{\mathrm{tX}}=1+\mathrm{tX}+\frac{(t x)^{2}}{2!}+\ldots \\
\mathrm{E}\left(\mathrm{e}^{\mathrm{tX}}\right)=\mathrm{E}\left(1+\mathrm{tX}+\frac{(t x)^{2}}{2!}+\ldots+\frac{t^{n} X^{n}}{n!}\right.
\end{array}
$$

Under fairly general conditions we shall assume that expectation of infinite sum equals the sum of the expected value but this is true in general for finite sum

$$
1+\mathrm{tE}(\mathrm{X})+\frac{t^{2}}{2!} E\left(X^{2}\right)+\frac{t^{n} X^{n}}{n!}+\ldots
$$

That is

$$
\mathrm{M}_{\mathrm{X}}(\mathrm{t})=1+\mathrm{tE}(\mathrm{X})+\frac{\tau^{2}}{2!} E\left(X^{2}\right)+\ldots+\frac{\tau^{n}}{n!} E\left(X^{n}\right)+\cdots
$$

Differentiating with respect to $t$, we have

$$
\begin{gathered}
\mathrm{M}_{\mathrm{X}(\mathrm{t})}^{\prime}=\mathrm{E}\left(\mathrm{X}^{2}\right)+\ldots+\frac{n(n-1) r^{n-2}}{m!} E\left(\mathrm{X}^{n}\right)+\cdots \\
\mathrm{M}^{\prime}{ }_{\mathrm{x}}(0)=\mathrm{E}\left(\mathrm{X}^{2+}\right)
\end{gathered}
$$

hence,

$$
\operatorname{Var}(\mathrm{X})=\mathrm{M}_{\mathrm{x}}{ }^{\prime}{ }^{\prime}(0)-\left[\mathrm{M}_{\mathrm{X}}{ }^{\prime}(0)^{2}\right]
$$

And

$$
\begin{equation*}
M_{x}(t)=E\left(e^{t \mathrm{X}}\right), M_{x}^{(r)}(t)=E\left[X^{r} e^{t X}\right] \tag{15}
\end{equation*}
$$

Putting $\mathrm{t}=0$, we have

$$
\begin{equation*}
M^{(\mathrm{r})}(0)=\mathrm{E}\left(\mathrm{X}_{\mathrm{r}}\right) \tag{16}
\end{equation*}
$$

that is, $E\left(X^{r}\right)$ is the rth derivative of $M_{x}(t)$ evaluated at $t=0$.

Note: It is assumed that $\sum e^{t X} f(x)$ converges for all values of $t$.
The domain of $M_{x}(t)$ is all real number $t$ such that $\sum e^{t X} f(x)$ converges. If $M_{x}(t)$ is defined for some $t_{0}>0$, then it is defined in the interval $0 \leq t \leq t_{0}$.

## Examples 4.9

Let X be a binomial random variable with parameters n and p . then

$$
\mathrm{M}_{\mathrm{X}}(\mathrm{t})=\mathrm{E}\left(\mathrm{e}^{\mathrm{tX}}\right)=\sum_{x=0}^{n} e^{t X \mathrm{n}} \mathrm{C}_{\mathrm{x}} \mathrm{P}^{\mathrm{x}}(1-\mathrm{p})^{\mathrm{n}-\mathrm{x}}=\sum_{x=0}^{n} \quad{ }^{\mathrm{n}} \mathrm{C}_{\mathrm{x}}\left(\mathrm{Pe}^{\mathrm{t}}\right)^{\mathrm{x}}(1-\mathrm{p})^{\mathrm{n}-\mathrm{x}}
$$

from the binomial theorem

$$
(\mathrm{a}+\mathrm{b})^{\mathrm{n}}=\sum_{x=0}^{n} \quad{ }^{\mathrm{n}} \mathrm{C}_{\mathrm{x}} \mathrm{a}^{\mathrm{x}} \mathrm{~b}^{\mathrm{n}-\mathrm{x}}=\left[\mathrm{pe}^{\mathrm{t}}+(1-\mathrm{p})\right]^{\mathrm{n}},
$$

on putting $\mathrm{a}=\mathrm{pe}^{\mathrm{t}}, \mathrm{b}=1-\mathrm{p}$.

## Example 4.10

Let $X$ be a Poisson random variable with parameter $\lambda$. Then

$$
\mathrm{M}_{\mathrm{X}}(\mathrm{t})=\sum_{x=0}^{\infty} e^{\tau X} \frac{e^{-\lambda} \lambda^{x}}{x!}=e^{-\lambda} \sum_{x=0} \frac{\left(\lambda \mathrm{e}^{\mathrm{t}}\right)^{\mathrm{X}}}{x!}=\mathrm{e}^{-\lambda} \mathrm{e}^{\lambda \mathrm{et}}=\mathrm{e}^{\lambda(\mathrm{et}-1)}
$$

Differentiating, we have

$$
\begin{gathered}
\mathrm{M}^{\prime}{ }_{\mathrm{x}}(0)=\lambda \mathrm{e}^{\mathrm{t}} \mathrm{e}^{-\lambda(1-\mathrm{et})} \\
\mathrm{M}_{\mathrm{x}}^{\prime}(0)=\left.\lambda \mathrm{e}^{\mathrm{t}} \mathrm{e}^{-\lambda(1-\mathrm{et})}\right|_{\lambda=0}=\lambda \mathrm{E}(\mathrm{X}) \\
\mathrm{M}_{\mathrm{x}}{ }^{\prime \prime}(\mathrm{t})=\lambda \mathrm{e}^{\mathrm{t}} \mathrm{e}^{-\lambda(1-\mathrm{et})}+\lambda^{2} \mathrm{e}^{2 \mathrm{t}} \mathrm{e}^{-\lambda(1-\mathrm{t})} \\
\mathrm{M}_{\mathrm{x}}{ }^{\prime}{ }^{\prime}(0)=\lambda+\lambda^{2}=\mathrm{E}\left(\mathrm{X}^{2}\right)
\end{gathered}
$$

Hence,

$$
\operatorname{Var}(\mathrm{x})=\lambda+\lambda^{2}-\lambda^{2}=\lambda .
$$

## Example 4.11

Let X be a geometric random variable with parameter p . them

$$
\begin{aligned}
\mathrm{M}_{\mathrm{x}}(\mathrm{t}) & =\sum_{x=1}^{\infty} e^{\tau X} P(1-p)^{x-1}=\frac{p}{1-p} \quad \sum_{x=1}^{\infty} e^{t X} P(1-p)^{x} \\
& =\frac{p}{1-p} \Sigma_{x=1}\left[e^{\mathrm{t}}(1-p)\right]^{X}=\frac{\mathrm{p}}{1-p} \cdot \frac{\mathrm{e}^{\mathrm{t}}(1-p)}{1-\mathrm{e}^{t}(1-p)}=p e^{t}\left[1-e^{t}(1-p)\right]^{-1}
\end{aligned}
$$

The fourth equality follows from sun to infinity of geometric series $\sum_{x=1}^{\infty} a^{x}$. Further applications of $\mathrm{M}_{\mathrm{x}}(\mathrm{t})$ will be considered later in Chapter 6.

## CONTINUES RANDOM

### 5.1 INTRODUCTION

In the chapter so far, we consider discrete random variables and their probability density functions e.g. Binomial, Poisson, Geometric. These are essentially counting variables. However, there exist random variables whose set of possible uncountable, such random variables are called continuous random variables.

In this chapter, we shall study in considerable detail, a number of important continuous random variables and their characteristics. We shall consider an idealized range space for a random variable $X$, in which all possible real number (in some specific intervals or set of intervals) many be considered as possible outcomes. We shall essentially replace the summation in the previous chapters in the discrete probability function case by integration for the continuous probability density function case.

## Example 5.1

Let a point be chosen at random from the interval $(0,2)$ and let $X$ represent the point chosen. Then $0 \leq X \leq 2$. the range space of $X$ consists of unaccountable real numbers. Any real number in the interval $(0,2)$ is a sample point. Let A be the event that the point chosen is 0.3 . From the basic definition of probability we have

$$
P(A)=\frac{\text { number of point } A}{\text { number of point } \sin \Omega}=\frac{1}{\infty}=0 \text {. }
$$

Hence,

In general, if $X$ is a continuous random variable, probability that $X$ takes a specific value is 0 . random variables denoting measurements of physical quantities such as time, weight, temperature, length are continuous random variables. The proability that $X$ lies between two defined values is given by

$$
\begin{gathered}
\mathrm{P}(\mathrm{a} \leq \mathrm{X} \leq \mathrm{b}) . \\
\mathrm{P}(\mathrm{X} \in \mathrm{~A})=\int_{A} f(x) d x
\end{gathered}
$$

For any set A of real numbers

$$
P(X) \text { is denoted by } F(X) \text {. }
$$

## Definition

The distribution function F of a random variable X is the function

$$
P(X)=P(X \leq x),-\infty<x<\infty,
$$

If we know the probability distribution function of $X$, then we can calculate the probability that $X$ fails in a specific interval. For example

$$
P(a<X \leq b)=P(X \leq b)-P(X \leq a)=F(b)-F(a) .
$$

## Properties of Distribution Function

A probability distribution function is any function $F$ satisfying the following conditions:
(i) $0 \leq \mathrm{F}(\mathrm{x}) \leq 1$ for all x
(ii) $F(x)$ is a non-decreasing function of $x$.
(iii) $F(-\infty)=0$ and $F(+\infty)=1$.
(iv) $F(x+)=F(x)$ for all values of $x$ where $F(x+)=\operatorname{Lim}_{\delta-0} F(x+\delta)$.

Graphs of a typical distribution function

Example 2

Show that

$$
F(x)= \begin{cases}e^{x} & x<0 \\ 1 & x>0\end{cases}
$$

is a probability distribution function

Solution
$0 \leq \mathrm{e}^{\mathrm{x}} \leq 1$ for $\mathrm{x} \leq 0$ and $\mathrm{e}^{\mathrm{x}}$ is a non decreasing continuous function, hence $\mathrm{F}(\mathrm{x})$ is a probability distribution function.

## Probability density function P.df

For discrete random variable

$$
\mathrm{F}(\mathrm{x})=\mathrm{P}(\mathrm{X} \leq \mathrm{x})=\sum_{-\infty}^{x} f(y)
$$

Where $f(y)=P(X=y)$.

Similarly, for continuous random variables, there exists a function $f(x)$ such that

$$
\mathrm{F}(\mathrm{x})=\mathrm{P}_{\mathrm{x}}(\mathrm{X} \leq \mathrm{x})=\int_{-\infty}^{x} f(y) d y
$$

Such a function $f$ is called probability density function of $X$. to see this consider the following.

The probability that the random variable $X$ takes on a value between $x$ and $x+\Delta x$ is

$$
\begin{aligned}
& P(x<X<x+\Delta x)=P(X \leq x+\Delta x)-P(X<x) \\
& =F(x+\Delta x)-F(x) .
\end{aligned}
$$

this is the probability associated with an interval of length $\Delta x$

$$
\frac{F(x+\Delta x)-F(x)}{\Delta x}
$$

is the probability per unit length in the interval. If we now let $\Delta x$ tends to zero, we have

$$
\operatorname{Lim}_{\Delta x-0} \frac{F(x+x)-F(x)}{\Delta x}=F^{\prime}(x)=f(x)
$$

Hence, $\mathrm{F}(\mathrm{x})=\int_{-\infty}^{x} f(y) d y$ where $\mathrm{F}(-\infty)=0$
$F(x)$ represents the probability per unit distance along the $x$ acis and

$$
\mathrm{F}(\mathrm{x})=\frac{d}{d x} \mathrm{~F}(\mathrm{x})
$$

This shows that the p.d.f of $X$ is obtained by differentiating the distribution function of $X$.

## Properties of probability density function

A probability density function is any function satisfying the following conditions.
(i) $f(x) \geq 0$
(ii) $\quad \int_{-\infty}^{\infty} f(x) d x=1$
(iii) $\mathrm{P}(\mathrm{X}<\mathrm{a})=\int_{-\infty}^{a} f(x) d x=1-\int_{a}^{\infty} f(x) d x=1-\mathrm{P}(\mathrm{X}>\mathrm{a})$
(iv) if A is any interval, $\mathrm{P}(\mathrm{X} \in \mathrm{A})=\int_{-\infty} f(x) d x$.

Figure (2) represents a graph of the function $f(x)$. the area enclosed by the curve $f(x)$ between $a$ and $b$ is

$$
\int_{a}^{b} f(x) d x=\mathrm{P}(\mathrm{a} \leq \mathrm{X} \leq \mathrm{b})=\mathrm{F}(\mathrm{~b})-\mathrm{F}(\mathrm{a}) .
$$

Graphical Representation of a Continuous Random Variable.

## Theorem

(i) The function F is non decreasing
(ii) $\quad \operatorname{Lim}_{x \rightarrow \infty} \mathrm{~F}(\mathrm{x})=0$ and $\operatorname{Lim}_{x \rightarrow \infty} \mathrm{~F}(\mathrm{x})=1$.

## Proof:

(i) Suppose $x_{1} \leq x_{2}$ and let $A=\left\{X \leq x_{1}\right\}, B=\left\{X \leq x_{2}\right)$, then

$$
A \subset B \text { since } x_{1} \leq x_{2}
$$

Thus

$$
P(A) \leq P(B)) \text {. }
$$

(ii) $\quad \operatorname{Lim}_{x-\infty} \mathrm{F}(\mathrm{X})=\operatorname{Lim}_{x-\infty} \int_{-\infty}^{x} f(y) d y=0$

$$
\operatorname{Lim}_{x \rightarrow \infty} \mathrm{~F}(\mathrm{x})=\operatorname{Lim}_{x \rightarrow \infty} \int_{-\infty}^{x} f(y) d y=1
$$

Examples
Exponential Distribution. Let $\mathrm{f}(\mathrm{x})=\left\{\begin{array}{lc}e^{-\lambda x}, & x \geq 0 \\ 0, & x<0\end{array}\right.$

The graph of $f(x)$ is shown in Figure 2 below


Figure 3. Density function of exponential distribution.

The random variable $X$ having its probability density function given by (1) is said to have exponential distribution with parameter $\lambda$.

### 5.4 Normal Distribution

Let $\mathrm{f}(\mathrm{x})=\frac{1}{\sqrt{2 \pi}} e^{-\frac{1}{2} x^{2}},-\infty<x<\infty$.
The graph of $f(x)$ is shown in Figure 4 below.


Figure 4. Standard Normal Distribution
5.5 Let the random variable $X$ have the probability density function $f(x)-1 / 2 e^{-1 / 2 x} 0$ $\leq x \leq \infty$. Find (i) $P(2 \leq x \leq 7)$ (ii) $P(X \geq 10)$.

## Solution

$$
\mathrm{P}(2 \leq \mathrm{x} \leq 7)=\int_{2}^{7} 1 / 2 e^{-1 / 2 x} d x=-e^{-\frac{x}{2}} \mathrm{I}_{2}^{7}=e^{-1}-e^{-7 / 2}=0.338
$$

And

$$
\mathrm{P}(\mathrm{X} \geq 10)=\int_{10}^{\infty} 1 / 2 e^{-1 / 2 x} d x=-e^{-1 / 2 x} \mathrm{I}_{10}^{\infty}=e^{-5} .
$$

Suppose that $X$ is a continuous random variable whose probability density function is given by

$$
f(x)=\left\{\begin{array}{l}
A e^{-2 x} 0<x<\infty \\
\end{array}\right.
$$

0 otherwise
(i) what is the value of a? and (ii) find $P(X>1)$.

## Solution

(i) From property (ii) of a probability density function, we have

$$
\int_{-\infty}^{\infty} f(x) d x=1
$$

implying that

$$
\begin{gathered}
\int_{0}^{\infty} a e^{-2 x} d x=1=a \int_{0}^{\infty} e^{-2 x} d x=1 / 2 \\
==>\mathrm{a}=2
\end{gathered}
$$

hence

$$
f(x)=2 e^{-2 x} 0<x<\infty
$$

0 otherwise
(ii)

$$
\mathrm{P}(\mathrm{X}>1)=\int_{1}^{\infty} 2 e^{-2 x} d x=\mathrm{e}^{-2}=0.14
$$

5.2 Expectation and variance of continuous random variables.

Let $X$ be a continuous random variable with probability density function $f(x)$. Suppose we divide the range of $X$ into small intervals, each of length $\Delta x$ (by the definition of $f(x)$ ).

The expected value of $X$ is therefore approximately

$$
\sum x f(x) \Delta x
$$

The limiting value of this as $\Delta x \quad 0$

$$
\int x f(x) d x .
$$

This leads us to the following definition.

## Definition 3

If $X$ is a continuous random variable with probability density function $f(x)$, then

$$
\mathrm{E}(\mathrm{x})=\int_{-\infty}^{\infty} x f(x) d x
$$

In general,

$$
\mathrm{E}\left(\mathrm{X}^{r}\right)=\int_{-\infty}^{\infty} x^{r} f(x) d x
$$

$$
\mathrm{E}(\Phi(\mathrm{X}))=\int_{-\infty}^{\infty} \Phi(x) f(x) d x
$$

The variance $\sigma^{2}=\mathrm{E}\left[(X-\mu)^{2}\right]=\int_{-\infty}^{\infty}(x-\mu)^{2} f(x) d x=E\left(x^{2}\right)-\mu^{2}$

Where $\mu=\mathrm{E}(\mathrm{x})$.

## Examples

5.6 Suppose $X$ is a continuous random variable with p.d.f $f(x)=\lambda e^{-\lambda x}, 0<x<\infty$.

Find (i) the mean and variance of $X$ and (ii) the probability distribution function $F(x)$, and the probability that X lies between 2 and 5 .

## Solution

$$
\mathrm{E}(\mathrm{X})=\int_{-\infty}^{\infty} x \cdot \lambda e^{-\lambda x} d x=\int_{0}^{\infty} x \lambda e^{-\lambda x} d x
$$

By integrating by parts

$$
=\int_{-\infty}^{\infty}-x \frac{d}{d x}\left(e^{-\lambda x}\right)=-x e^{-\lambda x} \mathrm{I}_{0}^{\infty}+\int_{0}^{\infty} e^{-\lambda x} d x=\frac{1}{\lambda}
$$

Similarly,

$$
\mathrm{E}\left(\mathrm{x}^{2}\right)=\int_{0}^{\infty} x^{2} \cdot \lambda e^{-\lambda x} d x=\int_{0}^{\infty}-x^{2} \frac{d}{d x}\left(e^{-\lambda x}\right)=-x^{2} e^{-\lambda x} \mathrm{I}_{0}^{\infty}+2 \int^{\infty} x e^{-\lambda x} d x
$$

$=2 \int_{o}^{0} x^{o-2 x} d x=\frac{2}{\lambda} \int x \lambda \ell^{-2 x} d x=2 E(x)=\frac{2}{\lambda^{2}}$
hence,

$$
\operatorname{var}(\mathrm{x})=\frac{2}{\lambda^{2}}-\frac{1}{\lambda^{2}}=\frac{1}{\lambda^{2}}
$$

(u) $\quad \mathrm{F}(\mathrm{x})=\int_{-}^{x f(y) d y=} \int f(y) d y=\int_{=}^{x} \lambda \ell-\lambda y d y=-e^{-\lambda y\left[\frac{x}{0}=1-e^{1 x}\right.}$

A probability density function $f(x)$ is said to be symmetric about a if

F(a+x)=f(a-x) \text { for all } x .
$$

If $x=0$. then $f(x)$ is symmetrical about 0 . for example, if

Then

\mathrm{F}\left((\mu-x)=\frac{1}{\sqrt{2 x}} e \frac{1}{2}\left(\mu+\mathrm{x}-\mu_{22}=\frac{1}{2 \pi} e \frac{-1}{2}\right.\right.
$$

\mathrm{F}(\mu-x)=\frac{1}{\sqrt{2 x}} e \frac{1}{2}(\mu+x-\mu)^{2}=\frac{1}{2 \pi} e \frac{-1}{2}
$$


theorem 1
if $f(x)$ is a symmetric probability density function then

$$
f(x)=1-f(-x)
$$

where $f(x)$ is the distribution function of $x$.
proof

$$
\mathrm{f}(-\mathrm{x})=\int_{-}^{x} f(y) d y=\int_{-}^{-x} f(-y) d y
$$

since $f(y)=f(-y)$. Let $z=-y$, then
$\mathrm{f}(-\mathrm{x})=\int_{-}^{x} f(z)(-1) d z=\int_{x}^{=} f(z) d z=\int_{-}^{-} f(z) d z-\int_{-}^{x} f(z) d z=1-f(x)$
and hence

f(x)=1-f(x)
$$

terminology
when we speak of the probability distribution of a random variable $X$ we mean its probability density function and when we speak of the distribution function or cumulative distribution function we always mean $f(x)$.
5.2 some important continuous random variables.

### 5.2.1 The Normal Distribution

one of the most important continuous random variables is the Normal random variable, $X$. The range of $X$ is the real line.

Definition
The Normal Distribution. The continuous random variable $X$ has the normal distribution with mean $\mu$ and varianceo ${ }^{3}$ if $\mu$ has the probability density function.

$$
\mathrm{F}(\mathrm{x})=\frac{1}{\sqrt{2 \pi}} e \frac{-1}{2} \frac{(x-\mu)^{3}}{0^{2}}=<x<=
$$

The graph of $f(x)$ is given in Figure (4)
It can be verified that $f(x)$ satisfies

1. $\int f(x) d x=1$
2. $\int x f(x) d x=\mu$
3. $\int(x-\mu)^{2} f(x) d x=0^{2}$

## Properties of the Normal Distribution.

1. $\int^{f(x) d x=1}$ this can be verified.

Thus let $\mathrm{z}=\frac{x-\mu}{\sigma}$

$$
\int_{-\infty}^{\infty} \frac{1}{\sigma \sqrt{2 \pi}} e^{-\frac{1}{2}} \frac{(x-\mu)^{2}}{\sigma^{2}} d x=\int_{-\infty}^{\infty} \frac{1}{\sqrt{2 x}} e^{-\frac{1}{2}} d z=1
$$

$$
I^{2}=\frac{1}{2 \pi} \int_{-\infty}^{\infty} e^{-\frac{1}{2} y^{2}} d y=\frac{1}{2 \pi} \int_{-\infty}^{\infty} \int_{-\infty}^{\infty} e^{-\frac{1}{2}\left(z^{2}+y^{2}\right)} d z d y
$$

Let us introduce polar coordinates to evaluate this double integral:

$$
\begin{gathered}
\mathrm{Z}=\mathrm{r} \cos \theta, \mathrm{y}=\mathrm{r} \sin \theta \\
I^{2}=\frac{1}{2} \int_{0}^{2 \pi} \int_{0}^{\infty} r e^{-r^{2}} d r d \theta=\frac{1}{2 \pi} \int_{0}^{2 \pi}-e^{-\frac{r^{2}}{2}} \mathrm{I}{ }_{0}^{\infty} d \theta=\frac{1}{2 \pi} \int_{0}^{2 \pi} d \theta=1 .
\end{gathered}
$$

where $d z d y=r d r d \theta$, Hence

$$
\int_{-\infty}^{\infty} \frac{1}{\sigma \sqrt{2 \pi}} e^{-\frac{1}{2}} \frac{(x-\mu)^{2}}{\sigma^{2}} d x=1
$$

2. $E(X)=\mu, \operatorname{Var}(X)=\sigma^{2}$.

The p.d.f is completely specified when $\mu$ and $\sigma$ are known.
When $\mu=0$ and $\sigma^{2}=1$. X is said to have a standardized normal distribution. This is, the pdf of $X$ is

$$
f(x)=\frac{1}{\sqrt{2 \pi}} e^{-\frac{1}{2} x^{2}},-\infty<x<\infty
$$

The importance of the standardized normal distribution is the fact that it is tabulated.
3. $f(x)$ is symmetrical about the point $\mu$, hence $F(-x)=1-F(x)$.

Most available tables are tabulated only for positive values of $x$ since $F(-x)$ can be found from $f(x)$ and $f(x)$ are given at the back of this book. The graph of $f(x)$ is bell-shaped curve centred at its mean.
4. IF X has a normal distribution with mean $\mu$ and variance $\sigma^{2}$, then $\mathrm{Y}=\frac{X-\mu}{o}$ has a standardized normal distribution. The proof of this is left as an exercise. Y is said to have a standard Normal distribution.
5. The moment generating function of $X$ is defined by

$$
\begin{aligned}
& \qquad \begin{aligned}
\mathrm{M}_{\mathrm{x}}(\mathrm{t})=\mathrm{E}\left(\mathrm{e}^{\mathrm{tx}}\right) & =\int_{-\infty}^{\infty} e^{t x} \frac{1}{\sqrt[\sigma]{2 \pi}} e^{-\frac{1}{2}} \frac{(x-\mu)^{2}}{\sigma^{2}} d x . \\
\text { Let } \mathrm{y}=\frac{X-\mu}{\sigma}, \text { then } d y & =\frac{1}{\sigma} d x . \\
\mathrm{x} & =\mu+\mathrm{y} \sigma .
\end{aligned}
\end{aligned}
$$

Thus,

$$
\mathrm{M}_{\mathrm{x}}(\mathrm{t})=\int_{-\infty}^{\infty} e^{t(\mu+y \sigma)} \frac{1}{\sqrt[6]{2 \pi}} e^{-\frac{1}{2} y^{2}} \cdot \sigma d x d y
$$

$$
=\frac{e^{t \mu}}{\sqrt{2 x}} \int_{-\infty}^{\infty} e^{-\frac{1}{2}(y-t \sigma)^{2}} d y=e^{t \mu+\frac{1}{2} \sigma^{2} t^{2}} \frac{1}{\sqrt{2 \pi}} \int_{-\infty}^{\infty} e^{-\frac{1}{2}(y-t \sigma)^{2}} d y
$$

Let $y-t \sigma=y$, then

$$
\frac{1}{\sqrt{2 \pi}} \int_{-\infty}^{\infty} e^{-\frac{1}{2}(y-t \sigma)^{2}} d y=\frac{1}{\sqrt{2 \pi}} \int_{-\infty}^{\infty} e^{-\frac{1}{2} y^{2}} d y=1
$$

Hence,

$$
\mathrm{M}_{\mathrm{x}}(\mathrm{t})=e^{t \mu+\frac{1}{2} \sigma^{2} t^{2}}
$$

## Examples

5.8 If $X$ has a standard normal distribution i.e. mean of $X, \mu=0$, and variance $=1$. Find
(i) $\quad \mathrm{P}(\mathrm{X} \leq 0.5)$
(ii) $\quad P(X \geq 0.5)$
(iii) $P(X \leq-0.3)$
(iv) $\mathrm{P}(0.3 \leq \mathrm{X} \leq 0.5)$
(v) $P(-0.3 \leq X \leq 0.5)$

## Solution

(i) $\mathrm{P}(\mathrm{X} \leq 0.5)=\int_{-\infty}^{\infty} f(x) d x=F(0.5)$.

From table (3) $F(0.5$ ) is found by locating the first two digits (0.5) in the column headed $x$, the desired probability of 0.6915 is found in the row labeled 0.5 and the labeled 0.00 . That is

$$
\mathrm{P}(\mathrm{X} \leq 0.5)=\int_{-\infty}^{0.5} \frac{1}{\sqrt{2 \pi}} e^{-\frac{1}{2} x^{2}} d x=0.6915
$$

and
(ii) $\mathrm{P}(\mathrm{X} \geq 0.5)=1-\mathrm{P}(\mathrm{X}<0.5)=1-0.6915=0.3085$.
(iii) $P(X \leq-0.3)=F(-0.3)=1-F(0.3)$

From the table, $F(0.3)=0.6179$.
(iv) $P(0.3 \leq X \leq 0.5)=F(0.5)-F(0.3)=0.6915-0.6179=0.0736$
(v) $P(-0.3 \leq X \leq 0.5)=F(0.5)-F(-0.3)=0.6915-0.3821=0.3074$.

## Example 5.9

If $x$ is a normal variable $=5$ and variance $0^{2}=16$, find (i) $P(X) \leq 6$ )
(ii) $\mathrm{P}(3<\mathrm{x}<7)$ (iii) $\mathrm{P}\{\mathrm{X}-5 \backslash>2\}$.

## Solution

From property (4)
(i) $\quad \mathrm{P}\left(\mathrm{X}<(6)=\mathrm{P}\left(\frac{X-\mu}{4} \leq \frac{6-5}{4}\right)=P\left(Y \leq \frac{1}{4}\right)=0.5987\right.$
(ii) $\mathrm{P}(3<\mathrm{X}<7)=\mathrm{P}\left(\frac{3-5}{4}<\frac{X-5}{4}<\frac{7-5}{4}\right)=(-0.5<Y<0.5)$

$$
=\Phi(0.5)-\Phi(-0.5)=0.6915-0.3085=0.3830
$$

(iii)

$$
\begin{aligned}
& \mathrm{P}\{|\mathrm{X}-5|>2\}=\mathrm{P}(\mathrm{X}-5>2 \text { or } \mathrm{X}-5<-2)=\mathrm{P}(\mathrm{X}>7 \text { or } \mathrm{X}<3\} \\
& =\mathrm{P}(\mathrm{X}>7)+\mathrm{P}(\mathrm{X}<3)=\mathrm{P}\left(Y>\frac{7-5}{4}\right)+\left(Y<\frac{3-5}{4}\right) \\
& =\mathrm{P}(\mathrm{Y}>0.5)+\mathrm{P}(\mathrm{Y}<-0.5)=0.3085+0.3085=0.6170 .
\end{aligned}
$$

## Notation:

When we write $X$ is $N\left(o^{2}\right)$, we mean that $X$ has a Normal probability distribution with mean and variance $\mathrm{O}^{2}$

### 5.3.2 The Normal Approximation to the Binomial

Let $X$ be a binomial random variable with parameters $n$ and $p$, then

$$
E(X)=n p, \operatorname{var}(X)=n p(1-p)
$$

An approximation to the distribution of $X$ is given by De Moivre Laplace limit theorem.

## Theorem (De Moivre laplace Limit Thoerem)

If $X$ denote a binomial random variable with mean up and variance $n p(1-p)$, then for any $a<b$,

$$
\lim _{n \rightarrow \infty} P\left\{a \leq \frac{X-n p}{\sqrt{n p(1-p)}} \leq b\right\}=\Phi(b)-\Phi(a)
$$

The accuracy of this approximation is quite good for values of n greater than $10 \mathrm{P}(1-\mathrm{p})$. This theorem says that if $X$ is $B(n, p)$ then large $n, X$ is $N(n p, n p(1-p)$.

## Example 5.10

Let $X$ be a binomial random variable with parameters $n=40, p=0.20$. find the probability that $\mathrm{X}=5$.

Since X is discrete and normal distribution is for continuous random variable, we write
$P(X=5)=\left\{\left(4.5<5.5=P\left(\frac{4.5-4}{1.90}<\frac{X-4}{1.90}>\frac{5.5-4}{1.90}\right)\right.\right.$
$=p(0.26<y<0.79)=\Phi(0.79)-\Phi(0.26)=0.18226$.
Notation: Whenwe write $X$ is $N_{0}(\mu \mathrm{o})$, we mean that X has a normal probability distribution with mean $\mu$ variance $0^{2}$

### 5.2.4 The Exponential Distribution

A continuous random variable, X is said to have an exponential distribution with parameter $>0$ if its pdf is given by,

$$
f(x)=\left\{\begin{array}{lr}
\lambda e^{-\lambda x} & \text { if } x \geq 0 \\
0 & x<0
\end{array}\right.
$$

The pdf has the graph shown in Figure 3. It can easily be shown that

$$
\int_{0}^{\infty} \lambda e^{-\lambda x}=1
$$

The exponential distribution plays an important role in point processes and in describing random phenomena. A number of real life situations can be modeled using an exponential distribution.

For example, time to failure of an equipment.

## Properties of the Exponential Distribution

(1) $\quad E(X)$ and standard deviation of $X$ are the same. The expected value of $X$ is given by

$$
\mathrm{E}(\mathrm{X})=\int_{0}^{\infty} x \lambda e^{-\lambda x} d x
$$

On integrating by parts we have

$$
\int_{0}^{\infty} x \lambda e^{-\lambda x} d x=\int_{0}^{\infty}-x d\left(e^{-\lambda x}\right)=-\left.x e^{-\lambda x}\right|_{0} ^{\infty}+\int_{0}^{\infty} e^{-\lambda x} d x=\frac{1}{\lambda}
$$

(ii) The variance of $X$ is given by

$$
\begin{gathered}
\operatorname{Var}(\mathrm{X})=\mathrm{E}\left(\mathrm{X}^{2}\right)-(\mathrm{E}(\mathrm{x}))^{2} \\
\mathrm{E}\left(\mathrm{X}^{2}\right)=\int_{0}^{\infty} x^{2} \lambda e^{-\lambda x} d x=\int_{0}^{\infty}-x^{2} d\left(e^{-\lambda x}\right)=-\left.x^{2} e^{-\lambda x}\right|_{0} ^{\infty}+2 \int_{0}^{\infty} x e^{-\lambda x} d x=\frac{2}{\lambda^{2}}
\end{gathered}
$$

Hence,

$$
\operatorname{Var}(X)=\frac{2}{\lambda^{2}}-\frac{1}{\lambda^{2}}=\frac{1}{\lambda^{2}} .
$$

Thus, the mean and standard deviation of an exponential distribution are the same.

## (ii) Lack of Memory of the Exponential Distribution

A random variable $X$ is said to be without memory $=$, or memorable, if

$$
P(X>s+t \backslash X>t)=P(X>s) \text { for all } s, t \geq 0
$$

$P(X>s+t) X>t=P(X>s+t$ and $X>t=P(X>s+t$

By the definition of memoryless, we have,

$$
P(x>s)=\frac{1-F(x+t)}{1-F(t)}
$$

That is,

$$
\begin{gathered}
1-F(s)=\frac{F(s+t)}{1-F(t)} \\
(1-F(s))(1-F(t)=1-F(s+t) \\
F(X)=P(X \leq x)=d y=1-e^{e} \\
1-F(x)=e x \\
P(X>s)=1-F(s)=e^{x} \\
P(X>s+t)=1-F(s+t)=e \\
(p(x>t)=1-F(t)=e \\
P(X>s)=e \\
e-\mu=e
\end{gathered}
$$

thus, an exponential random variable is memoryless. The only continuous random variable $X$ assuming non negative values satisfying

$$
P(X<s+t / X>t)=p(X>s) \text { for all } s, t>0
$$

(iii) The moment generating functions of $X$ is given by (definition 7 of chapter 4).

## 5,2,5 The Gamma Distribution

## Definition 6

The gamma function, denoted by l', is defined as follows:

$$

By integrating by parts, we have

$$
\mathrm{F}(\mathrm{X})=\int_{0}^{\infty}-y^{x-1} d\left(e^{-y}\right) d y=-y^{x-1} e^{-y}\left[\begin{array}{c}
\infty \\
0
\end{array}+\int_{0}^{\infty}(x-1) y^{x-2} e^{-y} d y\right.
$$

$$
=(x-1) \int_{0}^{\infty} y^{x-2} e^{-y} d y=(x-1) \Gamma(x-1)
$$

$\Gamma(x)=(x-1) \Gamma(x-1)=(x-1) \cdot(x-2) \Gamma(X-2)=(X-1)!\Gamma(1) \backslash$

$$
(1)=\int_{0}^{\infty} e^{-y} d y=1
$$

Hence

$$
\Gamma(x)=(x-1)!
$$

It is also easy to verity that
(i) $\Gamma\left(\frac{1}{2}\right)=\int_{0}^{\infty} y^{-\frac{1}{2}} e^{-y} d y=\sqrt{\pi}$
(ii) $\quad \int_{0}^{\infty} \frac{y^{n-1} e^{-y} d y}{\Gamma^{(n)}}=1$.

Definition 7
Let $X$ be a continuous random variable assuming only non-negative values. Then $X$ is said to have a gamma distribution if its pdf is given by

$$
f(x)= \begin{cases}\frac{\lambda(\lambda x)^{n-1}}{\Gamma(n)} e^{-\lambda x} & x>0 \\ 0 & \text { elsewhere }\end{cases}
$$

$\lambda$ and $n$ are called the paramenters of the distribution. $f(x)$ is denoted by $\Gamma(n, \lambda)$.

## Properties of the Gamma distribution

1. $\mathrm{E}(\mathrm{X})=\frac{n}{\lambda}, \operatorname{Var}(X)=\frac{n}{\lambda^{2}}$

To see this, we have

$$
\mathrm{E}(\mathrm{X})=\int_{0}^{\infty} x \cdot \frac{\lambda(\lambda x)^{n-1} e^{-\lambda x}}{\Gamma(n)} d x=\int_{0}^{\infty} \frac{\lambda^{n} X^{n} e^{-\lambda x}}{\Gamma(n)} d x=\frac{\lambda^{n}}{\Gamma(n)} \int_{0}^{\infty} X^{n} e^{-\lambda x} d x .
$$

Let $y=\lambda x, d y=\lambda d x$

$$
\int_{0}^{\infty} x^{n} e-\lambda x d x=\int_{0}^{\infty}\left(\frac{y}{\lambda}\right)^{n} e^{-y} \frac{1}{\lambda} d y=\frac{1}{\lambda^{n+1}} \int_{0}^{\infty} y^{n} e^{-y} d y
$$

Hence,

$$
\mathrm{E}(\mathrm{X})=\frac{\lambda^{n}}{\Gamma(n)} \cdot \frac{\Gamma(n+1)}{\lambda^{n+1}}=\frac{n}{\lambda} .
$$

Similarly,

$$
\begin{array}{r}
\mathrm{E}\left(\mathrm{X}^{2}\right)=\int_{0}^{\infty} x^{2} . \frac{\lambda(\lambda x)^{n-1} e^{-\lambda x}}{(n)} d x=\frac{\lambda^{n}}{\Gamma(n)} \int_{0}^{\infty} x^{n+1} e^{-\lambda x} d x . \\
\int_{0}^{\infty} x^{n+1} e^{-\lambda x} d x=\frac{\Gamma(n+2)}{\lambda^{n+2}} .
\end{array}
$$

Hence,

$$
\mathrm{E}\left(\mathrm{X}^{2}\right)=\frac{\lambda^{n}}{\Gamma(n)} \cdot \frac{\Gamma(n+2)}{\lambda^{n+2}}=\frac{n(n+1)}{\lambda^{2}} .
$$

Thus

$$
\operatorname{Var}(\mathrm{X})=\frac{n(n+1)}{\lambda^{2}}-\frac{n^{2}}{\lambda^{2}}=\frac{n}{\lambda^{2}} .
$$

The moment generating function of x is given by

$$
\begin{aligned}
\mathrm{M}_{\mathrm{x}}(\mathrm{t}) & =\int_{0}^{\infty} e^{t x} \frac{\lambda^{n} X^{n-1} e^{-\lambda x}}{\Gamma(n)} d x=\frac{\lambda^{2}}{\Gamma(n)} \int_{0}^{\infty} x^{n-1} e^{-x(\lambda-t)} d x \\
& =\frac{\lambda^{n}}{\Gamma(n)} \cdot \frac{1}{(\lambda-t)^{n-1}} \int_{0}^{\infty}[x(\lambda-t)]^{n-1} e^{-x(\lambda-t)} d x .
\end{aligned}
$$

Let $\mathrm{y}=\mathrm{x}(\lambda-\mathrm{t}), \mathrm{dy}=(\lambda-\mathrm{t}) \mathrm{dx}$. Therefore
$\mathrm{M}_{\mathrm{x}}(\mathrm{t})=\frac{\lambda^{n}}{\Gamma(n)(\lambda-t)^{n}} \int_{0}^{\infty} y^{n-1} e^{-y} d y=\frac{\lambda^{n}}{\Gamma(n)(\lambda-t)^{n}} . \Gamma(n)=\left[\frac{\lambda}{\lambda-t}\right]^{n}$
2. If $X$ is a random variable having $\Gamma(n, \lambda)$ distribution and $Y$ is a poisson random variable with parameter $\lambda x$, then

$$
P(X \leq x)=P(Y \geq n)
$$

That is

$$
\int_{0}^{\infty} \frac{\lambda^{n} y^{n-1} e^{-\lambda y}}{\Gamma(n)} d y=\sum_{n}^{\infty} \frac{(\lambda x)^{k} e^{-\lambda x}}{k!} .
$$

3. If $\mathrm{n}=1, \mathrm{f}(\mathrm{x})$ becomes

$$
f(x)=\lambda e^{-\lambda x}
$$

Hence, the exponential distribution is a special case of the Gamma distribution.

### 5.2.6 The Chi-square Distribution

A special case of the gamma distribution in which $\lambda=\frac{1}{2}$ and $n$ replaced by $n / 2$, where $n$ is a positive integer is called the chi-square distribution. The pdf is given by

$$
f(x)=\frac{x^{\frac{n}{2}-1}\left(\frac{1}{2}\right)^{\frac{n}{2}} e^{-\frac{n}{2} x}}{\Gamma\left(\frac{n}{2}\right)}=\frac{1}{2^{\frac{n}{2}} \Gamma\left(\frac{n}{2}\right)} x^{\frac{n}{2}-1} e^{-\frac{x}{2}}, x>0
$$

A continuous random variable having pdf $f(x)$ given by (7) is said to have a chi-square distribution with $n$ degrees of freedom (denoted by $\chi_{n}$ ). Because of its importance, the chi-square distribution is tabulated for various value of the parameter $n$ ) see table 4). If $X$ has a chi-square distribution with $n$ degrees of freedom, we have
(i) $E(X)=n$;
(ii) $\operatorname{Var}(X)=2 n$;
(iii) $\quad M_{x}(t)=(1-2 t)^{-n / 2} ; t>\frac{1}{2}$.

The graph of $f(x)$ is shown in figure below.

### 5.2.7 The uniform distribution

A continuous random variable $X$ assuming all values in the interval $(a, b)$ where both a and $b$ are finite is said to be uniformly distributed over the interval $(a, b)$ if its pdf is given by

$$
f(x)=\left(\begin{array}{lc}
\frac{1}{b-a} & a \leq x \leq b \\
0 & \text { elsewhere }
\end{array}\right.
$$

The graph of $f(x)$ is shown in figure below:

1. $\mathrm{E}(\mathrm{X}) \frac{a+b}{2}, M_{x}(t)=\frac{e^{b t}-e^{a t}}{t(b-a)}$

$$
\begin{aligned}
& e^{t a}=1+t a+\frac{(t a)^{2}}{2!}+\cdots \\
& e^{t a}+1+t b+\frac{(t b)^{2}}{2!}+\cdots \\
& \frac{e^{b t}-e^{a t}}{t(b-a)}=\frac{1}{b-a}\left[(b-a)+\frac{\left(b^{2}-a^{2}\right) t}{2!}+\frac{\left(b^{3}-a^{3}\right) t^{2}}{3!}+\cdots\right]
\end{aligned}
$$

$$
M_{X}(t)=\frac{1}{b-a}\left[\frac{\left(b^{2}-a^{2}\right) t}{2!}+\frac{\left(b^{3}-a^{3}\right) t^{2}}{3!}+\cdots\right]
$$

$$
\mathrm{M}_{\mathrm{x}}^{\prime}(0)=\frac{\left(b^{2}-a^{2}\right)}{2(b-a)}=\frac{(b-a)(b+a)}{2(b-a)}=\frac{b+a}{2}
$$

Similarly,

$$
\mathrm{M}_{\mathrm{x}}^{\prime}(0)=\frac{\left(b^{3}-a^{3}\right)}{3(b-a)}
$$

Hence,

$$
\begin{gathered}
\operatorname{Var}(\mathrm{X})=\frac{\left(b^{3}-a^{3}\right)}{3(b-a)}-\frac{a+b}{2}=\frac{\left.b^{2}+a b+a^{2}\right)}{3}-\frac{a+b}{2}=\frac{1}{6}\left[2\left(b^{2}+a b+a^{2}\right)-3(a+b)\right] \\
\mathrm{F}(\mathrm{x})=\mathrm{P}(\mathrm{X} \leq \mathrm{x})=\left\{\begin{array}{l}
\frac{x-a}{b-a} a \leq x \leq b \\
1
\end{array} \quad x>b\right.
\end{gathered}
$$

### 5.2.8 The Beta Distribution

A continuous random variable $X$ is said to have a beta distribution if its pdf is given by $\alpha$, $\beta>-1$

$$
f(X)=\left\{\begin{array}{c}
\frac{\alpha+\beta+1)!}{\alpha!\beta!} x^{\alpha}(1-x)^{\beta}, 0<x<1 \\
0 \\
\text { elsewhere }
\end{array}\right.
$$

$f(x)$ becomes the pdf of a uniform distribution over $(0,1)$ when $\alpha=\beta=0$.

1. $\mathrm{E}\left(\mathrm{x}^{r}\right)=\int_{0}^{1} x^{r} \frac{(\alpha+\beta+1)!}{\alpha!\beta!} x^{\alpha}(1-x)^{\beta} d x=\frac{(\alpha+\beta+1)!}{\beta!\alpha!} \int_{0} x^{r+\alpha}(1-x)^{\beta} d x$.

From definition (Beta function)

$$
\frac{\alpha!\beta!}{(\alpha+\beta+1)!}=\int_{0}^{1} x^{\alpha}(1-x)^{\beta} d x
$$

and

$$
\int_{0}^{1} x^{r+\alpha}(1-\alpha)^{\beta} d x=\frac{(r+\alpha)!\beta!}{(r+\alpha+\beta+1)!}
$$

We have

$$
E\left(x^{r}\right)=\frac{(\alpha+\beta+1)!}{\beta!\alpha!} \times \frac{(r+\alpha)!\beta!}{(r+\beta+1)!}=\frac{(\alpha+\beta+1)!(r+\alpha)!}{\alpha!(r+\beta+1)!} .
$$

The moment generating function of $X$ does not have a simple form.

### 5.2.9 The Weibull Distribution

A random variable is said to have a Cauchy distribution with parameter $\theta,-\infty<\theta<\infty$, if its pdf is given by

$$
\mathrm{f}(\mathrm{x})=\frac{1}{\pi} \cdot \frac{1}{\left[1+(x-\theta)^{2}\right]},-\infty<x<\infty
$$

For an illustration of a Cauchy distribution random variable. See example 6.12

## UNIT 2

## JOINTLY DISTRIBUTED RANDOM VARIABLES

### 6.1 Bivariate Distribution

In our study so far, we have considered only univariate distribution, Univariate distribution depends on only one random variable but we are frequently interested in specifying two or more random variables for a member of a population and interested in probability statements. For example, the age A and the systolic blood pressure, P may be of interest and we would consider ( $\mathrm{A}, \mathrm{P}$ ) as a single experimental outcome. We might study the height H and the weight W of a chosen person given rise to the outcome (h, w). A probability distribution which depends on two random variables. Table (1) gives the joint variables. Table (1) gives the joint probability density function of two discrete random variables X , number of white marbles, and Y , number of blue marbles in a sample of 3 chosen at random from a box containing 4 red, 3 white and 5 blue marbles.

Table 1

| $\mathrm{X} / \mathrm{Y}$ | 0 | 1 | 2 | 3 |  |
| :---: | :---: | :---: | :---: | :---: | :--- |
| 0 | $1 / 55$ | $3 / 22$ | $2 / 11$ | $1 / 22$ | $21 / 55$ |
| 1 | $9 / 110$ | $3 / 11$ | $3 / 22$ | 0 | 2755 |
| 2 | $3 / 55$ | $3 / 44$ | 0 | 0 | $27 / 220$ |
| 3 | $1 / 220$ | 0 | 0 | 0 | $1 / 220$ |
|  | $35 / 220$ | $21 / 44$ | $7 / 22$ | $1 / 22$ | 1 |

We denote the probability that $X$ takes the value of $x$ and $Y$ the value $y$ by $f(x, y)$ where $f(x, y)=P(X=x, Y=y)$.

For example, the probability that the sample contains 1 white and 2 blue marbles is denoted by $f(1,2)$. From the table,

$$
\mathrm{f}(1,2)=3 / 22
$$

This is calculated thus:

$$
\mathrm{P}(\mathrm{X}=1, \mathrm{Y}=2)=\frac{{ }^{3} C_{1} \times{ }^{5} C_{2}}{{ }^{12} C_{2}}=\frac{3 \times 10}{220}=3 / 22
$$

The reader should verify the entries in table (1).
Note:
(i) $\quad \sum \sum \mathrm{f}(\mathrm{x}, \mathrm{y})=1$.
(ii) $0 \leq f(x, y) \leq 1$ for all ( $x, y$ ).
(iii) the row totals form what is called the marginal distribution of $X$ denoted by $f_{x}(x)$ and the column totals is called the marginal distribution of $Y$ denoted by $f_{y}(y)$.
From table (1) the probability of obtaining a particular value of X irrespective of the value of Y is given below.

Table 2

| x | 0 | 1 | 2 | 3 |
| :---: | :---: | :---: | :---: | :---: |
| $\mathrm{f}_{\mathrm{x}}(\mathrm{x})$ | $21 / 55$ | $27 / 55$ | $27 / 220$ | $1 / 220$ |

Similarly for Y, we have

| $y$ | 0 | 1 | 2 | 3 |
| :--- | :--- | :--- | :---: | :---: |
| $f_{Y}(x)$ | $35 / 220$ | $21 / 44$ | $7 / 22$ | $1 / 22$ |

If we know the joint probability density function of two random variables X and Y , then we can compute the marginal probability density function $f_{x}(x)$ by summing over $y$ and the marginal probability density function $f_{y}(y)$ by summing over $x$ i.e.

$$
\begin{align*}
& \mathrm{f}_{\mathrm{x}}(\mathrm{x})=\Sigma_{y} f(x, y) \\
& \mathrm{f}_{\mathrm{y}}(\mathrm{y})=\Sigma_{x}(f(x, y)) \tag{1}
\end{align*}
$$

Note: It may happen that X is discrete while Y is continuous, but in most applications it is either both are discrete or both are continuous.

## Definition 1

Two discrete random variables X and Y are said to be independent if their joint density function is give by

$$
f(x, y)=f_{x}(x) f_{Y}(y)
$$

i.e.

$$
P(X=x, Y=y)=P(X=x) P(Y=y) \text { for all pairs of } x, y
$$

In the above example,

$$
\begin{gathered}
\mathrm{f}_{\mathrm{x}}(1)=\frac{27}{55} \\
\mathrm{f}_{\mathrm{y}}(2)=\frac{7}{22} \\
\mathrm{f}(1,2)=\frac{3}{22} \neq \frac{27}{55} \times \frac{7}{22}
\end{gathered}
$$

hence X and Y are dependent (not independent) random variables.

### 6.2 Expectation of Sum and Product of Jointly Distributed Discrete Random Variables

Let $f(x, y)$ be the joint probability density function of $X$ and $Y$ and $f_{x}(x), f_{y}(y)$, the marginal probability densities of X and Y respectively. Then

$$
\mathrm{E}(\mathrm{X})=\sum \mathrm{xf}_{\mathrm{x}}(\mathrm{x})
$$

and

$$
\mathrm{E}(\mathrm{Y})=\sum_{\mathrm{y}} \mathrm{y} \mathrm{f}_{\mathrm{y}}(\mathrm{y})
$$

For example, consider the variables X and Y having the joint pdf given by the table (1). The marginal pdf is given by table (2). Then

$$
\begin{aligned}
& E(X)=\left(0 \times \frac{21}{55}\right)+\left(1 \times \frac{27}{220}\right)+\left(2 \times \frac{27}{220}\right)+\left(3 \times \frac{1}{220}\right)=0.38 \\
& E(Y)=\left(0 \times \frac{35}{230}\right)+\left(1 \times \frac{21}{44}\right)+\left(2 \times \frac{7}{22}\right)+\left(3 \times \frac{1}{22}\right)=2.61
\end{aligned}
$$

and

$$
\mathrm{E}(\mathrm{X}+\mathrm{Y})=\mathrm{E}(\mathrm{X})+\mathrm{E}(\mathrm{Y})=2.99
$$

## Expectation of Product

The expectation of product of two discrete random variables is defined as

$$
\mathrm{E}(\mathrm{XY})=\Sigma_{y} \quad \Sigma_{x} x y f(x, y)
$$

For the above example we have
$\left(\quad(0 \times 0) \times \frac{1}{55}\right)+\left(\quad(0 \times 1) \times \frac{3}{22}\right)+\left(\quad(0 \times 2) \times \frac{2}{11}\right)+\left(\quad(0 \times 3) \times \frac{1}{22}\right)$
$+\left((1 \times 0) \times \frac{9}{110}\right)+\left((1 \times 1) \times \frac{3}{11}\right)+\left((1 \times 2) \times \frac{3}{22}\right)$
$+\left((2 \times 0) \times \frac{3}{55}\right)+\left((2 \times 1) \times \frac{3}{44}\right) \times\left((3 \times 0) \times \frac{1}{220}\right)$
$=\left(1 \times \frac{3}{11}\right)+\left(2 \times \frac{3}{22}\right)+\left(2 \times \frac{3}{44}\right)=\frac{30}{44}$

## Variance of Sum of Two Random Variables

From the definition variance $E\left(X^{2}\right)-[E(X)]^{2}$ replacing $X$ by $X+Y$ we have $\operatorname{Var}(X+Y)$

$$
\begin{aligned}
=\mathrm{E}(\mathrm{X}+\mathrm{Y})]^{2} & \\
& =\mathrm{E}\left(\mathrm{X}^{2}+\mathrm{Y}^{2}+2 \mathrm{XY}\right)-[\mathrm{E}(\mathrm{X})]^{2}-[\mathrm{E}(\mathrm{Y})]^{2}-2 \mathrm{E}(\mathrm{X}) \mathrm{E}(\mathrm{Y}) \\
& =\mathrm{E}\left(\mathrm{X}^{2}\right)+\mathrm{E}\left(\mathrm{Y}^{2}\right)+2 \mathrm{E}(\mathrm{XY})-[\mathrm{E}(\mathrm{X})]^{2}-[\mathrm{E}(\mathrm{Y})]^{2}-2 \mathrm{E}(\mathrm{X}) \mathrm{E}(\mathrm{Y}) \\
& =\mathrm{E}\left(\mathrm{X}^{2}\right)-[\mathrm{E}(\mathrm{X})]^{2}+\mathrm{E}\left(\mathrm{Y}^{2}\right)-[\mathrm{E}(\mathrm{Y})]^{2}+2[\mathrm{E}(\mathrm{XY})-\mathrm{E}(\mathrm{X}) \mathrm{E}(\mathrm{Y})] \\
& =\operatorname{Var}(\mathrm{X})+\operatorname{Var}(\mathrm{Y})+2[\mathrm{E}(\mathrm{XY})-\mathrm{E}(\mathrm{X}) \mathrm{E}(\mathrm{Y})] \\
& =\operatorname{Var}(\mathrm{X})+\operatorname{Var}(\mathrm{Y})+2 \operatorname{Cov}(\mathrm{X}, \mathrm{Y})]
\end{aligned}
$$

Where $\operatorname{Cov}(\mathrm{X}<\mathrm{Y})=\mathrm{E}(\mathrm{XY})-\mathrm{E}(\mathrm{X}) \mathrm{E}(\mathrm{Y})$

Definition 2: Covariance
The covariance of two random variables X and YU denoted by $\operatorname{Cov}(\mathrm{X}<\mathrm{Y})$ is denoted by

$$
\begin{aligned}
& \operatorname{Cov}(\mathrm{X}, \mathrm{y})=\mathrm{E}\{(\mathrm{X}-\mathrm{E}(\mathrm{X}))((\mathrm{Y}-\mathrm{E}(\mathrm{Y})\} \\
& \quad=\mathrm{E}[\mathrm{XY}-\mathrm{XE}(\mathrm{Y})-\mathrm{YE}(\mathrm{X})+\mathrm{E}(\mathrm{X}) \mathrm{E}(\mathrm{Y})=\mathrm{E}(\mathrm{XY})-\mathrm{E}(\mathrm{X}) \mathrm{E}(\mathrm{Y})
\end{aligned}
$$

## Example 1

Given the following joint probability density function of X and Y . Find
(i) The marginal probability density function of X and Y
(ii) The expectation of X and Y
(iii) The covariance of X and Y
(iv) The variance of $\mathrm{X}+\mathrm{Y}$.

| $\mathrm{X} / \mathrm{Y}$ | 1 | 2 | 3 |
| :--- | :--- | :--- | :--- |
| 3 | .1 | .2 | 0 |
| 4 | 0.2 | 0 | .1 |
| 6 | .15 | .15 | .1 |

(i) Summing along the rows we have

| x | 3 | 4 | 6 |
| :--- | :--- | :--- | :--- |
| $\mathrm{f}_{\mathrm{X}}(\mathrm{x})$ | .3 | .3 | .4 |

Summing along the column, we have

| $y$ | 1 | 2 | 3 |
| :--- | :--- | :--- | :--- |
| $f_{\mathrm{Y}}(\mathrm{y})$ | 0.45 | 0.35 | 0.2 |

(ii) $\mathrm{E}(\mathrm{X})=(3 \times 0.3)+(4 \times 0.3)+(6 \times 0.4)=4.5$

Similarly $\mathrm{E}(\mathrm{Y})=(1 \times 0.45)+(2 \times 0.35)+(3 \times 0.2)=1.75$
(iii) $\operatorname{Cov}(\mathrm{X}, \mathrm{y})=\mathrm{E}(\mathrm{XY})-\mathrm{E}(\mathrm{X}) \mathrm{E}(\mathrm{Y})$

$$
\begin{aligned}
\mathrm{E}(\mathrm{XY}) & =\sum \sum \mathrm{xyf}(\mathrm{x}, \mathrm{y}) \\
& =((3 \times 1) \times 0.1)+((3 \times 2) \times 0.2)+((4 \times 1) \times 0.2) \\
& +((4 \times 3) \times 0.1)+((6 \times 1) \times 0.15)+(12 \times 1.5)+((6 \times 3) \times 0.1)=8.0
\end{aligned}
$$

Hence,

$$
\operatorname{Cov}(\mathrm{X}, \mathrm{Y})=8.0-(4.5)(1.75)=0.125
$$

(iv) $\mathrm{E}\left(\mathrm{X}^{2}\right)=21.9$

$$
\begin{gathered}
\operatorname{Var}(\mathrm{X})=21.9-20.25=1.65 \\
\mathrm{E}\left(\mathrm{Y}^{2}\right)=3.65
\end{gathered}
$$

Hence,

$$
\operatorname{Var}(\mathrm{X}+\mathrm{Y})=\operatorname{Var}(\mathrm{X})+\operatorname{Var}(\mathrm{Y})+2 \operatorname{Cov}(\mathrm{X}, \mathrm{Y})=1.65+0.25=2.49
$$

### 6.3 Independent Random Variables

$X$ and $Y$ are said to be independent if

$$
P(X=x, Y=y)=P(X=x) P(Y=y)
$$

For all pairs (x. y). That is,

$$
f(x, y)=f_{x}(x) f_{y}(y) \text { for all pairs }(x, y)
$$

thus for any subset A and Bof R

$$
\mathrm{P}(\mathrm{X} \varepsilon \mathrm{~A}, \mathrm{Y} \varepsilon \mathrm{~B})=\mathrm{P}(\mathrm{X} \varepsilon \mathrm{~A}) \mathrm{P}(\mathrm{Y} \varepsilon \mathrm{~B}) .
$$

## Example 2

Two random variables X and Y have the joint probability distribution given by

| $\mathrm{X} / \mathrm{Y}$ | 1 | 2 |
| :--- | :--- | :--- |
| 1 | 0.2 | 0.4 |
| 2 |  | 0.3 |

Show that X and Y are not independent.

## Solution

The marginal pdf of X is

| x | 1 | 2 |
| :--- | :--- | :--- |
| $\mathrm{f}_{\mathrm{X}}(\mathrm{x})$ | 0.6 | 0.4 |

And that of Y is

| Y | 1 | 2 |
| :--- | :--- | :--- |
| $\mathrm{f}_{\mathrm{y}}(\mathrm{y})$ | 0.5 | 0.5 |

$$
\begin{gathered}
\mathrm{P}(\mathrm{X}=1, \mathrm{Y}=1)=0.2 \\
\mathrm{P}(\mathrm{X}=1)=0.6, \mathrm{P}(\mathrm{Y}=1)=0.5 \\
\mathrm{P}(\mathrm{X}=1) \mathrm{P}(\mathrm{Y}=1)=0.30 \neq \mathrm{P}(\mathrm{X}=1, \mathrm{Y}=1)=0.2
\end{gathered}
$$

Hence X and Y are not independent.
Consider two independent random variables X and Y . then

$$
\mathrm{E}(\mathrm{XY})=\mathrm{E}(\mathrm{X}) \mathrm{E}(\mathrm{Y})
$$

To see this, note that

$$
\begin{gathered}
\mathrm{E}(\mathrm{XY})=\Sigma_{x} \quad \Sigma_{y} x y f(x, y)=\Sigma_{x} \quad \Sigma_{y} x y f_{x}(x) f_{y}(y) \\
=\left[\Sigma x f_{x}(x)\right]\left[\Sigma y f_{y}(y)\right]=E(X) E(y)
\end{gathered}
$$

Thus if two random variables X and Y are independent, then

$$
\begin{equation*}
\mathrm{E}(\mathrm{XY})=\mathrm{E}(\mathrm{X}) \mathrm{E}(\mathrm{Y}) \tag{3}
\end{equation*}
$$

That is $\operatorname{Cov}(\mathrm{X}, \mathrm{Y})=0$.
Note that independent and zero covariance are not the same. That is if $\mathrm{E}(\mathrm{XY})=\mathrm{E}(\mathrm{X}) \mathrm{E}(\mathrm{Y})$ it does not imply that X and Y are independent.

## Definition 3: Correlation Coefficient

Let X and Y be two random variable having finite non-zero variance. One measure of degree of dependence between X and Y is the correlation coefficient denoted by $\mathrm{p}(\mathrm{X}, \mathrm{Y})$ and defined by

$$
\rho=\rho(\mathrm{X}, \mathrm{Y})=\frac{\operatorname{Cov}(X, Y)}{\sqrt{\operatorname{Var}(X) \operatorname{Var}(Y)}}
$$

it can be shown that $-1 \leq \mathrm{p} \leq 1$.
If X and Y are independent random variables then
(i) $\quad \rho=0$
(ii) $\operatorname{Var}(\mathrm{X}+\mathrm{Y})=\operatorname{Var}(\mathrm{X})+\operatorname{Var}(\mathrm{Y})$
(iii) $\operatorname{Var}(\mathrm{aX}+\mathrm{bY})=\mathrm{a}^{2} \operatorname{Var}(\mathrm{X})+\mathrm{b}^{2} \operatorname{Var}(\mathrm{Y})$ where a and b are constants.
(iv) $\operatorname{Var}(\mathrm{X}-\mathrm{Y})=\operatorname{Var}(\mathrm{X})+\operatorname{Var}(\mathrm{Y})$.

### 6.4 Conditional Probability Density Function

In chapter Two, we defined the conditional probability of an event A given event $B$ by

$$
\mathrm{P}(\mathrm{~A} \mid \mathrm{B})=\frac{P(\mathrm{~A} \cap B)}{P(B)}
$$

Similarly, this idea can be extended to random variables. Thus

$$
\mathrm{P}(\mathrm{X}=\mathrm{x} \mid \mathrm{Y}=\mathrm{y})=\frac{P(X=x \text { and } Y=y)}{P(Y=y)}
$$

## Definition 4

If X and Y are two jointly distributed discrete random variables, trhe conditional probability density function of X given $\mathrm{Y}=\mathrm{y}$ is denoted and defined by

$$
\left.\mathrm{f}_{\mathrm{X}}\right|_{\mathrm{y}}(\mathrm{x} \mid \mathrm{y})=\mathrm{P}(\mathrm{X}=\mathrm{x} \mid \mathrm{Y}=\mathrm{y})=\frac{P(X=x \cdot Y=y)}{P(Y=y)}=\frac{f(X, y)}{f_{Y}(y)} .
$$

It follows that

$$
\left.\mathrm{f}_{\mathrm{X}}\right|_{\mathrm{y}}(\mathrm{x} \mid \mathrm{y})=\frac{f(\mathrm{X}, y)}{f_{\mathrm{Y}}(y)} .
$$

And

$$
F(x, y)=\left.f_{x}\right|_{y}\left(\left.x\right|_{y)} f_{y}(y)\right.
$$

## Example 3

Let the joint probability density function of X and Y be given by the table below.

| $\mathrm{X} / \mathrm{Y}$ | 1 | 2 | 3 |
| :--- | :--- | :--- | :--- |
| 3 | .1 | .2 | 0 |
| 4 | .2 | 0 | .1 |
| 6 | .15 | .15 | .1 |

Compute the conditional probability density function of X given that $\mathrm{Y}=2$.

## Solution

From the joint p.d.f. table we have using the formula

$$
\begin{gathered}
\left.\mathrm{f}_{\mathrm{X}}\right|_{\mathrm{y}}(\mathrm{x} \mid \mathrm{y})=\frac{f(X, y)}{f_{Y}(y)} . \\
\left.\mathrm{f}_{\mathrm{X}}\right|_{\mathrm{y}=2}(3 \mid 2)=\frac{f(3,2)}{f_{Y}(2)}=\frac{P(X=3, Y=2)}{P(Y=2)}=\frac{0.2}{0.35}=\frac{4}{7} \\
\left.\mathrm{f}_{\mathrm{X}}\right|_{\mathrm{y}=2}\left(\left.4\right|_{2)}=\frac{P(X=4, Y=2)}{P(Y=2)}=0\right.
\end{gathered}
$$

$$
\left.\mathrm{f}_{\mathrm{X}}\right|_{\mathrm{y}=2}\left(\left.6\right|_{2)}=\frac{P(X=6, Y=2)}{P(Y=2)}=\frac{0.15}{0.35}=\frac{3}{7^{\prime}}\right.
$$

Hence, the conditional pdf of $X$ given $Y=2$ is

| $X$ | 3 | 4 | 6 |
| :--- | :--- | :--- | :--- |
| $\left.\mathrm{f}_{\mathrm{X}}\right\|_{\mathrm{y}=2}(\mathrm{x}$ | $2)$ | $\frac{4}{7}$ | 0 |
| $\frac{3}{7}$ |  |  |  |

It is left as an exercise to show that the conditional pdf of X given that $\mathrm{Y}=1,3$ are

1. $\left.\mathrm{f}_{\mathrm{X}}\right|_{1}(\mathrm{x} \mid 1)$

| x | 3 | 4 | 6 |
| :---: | :---: | :---: | :---: |
| $\left.\mathrm{f}_{\mathrm{X}}\right\|_{1}(\mathrm{x} \mid 1)$ | $\frac{2}{9}$ | $\frac{4}{9}$ | $\frac{3}{9}$ |

2. $\left.\mathrm{f}_{\mathrm{X}}\right|_{3}(\mathrm{x} \mid 3)$

| X | 3 | 4 | 6 |
| :--- | :--- | :--- | :--- |
| $\left.\mathrm{f}_{\mathrm{X}}\right\|_{3}(\mathrm{x} \mid 3)$ | 0 | $\frac{1}{2}$ | $\frac{1}{2}$ |

Definition 5: Conditional Expectation
The conditional expectation of X given $\mathrm{Y}=\mathrm{y}$ is defined by

$$
\mathrm{E}(\mathrm{X} \mid \mathrm{y})=\left.\sum \mathrm{xf}_{\mathrm{x}}\right|_{\mathrm{y}}(\mathrm{x} \mid \mathrm{y})
$$

Where $\left.f_{X}\right|_{y}(x \mid y)$ is the conditional probability density function of $X$ given $Y=y$.

Definition 6: Conditional Variance
The conditional variance of X given y is defined by

$$
\operatorname{Var}(X \mid y)=E\left(X^{2} \mid y\right)-[E(X \mid y)]^{2}
$$

## Example 4

Calculate the conditional expectation and conditional variance of X given that $\mathrm{Y}=2$ where the joint pdf of X and Y is given in Example 3. From example 3, we have

$$
\begin{aligned}
& \mathrm{E}(\mathrm{X} \mid \mathrm{Y}=2)=\left(3 \times \frac{4}{7}\right)+\left(6 \times \frac{3}{7}\right)=\frac{30}{7}=4 \frac{2}{7} \\
& \mathrm{E}\left(\mathrm{X}^{2} \mid \mathrm{Y}=2\right)=\left(9 \times \frac{4}{7}\right)+\left(36 \times \frac{3}{7}\right)=\frac{144}{7}
\end{aligned}
$$

Hence condition variance of X given that $\mathrm{Y}=2$ is

$$
\operatorname{Var}\left(\left.\mathrm{X}\right|_{\mathrm{Y}=2)}=\mathrm{E}\left(\left.\mathrm{X}^{2}\right|_{\mathrm{Y}=2)}-[\mathrm{E}(\mathrm{X} \mid \mathrm{Y}=2)]^{2}=\frac{144}{7}-\left(\frac{30}{7}\right)^{2}=2.20\right.\right.
$$

(a) Find the value of k, (b) Find the marginal distribution of X and Y and
(c) Are X and Y independent?

### 6.5 Multinomial Distribution

Multinomial distribution is a generalization of the binomial distribution in which each of n independent identical experiments can result in any of k possible outcomes with probabilities

$$
\mathrm{p}_{1}, \mathrm{p}_{2}, \ldots \mathrm{p}_{\mathrm{k}}, \sum \mathrm{p}_{\mathrm{k}}=1
$$

For $\mathrm{k}=2$ we have the binomial distribution.
Consider an experiment, such as rolling a die, that can result in only a finite number of k distinct outcomes at let $X_{i}$ be the number of the $n$ experiments that result in outcome number i.

Then

$$
\mathrm{P}\left(\mathrm{X}_{1}=\mathrm{x}_{1}, \mathrm{X}_{2}=\mathrm{x}_{2}=\ldots \mathrm{X}_{\mathrm{k}}=\mathrm{x}_{\mathrm{k}}\right)=p_{1}^{x_{1}} \cdot p_{2}^{x_{2}} \ldots p_{k}^{x_{k}} \cdot c\left(\mathrm{x}_{1}, \mathrm{x}_{2}, \ldots \mathrm{x}_{\mathrm{k}}\right)
$$

Where $\mathrm{c}\left(\mathrm{x}_{1}, \mathrm{x}_{2}, \ldots \mathrm{x}_{\mathrm{k}}\right)=$ number of possible sequences of outcomes for the n experiments to yield

$$
\mathrm{X}_{1}=\mathrm{x}_{1}, \mathrm{X}_{2}=\mathrm{x}_{2}=\ldots \mathrm{X}_{\mathrm{n}}=\mathrm{x}_{\mathrm{n}} .
$$

From our knowledge of mathematics of counting,

$$
\mathrm{c}\left(\mathrm{x}_{1}, \mathrm{x}_{2}, \ldots \mathrm{x}_{\mathrm{k}}\right)=\frac{n!}{x_{1}!x_{2}!\ldots x_{k}!}
$$

can be regarded as the number of ways n objects can be partitioned into k classes such that class contains $\mathrm{x}_{\mathrm{i}}$ objects $(\mathrm{I}=1,2, \ldots \mathrm{k})$. Thus,

$$
\begin{gathered}
\mathrm{P}\left(\mathrm{X}_{1}=\mathrm{x}_{1}, \mathrm{X}_{2}=\mathrm{x}_{2}, \ldots \mathrm{X}_{\mathrm{k}}=\mathrm{x}_{\mathrm{k}}\right)=\frac{n!}{x_{1} \mid x_{2}!\ldots x_{k}!} p_{1}^{x_{1}} p_{2}^{x_{2}} \ldots p_{k}^{x_{k}} \\
\sum_{1}^{k} x_{i}=n, \sum_{1}^{k} p_{i}=1 .
\end{gathered}
$$

Example 5
Suppose that a fair die is rolled 12 times. Find the probability that 1 and 6 appear 2 times each. 3 thrice each, 3 times, and 4 and 5 once each.

## Solution

Let $X_{i}$ be the number of times ith outcome appears.

$$
\mathrm{n}=12, \mathrm{x}_{1}=2, \mathrm{x}_{2}=3, \mathrm{x}_{3}=3, \mathrm{x}_{4}=1, \mathrm{x}_{5}=1, \mathrm{x}_{6}=2, \mathrm{p}_{\mathrm{i}}=\frac{1}{6}
$$

Hence,

$$
\begin{aligned}
& \mathrm{P}\left(\mathrm{X}_{1}=2, \mathrm{X}_{2}=3, \mathrm{x}_{3}=3, \mathrm{x}_{4}=1, \mathrm{x}_{5}=1, \mathrm{x}_{6}=2\right) \\
& =\frac{12!}{2|3| 3!1 \mid 2!}\left(\frac{1}{6}\right)^{2}\left(\frac{1}{6}\right)^{3}\left(\frac{1}{6}\right)\left(\frac{1}{6}\right)\left(\frac{1}{6}\right)^{2}\left(\frac{1}{6}\right)^{3}=\frac{12!}{2|3| 2 \mid 3!}\left(\frac{1}{6}\right)^{12}
\end{aligned}
$$

Example 6
In a certain large population, $70 \%$ are right-handed, $20 \%$ left handed and $10 \%$ are ambidextrous. If 10 persons are chosen at random from the population, what is the probability that (i) all are right-handed? (ii) 7 are right-handed, 2 are left handed and 1 is ambidextrous.

## Solution

$$
\mathrm{P}_{1}=0.7, \mathrm{P}_{2}=0.2, \mathrm{P}_{3}=0.1
$$

Let $X_{1}, X_{2}, X_{3}$ denote number that are right-handed and ambidextrous respectively, then

$$
\mathrm{P}\left(\mathrm{X}_{1}=\mathrm{x}_{1}, \mathrm{X}_{2}=\mathrm{x}_{2}=\mathrm{X}_{3}=\mathrm{x}_{3}\right)=\frac{n!}{x_{1}\left|x_{2}\right| x_{\mathrm{a}}!} p_{1}^{x_{1}} p_{2}^{x_{2}} p_{3}^{x_{3}}
$$

(i) $\quad \mathrm{P}\left(\mathrm{X}_{1}=10, \mathrm{X}_{2}=0=\mathrm{X}_{3}=0\right)=\frac{101}{10!}(0.7)^{10}(0.2)^{0}(0.1)^{0}=(0.7)^{10}=0.028$
(ii) $\mathrm{P}\left(\mathrm{X}_{1}=7, \mathrm{X}_{2}=2=\mathrm{X}_{3}=1\right)=\frac{10!}{7 \mid 211!}(0.7)^{7}(0.2)^{2}(0.1)^{1}=0.0119$.

### 6.6 Continuous Random Variables

In this section we will consider a pair of continuous random variables X and Y and some of their properties. The results in the earlier section, which have been proved for discrete random variables are also applicable to continuous random variables. The joint probability density function of $X$ and $Y$ is denoted by $f(x, y)$ such that

$$
\int_{-\infty}^{\infty} \int_{-\infty}^{\infty} f(x, y) d x d y=1
$$

and

$$
f(x, y) \geq \text { for all }(x, y) \varepsilon[P
$$

(that is, summation in discrete case is replaced by integrals) and the marginal probability density functions are given by

$$
\begin{aligned}
& \mathrm{f}_{\mathrm{X}}(\mathrm{x})=\int_{-\infty}^{\infty} f(x, y) d y \\
& \mathrm{f}_{\mathrm{Y}}(\mathrm{y})=\int_{-\infty}^{\infty} f(x, y) d x
\end{aligned}
$$

The joint probability distribution function F is defined by

$$
F(x, y)=P(X \leq x, Y \leq y)
$$

Where $\mathrm{X}, \mathrm{Y}$ are defined on the same probability space.

$$
\mathrm{F}(\mathrm{x}, \mathrm{y})=\int_{-\infty}^{y} \int_{-\infty}^{x} f(u, v) d u d v
$$

If $B$ is in the range space of $(X, Y)$

$$
\mathrm{P}(\mathrm{X}, \varepsilon<=\mathrm{B})=\mathrm{P}(\mathrm{~B})=\int \quad \int_{B} f(x, y) d x d y
$$

and

$$
\frac{\partial^{2}}{\partial x \partial y} F(x, y)=f(x, y)
$$

The marginal probability distribution function are defined yb

$$
\mathrm{F}_{\mathrm{x}}(\mathrm{x})=\mathrm{P}(\mathrm{X} \leq \mathrm{x}) \text { and } \mathrm{F}_{\mathrm{y}}(\mathrm{y})=\mathrm{P}(\mathrm{Y} \leq \mathrm{y})
$$

From the joint probability distribution function we can get the marginal distribution functions by the following relationship

$$
\begin{aligned}
& \mathrm{F}_{\mathrm{X}}(\mathrm{x})=\mathrm{F}(\mathrm{x}, \infty)=\lim _{y \rightarrow \infty} F(X, y) . \\
& \mathrm{F}_{\mathrm{Y}}(\mathrm{y})=\mathrm{F}(\infty, \mathrm{y})=\lim _{x \rightarrow \infty} F(x, y) .
\end{aligned}
$$

Let X and Y be any continuous random variables. Then X and Y are independent if and only if

$$
f(x, y)=f_{X}(x) f_{Y}(y),-\infty<x<\infty,-\infty<y<\infty
$$

The conditional probability density function of X is defined by

$$
f_{x I y}(x l y)=\frac{f(x, y)}{f_{y}(y)} .
$$

Similarly, the conditional probability function of Y given X is

$$
f_{Y I x}(y I x)=\frac{f(x, y)}{f_{x}(x)}
$$

The conditional expectation is defined by

$$
\mathrm{E}(\mathrm{Y} \mid \mathrm{X}=\mathrm{x})=\left.\int_{-\infty}^{\infty} y f_{Y}\right|_{\mathrm{X}}\left(\left.y\right|_{\mathrm{X}}\right) \mathrm{dy}
$$

## Example 7

Let X and Y have the joint pdf

$$
f(x, y)=\left\{\begin{array}{cc}
2 & 0<x<y<1 \\
0 & \text { elsewhere }
\end{array}\right.
$$

Find
(i) The marginal probability density functions.
(ii) Determine whether or not X and Y are independent
(iii) Find the conditional expectation of X given $\mathrm{Y}=\mathrm{y}$.

## Solution

The marginal probability density function is given by
(i) $\mathrm{f}_{\mathrm{X}}(\mathrm{x})=\int f(x, y) d y, x<y<1,0<x<1$

$$
\mathrm{f}_{\mathrm{X}}(\mathrm{x})=\int_{x}^{1} 2 d y=2 y I_{x}^{1}=2(1-x)
$$

and

$$
\begin{aligned}
\mathrm{f}_{\mathrm{Y}}(\mathrm{y}) & =\int f(x, y) d x, 0<x<y \\
& =\int_{0}^{y} 2 d x=2 x I_{0}^{y}=2 y
\end{aligned}
$$

Hence

$$
f_{x}(x)=\left\{\begin{array}{lc}
2(1-x) & 0<x<1 \\
0 & \text { elsewhere }
\end{array}\right.
$$

and

$$
\mathrm{f}_{\mathrm{y}}(\mathrm{y})=\left\{\begin{array}{lr}
2 \mathrm{y} & 0<\mathrm{y}<1 \\
0 & \text { elsewhere }
\end{array}\right.
$$

(ii) $\quad \mathrm{f}_{\mathrm{x}}(\mathrm{x}) \mathrm{f}_{\mathrm{Y}}(\mathrm{y})=2(1-\mathrm{x}) 2 \mathrm{y}=4 \mathrm{y}(1-\mathrm{x}) \neq \mathrm{f}(\mathrm{x}, \mathrm{y})$

So $X$ and $Y$ are not independent.
(iii) $\quad \mathrm{E}(\mathrm{X} \mid \mathrm{y})=\left.\int x f_{x}\right|_{\mathrm{y}}(x \mid y) \mathrm{dx}=\int \mathrm{x} \frac{\mathrm{f}(\mathrm{x}, \mathrm{y})}{\mathrm{f}(\mathrm{y})} \mathrm{dx}=\int \mathrm{x} \frac{2}{z \mathrm{y}} \mathrm{dx}=\int \frac{\mathrm{x}}{\mathrm{y}} \mathrm{dx}$.

$$
\begin{aligned}
& =\frac{1}{y} \int_{0}^{y} x d x, 0<x<y \\
& =\frac{1}{2} y, 0<y, 1 .
\end{aligned}
$$

## Example 8

Let the random variables X and Y have the joint pdf.


$$
f(x, y)=\quad 0 \quad \text { elsewhere }
$$

Find (i) the marginal probability density functions, (ii) are $\mathrm{X}, \mathrm{Y}$ independent? And (iii) find the $\operatorname{Cov}(x, Y)$.

## Solution

(i) $\mathrm{f}_{\mathrm{X}}(\mathrm{x})=\int f(x, y) d y, 0<y<1$

$$
\begin{gathered}
=\int_{0}^{1}(x+y) d y=x y+\frac{1}{2} y^{2} I_{0}^{1}=x+\frac{1}{2} \\
\mathrm{f}_{\mathrm{Y}}(\mathrm{y})=\int_{0}^{-1}(x+y) d x, 0<x<1 \\
=\frac{1}{2} x^{2}+x y\left[\begin{array}{l}
1 \\
0
\end{array}=\frac{1}{2}+y .\right.
\end{gathered}
$$

Hence,

$$
\begin{aligned}
& \mathrm{f}_{\mathrm{X}}(\mathrm{x}) \stackrel{\frac{1}{2}+\mathrm{X}}{\stackrel{1}{=}} \begin{array}{l}
0<\mathrm{x}<1 \\
0
\end{array} \quad \text { elsewhere }
\end{aligned}
$$

elsewhere
(ii) $\left.f(x, y) \neq f_{X}(x) f_{Y}(x)\right)$. Thus, $X$ and $Y$ are not independent.
(iii) $\mathrm{E}(\mathrm{X})=\int_{0}^{1} x f_{x}(x) d x=\int_{0}^{1} x\left(\frac{1}{2}+x\right) d x=\frac{7}{12}$

$$
\begin{gathered}
\mathrm{E}(\mathrm{Y})=\int_{0}^{1} y f_{Y}(y) d y \\
\mathrm{E}(\mathrm{Y})=\frac{7}{12}
\end{gathered}
$$

$$
\begin{gathered}
E(X Y)=\iint x y f(x, y) d x d y=\int_{0}^{1} \int_{0}^{1} x y(x+y) d x d y=\int_{0}^{1}\left[\int_{0}^{1}\left(x^{2} y+x y^{2}\right) d x\right] d y \\
\int_{0}^{1}\left(x^{2} y+x y^{2}\right) d x=1 / 3 x^{3} y+\frac{1}{2} x^{2} y^{2} I_{0}^{1}=\left(\frac{1}{3}\right) y+\frac{1}{2} y^{2} \\
\int_{0}^{1}\left(\frac{y}{3} y+\frac{1}{2} y^{2}\right) d y=\frac{y^{2}}{6}+\frac{y^{3}}{6} I_{0}^{1}
\end{gathered}
$$

Hence

$$
\mathrm{E}(\mathrm{XY})=1 / 3
$$

Thus,

$$
\operatorname{Cov}(\mathrm{X}, \mathrm{Y})=1 / 3-7 / 12 \cdot 7 / 12 .=-1 / 144
$$

Example 9
Let the random variables $X$ and $Y$ have the joint $p d f$

$$
\mathrm{f}(\mathrm{x}, \mathrm{y}) \stackrel{\frac{1}{x}}{=}\left\{\begin{array}{l}
0<\mathrm{y}<\mathrm{x}<1 \\
0 \quad \text { elsewhere }
\end{array}\right.
$$

Find the marginal p.d.f of X and of Y and the conditional pdf of Y given $\mathrm{X}=\mathrm{x}$.

## Solution

$$
f_{X}(x)=\int f(x, y) d y, 0<y<x, 0<x<1
$$

$=\int_{0}^{x_{1}} \frac{1}{x} d y=\frac{1}{x} y_{0}^{x}=1$.
Therefore

$$
\begin{gathered}
\mathrm{f}_{\mathrm{X}}(\mathrm{x})=\left\{\begin{array}{l}
0<\mathrm{x}<1 \\
0 \quad \text { elsewhere }
\end{array}\right. \\
\mathrm{F}_{\mathrm{Y}}(\mathrm{y})=\int_{y}^{1} f(x, y) d x=\int_{y}^{1} \frac{1}{x} d x=-\log y
\end{gathered}
$$

Therefore

$$
\begin{aligned}
& \mathrm{f}_{\mathrm{y}}(\mathrm{y})= \begin{cases}-\log \mathrm{y} & 0<\mathrm{y}<1 \\
0 & \text { elsewhere }\end{cases} \\
& \left.\mathrm{f}_{\mathrm{Y}}\right|_{\mathrm{x}}\left(\left.\mathrm{y}\right|_{\mathrm{x})}=\frac{f(x, y)}{f_{x}(x)}= \begin{cases}\frac{1}{x} & 0<\mathrm{y}<\mathrm{x}<1 \\
0\end{cases} \right.
\end{aligned}
$$

Hence X and $\mathrm{Y} / \mathrm{x}$ are uniformly distributed over ( 0,1 ), ( $0, \mathrm{x}$ ) respectively.

## Example 10

Let the random variables X and Y have the joint pdf

$$
\mathrm{f}(\mathrm{x}, \mathrm{y})=\left\{\begin{array}{cc}
\mathrm{x}^{2} f \frac{x y}{3} & 0 \leq \mathrm{x} \leq 1,0 \leq \mathrm{y} \leq 2 \\
0 & \text { elsewhere }
\end{array}\right.
$$

Find the $\mathrm{P}(\mathrm{X}+\mathrm{Y} \leq 2)$.

## Solution

Let $A \equiv\{x, y: x+y \leq 2\}$.

$$
\begin{aligned}
\mathrm{P}(\mathrm{~A}) & =\int_{0}^{1} \int_{0}^{2-x} f(x, y) d y d x=\int_{0}^{1} \int_{0}^{2-x}\left[x^{2}+\frac{x y}{3}\right] d y d x \\
& =\int_{0}^{1} \frac{4 x+8 x^{2}-5 x^{3}}{6} d x=0.57
\end{aligned}
$$

Let X have the poisson pdf with parameter $\lambda$. Find the pdf of $\mathrm{Y}=\mathrm{X}^{2}$

\mathrm{f}(\mathrm{x})=\frac{e^{-\lambda} \lambda^{X}}{x!} ; X=0,1,2, \ldots
$$

## Solution

Possible values of Y are: $0,1,4,9,16 \ldots$

$$
\mathrm{P}(\mathrm{Y}=\mathrm{y})=\mathrm{P}\left(\mathrm{X}^{2}=\mathrm{y}\right)=\mathrm{P}(\mathrm{X}=+\sqrt{y})
$$

(single-valued inverse function)

$$
\begin{aligned}
& =\mathrm{f}(\sqrt{y}), \mathrm{x}=\sqrt{y} \\
& =\left\{\begin{array}{c}
\frac{e^{-\lambda} \lambda \sqrt{y}}{\sqrt{y}}, \quad y=0,1,4,9,16 \ldots \\
0
\end{array} \quad\right. \text { elsewhere }
\end{aligned}
$$

Since X is a positive random variable), $\mathrm{y}=0,1,4,9,16, \ldots$
Example 3
Suppose X is a random variable having probability density function $\mathrm{f}(\mathrm{x})$ given by

| X | -2 | -1 | 0 | 1 | 2 | 3 |
| :--- | :--- | :--- | :--- | :--- | :--- | :--- |
| $\mathrm{f}(\mathrm{x})$ | .15 | .25 | 0.15 | .2 | .15 | .1 |

Find the p.d.f. of $Y=X^{2}$

## Solution

Possible values of Y are $0,1,4,9$.
This is not a one-to-one function

$$
\mathrm{P}(\mathrm{Y}=0)=\mathrm{P}(\mathrm{X}=0)=0.15
$$

$$
\begin{gathered}
\mathrm{P}(\mathrm{Y}=1)=\mathrm{P}(\mathrm{X}=-1 \text { or } 1)=\mathrm{P}(\mathrm{X}=-1)+\mathrm{P}(\mathrm{X}=1)=0.25+0.2=0.45 \\
\mathrm{P}(\mathrm{Y}=4)=\mathrm{P}(\mathrm{X}=-2 \text { or } 2)=\mathrm{P}(\mathrm{X}=-2)+\mathrm{P}(\mathrm{X}=2)=0.15+0.15=0.3 \\
\mathrm{P}(\mathrm{Y}=9)=\mathrm{P}(\mathrm{X}=3)=0.1
\end{gathered}
$$

Hence, the pdf of Y is given by

| y | 0 | 1 | 4 | 9 |
| :--- | :--- | :--- | :--- | :--- |
| $\mathrm{~h}(\mathrm{y})$ | 0.15 | 0.45 | 0.3 | 0.1 |

## Example 4

Let X has the pdf given by

f(x)=\left\{\begin{array}{cc}
\left(\frac{1}{2}\right)^{x}, & x=1,2 \\
0 & \text { elsewhere }
\end{array}\right.
$$

Find the pdf of Y defined by

$$
Y=\left\{\begin{array}{l}
1 \text { if } X \text { is even } \\
1 \text { if } X \text { is odd }
\end{array}\right.
$$

Solution

$$
\begin{aligned}
\mathrm{P}(\mathrm{Y}= & 1)=\mathrm{P}(\mathrm{X}=2,4,6,8, \ldots \\
& =\mathrm{P}(\mathrm{X}=2)+\mathrm{P}(\mathrm{X}=4)+\mathrm{P}(\mathrm{X}=6)+\ldots \\
& =\left(\frac{1}{2}\right)^{2}+\left(\frac{1}{2}\right)^{4}+\left(\frac{1}{2}\right)^{6}+\ldots=\frac{1}{3}
\end{aligned}
$$

Similarly,

$$
\mathrm{P}(\mathrm{Y}=-1)=\frac{2}{3}
$$

Hence, the pdf of Y is given by

| Y | 1 | 1 |
| :---: | :---: | :---: |
| $\mathrm{~g}(\mathrm{y})$ | $\frac{1}{3}$ | $\frac{2}{3}$ |

## Continuous Case

Let $X$ be a continuous random variable having probability density function $f(x)$. we wish to find the probability density of a variable $Y=g(X)$. We shall discuss methods for finding the pdf of Y .
Let $\mathrm{F}_{\mathrm{Y}}(\mathrm{y})$ be the probability distribution function of Y . Then, expressing $\mathrm{F}_{\mathrm{Y}}(\mathrm{y})$ in terms of X , we obtain
$\left.\mathrm{F}_{\mathrm{Y}}(\mathrm{y})=\mathrm{P}(\mathrm{Y} \leq \mathrm{y})=\mathrm{P}(\mathrm{g}(\mathrm{X})) \leq \mathrm{y}\right)$
$= \begin{cases}P\left(X \leq g^{-1}(y)\right) & \text { if } Y \text { is a strictly increasing function of } X \\ P\left(X \geq g^{-1}(y)\right) & \text { if } Y \text { is a strictly increasing function of } X\end{cases}$
Where $X=g^{-1}(y)$ is the inverse of the transformation $Y=g(X)$ and $g(X)$ is a one-to-one function.
Hence,

$$
\mathrm{F}_{\mathrm{Y}}(\mathrm{y})=\mathrm{F}_{\mathrm{X}}\left(\mathrm{~g}^{-1}(\mathrm{y})\right)
$$

Thus, the pdf of Y is given by

$$
\mathrm{F}_{\mathrm{Y}}(\mathrm{y})=\mathrm{F}_{\mathrm{Y}}(\mathrm{y})=\mathrm{F}_{\mathrm{X}}\left(\mathrm{~g}^{-1}(\mathrm{y})\right)
$$

Example 5
Let X be uniformly distributed over $(0,1)$. Find the pdf of $\mathrm{Y}=\frac{-1}{\lambda} \log _{e}(1-x), x>0$.
Solution

$$
\begin{aligned}
\mathrm{F}_{\mathrm{Y}}(\mathrm{y}) & \left.=\mathrm{P}(\mathrm{Y} \leq \mathrm{y})=\mathrm{P} \frac{1}{\lambda} \log _{e}(1-x) \leq y\right)=P(-\log (1-x) \leq \lambda y) \\
& =\mathrm{P}(\log (1-\mathrm{X}) \geq-\lambda \mathrm{y})=\mathrm{P}\left(1-\mathrm{X} \geq \mathrm{e}^{-\lambda y}\right)=\mathrm{P}\left(\mathrm{X} \leq 1-\mathrm{e}^{-\lambda y}\right)
\end{aligned}
$$

The pdf of $X$ is given by

$$
f(x)= \begin{cases}1 & 0<x<1 \\ 0 & \text { elsewhere }\end{cases}
$$

and

$$
\mathrm{F}_{\mathrm{X}}(\mathrm{u})=\int_{0}^{u} f(x) d x=\int_{0}^{u} 1 d x=u
$$

Hence

$$
\mathrm{F}_{\mathrm{Y}}(\mathrm{y})=\left(1-\mathrm{e}^{-\lambda y}\right)
$$

Thus, the pdf of Y is given by

$$
f(x)=\begin{array}{lr}
\lambda e^{-\lambda y} & y \geq 0 \\
0 & \text { elsewhere }
\end{array}
$$

Example 6
Let X has the $\mathrm{pdf}, \mathrm{f}(\mathrm{x})=\mathrm{e}^{-\mathrm{x}}, \mathrm{x}>0$. Find the pdf of $\mathrm{Y}=2 \mathrm{X}+1$.
Solution

$$
\begin{gathered}
\mathrm{P}(\mathrm{Y} \leq \mathrm{y})=\mathrm{P}(2 \mathrm{X}+1 \leq \mathrm{y})=\mathrm{P}\left(X \leq \frac{y-1}{2}\right) \\
\mathrm{P}(\mathrm{X} \leq \mathrm{x})=\int_{0}^{x} e^{-x} d x=1-e^{-x} \\
\mathrm{~F}_{\mathrm{X}}\left(\frac{y-1}{2}\right)=\mathrm{P}\left(X \leq \frac{y-1}{2}\right)=1-e^{-(y-1) / 2}
\end{gathered}
$$

On differentiating, we obtain

$$
\mathrm{F}_{\mathrm{Y}}(\mathrm{y})=\mathrm{F}_{\mathrm{y}}^{\prime}(\mathrm{y})=\frac{1}{2} e^{-\frac{1}{2}(y-1)}
$$

Hence,

$$
\mathrm{f}_{\mathrm{Y}}(\mathrm{y})=\left\{\begin{array}{l}
\frac{1}{2} e^{-\frac{1}{2}(y-1)}, y \geq 1 \\
0 \quad \text { elsewhere }
\end{array}\right.
$$

## Example 7

let X has the density function given by

$$
\mathrm{f}_{\mathrm{x}}(\mathrm{x})= \begin{cases}\lambda x^{\lambda-1} & 0 \leq \mathrm{x} \leq 1 \\ 0 & \text { elsewhere }\end{cases}
$$

Show that $Y=-\log _{e} X$ is an exponential random variable.

## Solution

$$
\begin{gathered}
\mathrm{P}(\mathrm{Y} \leq \mathrm{y})=\mathrm{P}\left(-\log _{\mathrm{e}} \mathrm{X} \leq \mathrm{y}\right)=\mathrm{P}\left(\mathrm{X} \geq \mathrm{e}^{-\mathrm{y}}\right)=1-\mathrm{P}\left(\mathrm{X} \leq \mathrm{e}^{-\mathrm{y}}\right) \\
\mathrm{P}(\mathrm{X} \leq \mathrm{u})=\int_{0}^{u} \lambda x^{\lambda-1} d x=\left.x^{\lambda}\right|_{0} ^{u}=u^{\lambda}
\end{gathered}
$$

thus,

$$
\begin{gathered}
\mathrm{P}\left(\mathrm{X}<\mathrm{e}^{-\mathrm{y}}\right)=\mathrm{e}^{-\lambda y} \\
\mathrm{P}(\mathrm{Y} \leq \mathrm{y})=1-\mathrm{e}^{-\lambda y} ; \mathrm{f}_{\mathrm{Y}}(\mathrm{y})=\lambda \mathrm{e}^{-\lambda y}, \mathrm{y} \geq 0
\end{gathered}
$$

Hence,

$$
\begin{aligned}
F_{Y}(y)= & P(Y \leq y)=1-e^{-\lambda y}, \\
F_{y}(y)= & F_{Y}^{\prime}(y)= \begin{cases}\lambda e^{-\lambda y} & y \geq 0 \\
0 & \text { elsewhere }\end{cases}
\end{aligned}
$$

This shows that Y is an exponential random variable.

## Example 8

Let X be a random variable having pdf

$$
f_{x}(x)= \begin{cases}2 x & 0 \leq x \leq 1 \\ 0 & \text { elsewhere }\end{cases}
$$

Find the pdf of $Y=4 x^{2}$.

## Solution

$$
\begin{aligned}
& \mathrm{F}_{\mathrm{Y}}(\mathrm{y})=\mathrm{P}(\mathrm{Y} \leq \mathrm{y})=\mathrm{P}\left(4 \mathrm{X}^{2} \leq \mathrm{y}\right)=\mathrm{P}\left(X^{2} \leq \frac{y}{4}\right) \\
& =\mathrm{P}\left(X^{2} \leq \frac{y}{4}\right)=\mathrm{P}\left(\frac{-\sqrt{y}}{2} \leq X \leq \frac{+\sqrt{y}}{2}\right)=\mathrm{F}_{\mathrm{X}}\left(\frac{+\sqrt{y}}{2}\right)-\mathrm{F}_{\mathrm{X}}\left(\frac{-\sqrt{y}}{2}\right) \\
& \mathrm{F}_{\mathrm{X}}(\mathrm{u})=\int_{0}^{u} f(x) d x=\int_{0}^{u} 2 x d x=\left.x^{2}\right|_{0} ^{u}=u^{2}
\end{aligned}
$$

Thus,

$$
\mathrm{F}_{\mathrm{Y}}(\mathrm{y})=\mathrm{F}_{\mathrm{X}}\left(\frac{\sqrt{y}}{2}\right)^{2} ; \mathrm{F}_{\mathrm{X}}\left(\frac{-\sqrt{y}}{2}\right)=0
$$

since X cannot be less than zero. Hence,

$$
\mathrm{F}_{\mathrm{Y}}(\mathrm{y})=\left(\frac{\sqrt{y}}{2}\right)^{2}=\frac{y}{4} .
$$

Thus, the pdf of Y is

$$
F_{Y}^{\prime}(y)=f_{Y}(y)= \begin{cases}\frac{1}{4} & 0<Y<4 \\ 0 & \text { elsewhere }\end{cases}
$$

that is, Y is uniformly distributed over $(0,4)$.

## Example 9

Let $X$ be a continuous random variable having probability density function $f(x)$. derive an expression for the probability density function of the random variable $Y=X^{2}$.

## Solution

$$
\mathrm{F}_{\mathrm{Y}}(\mathrm{y})=\mathrm{P}(\mathrm{Y} \leq \mathrm{y})=\mathrm{P}\left(\mathrm{X}^{2} \leq \mathrm{y}\right)=(-\sqrt{y} \leq X \leq+\sqrt{y})=\mathrm{F}_{\mathrm{X}}(+\sqrt{y})-\mathrm{F}_{\mathrm{X}}(-\sqrt{y})
$$

Differentiation gives

$$
\mathrm{F}_{\mathrm{x}}^{\prime}(\sqrt{y})=\frac{1}{2 \sqrt{y}} \mathrm{f}_{\mathrm{X}}(\sqrt{y}), \mathrm{F}_{\mathrm{x}}^{\prime}(-\sqrt{y})=\frac{-1}{2 \sqrt{y}} \mathrm{f}_{\mathrm{X}}(-\sqrt{y})
$$

Hence

$$
F_{Y}^{\prime}(y)=f_{Y}(y)= \begin{cases}\frac{1}{2 \sqrt{y}} & \left(f_{X}(\sqrt{y})+f_{X}(-\sqrt{y}) ; y>0\right. \\ 0 & \text { elsewhere }\end{cases}
$$

## Example 10

Lex $X$ be a random variable having the pdf.

$$
f(x)=\left\{\begin{array}{cc}
\frac{1}{2}(x+1) ; & -1 \leq x<1 \\
160
\end{array}\right.
$$

## Solution

From example 10above, we have

$$
\begin{aligned}
& \mathrm{f}_{\mathrm{Y}}(\mathrm{y})=\frac{1}{2 \sqrt{y}}\left(\mathrm{f}_{\mathrm{X}}(\sqrt{y})+\mathrm{f}_{\mathrm{X}}(-\sqrt{y})\right. \\
& \mathrm{f}_{\mathrm{X}}(\sqrt{y})=\frac{1}{2}(\sqrt{y}+1)
\end{aligned}
$$

hence,

$$
f_{X}(y)=\frac{1}{2 \sqrt{y}}\left\{\frac{1}{2}(\sqrt{y}+1)+\frac{1}{2}(-\sqrt{y}+1)\right\}=\frac{1}{2 \sqrt{y}}(1)= \begin{cases}\frac{1}{2} y^{\frac{1}{2}} & 0<y<1 \\ 0 & \text { elsewhere }\end{cases}
$$

Note: The transformation $Y=X^{2}$ mapped $\mathrm{x}:-1 \leq \mathrm{x}<1$ onto the set $\mathrm{y}: 0<\mathrm{y}<1$.

## Example 11

Let $X$ be a continuous random variable having $\operatorname{pdf} f(x)$. Derive the formula for the pdf of $\mathrm{Y}=|\mathrm{X}|$

$$
\mathrm{F}_{\mathrm{Y}}(\mathrm{y})=\mathrm{P}(\mathrm{Y} \leq \mathrm{y})=\mathrm{P}(|\mathrm{X}| \leq \mathrm{y})=\mathrm{P}(-\mathrm{y}<\mathrm{X}<\mathrm{y})=\mathrm{F}_{\mathrm{X}}(\mathrm{y})-\mathrm{F}_{\mathrm{X}}(-\mathrm{y})
$$

By differentiation we see that

$$
\mathrm{F}_{\mathrm{Y}}(\mathrm{y})=\left\{\begin{array}{cc}
\left(f_{x}(y)+\left(f_{x}(-y)\right.\right. & y>0 \\
0 & y \leq 0
\end{array}\right.
$$

## Theorem 1

Let $Y=g(X)$ be a differentiable strictly increasing or strictly decreasing function on an interval $D$ and let $D$ * denote the range of $g$. let X e a continuous random variable with $\operatorname{pdf} f(x)$ such that $f(x)=0$ for $x \square D$. Then the pdf of $Y$ is given by

$$
\mathrm{f}_{\mathrm{Y}}(\mathrm{y})=\mathrm{f}_{\mathrm{X}}\left(\mathrm{~g}^{-1}(\mathrm{y})\right)\left|\frac{d g^{-1}(y)}{d y}\right| ; y \in D^{*}
$$

where $x=g^{-1}(y)$ is the inverse function of $g$. equivalently

$$
\mathrm{f}_{\mathrm{Y}}(\mathrm{y})=\mathrm{f}(\mathrm{x})\left|\frac{d x}{d y}\right|
$$

where $x$ is expressed in terms of $y, y \square D^{*}$ and $x=g^{-1}(y)$.

## Proof:

Case 1: suppose that $g(X)$ is strictly increasing

$$
\mathrm{F}_{\mathrm{Y}}(\mathrm{y})=\mathrm{P}(\mathrm{Y} \leq \mathrm{y})=\mathrm{P}(\mathrm{~g}(\mathrm{X}) \leq \mathrm{y})=\mathrm{P}\left(\mathrm{X} \leq \mathrm{g}^{-1}(\mathrm{y})\right)=\mathrm{F}_{\mathrm{X}}\left(\mathrm{~g}^{-1}(\mathrm{y})\right)
$$

Thus by differentiation, we have

$$
\mathrm{F}_{\mathrm{Y}}(\mathrm{y})=\mathrm{f}_{\mathrm{X}}\left(\mathrm{~g}^{-1}(\mathrm{y})\right) \frac{d}{d y}\left(\mathrm{~g}^{-1}(\mathrm{y})\right)
$$

Since $g(X)$ is strictly increasing so also is $g^{-1}(y)$.
Hence

$$
\left.\frac{d}{d y}\left[g^{-1}(y)\right)\right]=\left\lvert\, \frac{d}{d y}\left[g^{-1}(y) \mid\right.\right.
$$

Since $\frac{d}{d y}\left[g^{-1}(y)\right)>0$. Thus

$$
\mathrm{F}_{\mathrm{Y}}(\mathrm{y})=\mathrm{f}_{\mathrm{X}}\left(\mathrm{~g}^{-1}(\mathrm{y})\right) \left\lvert\, \frac{d}{d y}\left[\left.g^{-1}(y)\left|=f_{X}(x)\right| \frac{d x}{d y} \right\rvert\, ; x=g^{-1}(y)\right.\right.
$$

Case II: When $g(X)$ is a strictly decreasing function of $X$

$$
\begin{aligned}
\mathrm{F}_{\mathrm{Y}}(\mathrm{y}) & =\mathrm{P}(\mathrm{Y} \leq \mathrm{y})=\mathrm{P}(\mathrm{~g}(\mathrm{X}) \leq \mathrm{y})=\mathrm{P}\left(\mathrm{X} \geq \mathrm{g}^{-1}(\mathrm{y})\right) \\
& \left.\left.=1-\mathrm{P}\left(\mathrm{X} \leq \mathrm{g}^{-1}(\mathrm{y})\right)=1-\mathrm{F}_{\mathrm{X}}\left(\mathrm{~g}^{-1}\right) \mathrm{y}\right)\right) .
\end{aligned}
$$

Thus,

$$
\left.\left.F_{Y}^{\prime}(y)=f_{Y}(y)=-f_{X}\left(g^{-1}\right) y\right)\right)
$$

Since $g(X)$ is strictly decreasing so also is $g^{-1}(y)$.
Therefore, $\frac{d}{d y} \mathrm{~g}^{-1}(\mathrm{y})$ is negative and $\frac{d}{d y} \mathrm{~g}^{-1}(\mathrm{y})=\left|\frac{d}{d y} \mathrm{~g}-1(\mathrm{y})\right|$.
Thus,

$$
\mathrm{f}_{\mathrm{y}}(\mathrm{y})=\mathrm{f}_{\mathrm{X}}\left(\mathrm{~g}^{-1}(\mathrm{y})\right)\left|\frac{d}{d y} \mathrm{~g}-1(\mathrm{y})\right|=\mathrm{f}_{\mathrm{X}}(\mathrm{x})\left|\frac{d x}{d y}\right| ; \mathrm{x}=\mathrm{g}^{-1}(\mathrm{y})
$$

## Example 12

Let $X$ be a random variable having the pdf

$$
f(x)= \begin{cases}1 & 0<x<1 \\ 0 & \text { elsewhere }\end{cases}
$$

Find the pdf of $Y=-2 \log _{e} x$.

## Solution

Y is a strictly decreasing differentiable function of X . hence by Theorem 1

$$
\begin{gathered}
\mathrm{f}_{\mathrm{Y}}(\mathrm{y})=\mathrm{f}_{\mathrm{X}}(\mathrm{x})\left|\frac{d x}{d y}\right| ; \mathrm{x}=\mathrm{e}^{-\mathrm{y} / 2} \\
\mathrm{Y}=-2 \log _{\mathrm{e}} \mathrm{x},
\end{gathered}
$$

then

$$
\frac{d x}{d y}=-\frac{1}{2} \mathrm{e}^{-y / 2},\left|\frac{d x}{d y}\right|=\frac{1}{2} \mathrm{e}^{-\mathrm{y} / 2}
$$

Hence

$$
\mathrm{f}_{\mathrm{Y}}(\mathrm{y})=1, \frac{1}{2} \mathrm{e}^{-\mathrm{y} / 2}, \mathrm{y} \geq 0 .
$$

Thus

$$
\mathrm{f}_{\mathrm{Y}}(\mathrm{y})= \begin{cases}\frac{1}{2} \mathrm{e}^{-\mathrm{y} / 2} & \mathrm{y}>0 \\ 0 & \text { elsewhere }\end{cases}
$$

## Example 13

Let X be a random variable with pdf

$$
f_{X}(x)= \begin{cases}2 x & 0 \leq x \leq 1 \\ 0 & \text { elsewhere }\end{cases}
$$

Find the pdf of (i) $Y=2 X-5$ (ii) $Y=X^{2}$.

## Solution

(i) Y is a strictly increasing function of X . thus,

$$
\begin{gathered}
f_{Y}(y)=f_{X}(x) \frac{d x}{d y}, x=\frac{y+5}{2} \\
\frac{d x}{d y}=\frac{1}{2}
\end{gathered}
$$

Thus,

$$
f_{Y}(y)=2 x, \frac{1}{2}=x=\frac{y+5}{2}
$$

Hence

$$
\mathrm{f}_{\mathrm{Y}}(\mathrm{y})=\left\{\begin{array}{cc}
\frac{y+5}{2} & -5 \leq y \leq-3 \\
0 & \text { elsewhere }
\end{array}\right.
$$

(ii) Y is strictly increasing on $(0,1)$ and $0 \leq \mathrm{Y} \leq 1$.

$$
X=+\sqrt{y} \text { and } \frac{d x}{d y}=\frac{1}{2} y^{-\frac{1}{2}}
$$

thus,

$$
\begin{aligned}
f_{Y}(y) & =f_{X}(x) \frac{d x}{d y} \\
f_{Y}(y)=2 x\left|\frac{1}{2} y^{-\frac{1}{2}}\right| & =2 \cdot y^{-\frac{1}{2}} \cdot \frac{1}{2} y^{-\frac{1}{2}}, x=\sqrt{y}=1 .
\end{aligned}
$$

Hence,

$$
\mathrm{f}_{\mathrm{Y}}(\mathrm{y})= \begin{cases}1 & 0 \leq \mathrm{y} \leq 1 \\ 0 & \text { elsewhere }\end{cases}
$$

## Example 14:Chi-square Distribution

Let X be a random variable having the $\mathrm{N}\left(\mu, \sigma^{2}\right)$. Find the pdf of (i) $Y=\frac{X-\mu}{\sigma}$ (ii) $\mathrm{Z}=\mathrm{Y}^{2}$.

## Solution

(i) $\quad Y=\frac{X-\mu}{\sigma}, \mathrm{X}=\mu+\mathrm{Y} \sigma, \frac{d x}{d y}=\sigma$
$Y$ is a strictly increasing function of $X$, hence

$$
\begin{aligned}
& \mathrm{f}_{\mathrm{Y}}(\mathrm{y})=\mathrm{f}_{\mathrm{X}}(\mathrm{x})\left|\frac{d x}{d y}\right| ; \mathrm{x} \mu+\mathrm{y} \sigma \\
& f_{X}(x)=\frac{1}{\sigma \sqrt{2 \pi}} e^{-\frac{1}{2} \frac{(x-\mu)^{2}}{\sigma^{2}}}
\end{aligned}
$$

Substituting for x , we see that

$$
f_{X}(\mu+y \sigma)=\frac{1}{\sigma \sqrt{2 \pi}} e^{-\frac{1}{2} y^{2}}
$$

Thus

$$
f_{Y}(y)=\frac{1}{\sigma \sqrt{2 \pi}} e^{-\frac{1}{2} y^{2}} \cdot \sigma=\frac{1}{\sigma \sqrt{2 \pi}} e^{-\frac{1}{2} y^{2}},-\infty<y<\infty .
$$

That is Y is a standard normal random variable $(\mathrm{N}(0,1))$.
(ii) $\mathrm{Z}=\mathrm{Y}^{2}$

$$
\begin{gathered}
\mathrm{f}_{\mathrm{Z}}(\mathrm{z})=\mathrm{f}_{\mathrm{Y}}(\mathrm{y})\left|\frac{d y}{d z}\right|_{-\infty}^{0}+f_{Y}(y)\left|\frac{d y}{d z}\right|_{-\infty}^{0} \\
y=z^{\frac{1}{2}}, \frac{d y}{d z}=\frac{1}{2} z^{\frac{1}{2}}
\end{gathered}
$$

Hence

$$
\begin{aligned}
& f_{Z}(z)=\frac{1}{\sqrt{2 \pi}} e^{-\frac{1}{2} z \cdot \frac{1}{2} Z^{\frac{1}{2}}+\frac{1}{\sqrt{2 \pi}} e^{-\frac{1}{2} z} \cdot \frac{1}{2} Z^{\frac{1}{2}}} \\
& =\frac{z^{-\frac{1}{2}}}{\sqrt{2 \pi}} e^{-\frac{1}{2} z}= \begin{cases}\frac{\left(\frac{1}{2}\right)^{\frac{1}{2}} z^{\frac{1}{2}} e^{-\frac{1}{2} z}}{\sqrt{\pi}} & 0<z<\infty \\
0 & \text { elsewhere }\end{cases}
\end{aligned}
$$

## Definition 3

A continuous random variable X that has the pdf

$$
f(x)=\left\{\begin{array}{l}
\left(\frac{1}{2}\right)^{\frac{n}{2}} \\
\Gamma\left(\frac{n}{2}\right)
\end{array} x^{\frac{n}{2}-1} e^{-\frac{x}{2}}, \quad 0<x<\infty\right.
$$

$$
0 \quad \text { elsewhere }
$$

is said to have a chi square distribution with n degrees of freedom and is written $X^{2}{ }_{(n)}$.
Let $X$ be a random variable having the $\mathrm{N}\left(\mu, \sigma^{2}\right)$ distribution.
Then the pdf of $Y=\left(\frac{X-\mu}{\sigma}\right)^{2}$ is $X^{2}{ }_{(1)}$.
Proof: See Example 14.
The pdf of $Y=g(X)$ when $g$ is not one to one.

## Theorem 2

Let $X$ be a continuous random variable having $\operatorname{pdf} f(x)$ such that $f(x)>0, x \in D$ and $f(x)=0, x \notin$ D. Suppose $D$ can be partitioned into two sets $D_{1}$ and $D_{2}$ such that the transformation $Y=g(x)$ which is a monotone differentiable function in D and is a strictly increasing function on $\mathrm{D}_{1}$ and strictly decreasing differentiable function of $X$ on $D_{2}$, then the pdf of $Y$ is given by

$$
f_{Y}(y)=f_{X}(x)\left|\frac{d x}{d y}\right|_{o n D_{1}}+\left.f_{X}(x) \frac{d x}{d y}\right|_{o n D_{2}}
$$

Where $\mathrm{x}=\mathrm{g}^{-1}(\mathrm{y}), \mathrm{D}=\mathrm{D}_{1} \cup \mathrm{D}_{2}$

Consider the following examples.

## Example 15

Let $X$ be a continuous random variable having pdf $f(x)$ given by

$$
f(x)=\frac{1}{\sqrt{2 \pi}} e^{-\frac{1}{2} x^{2}}-\infty<x<\infty
$$

Find the pdf of (i) $\mathrm{Y}=|X|$ (ii) $\mathrm{Y}=\mathrm{X}^{2}$.
(i) The graph of Y is given below.


Y is strictly increasing on $(0, \infty)=\mathrm{D}_{1}$ and strictly decreasing on $(-\infty, 0)=\mathrm{D}_{2}$
On $\mathrm{D}_{1}, \mathrm{y}=\mathrm{x}, \frac{d x}{d y}=1$.

$$
f_{X}(y)\left|\frac{d x}{d y}\right|=\frac{1}{\sqrt{2 \pi}} e^{-\frac{1}{2} y^{2}}
$$

On $\mathrm{D}_{2}, \mathrm{y}=\mathrm{x}, \frac{d x}{d y}=1$.

$$
f_{X}(-y)\left|\frac{d x}{d y}\right|=\frac{1}{\sqrt{2 \pi}} e^{-\frac{1}{2} y^{2}} .
$$

Thus,

$$
f_{Y}(y)=f_{X}(y)\left|\frac{d x}{d y}\right|_{D_{1}}+f_{X}(-y)\left|\frac{d x}{d y}\right|_{D_{2}}=\frac{1}{\sqrt{2 \pi}} e^{-\frac{1}{2} y^{2}}+\frac{1}{\sqrt{2 \pi}} e^{-\frac{1}{2} y^{2}},
$$

Hence
(ii) The function $\mathrm{Y}=\mathrm{X}^{2}$ is a strictly decreasing differentiable function of X on $(-\infty, 0)$ and is a strictly increasing function of $X$ on $(0, \infty)$. Thus $D=(-\infty, \infty)$ can be partitioned in to $D_{1}$ $=(-\infty, 0)$ and $D_{2}=(0, \infty)$ so that $D=D_{1} \cup D_{2}$.

Thus, by Theorem 2, we have

$$
f_{Y}(y)=f_{X}(x)\left|\frac{d x}{d y}\right|_{o n D_{1}}+f_{X}(x)\left|\frac{d x}{d y}\right|_{o n D_{2}}
$$

$$
\begin{aligned}
& f(x)=\frac{1}{\sqrt{2 \pi}} e^{-\frac{1}{2} x^{2}} \\
& x= \pm \sqrt{y}
\end{aligned}
$$

$$
\begin{aligned}
& \text { on } \mathrm{D}_{1}, \mathrm{x}=-\sqrt{y} \text { and }\left|\frac{d x}{d y}\right|=\frac{1}{2} y^{-\frac{1}{2}} \\
& \qquad f_{X}(-\sqrt{y})\left|\frac{d x}{d y}\right|=\frac{1}{\sqrt{2 \pi}} e^{-\frac{1}{2} y} \cdot \frac{1}{2} y^{-\frac{1}{2}}
\end{aligned}
$$

On $\mathrm{D}_{2}, \mathrm{x}=+\sqrt{y}$ and

$$
f_{X}(\sqrt{y})\left|\frac{d x}{d y}\right|=\frac{1}{\sqrt{2 \pi}} e^{-\frac{1}{2} y} \cdot \frac{1}{2} y^{-\frac{1}{2}}
$$

Hence

$$
f_{Y}(y)=\frac{1}{\sqrt{2 \pi}} e^{-\frac{1}{2} y} \cdot \frac{1}{2} y^{\frac{1}{2}}+\frac{1}{\sqrt{2 \pi}} e^{-\frac{1}{2} y} \cdot \frac{1}{2} y^{\frac{1}{2}}= \begin{cases}\frac{y^{\frac{1}{2}} e^{-\frac{1}{2}} y}{\sqrt{2 \pi}} y \geq 0 \\ 0 & \text { elsew } \square \text { ere }\end{cases}
$$

## Example 16

Let X be a uniform random variable over the interval $\left(\frac{-\pi}{2}, \frac{\pi}{2}\right)$. Find the probability density function of $Y=\tan X$.

## Solution

$$
f_{x}(X)=\left\{\frac{1}{\pi} \frac{-\pi}{2}<x<\frac{\pi}{2}\right.
$$

0 elsewhere
$\mathrm{Y}=\tan \mathrm{X}$ is a strictly increasing function of X in the interval $\left(\frac{-\pi}{2}, \frac{\pi}{2}\right)$ Hence,

$$
\begin{aligned}
f_{Y}(y)= & f(x)\left|\frac{d x}{d y}\right| ; x=\tan ^{-1} y \\
& \frac{1}{\pi} \cdot \frac{1}{1+y^{2}}
\end{aligned}
$$

Thus, the pdf of Y is given by

$$
f_{Y}(y)=\frac{1}{\pi\left(1+y^{2}\right)} \quad-\infty<\mathrm{y}<\infty
$$

This pdf is called the Cauch pdf.

### 7.2 Functions of Two Random Variables

The method discussed in section 7.1 of finding the pdf of a function of one random variable of the continuous type will now be extended to functions of two random variables

Let X and Y be continuous random variables and $\mathrm{Z}=\mathrm{X}+\mathrm{Y}$.
The problem of finding the pdf of Z is somewhat more involved. The following steps are useful.

1. Introduce a second random variable $\mathrm{W}=\mathrm{K}(\mathrm{X}, \mathrm{Y})$.
2. Obtain the joint pdf of Z and W , say $\mathrm{d}(\mathrm{z}, \mathrm{w})$.
3. Obtain the desired pdf of $Z$ by simply integrating $d(z, w)$ with respect to $w$. that is

$$
\int \mathrm{d}(\mathrm{z}, \mathrm{w}) \mathrm{dw}
$$

The following will be assumed in obtaining the jointing pdf of Z and w .
(i) The functions $\mathrm{h}(\mathrm{X}, \mathrm{Y})$ and $\mathrm{k}(\mathrm{X}, \mathrm{Y})$ satisfy the following conditions.
(a) The equations

$$
\mathrm{Z}=\mathrm{h}(\mathrm{x}, \mathrm{y}) \text { and } \mathrm{w}=\mathrm{k}(\mathrm{x}, \mathrm{y})
$$

may be uniquely solved for x and y in termsof z and w , ssay $\mathrm{x}=\mathrm{g}_{1}(\mathrm{z}, \mathrm{w})$,

$$
\mathrm{y}=\mathrm{g}_{2}(\mathrm{x}, \mathrm{w})
$$

(b) The partial derivatives $\frac{\partial x}{\partial z}, \frac{\partial x}{\partial w}, \frac{\partial y}{\partial z}, \frac{\partial y}{\partial w}$ exist and are continuous

From the result of section 7.1 it can be proved using results of advanced calculus that under the assumptions (i) and (ii), the joint pdf of Z and W is given by $\mathrm{d}(\mathrm{z}, \mathrm{w})=\mathrm{f}(\mathrm{x}, \mathrm{y})|\mathrm{J}|$ where $\mathrm{x}=\mathrm{g}_{1}(\mathrm{z}$, w), $y=g_{2}(z, w)$ and

$$
J=\left|\begin{array}{ll}
\frac{\partial x}{\partial z} & \frac{\partial x}{\partial w} \\
\frac{\partial y}{\partial z} & \frac{\partial y}{\partial w}
\end{array}\right| .
$$

The determinant J , is called the Jacobian of the transformation ( $\mathrm{x}, \mathrm{y}$ ) $\rightarrow(\mathrm{z}, \mathrm{w})$. some of the important random variables we shall be interested in are

$$
\mathrm{X}+\mathrm{Y}, \mathrm{XY}, \mathrm{X} / \mathrm{Y}, \min .(\mathrm{X}, \mathrm{Y}), \max .(\mathrm{X}, \mathrm{Y}), \text { etc. }
$$

## Distribution of Sum

Let $\mathrm{Z}=\mathrm{X}+\mathrm{Y}$ and $\mathrm{W}=\mathrm{X}$, the Jacobian,

$$
J=\left|\begin{array}{cc}
0 & 1 \\
1 & -1
\end{array}\right|=-1
$$

Thus $d(z, w)=f(x, y)|J|=f(w,(z-w))$,

$$
\mathrm{F}_{\mathrm{Z}}(\mathrm{z})=\int_{-\infty}^{\infty}(w, z-w) d w=\int_{-\infty}^{\infty} f(x, z-x) d x
$$

If X and Y are nonnegative independent random variables, then

$$
\mathrm{F}_{\mathrm{Z}}(\mathrm{z})=\int_{0}^{z} f_{X}(x) f_{Y}(z-x) d x
$$

## Example 17

Let X and Y have the joint $\operatorname{pdf} \mathrm{f}(\mathrm{x}, \mathrm{y})=\left\{\begin{array}{lll}1 & 0<\mathrm{x}<1 & 0<\mathrm{y}<1 \\ 0 & & \text { elsewhere }\end{array}\right.$
Find the pdf of $\mathrm{Z}=\mathrm{X}+\mathrm{Y}$.

## Solution

Let $\mathrm{W}=\mathrm{X} ; \mathrm{Z}=\mathrm{X}+\mathrm{Y}$, then $\mathrm{x}=\mathrm{w} ; \mathrm{y}=\mathrm{z}-\mathrm{w}$ and

$$
J=\left|\begin{array}{cc}
0 & 1 \\
1 & -1
\end{array}\right|=-1
$$

Hence, $\mathrm{d}(\mathrm{z}, \mathrm{w})=1.1=1$.
Let A be the set $\mathrm{A}=\{(\mathrm{x}, \mathrm{y}), 0 \leq \mathrm{x} \leq 1,0 \leq 1\}$. A is shown in figure below.


Under the transformation, $\mathrm{Z}=\mathrm{X}+\mathrm{Y}, \mathrm{W}=\mathrm{X}$, the boundaries of A are $\mathrm{x}=0, \mathrm{x}=1, \mathrm{y}=0$ and $\mathrm{y}=$ 1. The set B in the $\mathrm{z}, \mathrm{w}$-plane which is the mapping of A under the one-to-one transformation is determined as follows:
$\mathrm{x}=0$ implies that $\mathrm{w}=0 ; \mathrm{y}=1$ implies that $\mathrm{w}=1$
$\mathrm{y}=0$ implies that $\mathrm{z}=\mathrm{w} ; \mathrm{y}=1$ implies that $\mathrm{z}=\mathrm{w}+1$.

Thus, the boundaries of B are the lines $\mathrm{w}=0, \mathrm{w}=1, \mathrm{z}=\mathrm{w}, \mathrm{z}=\mathrm{w}+1$. This is show in the figure below.


Figure 3
Hence

$$
\mathrm{d}(\mathrm{z}, \mathrm{w})=1
$$

thus,

$$
\begin{gathered}
d(z)=\int_{0}^{z} 1 d w=z \\
\left.\int_{z-1} 1 d w=1-\mathrm{z}, \mathrm{w}\right) \in \mathrm{B} \\
\mathrm{~d}(\mathrm{z})= \begin{cases}\mathrm{Z} & 0<\mathrm{z}<1 \\
2-\mathrm{z} & 1<\mathrm{z}<2 \\
0 & \text { elsewhere }\end{cases}
\end{gathered}
$$

## Example 18

Suppose a point ( $\mathrm{x}, \mathrm{y}$ )is selected at random in a circle centre $(0,0)$ and radius 1 and that this point is uniformly distributed over the circle. Find the pdf of $R=\sqrt{\left(X^{2}+Y^{2}\right)}$, the distance from the origin.

The joint pdf of X and Y is

$$
\mathrm{d}(\mathrm{z})= \begin{cases}\frac{1}{\pi} & \text { if }(\mathrm{x}, \mathrm{y}) \text { lies inside or on the circle }\end{cases}
$$

0 elsewhere

Let $\mathrm{W}=\tan ^{-1}(\mathrm{Y} / \mathrm{X})$ then $\tan \mathrm{W}=\mathrm{Y} / \mathrm{X}, \mathrm{x}=\mathrm{r} \cos \mathrm{w}, \mathrm{y}=\mathrm{r} \sin \mathrm{w}$.



Figure 4
The Jacobian is

$$
\left.J=\left|\begin{array}{ll}
\frac{\partial x}{\partial r} & \frac{\partial x}{\partial w} \\
\frac{\partial y}{\partial x} & \frac{\partial y}{\partial w}
\end{array}\right| \begin{array}{cc}
\cos w & -r \sin w \\
\sin w & r \cos w
\end{array} \right\rvert\,=r\left(\cos ^{2} w+\sin ^{2} w\right)=r
$$

hence

$$
\mathrm{d}(\mathrm{r}, \mathrm{w})=\mathrm{f}(\mathrm{x}, \mathrm{y})|J|= \begin{cases}\frac{1}{\pi} \mathrm{r} & (\mathrm{r}, \mathrm{w}) \in \mathrm{B} \\ 0 & \text { elsewhere }\end{cases}
$$

Thus,

$$
\mathrm{d}(\mathrm{r})=\int \mathrm{d}(\mathrm{r}, \mathrm{w}) \mathrm{dw}=\mathrm{r} \int_{0}^{2 \pi} \frac{1}{\pi} d w= \begin{cases}2 r & 0 \leq r \leq 1 \\ 0 & \text { elsewhere }\end{cases}
$$

## Example 19

$$

Let $W=X, A=\{(x, y), 0<y<x, 0<x<1\}$ and $B=\{(z, w): z=x-y, w=x\}$

The Jacobian is

$$
J=\left|\begin{array}{cc}
0 & 1 \\
-1 & 1
\end{array}\right|
$$

hence

$$
\begin{gathered}
\mathrm{d}(\mathrm{z}, \mathrm{w})= \begin{cases}3 \mathrm{w} & 0<\mathrm{z}<\mathrm{w} \\
0 & 0<\mathrm{w}<1\end{cases} \\
d(z)==\int_{z}^{1} 3 w d w \\
\mathrm{~d}(\mathrm{z})= \begin{cases}\frac{3}{2}\left(1-z^{2}\right) & 0<\mathrm{z}<1 \\
0 & \text { elsewhere }\end{cases} \\
d
\end{gathered}
$$

## Distribution of Product

Suppose $X$ and $Y$ are continuous random variables having the joint $\operatorname{pdf}(x, y)$. show that the pdf of $\mathrm{Z}=\mathrm{XY}$ is given by

$$
\int\left|\frac{1}{x}\right| f\left(x, \frac{z}{x}\right) d x
$$

Solution
Let $\mathrm{W}=\mathrm{X}$, thus, $\mathrm{x}=\mathrm{w}, \mathrm{y}=\frac{z}{w}$. The Jacobian

$$
J=\left|\begin{array}{cc}
1 & 0 \\
\frac{-z}{w^{2}} & \frac{1}{w}
\end{array}\right|=\frac{1}{w}
$$

Hence,

$$
d(z, w)=f\left(w, \frac{z}{w}\right)|J|
$$

Thus,

$$
\begin{equation*}
d(z)=\int\left|\frac{1}{w}\right| f\left(w, \frac{z}{w}\right) d w \tag{2}
\end{equation*}
$$

## Example 20

Let X and Y be independent random variables with the following pdfs.

$$
f(x)=\left\{\begin{array}{ll}
2 x & 0 \leq x \leq 1 \\
0 & \text { elsewhere }
\end{array}, \quad g(y)=\left\{\begin{array}{cc}
4 y^{3} / 15 & 1 \leq y \leq 2 \\
0 & \text { elsewhere }
\end{array}\right.\right.
$$

Find the pdf of $\mathrm{Z}=\mathrm{XY}$.

## Solution

The joint pdf of $X$ and $Y$ is $f(x . y)=f(x) g(y)$.
Thus, from 2.

$$
\begin{array}{r}
d(z)=\int\left|\frac{1}{w}\right| g(w) g\left(\frac{z}{w}\right) d w, \text { where } \mathrm{W}=\mathrm{X} \\
d(z)=\int\left|\frac{1}{w}\right| \cdot 2 w \frac{4}{15}\left(\frac{z}{w}\right)^{3} d w=\frac{8}{15} z^{3} \int \frac{1}{w^{3}} d w .
\end{array}
$$

Let $\mathrm{A}=\{(\mathrm{x} . \mathrm{y}): 0<\mathrm{x}<1,1 \leq \mathrm{y} \leq 2\}$. The transformation, $\mathrm{Z}=\mathrm{XY}, \mathrm{W}=\mathrm{X}$ gives the set B determined as follows:

When $\mathrm{x}=0, \mathrm{w}=0$; when $\mathrm{x}=1, \mathrm{w}=1$,
When $\mathrm{y}=1, \mathrm{Z}=\mathrm{w}$, when $\mathrm{y}=2, \mathrm{z}=2 \mathrm{w}$.

The lines $w=0 ; w=1 ; x=w, z=2 w$ are the boundaries of $B$ as shown in the figure below.

Thus

$$
\begin{aligned}
& d(z)= \frac{8 z^{3}}{15} \int_{z / 2}^{z} \frac{1}{w^{3}} d w=\frac{4}{5} z, \quad 0<z<1 \\
&=\frac{8 z^{3}}{15} \int_{z / 2}^{1} \frac{1}{w^{3}} d w=\frac{4 z}{15}\left(4-z^{2}\right), \quad 1<z<2 \\
& d(z)= \begin{cases}\frac{4 z}{5} & 0<z<1 \\
\frac{4 z}{15}\left(4-z^{2}\right) & 1<z<2\end{cases}
\end{aligned}
$$

## Distribution of Quotients

Suppose $X$ and $Y$ are continuous random variables having the joint $\operatorname{pdf} f(x, y)$. show that the pdf of $Z=Y / X$ is given by

$$
f_{z}(z)=\int_{-\infty}^{\infty}|x| f(x, x z) d x-\infty<z<\infty
$$

Let $\mathrm{W}=\mathrm{X}$, then $\mathrm{x}=\mathrm{w}, \mathrm{y}=\mathrm{zw}$, the Jacobian is

$$
J=\left|\begin{array}{cc}
1 & 0 \\
Z & w
\end{array}\right|=w .
$$

Hence

$$
d(z, w)=f(w, z w)|J|=f(w, z w)|w|
$$

Thus

$$
\begin{equation*}
f_{z}(z)=\int|w| f(w, z w) d w \tag{3}
\end{equation*}
$$

## Example 21

Let X and Y be independent random variables having the respective gamma densities $\Gamma\left(\alpha_{1}, \lambda\right)$ and $\Gamma\left(\alpha_{2}, \lambda\right)$. Find the probability density function of $Z=Y / X$.

$$
\begin{array}{lr}
f_{X}(x)=\frac{\lambda^{\alpha_{1}} x^{\alpha_{1}-1} e^{-\lambda x}}{\Gamma\left(\alpha_{1}\right)} & \mathrm{x}>0 \\
f_{Y}(y)=\frac{\lambda^{\alpha_{2}} x^{\alpha_{2}-1} e^{-\lambda x}}{\Gamma\left(\alpha_{2}\right)} & \mathrm{y}>0
\end{array}
$$

The joint pdf of X and Y is given by

$$
f(x, y)=f_{X}(x) f_{Y}(y)=\frac{\lambda^{\alpha_{1+}+\alpha_{2}} x^{\alpha_{1}-1} e^{-\lambda(x+y)}}{\Gamma\left(\alpha_{1}\right) \Gamma\left(\alpha_{2}\right)}
$$

From (3) we have

$$
\begin{aligned}
f_{Z}(z) & =\int w f(x, z w) d w=\int w \frac{\lambda^{\alpha_{1}+\alpha_{2}} w^{\alpha_{1}-1}(z w)^{\alpha_{2}-1}}{\Gamma\left(\alpha_{1}\right) \Gamma\left(\alpha_{2}\right)} e^{\lambda(w+w z)} d w \\
& =\frac{\lambda^{\alpha_{1}+\alpha_{2}} Z^{\alpha_{2}-1}}{\Gamma\left(\alpha_{1}\right) \Gamma\left(\alpha_{2}\right)} \int_{0}^{\infty} x^{\alpha_{1+\alpha_{2}}-1} e^{-\lambda x(1+z)} d w
\end{aligned}
$$

But

$$
\int_{0}^{\infty} w^{\alpha_{1}+\alpha_{2}-1} e^{-\lambda w(1+z)} d w=\frac{\Gamma\left(\alpha_{1}+\alpha_{2}\right)}{(\lambda(1+z))^{\alpha_{1}+\alpha_{2}}}
$$

Hence

$$
\mathrm{f}_{\mathrm{Z}}(\mathrm{z})=\frac{\Gamma\left(\alpha_{1}+\alpha_{2}\right)}{\Gamma\left(\alpha_{1}\right) \Gamma\left(\alpha_{2}\right)} \frac{Z^{\alpha_{2}-1}}{(1+z)^{\alpha_{1}+\alpha_{2}}}, \quad \mathrm{z}>0
$$

## Example 22

Let X and Y be independent exponential random variables with parameter $\lambda$. Find the joint pdf of $\mathrm{Z}=\mathrm{X}+\mathrm{Y}$ and $\mathrm{W}=\frac{X}{X+Y}$.

## Solution

The joint pdf of $X$ and $Y$ is given by

$$
\mathrm{f}_{\mathrm{X}, \mathrm{Y}}(\mathrm{x}, \mathrm{y})=\lambda^{2} \mathrm{e}^{-\lambda(\mathrm{x}+\mathrm{y})} \quad \mathrm{x}>0, \quad \mathrm{y}>0
$$

The transformation gives

$$
x=w z, y=z(1-w)
$$

The Jacobian of the transformation is

$$
|J|=\mathrm{z}
$$

The joint pdf of Z and W is given by

$$
f_{Z, w}(z, w)=\left\{\begin{array}{lc}
z \lambda^{2} e^{-\lambda z}, & z>0,0<w<1 \\
0 & \text { elsewhere }
\end{array}\right.
$$

## Example 23

Let $X$ and $Y$ have the joint pdf $f_{X, Y}(x, y)=\frac{1}{x^{2} y^{2}} x \geq 1, y \geq 1$, find the joint pdf of $Z=X Y$ and $W=\frac{X}{Y}$.

## Solution

From the transformation $\mathrm{z}=\mathrm{wy}, \mathrm{w}=\mathrm{x} / \mathrm{y}$, we have

$$
\begin{aligned}
& J=\left|\begin{array}{cc}
y & x \\
\frac{1}{y} & \frac{-x}{y^{2}}
\end{array}\right|=\frac{-2 x}{y} \\
& |J|=2 w .
\end{aligned}
$$

Thus

$$
\begin{aligned}
f_{Z, w}(z, w)= & f_{Z, w}(x, y)|J|^{-1}=\frac{1}{Z^{2}} \cdot \frac{1}{2 w} \\
& =\frac{1}{2 w z^{2}} z \geq 1, \quad 0<w<z \\
& =0, \text { otherwise. }
\end{aligned}
$$

## Example 24

Let $\mathrm{X}_{1}$ and $\mathrm{X}_{2}$ be random variable with joint pdf $f_{x_{1}, x_{2}},\left(\mathrm{x}_{1}, \mathrm{x}_{2}\right)$. Let $\mathrm{Y}_{1}=\mathrm{X}_{1}+\mathrm{X}_{2}$, $\mathrm{Y}_{2}=\mathrm{X}_{1}-\mathrm{X}_{2}$. Find the joint pdf of $\mathrm{Y}_{1}$ and $\mathrm{Y}_{2}$ in terms of $f_{x_{1, x_{2}}},\left(\mathrm{x}_{1}, \mathrm{x}_{2}\right)$.

## Solution

$$
\begin{gathered}
f_{Y_{1, Y_{2}}},\left(\mathrm{y}_{1}, \mathrm{y}_{2}\right)=f_{x_{1, x_{2}},}\left(\mathrm{x}_{1}, \mathrm{x}_{2}\right)|J| \\
x_{1}=\frac{1}{2}\left(y_{1}+y_{2}\right), x_{2}=\frac{1}{2}\left(y_{1}-y_{2}\right) \\
J=\left|\begin{array}{ll}
\frac{\partial x_{1}}{\partial y_{1}} & \frac{\partial x_{1}}{\partial y_{2}} \\
\frac{\partial y_{2}}{\partial y_{1}} & \frac{\partial x_{2}}{\partial y_{2}}
\end{array}\right|=\left|\begin{array}{cc}
\frac{1}{2} & \frac{1}{2} \\
\frac{1}{2} & -\frac{1}{2}
\end{array}\right|=-\frac{1}{2} .
\end{gathered}
$$

Hence

$$
f_{Y_{1, Y_{2}}}\left(\mathrm{y}_{1}, \mathrm{y}_{2}\right)=\frac{1}{2} f_{x_{1, x_{2}}}\left(\frac{y_{1}+y_{2}}{2}, \frac{y_{1}-y_{2}}{2}\right)
$$

## Example 25

Let X and Y be independent exponential random variables with parameters $\lambda_{1}$ and $\lambda_{2}$ respectively.
(i) find the joint pdf of $\mathrm{U}=\mathrm{X}+\mathrm{Y}$ and $\mathrm{V}=\frac{X}{X+Y}$
(ii) show that U and V are independent if $\lambda_{1}=\lambda_{2}$.

## Solution

The joint pdf of $X$ and $Y$ is given by

$$
\begin{aligned}
& \mathrm{f}_{\mathrm{X}, \mathrm{Y}}(\mathrm{x}, \mathrm{y})=\lambda_{1} \lambda_{2} e^{-\left(\lambda_{1} x+\lambda_{2} y\right)} \\
& \mathrm{x}=\mathrm{uv} \text { and } \mathrm{y}=\mathrm{u}-\mathrm{uv} .
\end{aligned}
$$

The joint pdf of $u$ and $v$ is given by

$$
\mathrm{f}_{\mathrm{u}, \mathrm{v}}(\mathrm{u}, \mathrm{v})=\mathrm{f}_{\mathrm{X}, \mathrm{Y}}(\mathrm{x}, \mathrm{y})|J| .
$$

Substituting for x and y in terms of u and v

$$
\mathrm{f}_{\mathrm{u}, \mathrm{v}}(\mathrm{u}, \mathrm{v})=\lambda_{1} \lambda_{2} e^{-\left(\lambda_{1} u v+\lambda_{2} u(1-v)\right)}|J|=u \lambda_{1} \lambda_{2} e^{-u v\left(\lambda_{1}-\lambda_{2}\right)-u \lambda_{2}}
$$

(ii) Putting $\lambda_{1}=\lambda_{2}=\lambda$. We obtain

$$
f_{u, v}(u, v)=u \lambda^{2} e^{-\lambda u}, u \geq 0,0<v<1
$$

$$
\begin{aligned}
& f_{u}(u)=\int_{0}^{1} u \lambda^{2} e^{-\lambda u} d v=u \lambda^{2} e^{\lambda u}, u \geq 0 \\
& f_{v}(v)=\int_{0}^{\infty} u \lambda^{2} e^{-\lambda u} d u=1 \quad 0<v<1
\end{aligned}
$$

## Example 26

The joint pdf of X and Y is given by

$$
f(x, y)=\left\{\begin{array}{cc}
e^{-(x+y)} & X>0, y>0 \\
0 & \text { otherwise }
\end{array}\right.
$$

find (i) $\mathrm{P}(\mathrm{X}>2, \mathrm{Y}>3$ ), (ii) $\mathrm{P}(\mathrm{Y}<\mathrm{X})$ and (iii) the pdf of $\mathrm{Z}=\mathrm{X} / \mathrm{Y}$.

## Solution

Let $A=\{x, y)!x>2, y>3)$, we have

$$
\begin{aligned}
& \mathrm{P}(\mathrm{X}>2, \mathrm{Y}>3)=\iint_{A} f(x, y) d x d y=\int_{3}^{\infty} \quad \int_{2}^{\infty} f(x, y) d x d y \\
& =\int_{3}^{\infty} \quad\left[\int_{2}^{\infty} e^{-(x+y)} d x\right] d y=\int_{3}^{\infty} e^{-y}\left[\int_{2}^{\infty} e^{-x} d x\right] d y=e^{-2} \int_{3}^{\infty} e^{-y} d y=e^{-5}
\end{aligned}
$$

(ii) $\operatorname{Let} \mathrm{A}\{(\mathrm{x}, \mathrm{y}) ; \mathrm{y}<\mathrm{x}\}$

$$
\mathrm{P}(\mathrm{Y}<\mathrm{X})=\iint_{A} f(x, y) d x d y=\int_{0}^{\infty} \quad\left[\int_{y}^{\infty} e^{-(x+y)} d x\right] d y=\int_{0}^{\infty} e^{-2 y} d y=\frac{1}{2}
$$

## Example27

Let $\mathrm{f}(\mathrm{x}, \mathrm{y})=\left\{\begin{array}{l}\frac{1}{\pi r^{2}} x^{2}+y^{2} \leq r^{2} \\ 0 \quad \text { elsewhere }\end{array}\right.$
find (i) $\mathrm{f}_{\mathrm{X}}(\mathrm{x})$ and (ii) $\mathrm{f}_{\mathrm{Z}}(\mathrm{z})$ where $\mathrm{Z}=\sqrt{X^{2}+Y^{2}}$.

## Solution

$$
f_{x}(x)=\int_{-\infty}^{\infty} f(x, y) d y=\int \frac{1}{\pi r^{2}} d y=\frac{y}{\pi r^{2}} \left\lvert\, \begin{align*}
& \sqrt{r^{2}+x^{2}}  \tag{i}\\
& \sqrt{r^{2}-x^{2}}
\end{align*}=\frac{2}{\pi x^{2}} \sqrt{r^{2}-x^{2}}\right.
$$

(ii) $\mathrm{f}_{\mathrm{Z}}(\mathrm{z})=\mathrm{P}\left\{\mathrm{X}^{2}+\mathrm{Y}^{2} \leq \mathrm{z}^{2}\right)=\iint_{x^{2}+y^{2} \leq z^{2}} f(x, y) d x d y=\iint_{x^{2}+y^{2} \leq z^{2}} \frac{1}{\pi r} d x d y$

$$
=\frac{\pi z^{2}}{\pi r^{2}}=\frac{z^{2}}{r^{2}}\left(\text { since } \iint_{x^{2}+y^{2} \leq z^{2}} d x d y=\text { area of a circle radius } \mathrm{z} .\right)
$$

(iii) $\quad \mathrm{F}_{\mathrm{Z}}=\mathrm{P}(\mathrm{z} \leq \mathrm{z})=P\left(\frac{X}{Y} \leq x\right)=\iint_{\frac{X}{Y} \leq Z} f(x, y) d x d y$

$$
=\int_{0}^{\infty} \quad \int_{0}^{y z} e^{-(x+y)} d x d y=1-\frac{1}{z+1}
$$

Differentiating we obtain

$$
f_{z}(z)=\frac{1}{(z+1)^{2}}, 0<z<\infty .
$$

## Example 28

Distribution of sum. Let X and Y have the joint $\mathrm{pdf} \mathrm{f}(\mathrm{x}, \mathrm{y})$ and let $\mathrm{Z}=\mathrm{X}+\mathrm{Y}$ then

$$
\mathrm{F}_{\mathrm{Z}}(\mathrm{z})=\mathrm{P}(\mathrm{X}+\mathrm{Y} \leq \mathrm{z})=\iint_{x+y<z} f(x, y) d x d y=\int_{-\infty}^{\infty} \int_{-\infty}^{z-y} f(x, y) d x d y
$$

Changing variable, $\mathrm{x}=\mathrm{v}-\mathrm{y}$

$$
\mathrm{F}_{\mathrm{z}}(\mathrm{z})=\int_{-\infty}^{\infty} \quad \int_{-\infty}^{z-y} f(v-y, y) d v d y=\int_{-\infty}^{z}\left[\int_{-\infty}^{z} f(v-y, y) d y\right] d v
$$

Thus

$$
\mathrm{F}_{\mathrm{Z}}(\mathrm{z})=\int_{-\infty}^{\infty} f(z-y, y) d y
$$

Example 29: Student's $t$-Distribution
Let X be a standard normal distribution and Y a chi-square random variable with v degrees of freedom. Find the pdf of $Z=\frac{X \sqrt{v}}{\sqrt{Y}}$ where X and Y are independent.

## Solution

Let $Z=\frac{X \sqrt{v}}{\sqrt{Y}}$ and $\mathrm{W}=\mathrm{Y}$ then $\mathrm{y}=\mathrm{w}$ and $\mathrm{x}=z \frac{\sqrt{w}}{\sqrt{v}}$.
Then Jacobian of the transformation is

$$
J=\left|\begin{array}{cc}
1 & 0 \\
-\frac{1}{2} z \frac{\sqrt{w}}{V^{-\frac{3}{2}}} & \frac{\sqrt{w}}{\sqrt{v}}
\end{array}\right|=\frac{\sqrt{y}}{\sqrt{w}} .
$$

Thus
$\mathrm{d}_{\mathrm{Z}, \mathrm{w}}(\mathrm{z}, \mathrm{w})=\mathrm{f}_{\mathrm{x}}(\mathrm{x}) \mathrm{f}_{\mathrm{Y}}(\mathrm{y})\left|\frac{\sqrt{w}}{V}\right|=\frac{1}{\sqrt{2 \pi}} e^{-\frac{1}{2} x^{2}} \frac{1}{\Gamma\left(\frac{V}{2}\right) 2^{v / 2}} y^{\frac{v}{2}-1} e^{-\frac{y}{2}} \frac{\sqrt{W}}{V}$
substituting for x and y , we have
$\mathrm{d}_{\mathrm{Z}, \mathrm{w}}(\mathrm{z}, \mathrm{w})=\frac{1}{\sqrt{2 \pi}} e^{-\frac{1 z^{2} w}{2 v}} \cdot \frac{1}{\Gamma\left(\frac{V}{2}\right) 2^{\frac{n}{2}}} w^{\frac{v}{2}-1} e^{-\frac{w}{2}} \cdot \frac{\sqrt{W}}{\sqrt{V}}=\frac{w^{\frac{v-1}{2}}}{\sqrt{2 \pi} \Gamma\left(\frac{V}{2}\right)^{\frac{v}{2}}} e^{-\frac{1 z^{2} w}{2 v}-\frac{w}{2}}$.
The marginal pdf of z is given by

$$
d_{z}(z)=\int \frac{w^{\frac{v-1}{2}}}{\sqrt{2 \pi} \Gamma\left(\frac{V}{2}\right) 2^{\frac{n}{2}}} e^{-\frac{1 z^{2} w}{2 v}-\frac{w}{2}} \cdot \frac{\sqrt{W}}{\sqrt{V}} d w=\frac{1}{\sqrt{2 \pi} \Gamma\left(\frac{V}{2}\right) 2^{\frac{v}{2}}} \int_{0}^{\infty} w^{\frac{v-1}{2}} e^{-\frac{w}{2}\left(1+\frac{z^{2}}{v}\right)} \frac{\sqrt{W}}{\sqrt{V}} d w
$$

Let $\mathrm{u}=\frac{w}{2}\left(1+\frac{z^{2}}{v}\right) ; \frac{d u}{d w}=\frac{1}{2}\left(1+\frac{z^{2}}{v}\right), w=\frac{2 u}{1+\frac{z^{2}}{V}}$

$$
\begin{aligned}
d_{Z}(z) & =\frac{2^{\frac{v-1}{2}}}{\sqrt{2 \pi v} \Gamma\left(\frac{V}{2}\right) 2^{\frac{v}{2}-1}} \int_{0}^{\infty}\left[\frac{2 u}{1+\frac{z^{2}}{V}}\right] e^{-u} \frac{d u}{\frac{1}{2}\left(1+\frac{z^{2}}{V}\right)} \\
& \frac{1}{\sqrt{2 \pi} \Gamma\left(\frac{V}{2}\right) 2^{\frac{v}{2}}\left(1+\frac{z^{2}}{V}\right)^{\frac{v-1}{2}}} \int u^{\frac{v-1}{2}-1} e^{-u} d u .
\end{aligned}
$$

Note

$$
\int_{0}^{\infty} u^{\frac{v}{2}-1} e^{-u} d u=\Gamma\left(\frac{v+1}{2}\right)
$$

Hence

$$
d_{Z}(z)=\frac{\Gamma\left(\frac{v+1}{2}\right)}{\sqrt{2 \pi v} \Gamma\left(\frac{V}{2}\right)} \cdot \frac{1}{\left(1+\frac{z^{2}}{V}\right)^{\frac{v+1}{2}}},-\infty<z<\infty
$$

The above distribution, $\mathrm{d}_{\mathrm{Z}}(\mathrm{z})$ is called a t -distribution.
Note
(i) That a t-distribution is completely determined by the parameter v , the number of degrees of freedom of the random variable that has the chi-square distribution.
(ii) The t-distribution is a bell-shaped distribution, symmetric about zero.
(iii) The t -distribution is flatter than the Normal distribution. As the sample size becomes large, t -distribution approaches the standard normal distribution ( $\mathrm{n}>30$ is sufficient).
(iv) The values of the t-distribution for various values of degrees of freedom have been tabulated.

### 7.3 Sum of Independent Identically Distributed RandomVariables The Moment Generating Function Technique

Let $\mathrm{X}_{1}, \mathrm{X}_{2}, \ldots \mathrm{X}_{\mathrm{n}}$ be independent identically distributed random variables. In this section we will find the pdf of sum of the X's. The moment generating function technique will be used to establish the pdf of sum Bernoulli, Poisson, exponential, Normal, Gamma random
variables. All the probability distributions above except Bernoulli and exponential has the following remarkable and very useful property called Reproductive properties.

## Definition: Reproductive Property

A probability distribution F is said to have reproductive property if when two or more independent random variables having the probability distribution $F$ are added, the resulting random variable has the distribution F . we shall establish this result using moment generating function defined in Chapter 4, section 4.3.

## Moment Generating Function

The moment generating function $\mathrm{M}_{\mathrm{X}}(\mathrm{t})$ of a random variable X is defined by

$$
\mathrm{M}_{\mathrm{X}}(\mathrm{t})=\mathrm{E}\left(\mathrm{e}^{\mathrm{tX}}\right)
$$

The domain of $\mathrm{M}_{\mathrm{x}}(\mathrm{t})$ is all numbers t such that $\mathrm{e}^{\mathrm{tX}}$ has finite expectation.

## Theorem 3

Suppose that a random variable $X$ has $m g f M_{x}(t)$. Let $Y=a X+b$. Then, the mgf of the random variable $Y$ is given by $M_{Y}(t)=e^{b t} M_{x}(a t)$.
Proof:

$$
\mathrm{M}_{\mathrm{Y}}(\mathrm{t})=\mathrm{E}\left(\mathrm{e}^{\mathrm{ty}}\right)=\mathrm{E}\left(\mathrm{e}^{(\mathrm{aX}+\mathrm{b}) \mathrm{t}}\right)=\mathrm{E}\left(\mathrm{e}^{\mathrm{atX} \mathrm{X}+\mathrm{bt}}\right)=\mathrm{E}\left(\mathrm{e}^{\mathrm{atX} X} \mathrm{e}^{\mathrm{bt}}\right)=\mathrm{e}^{\mathrm{bt}} \mathrm{E}\left(\mathrm{e}^{\mathrm{atX}}\right)=\mathrm{e}^{\mathrm{bt}} \mathrm{M}_{\mathrm{X}}(\mathrm{at}) .
$$

Theorem 4
Let $X$ and $Y$ be two random variables with $m g f$ 's $M_{x}(t)$ and $M_{Y}(t)$, respectively. If $M_{x}(t)$ $=\mathrm{M}_{\mathrm{Y}}(\mathrm{t})$ for all values of t , then X and Y have the probability distribution. That is, the mgf uniquely determines the probability distribution of the random variable. The proof of this theorem is outside the scope of this work, the reader is referred to volume II of this book.

This theorem will now be used to show that a linear function of a random variable also has a normal distribution.

Example 31
Suppose that $X$ has distribution $N\left(\mu, \sigma^{2}\right)$.
Let $Y=a X+b$. show that $Y$ also has a Normal distribution with mean $a \mu+b$ and variance $a^{2} \sigma^{2}$. The mgf of $Y$ is

$$
\mathrm{M}_{\mathrm{Y}}(\mathrm{t})=\mathrm{E}\left(\mathrm{e}^{\mathrm{ty}}\right)=\mathrm{e}^{\mathrm{bt}}\left(\mathrm{M}_{\mathrm{X}}(\mathrm{at})\right)
$$

from theorem I.

$$
\begin{gathered}
\mathrm{M}_{\mathrm{X}}(\mathrm{t})=\mathrm{E}\left(\mathrm{e}^{\mathrm{tx}}\right) \\
\int_{-\infty}^{\infty} e^{t x}=\frac{1}{\sigma \sqrt{2 \pi}} e^{-\frac{1 / 2(x-\mu)^{2}}{\sigma^{2}}} d x=\frac{1}{\sigma \sqrt{2 \pi}} \int_{-\infty}^{\infty} e^{t x} e^{-\frac{1 / 2(x-\mu)^{2}}{\sigma^{2}}} d x
\end{gathered}
$$

Let $s=\frac{x-\mu}{\sigma}$, then $\mathrm{M}_{\mathrm{X}}(\mathrm{t})$ becomes

$$
M_{X}(t)=\frac{1}{\sigma \sqrt{2 \pi}} \int_{-\infty}^{\infty} e^{t(\sigma s+\mu)} e^{-1 / 2 s^{2}} \sigma d s=\frac{e^{t \mu}}{\sqrt{2 \pi}} \int_{-\infty}^{\infty} e^{-1 / 2 S^{2}+t \sigma s} d s
$$

$$
\frac{e^{t \mu}+\sigma^{2} \frac{t^{2}}{2}}{\sqrt{2 \pi}} \int_{-\infty}^{\infty} e^{-1 / 2 s^{2}+t \sigma s} d s
$$

Making the change of variable $\mathrm{u}=\mathrm{s}-\sigma \mathrm{t}$, we see that

$$
\mathrm{M}_{\mathrm{x}}(\mathrm{t})=e^{t \mu+\frac{1}{2} \sigma^{2} t^{2}} \frac{1}{\sqrt{2 \pi}} \int_{-\infty}^{\infty} e^{-u^{2}} d u=t \mu+e^{t u+\frac{\sigma^{2} t^{2}}{2}}
$$

Substituting at for t , we have

$$
\mathrm{M}_{\mathrm{X}}(\mathrm{at})=e^{a t \mu+\sigma^{2} a^{2} t^{2} / 2}
$$

Hence,

$$
M_{Y}(t)=e^{b t}\left(e^{a t \mu}+\frac{\sigma^{2} a^{2} t^{2}}{2}\right)=e^{t(b+a \mu)+\frac{\sigma^{2} a^{2} t^{2}}{2}}=e^{t \gamma+\sigma^{2} t^{2} a^{2} / 2}
$$

Where $\gamma=b+\mu \mathrm{a}=\mathrm{E}(\mathrm{Y})$, $\operatorname{Vara}=\mathrm{E}(\mathrm{Y}), \operatorname{Var}(\mathrm{Y})=\mathrm{a}^{2} \sigma^{2}$.
This is the mgf of a normal variable with mean $\gamma=a \mu+b$ and variance $a^{2} \sigma^{2}$. Thus, by theorem 2, Y is a normal random variable with mean $a \mu+b$ and variance $a^{2} \sigma^{2}$.

## Example 32

Let X be $\mathrm{N}\left(\mu, \sigma^{2}\right)$. Show that $Y=\frac{x-\mu}{\sigma}$ is $\mathrm{N}(0,1)$.

## Solution

$$
Y=\frac{X-\mu}{\sigma}=\frac{X}{\sigma}-\frac{\mu}{\sigma} .
$$

Let $\mathrm{a}=\frac{1}{\sigma}$ and $\mathrm{b}=-\frac{\mu}{\sigma}$, then $\mathrm{Y}=\mathrm{aX}+\mathrm{b}$.
From Example 312, Y is a normal random variable with mean $\mathrm{a} \mu+\mathrm{b}$ and variance $\mathrm{a}^{2} \sigma^{2}$.
Substituting for $a$ and $b$, we see that
(i) $\mathrm{a} \mu+\mathrm{b}=\frac{\mu}{\sigma}-\frac{\mu}{\sigma}=0$
(ii) $\mathrm{a}^{2} \sigma^{2}=\frac{\sigma^{2}}{\sigma^{2}}=1$

Thus Y is standard normal $(\mathrm{N}(0,1))$ random variable.

## Theorem 5

Let X and Y be independent random variables and $\mathrm{Z}=\mathrm{X}+\mathrm{Y}$.
Let $\mathrm{M}_{\mathrm{X}}(\mathrm{t}), \mathrm{M}_{\mathrm{Y}}(\mathrm{t})$ and $\mathrm{M}_{\mathrm{Z}}(\mathrm{t})$ be the mgfs of the random variables $\mathrm{X}, \mathrm{Y}$ and Z respectively. Then

$$
\begin{equation*}
\mathrm{M}_{\mathrm{Z}}(\mathrm{t})=\mathrm{M}_{\mathrm{X}}(\mathrm{t}) \mathrm{M}_{\mathrm{Y}}(\mathrm{t}) \tag{4}
\end{equation*}
$$

## Proof:

By definition,

$$
\mathrm{M}_{\mathrm{Z}}(\mathrm{t})=\mathrm{E}\left(\mathrm{e}^{\mathrm{Zt}}\right)=\mathrm{E}\left(\mathrm{e}^{(\mathrm{X}+\mathrm{Y}) \mathrm{t})}=\mathrm{E}\left(\mathrm{e}^{\mathrm{Xt}}+\mathrm{e}^{\mathrm{Yt})=} \mathrm{E}^{(\mathrm{e}+\mathrm{Xt}}\right) \mathrm{E}\left(\mathrm{e}^{\mathrm{Yt}}\right)=\mathrm{M}_{\mathrm{X}}(\mathrm{t}) \mathrm{M}_{\mathrm{Y}}(\mathrm{t}) .\right.
$$

In general, if $X_{1}, X_{2}, \ldots, X_{n}$ are independent random variables.
The mfg of $\mathrm{Z}=\mathrm{X}_{1}+\mathrm{X}_{2}+\ldots+\mathrm{X}_{\mathrm{n}}$ is

$$
M_{Z}(t)=M_{X_{1}}(t) M_{X_{2}}(t) \ldots M_{X_{n}}(t)
$$

If $X_{1}, X_{2}, \ldots, X_{n}$ are independent identically distributed with $\operatorname{mgf}^{M_{X}}(\mathrm{t})$, then

$$
\mathrm{M}_{\mathrm{Z}}(\mathrm{t})=\left[\mathrm{M}_{\mathrm{X}}(\mathrm{t})\right]^{\mathrm{n}}
$$

Example 33: Sum of Binomial Random Variables
Let $X$ and $Y$ be independent binomial random variables with parameters $\left(n_{1}, p\right),\left(n_{2}, p\right)$ respectively. Find the pdf of $\mathrm{Z}=\mathrm{X}+\mathrm{Y}$.

$$
\mathrm{M}_{\mathrm{X}}(\mathrm{t})=\mathrm{E}\left(\mathrm{e}^{\mathrm{tX}}\right)=\sum_{x=0}^{n_{1}} e^{t X}\binom{n_{1}}{x} p^{X}(1-p)^{n_{1}-x}=\left[p e^{t}+(1-p)\right]^{n_{2}}
$$

The mgf of Z is given by (from Theorem 5).

$$
\mathrm{M}_{\mathrm{Z}}(\mathrm{t})=\mathrm{M}_{\mathrm{X}}(\mathrm{t}) \mathrm{M}_{\mathrm{Y}}(\mathrm{t})=\left[p e^{t}+(1-p)\right]^{n_{1}+n_{2}}
$$

but this is the mgf of a binomially distributed random variable with parameters $\left(\mathrm{n}_{1}+\mathrm{n}_{2}\right.$, P).
thus, by theorem $2, \mathrm{Z}$ is a binomial random variable and its pdf is given y

$$
f_{Z}(z)=\left\{\begin{array}{cc}
{ }_{1}+n_{2} & C_{z} p^{Z}(1-p)^{n_{1}+n_{2}-z} \\
0=0,1,2, \ldots n_{1}+n_{2} \\
0 & \text { elsewhere }
\end{array}\right.
$$

In general, if $X_{1}, X_{2}, \ldots X_{K}$ are independent binomial random variables with parameters $\left(n_{1}, p\right),\left(n_{2}, p\right), \ldots\left(n_{k}, p\right)$ respectively, then the moment generating function of $Z=X_{1}$,
$X_{2}, \ldots \ldots, X_{k}$ is given by

$$
\mathrm{M}_{\mathrm{Z}}(\mathrm{t})=\left[p e^{t}+(1-p)\right]^{n_{1}+n_{2}+\cdots+n_{k}} .
$$

Thus Z is a binomial variable with parameters ( $n, p$ ) where $\mathrm{n}=\mathrm{n}_{1}+\mathrm{n}_{2} \ldots \mathrm{n}_{\mathrm{k}}$.

## Example 34: Sum of normal random variables

Suppose that $X$ and $Y$ are independent random variables with distribution $N\left(\mu_{1}, \sigma^{2}{ }_{1}\right)$ and $\mathrm{N}\left(\mu_{2}, \sigma^{2}{ }_{2}\right)$ respectively. Show that $\mathrm{Z}=\mathrm{X}+\mathrm{Y}$ is a normal random variable with mean $\mu_{1}+$ $\mu_{2}$ and variance $\sigma^{2}{ }_{1}+\sigma_{2}^{2}$

$$
\begin{aligned}
& \mathrm{M}_{\mathrm{X}}(\mathrm{t})=e^{\mu_{1} t+1 / 2 \sigma^{2}{ }_{1} t^{2}} \\
& \mathrm{M}_{\mathrm{Y}}(\mathrm{t})=e^{\mu_{2} t+1 / 2 \sigma^{2}{ }_{2} t^{2}}
\end{aligned}
$$

Hence

$$
\begin{aligned}
\mathrm{M}_{\mathrm{Z}}(\mathrm{t}) & =\mathrm{M}_{\mathrm{X}}(\mathrm{t}) \mathrm{M}_{\mathrm{X}}(\mathrm{t})=e^{\mu_{1} t+1 / 2 \sigma^{2}{ }_{1} t^{2}} e^{\mu_{2} t+\frac{1}{2} \sigma^{2}{ }_{2} t^{2}} \\
& =e^{t\left(\mu_{1}+\mu_{2}\right)+1 / 2 t^{2}\left(\sigma^{2}{ }_{1}+\sigma^{2}{ }_{2}\right)}=e^{t \mu+1 / 2 t^{2} \sigma^{2}}
\end{aligned}
$$

where $\mu=\mu_{1}+\mu_{2}, \sigma^{2}=\sigma_{1}{ }_{1}+\sigma^{2}{ }_{2}$. Since $e^{t \mu+1 / 2 t^{2} \sigma^{2}}$ is the $\operatorname{mgf}$ of $N\left(\mu, \sigma^{2}\right)$, hence by Theorem $4, \mathrm{z}$ is a normal random variablewith mean $\mu=\mu_{1}+\mu_{2}$ and variance $\sigma^{2}=\sigma^{2}{ }_{1}+\sigma^{2}{ }_{2}$.
In general, if $X_{1}, X_{2}, \ldots ., X_{n}$ are independent $N\left(\mu_{1}, \sigma^{2}{ }_{1}\right)$ then

$$
\mathrm{Z}=\mathrm{X}_{1}+\mathrm{X}_{2}+\ldots+\mathrm{X}_{\mathrm{k}}
$$

is $N\left(\mu, \sigma^{2}\right)$ where $\mu=\mu_{1}+\mu_{2}+\ldots+\mu_{\mathrm{n}}, \sigma^{2}=\sigma^{2}{ }_{1}+\sigma^{2}{ }_{2}+\ldots+\sigma^{2}{ }_{k}$

## Example 35: Sum of Poisson Random Variables.

Suppose that X and Y are independent poisson random variable with mean $\lambda_{1}$ and $\lambda_{2}$ respectively. Show that $\mathrm{Z}=\mathrm{X}+\mathrm{Y}$ is a Poisson random with mean $\lambda_{1}+\lambda_{2}$

$$
M_{X}(t)=E\left(e^{t X}\right)=\sum_{x=0}^{\infty} e^{t X} \frac{e^{-\lambda_{1} \lambda^{X}}}{x!}=e^{-\lambda_{1}\left(1-e^{t}\right)} .
$$

Similarly,

$$
\mathrm{M}_{\mathrm{Y}}(\mathrm{t})=e^{-\lambda_{1}\left(1-e^{t}\right)}
$$

Hence,

$$
\mathrm{M}_{\mathrm{Z}}(\mathrm{t})=e^{-\lambda_{1}\left(1-e^{t}\right)} e^{-\lambda_{2}\left(1-e^{t}\right)}=e^{-\left(1-e^{t}\right)\left(\lambda_{1}+\lambda_{2}\right)}=e^{-\left(1-e^{t}\right) \lambda}, \lambda=\lambda_{1}+\lambda_{2}
$$

The mgf of Poisson distribution with parameter $\lambda$ is $e^{-\lambda\left(1-e^{t}\right)}$, thus Z is a poisson random variable with mean (parameter) $\lambda=\lambda_{1}+\lambda_{2}$. In general, if $X_{1}, X_{2}, \ldots, X_{n}$ are independent $\mathrm{P}\left(\lambda_{1}\right)$, then

$$
Z=X_{1}+X_{2}+\ldots+X_{n}
$$

is a Poisson random variable with parameter $\lambda=\lambda_{1}+\lambda_{2}+\ldots+\lambda_{n}$.

## Example 36

Let $X$ and $Y$ be independent gamma random variable with parameters $\left(n_{1}, \lambda\right)$ and $\left(n_{2}, \lambda\right)$ respectively. Show that $Z=X+Y$ is a gamma random variable withparameter $\left(n_{1}+n_{2}\right.$, $\lambda)$.

## Solution

$$
\begin{aligned}
M_{X}(t) & =E\left(e^{t X}\right)=\int_{-\infty}^{\infty} e^{t x} \frac{\lambda^{n_{1}} x_{1}{ }^{n-1} e^{-\lambda x}}{\Gamma\left(n_{1}\right)} d x=\int_{0}^{\infty} \lambda^{n_{1}} \frac{(x)^{n_{1}-1} e^{-x(\lambda-t)}}{\Gamma\left(n_{1}\right)} d x \\
= & \frac{\lambda^{n_{1}}}{\Gamma\left(n_{1}\right)} \int_{0}^{\infty} x^{n-1} e^{-x(\lambda-t)} d x=\frac{\lambda^{n_{1}}}{(\lambda-t)^{n_{1}-1} \Gamma\left(n_{1}\right)} \int_{0}^{\infty} u^{n_{1}-1} e^{-u} d u
\end{aligned}
$$

But $\int_{0}^{\infty} u^{n_{1}-1} e^{-u} d u=\Gamma(n)$.
Hence,

$$
\mathrm{M}_{\mathrm{X}}(\mathrm{t})=\left[\frac{\lambda}{\lambda-t}\right]^{n_{1}}
$$

Similarly $\quad \mathrm{M}_{\mathrm{Y}}(\mathrm{t})=\left[\frac{\lambda}{\lambda-t}\right]^{n_{2}}$.
Thus,

$$
\mathrm{M}_{\mathrm{Z}}(\mathrm{t})=\left[\frac{\lambda}{\lambda-t}\right]^{n_{1}} \cdot\left[\frac{\lambda}{\lambda-t}\right]^{n_{2}}=\left[\frac{\lambda}{\lambda-t}\right]^{n_{1}+n_{2}}=\left[\frac{\lambda}{\lambda-t}\right]^{n} \cdot n=n_{1}+n_{2} .
$$

This show that Z is a gamma random variable with parameters $\left(\mathrm{n}_{1}+\mathrm{n}_{2}, \lambda\right)$.
In general, if $X_{1}, X_{2}, \ldots+X_{k}$ are independent gamma random variables with parameters $\left(n_{1}, \lambda\right), I=1,2, \ldots k$. then $Z=X_{1}+X_{2}+\ldots+X_{k}$ has a gamma distribution with parameters $(\mathrm{n}, \lambda)$ where $\mathrm{n}=\mathrm{n}_{1}+\mathrm{n}_{2}+\ldots+\mathrm{n}_{\mathrm{k}}$.

## Example 37

Suppose that $X_{i}$ has $\chi^{2}\left(n_{1}\right)$ (chi-square distribution with $n_{i}$ degrees of freedom) $I=1$, $2, \ldots \mathrm{k}$ where the $\mathrm{X}_{\mathrm{i}}$ 's are independent random variables.

Let $Z=X_{1}+X_{2}+\ldots+X_{k}$. Show that $Z$ has distribution $\chi_{n}^{2}$ where $n=n_{1}+n_{2}+\ldots+n_{k}$. Recall (5.9) that chi-square distribution is a special case of the gamma distribution in which $\lambda=1 / 2$ and $n$ replaced by $n / 2$. Since the mgf of gamma $(n, \lambda)$ is given by

$$
\left[\frac{\lambda}{\lambda-t}\right]^{n} ;
$$

substituting for $\lambda=1 / 2$ and replacing $n$ by $n / 2$ we have

$$
\mathrm{M}_{\mathrm{X}}(\mathrm{t})=\left[\frac{1 / 2}{1 / 2-t}\right]^{n / 2}=\left[\frac{1}{1-2 t}\right]^{n / 2} .
$$

The mgf of $\mathrm{X}_{\mathrm{i}}$ is therefore given by

$$
\mathrm{M}_{\mathrm{X}}(\mathrm{t})=\left[\frac{1}{1-2 t}\right]^{n / 2} \mathrm{I}=1,2, \ldots
$$

Hence, the mgf of Z is

$$
\mathrm{M}_{\mathrm{Z}}(\mathrm{t})=M_{X_{1}}(t) M_{X_{2}}(t) \ldots M_{X_{k}}(t)=\left[\frac{1}{1-2 t}\right]^{\frac{n_{1}+n_{2}+\cdots+n_{k}}{2}}=\left[\frac{1}{1-2 t}\right]^{\frac{n}{2}}
$$

where $\mathrm{n}=\mathrm{n}_{1}+\mathrm{n}_{2}+\ldots+\mathrm{n}_{\mathrm{k}}$ which is the mgf of $\chi_{\mathrm{n}}^{2}$ distribution.
Example 38
Let $X_{1}, X_{2}, \ldots X_{n}$ be independent identically normal variables with mean $\mu$ and variance $\sigma^{2}$. Show that (i) $\mathrm{E}(\bar{X})=\mu$, where $\bar{X}=\frac{1}{n}\left(\mathrm{X}_{1}+\mathrm{X}_{2}+\ldots+\mathrm{X}_{\mathrm{n}}\right)$ (ii) $\operatorname{Var}(\bar{X})=\frac{\sigma^{2}}{n}$ and (iii) $Y=\frac{\sum_{1}^{n}\left(X_{1}-\mu\right)^{2}}{\sigma^{2}}$ has a $\chi^{2}(\mathrm{n})$.
(i) $\mathrm{E}(\bar{X})=E\left(\frac{1}{n} \sum_{1}^{n} X_{i}\right)=\frac{1}{n} \sum_{1}^{n} E\left(X_{i}\right)=\frac{1}{n} \cdot n \mu=\mu$
(ii) $\operatorname{Var}(\bar{X})=\operatorname{Var}\left(\frac{1}{n} \sum_{1}^{n} X_{i}\right)=\frac{1}{n^{2}} \sum \operatorname{Var}\left(X_{i}\right)=\frac{1}{n^{2}} n \sigma^{2}=\frac{\sigma^{2}}{n}$
(iii) $Y=\frac{\sum_{1}^{n}\left(X_{1}-\mu\right)^{2}}{\sigma^{2}}=\frac{\left(X_{1}-\mu\right)^{2}}{\sigma^{2}}+\frac{\left(X_{2}-\mu\right)^{2}}{\sigma^{2}}+\cdots+\frac{\left(X_{n}-\mu\right)^{2}}{\sigma^{2}}$
$=\left(\frac{X_{1}-\mu}{\sigma}\right)^{2}+\left(\frac{X_{2}-\mu}{\sigma}\right)^{2}+\cdots+\left(\frac{X_{n}-\mu}{\sigma}\right)^{2}=\mathrm{Y}_{1}^{2}+\mathrm{Y}_{2}^{2}+\ldots+\mathrm{Y}_{\mathrm{n}}{ }^{2}$.
From Example 14, we know that $\mathrm{Y}_{1}{ }^{2}$ has $\chi^{2}(1)$ and from Example 30, since $\mathrm{Y}_{1}{ }^{2}$ are independent $\chi^{2}(1)$ we have that $Y$ is $\chi^{2}(n)$.

Example 39
Let $X_{1}, X_{2}, \ldots X_{n}$ be independent identical normal random variables with mean $\mu$ and variance $\sigma^{2}$
Show that $S^{2}=\frac{\sum_{i=1}^{n}\left(X_{1}-\bar{X}\right)^{2}}{\sigma^{2}}$ has a $\chi^{2}(\mathrm{n}-1)$.
We shall proceed as follows:

$$
\begin{gathered}
\mathrm{X}_{1}-\mu=\mathrm{X}_{\mathrm{i}}-\bar{X}+\bar{X}-\mu \\
\left(\mathrm{X}_{1}-\mu\right)^{2}=\left(\mathrm{X}_{1}-\bar{X}\right)^{2}+(\bar{X}-\mu)^{2}+2\left(\mathrm{X}_{\mathrm{i}}-\bar{X}\right)(\bar{X}-\mu)
\end{gathered}
$$

Summing, we have

$$
\begin{gathered}
\sum_{i=1}^{n}\left(\mathrm{X}_{i}-\mu\right)^{2}=\sum_{i=1}^{n}\left(\mathrm{X}_{i}-\bar{X}\right)^{2}+\sum_{i=1}^{n}(\overline{\mathrm{X}}-\mu)^{2}+2 \sum_{i=1}^{n}\left(\mathrm{X}_{i}-\bar{X}\right)(\bar{X}-\mu) \\
\sum_{i=1}^{n}\left(\mathrm{X}_{i}-\bar{X}\right)(\bar{X}-\mu)=(\bar{X}-\mu) \sum_{i=1}^{n}\left(\mathrm{X}_{i}-\bar{X}\right) \backslash
\end{gathered}
$$

since $\sum\left(X_{i}-\bar{X}\right)=0$, we see that

$$
\sum_{i=1}^{n}\left(X_{i}-\mu\right)^{2}=\sum_{i=1}^{n}\left(X_{i}-\bar{X}\right)^{2}+\sum_{i=1}^{n}(\bar{X}-\mu)^{2}
$$

dividing through by $\sigma^{2}$, we have

$$
\frac{\sum_{i=1}^{n}\left(\mathrm{X}_{i}-\mu\right)^{2}}{\sigma^{2}}=\frac{\sum\left(X_{1}-\bar{X}\right)}{\sigma^{2}}+\frac{\sum_{i=1}^{n}(\overline{\mathrm{X}}-\mu)^{2}}{\sigma^{2}}
$$

From Example 37, we have $\sum_{i=1}^{n} \frac{\left(\mathrm{X}_{i}-\mu\right)^{2}}{\sigma^{2}}$ is $\chi^{2}(\mathrm{n})$ and (it is left as an exercise to show that $\frac{\sum\left(\mathrm{X}_{i}-\mu\right)^{2}}{\sigma^{2}}$ is $\chi^{2}(1)$.
Let $\mathrm{Z}=\frac{\sum\left(\mathrm{X}_{i}-\mu\right)^{2}}{\sigma^{2}}$ and $\mathrm{Y}=\frac{\sum\left(\mathrm{X}_{i}-\mu\right)^{2}}{\sigma^{2}}$

$$
S^{2}=\frac{\sum\left(\mathrm{X}_{i}-\overline{\mathrm{x}}\right)^{2}}{\sigma^{2}}
$$

Since $\overline{\mathrm{X}}$ and $\mathrm{S}^{2}$ are stochastically independent, we have

$$
\mathrm{E}\left(\mathrm{e}^{\mathrm{t} \mathrm{Z}}\right)=\mathrm{E}\left(\mathrm{e}^{\mathrm{t}(\mathrm{Y}+\mathrm{S} 2)}=\mathrm{E}\left(\mathrm{e}^{\mathrm{tY}}\right) \mathrm{E}\left(\mathrm{e}^{\mathrm{ts} 2}\right)\right.
$$

but $\mathrm{M}_{\mathrm{Z}}(\mathrm{t})=\mathrm{E}\left(\mathrm{e}^{\mathrm{tZ}}\right)=\left[\frac{1}{1-2 t}\right]^{n / 2}$, since Z is $\chi(\mathrm{n})$,

$$
\mathrm{M}_{\mathrm{Y}}(\mathrm{t})=\mathrm{E}\left(\mathrm{e}^{\mathrm{tY}}\right)=\left[\frac{1}{1-2 t}\right]^{t / 2}\left(\mathrm{Y} \text { is } \mathrm{Z}_{(1)}^{2}\right)
$$

hence,

$$
\mathrm{E}\left(\mathrm{e}^{\mathrm{tS}}\right)^{2}=\left[\frac{1}{1-2 t}\right]^{\frac{n-1}{2}}
$$

and this is the mgf of a chi-square distribution with $n-1$ degrees of freedom. This shows that $S^{2}$ has a chi-square distribution with $n-1$ degrees of freedom.

### 7.4 Order Statistics

### 7.4.1 Independent Identically Distributed Random Variables

Let $X_{1}, X_{2}, \ldots, X_{n}$ be independent continuous random variables, each having distribution function $F(x)$ and probability density function $f(x)$. define

$$
\begin{array}{ll}
X_{(1)} & = \\
X_{(2)} & = \\
\text { smallest of } X_{1}, X_{2}, \ldots X_{n} \\
\text { second smallest of } X_{1}, X_{2}, \ldots X_{n}
\end{array}
$$

$$
X_{(n)}=\text { largest of } X_{1}, X_{2}, \ldots X_{n}
$$

That is, $X_{(1)}, X_{(2)}, \ldots X_{(n)}$ are random variable obtained by arranging $X_{1}, X_{2}, \ldots X_{n}$ in an increasing order.

$$
\begin{aligned}
X_{(1)} & =\min \left(X_{1}, X_{2}, \ldots X_{n}\right) \\
X_{(n)} & =\max \left(X_{1}, X_{2}, \ldots X_{n}\right) .
\end{aligned}
$$

The random variables $\mathrm{X}_{(\mathrm{i})}$ is called the $\mathrm{i}^{\text {th }}$ order statistics and the ordered values $\mathrm{X}_{(1)} \leq \mathrm{X}_{(2)}$ $\leq \ldots \leq \mathrm{X}_{(\mathrm{n})}$ are known as the order statistics corresponding to the random variables $\mathrm{X}_{1}$, $X_{2}, \ldots X_{n}$.
For Example, let $\mathrm{x}_{1}, \mathrm{x}_{2}, \mathrm{x}_{3}$ be a random sample of size 3 from a random variables X having probability density function $\mathrm{f}(\mathrm{x})-\infty<\mathrm{x}<\infty$.
The possible values of $X_{(1)}, X_{(2)}$ and $X_{(3)}$ are as follows:

$$
\begin{array}{lll}
\mathrm{x}_{(1)}=\mathrm{x}_{1}, & \mathrm{x}_{(2)}=\mathrm{x}_{2}, & \mathrm{x}_{(3)}=\mathrm{x}_{3} \text { if } \mathrm{x}_{1}<\mathrm{x}_{2}<\mathrm{x}_{3} \\
\mathrm{x}_{(1)}=\mathrm{x}_{2}, & \mathrm{x}_{(2)}=\mathrm{x}_{1}, & \mathrm{x}_{(3)}=\mathrm{x}_{3} \text { if } \mathrm{x}_{2}<\mathrm{x}_{1}<\mathrm{x}_{3} \\
\mathrm{x}_{(1)}=\mathrm{x}_{3}, & \mathrm{x}_{(2)}=\mathrm{x}_{2}, & \mathrm{x}_{(3)}=\mathrm{x}_{1} \text { if } \mathrm{x}_{3}<\mathrm{x}_{2}<\mathrm{x}_{1} \\
& . \\
& \\
\mathrm{x}_{(1)}=\mathrm{x}_{3}, & \mathrm{x}_{(2)}=\mathrm{x}_{1}, & \mathrm{x}_{(3)}=\mathrm{x}_{2} \text { if } \mathrm{x}_{3}<\mathrm{x}_{1}<\mathrm{x}_{2}
\end{array}
$$

There are $3!=6$ permutations of $\left(x_{1}, x_{2}, x_{3}\right)$ and hence 6 possible ordered statistics. We shall now find the joint probability density function of $X_{(1)}, X_{(2)}, X_{(3)}$. Since for any permutation, say ( $\mathrm{x}_{2}<\mathrm{x}_{1}<\mathrm{x}_{3}$ )

$$
\begin{gathered}
P\left(x_{2}-\frac{\epsilon}{2}<X_{(1)}<x_{2}+\frac{\epsilon}{2}, x_{1}+\frac{\epsilon}{2}<X_{(2)}<x_{1}+\frac{\epsilon}{2}, x_{(3)}<x_{3}+\frac{\epsilon}{2}\right)=\epsilon f\left(x_{2}\right) \\
\in f\left(x_{1}\right) \in f\left(x_{3}\right)=\epsilon^{3} f\left(x_{1}\right) f\left(x_{2}\right) f\left(x_{3}\right),
\end{gathered}
$$

as illustrated in the Figure (1) below


Figure 1
Since there are 3! Possible permutations, the region D is partitioned into six dejoint sets $D_{1}, D_{2=\ldots} D_{6}$. We have $X_{(1)} X_{(2)} X_{(3)}$.
Thus, for $\mathrm{x}_{1}<\mathrm{x}_{2}<\mathrm{x}_{3}$

$$
\begin{gathered}
P\left(x_{1}-\frac{\epsilon}{2}<X_{(1)}<x_{1}+\frac{\epsilon}{2}<x_{(2)}<x_{2}-\frac{\epsilon}{2}, x_{3}-\frac{\epsilon}{2}<X_{(3)}<x_{2}-\frac{\epsilon}{2}\right) \\
=3!\epsilon^{3} f\left(x_{1}\right)\left(f\left(x_{2}\right)\right) f\left(x_{3}\right)
\end{gathered}
$$

Dividing by $\square^{3}$ and letting $\varepsilon->0$, we have

$$
f\left(x_{(1)}, x_{(2)}, x_{(3)}\right)=n!f\left(x_{1} f\left(x_{2}\right) f\left(x_{3}\right) ; x_{1}<x_{2}<x_{3}\right.
$$

in general, we can extend this idea to a sample of size $n$ and we have for $x_{1} x_{2} \ldots x_{n}$

$$
\mathrm{f}_{\mathrm{x}(1),}, \mathrm{x}_{(2)}, \ldots \mathrm{x}_{(\mathrm{n})}\left(\mathrm{x}_{1}, \mathrm{x}_{2}, \ldots \mathrm{x}_{\mathrm{n}}\right)=\mathrm{n}!\mathrm{f}\left(\mathrm{x}_{1}\right) \mathrm{f}\left(\mathrm{x}_{2}\right) \ldots \mathrm{f}\left(\mathrm{x}_{\mathrm{n}}\right)
$$

$$
\mathrm{x}_{1}<\mathrm{x}_{2}<\ldots<\mathrm{x}_{\mathrm{n}} .
$$

the marginal density function of $\mathrm{X}_{(\mathrm{i})}$ the $\mathrm{i}^{\text {th }}$ order statistic can be obtained by integrating the probability density function (5)

$$
\begin{gathered}
f_{x_{1}}(x)=\int \ldots \int f_{x_{(1)}, x_{(2)} \ldots x_{(n)}}\left(x_{1} x_{2}, \ldots x_{n}\right) d x_{2} d x_{3} \ldots d x_{n} \\
f_{x_{(1)}}\left(x_{i}\right)=\int \ldots \int f_{x_{(1)} \ldots, x_{(n)}}\left(x_{1}, x_{2}, \ldots x_{n}\right) d x_{1} d x_{2} \ldots d x_{i-1} d x_{i+1} \ldots d x_{n}
\end{gathered}
$$

Example 33

Find
(i) the joint p.d.f. of $X_{1}, X_{2}$ and $X_{3}$
(ii) the joint p.d.f of $X_{(1)}, X_{(2)}$ and $X_{(3)}$ the ordered statistics
(iii) the marginal p.d.f of $\mathrm{X}_{(1)}$.

## Solution

$$
\begin{aligned}
& f_{x_{1}, x_{2}, x_{3}}\left(x_{1}, x_{2}, x_{3}\right)=f_{x_{1}}\left(x_{1}\right) f_{x_{2}}\left(x_{2}\right) f_{x_{3}}\left(x_{3}\right)-1 ; 0<x_{1}, x_{2}, x_{3}<1 \\
& f_{x_{(1)}, x_{(2)}, x_{(3)}}\left(x_{(1)}, x_{(2)}, x_{(3)}\right)=3!f_{x_{1}}\left(x_{1}\right) f_{x_{2}}\left(x_{2}\right) f_{x_{3}}\left(x_{3}\right) ; 0<x_{1}, x_{2}, x_{3}<1
\end{aligned}
$$

$$
\begin{aligned}
f_{x_{1}}\left(x_{1}\right)=\int_{x_{1}}^{1} & {\left[\int_{x_{2}}^{1} 3!d x_{(3)}\right] d x_{(2)} } \\
& =3!\int_{x_{1}}^{1}\left(1-x_{2}\right) d x_{2}=3!\left[\frac{1}{2}-x_{1}-\frac{1}{2} x_{1}^{2}\right]=\frac{3!}{2}\left[1-2 x_{1}-x_{1}^{2}\right] \\
& =3\left(1-x_{1}\right)^{2}
\end{aligned}
$$

Thus,

$$
f_{x_{(1)}}(x)=\left\{\begin{array}{cc}
3(1-x)^{2} & 0<x<1 \\
0 & \text { elsewhere }
\end{array}\right.
$$

Another method of finding the joint marginal p.d.f of $X_{(1)}, X_{(2)}, \ldots X_{(n)}$ is by direct reasoning as follows:
(i) For $X_{(i)}$ to equal $\mathrm{x}, \mathrm{I}-1$ of $\left(\mathrm{x}_{1}, \mathrm{x}_{2} \ldots \mathrm{x}_{\mathrm{n}}\right)$ should be less than x and $\mathrm{n}-1$ should be greater than $x$ and 1 of them equals $x$.

$\mathrm{P}\left(\mathrm{I}-1\right.$ of the $\mathrm{X}_{\mathrm{i}}$ 's are less than $\left.{ }^{\mathrm{x}}\right)=[\mathrm{F}(\mathrm{x})]^{\mathrm{i}-1}$
$P\left(n-1\right.$ of the $X_{i}^{\prime} s$ are greater than $\left.x\right)=[1-F(x)]^{n-i}$
Thus for any given set of partition of $\left(\mathrm{X}_{1}, \mathrm{X}_{2} \ldots \mathrm{X}_{\mathrm{n}}\right)$ into 3 as stated above, the required probability is from Chapter 1 section 14 number of ways of partitioning a set of $n$ object into the 3 group above is $\frac{n!}{(i-1)!1!(n-i)!}$. given by

f_{x_{1}}(x)=\frac{n!}{(i-1)!1!(n-i)!}[F(x)]^{i=1}[1-F(x)]^{n=1} f(x) \tag{6}
\end{equation*}
$$

(ii) The joint p.d.f. of $\mathrm{X}_{(\mathrm{i})}$ and $\mathrm{X}_{(\mathrm{j})} \mathrm{I}<\mathrm{j}$

The probability that exactly $i$ of the $X_{i}$ 's lie in $(-\infty, x)$ and ( $n-1$ ) lie in $(x, \infty)$ is

$$
{ }^{n} C_{i}[F(x)]^{i}\left[1-F\left(x_{i}\right)\right]^{n-1}
$$

since $F(x)=P(X \leq x)=P\left(\right.$ any of the $x_{1}, \ldots, X_{n}$ falls in $(-\infty, x)$.
the event $\left\{\mathrm{X}_{(\mathrm{i})} \leq \mathrm{x}\right\}$ occurs if and only i or more of the $\mathrm{X}_{\mathrm{i}}$ 's lie in $(-\infty, \mathrm{x})$. Thus $F_{x_{(1)}}(x)=P\left(X_{(i)} \leq x\right)=\sum_{j=1}^{n} \quad{ }^{\mathrm{n}} \mathrm{C}_{\mathrm{j}}[\mathrm{F}(\mathrm{x})]^{\mathrm{j}}[1-\mathrm{F}(\mathrm{x})]^{\mathrm{n}-\mathrm{j}} \quad-\infty<\mathrm{x}<\infty$
If $\mathrm{i}=1$, we have

$$
F_{x_{(1)}}(x)=\sum_{j=1}^{n} \quad{ }^{\mathrm{n}} \mathrm{C}_{\mathrm{j}}[\mathrm{~F}(\mathrm{x})]^{\mathrm{j}}[1-\mathrm{F}(\mathrm{x})]^{\mathrm{n}-\mathrm{j}}
$$

By Binomial theorem $\sum_{j=1}^{n} \quad{ }^{n} C_{j}[F(x)]^{j}[1-F(x)]^{n-j}=1$
Thus

$$
\begin{equation*}
F_{x_{(1)}}(x)=1-{ }^{\mathrm{n}} \mathrm{C}_{\mathrm{j}}[\mathrm{~F}(\mathrm{x})]^{0}[1-\mathrm{F}(\mathrm{x})]^{\mathrm{n}-0}=1-[1-\mathrm{F}(\mathrm{x})]^{\mathrm{n}} \quad-\infty<\mathrm{x}<\infty \tag{10}
\end{equation*}
$$

Similarly, when we put $\mathrm{i}=\mathrm{n}$ in (8)

\begin{equation*}
F_{x_{(1)}}(x)=[\mathrm{F}(\mathrm{x})]^{\mathrm{n}} \quad-\infty<\mathrm{x}<\infty \tag{11}
\end{equation*}
$$

By differentiating, we have

F_{x_{(n)}}(x)=F_{x_{(n)}}(x)=\mathrm{n}[\mathrm{~F}(\mathrm{x})]^{\mathrm{n}-1} \mathrm{f}(\mathrm{x}) & -\infty<\mathrm{x}<\infty
\end{array}
$$

2. The Joint Distribution Function of $X_{(1)}, X_{(n)}$.

To find the joint distribution function of $X_{i}$ and $X_{n}$, we proceed as follows.

\left\{\left(\mathrm{x}_{1}, \mathrm{x}_{\mathrm{n})}\right): \mathrm{X}_{(1)} \leq \mathrm{x}_{1}, \mathrm{x}_{(\mathrm{n})} \leq \mathrm{x}_{(\mathrm{n})}\right\}=\left\{\left(\mathrm{x}_{1}, \mathrm{x}_{\mathrm{n}}\right): \mathrm{X}_{(\mathrm{n})} \leq \mathrm{x}_{(\mathrm{n})} \backslash \backslash\{\mathrm{x}, \mathrm{y})\right\}: \\
\left.\mathrm{X}_{(1)}>\mathrm{x}_{1}, \mathrm{x}_{(\mathrm{n})} \leq \mathrm{x}_{\mathrm{n}}\right\} .
\end{gathered}
$$

See figure 5 below.

We know that $\mathrm{P}\left(\mathrm{X}_{(\mathrm{n})} \leq \mathrm{x}_{\mathrm{n}}\right)=\left[\mathrm{F}\left(\mathrm{x}_{\mathrm{n}}\right)\right]^{\mathrm{n}}$, therefore
$\mathrm{P}\left(\mathrm{X}_{(1)}>\mathrm{x}_{1}, \mathrm{X}_{(\mathrm{n})}\right)=\mathrm{P}\left(\mathrm{x}_{1}<\mathrm{X}_{1} \leq \mathrm{x}_{\mathrm{n}}, \mathrm{x}_{1}<\mathrm{x}_{2} \leq \mathrm{x}_{\mathrm{n}} \ldots \mathrm{x}_{1}<\mathrm{X}_{\mathrm{n}} \leq \mathrm{x}_{\mathrm{n}}\right)$

$$
\begin{equation*}
=\left(\mathrm{F}\left(\mathrm{x}_{\mathrm{n}}\right)-\mathrm{F}\left(\mathrm{x}_{1}\right)\right)^{\mathrm{n}} \tag{12}
\end{equation*}
$$

Thus
$f_{x_{(1)} x_{(n)}}\left(x_{1}, x_{n}\right)=\mathrm{P}\left(\mathrm{X}_{(1)} \leq \mathrm{x}_{1}, \mathrm{X}_{(\mathrm{n})} \leq \mathrm{x}_{\mathrm{n}}\right)=\left[\mathrm{F}\left(\mathrm{x}_{\mathrm{n}}\right)\right]^{\mathrm{n}}-\left\{\mathrm{F}\left(\mathrm{x}_{\mathrm{n}}\right)-\mathrm{F}\left(\mathrm{x}_{1}\right)\right\}^{\mathrm{n}}$
from which the density function can be derived by differentiation:

= & \mathrm{n}(\mathrm{n}-1) \mathrm{f}\left(\mathrm{x}_{1}\right) \mathrm{f}\left(\mathrm{x}_{\mathrm{n}}\right)\left[\mathrm{F}\left(\mathrm{x}_{\mathrm{n}}\right)-\mathrm{F}\left(\mathrm{x}_{1}\right)\right]^{\mathrm{n}-2}, \mathrm{x}_{1} \leq \mathrm{x}_{\mathrm{n}} \tag{13}
\end{align*}
$$

## Distribution Function of the Range of a Random Sample

The random variable $R$, defined by $R=X_{(n)}-X_{(1)}$ is called the range of the observed random variables.

$$
\begin{aligned}
\mathrm{P}(\mathrm{R} \leq \mathrm{r}) & =\mathrm{P}\left(\mathrm{X}_{(\mathrm{n})}-\mathrm{X}_{(1)} \leq \mathrm{r}\right)=\iiint_{x_{n}-x_{1} \leq r} f_{x_{(1)}, x_{(n)}}\left(\mathrm{x}_{1}, \mathrm{x}_{\mathrm{n}}\right) \mathrm{dx}_{1} \mathrm{dx}_{2} \\
& =\int_{-\infty}^{\infty} \quad \int_{x_{1}}^{x_{1}+r} n(n-1)\left[\mathrm{F}\left(\mathrm{x}_{\mathrm{n}}\right)-\mathrm{f}\left(\mathrm{x}_{1}\right)\right]^{\mathrm{n}-2} \mathrm{f}\left(\mathrm{x}_{1}\right) \mathrm{f}\left(\mathrm{x}_{\mathrm{n}}\right) \mathrm{dx}_{\mathrm{n}} \mathrm{dx}_{1} .
\end{aligned}
$$

Making the change of variable $y=F\left(X_{n}\right)-F\left(x_{1}\right)$, $d y=f\left(x_{n}\right) d x_{n}$

$$
\begin{aligned}
& \int_{x_{1}}^{x_{1}+r}\left[F\left(x_{n}\right)-F\left(x_{1}\right)\right]^{n-2} f\left(x_{n}\right) d x_{n}=\int^{F\left(x_{1}+r\right)-F\left(x_{1}\right)} y^{n-2} d y=\frac{1}{n-1}\left[F\left(x_{1}+r\right)\right. \\
&\left.-F\left(x_{1}\right)\right]^{n-1}
\end{aligned}
$$

Thus

$$
\begin{align*}
& \mathrm{F}_{\mathrm{R}}(\mathrm{r})=\mathrm{P}(\mathrm{R} \leq \mathrm{r})=\mathrm{n} \int_{-\infty}^{\infty}\left[F\left(x_{1}+r\right)-F\left(x_{1}\right)\right]^{n-1} f\left(x_{1}\right) d x_{1}  \tag{14}\\
& \mathrm{~F}_{\mathrm{R}}(\mathrm{r})=\mathrm{n}(\mathrm{n}-1) \int_{-\infty}^{\infty} F\left(x_{1}\right) f\left(x_{1}+r\right)\left[F\left(x_{1}+r\right)-F\left(x_{1}\right)\right]^{n-2} d x_{1}
\end{align*}
$$

## Example 40

Let $X_{1}, X_{2}, \ldots X_{n}$ be a random sample from uniform distribution on (0, 1). Find
(i) The distribution function of $\mathrm{R}=\mathrm{X}_{(\mathrm{n})}-\mathrm{X}_{(1)}$
(ii) The probability density function of R.

## Solution

(i) $\quad \mathrm{P}(\mathrm{R} \leq \mathrm{r})=\int_{0}^{x}\left[F\left(x_{1}+r\right)-F\left(x_{1}\right)\right]^{n-1} f\left(x_{1}\right) d x_{1}$

$$
\text { Where } \mathrm{F}(\mathrm{x})=\int_{0}^{x} 1 d x=x \text {; }
$$

$$
\mathrm{F}\left(\mathrm{x}_{1}+\mathrm{r}\right)=1 \text { if } \mathrm{x}_{1}+\mathrm{r}>1
$$

$$
=x_{1}+r \text { if } x_{1}+r<1 .
$$

Thus

$$
\begin{gathered}
\mathrm{P}(\mathrm{R} \leq \mathrm{r})=\mathrm{n} \int_{0}^{1-r} r^{n-1} d x_{1}+n \int_{1-r}^{1}\left(1-x_{1}\right)^{n-1} d x_{1} \\
\mathrm{~F}_{\mathrm{R}}(\mathrm{r})=\mathrm{n}(1-\mathrm{r}) \mathrm{r}^{\mathrm{n}-1}+\mathrm{r}^{\mathrm{n}}
\end{gathered}
$$

(ii) $\quad \mathrm{f}_{\mathrm{R}}(\mathrm{r})=\mathrm{F}^{\prime}{ }_{\mathrm{R}}(\mathrm{r})=\left\{\begin{array}{ll}n(n-1)(1-r) r^{n-2} & 0 \leq r \leq 1 \\ 0 & \text { otherwise }\end{array}\right.$.

Another method of finding the probability density function of R is by using the formula (1) for sum of random variables.

Example 41
Let $X_{1}, X_{2}, \ldots X_{n}$ be independent random variables having the uniform distribution on (a, b). Find the pdf of (i) $X_{(1)}=\min \left(X_{1}, X_{2}, \ldots X_{n}\right)$ (ii) $X_{(n)}=\max \left(X_{1}, X_{2}, \ldots X_{n}\right)$.

## Solution

The pdf of X is

$$
f_{x}(x)=\frac{1}{b-a}, a<x<b
$$

The pdf of $X_{(i)}$ is given by

$$
f_{x_{(1)}}(x)=\frac{n!}{(i-1)!(n-1)!}[F(x)]^{i-1}[1-F(x)]^{n-1} f(x) f(x)
$$

where

$$
\begin{gathered}
\mathrm{F}(\mathrm{X})=\int_{a}^{x} \frac{1}{b-a} d x=\frac{x-a}{b-a} \\
f_{x_{(1)}}(x)=n\left[1-\frac{x-a}{b-a}\right]^{n-1} \frac{1}{b-a}=\frac{n(b-x)^{n-1}}{(b-a)^{n}}, a<x<b
\end{gathered}
$$

(ii)

$$
f_{x_{(1)}}(x)=n\left[\frac{x-a}{b-a}\right]^{n-1} \frac{1}{b-a}= \begin{cases}\frac{n(b-x)^{n-1}}{(b-a)^{n}}, & a<x<b \\ 0 & \text { elsewhere }\end{cases}
$$

$$
\begin{aligned}
& f_{R}(r)=\int_{-\infty}^{\infty} f_{x_{(1)}, x_{(n)}}\left(x_{1}, r+x_{1}\right) d x_{1} \\
& = \begin{cases}n(n-1) \int_{-\infty}^{\infty} f(x) f(r+x)[F(r+x)-F(x)]^{n-2} d x & r>0 \\
r<0\end{cases}
\end{aligned}
$$

## LIMIT THEOREMS

## The Law of Large Numbers and the Central Limit Theorem

The most important theoretical results in probability are limit theorems. In this chapter we prove often useful tools in probability, the Chebychev's inequality. This inequality is then used to deduce the law of large numbers for independent and identically distributed random variables. In section 8.5 the central limit theorem which is a fundamental result in the theory and applications f probability theory is given.

### 8.1 Chebychev's Inequality

Chebychev;s inequality gives an upper bound in terms of variance of a random variable X for probability that X deviates from its mean by more than k units.

## Theorem 8.1: Chebychev's Inequality

Let $X$ be a random variable (discrete or continuous) with mean $\mu$ and variance $\sigma^{2}$. Then for any positive number k we have

$$
\mathrm{P}\{|\mathrm{X}-\mu|>\mathrm{k}\} \leq \frac{\sigma^{2}}{k^{2}}
$$

Or equivalently

$$
\mathrm{P}\{|\mathrm{X}-\mu| \geq \mathrm{k} \sigma\}\} \leq \frac{1}{k^{2}}
$$

## Proof:

Let $X$ be a non-negative random variable such that $E(X)=\mu<\infty$.
Define another random variable Y as follows:

$$
\begin{array}{cc} 
& 0 \\
= & =
\end{array} \quad \begin{array}{r}
\text { if } X<k \\
\text { if } X>k
\end{array}
$$

This new variable Y is a discrete variable having two values $0, \mathrm{k}$. The probability density function of Y can be written thus:

| $y$ | 0 | $k$ |
| :---: | :---: | :---: |
| $\mathrm{P}(\mathrm{Y}=\mathrm{y})$ | $\mathrm{P}(\mathrm{X}<\mathrm{k})$ | $\mathrm{P}(\mathrm{X}>k)$ |

Hence,

$$
\mathrm{E}(\mathrm{Y})=\mathrm{OP}(\mathrm{X}<\mathrm{k})+\mathrm{kP}(\mathrm{X}>\mathrm{k})
$$

That is

$$
\mathrm{E}(\mathrm{Y})=\mathrm{kP}(\mathrm{X} \geq \mathrm{k}) .
$$

Since the variable $\mathrm{X} \geq \mathrm{Y}$ for all possible values, we have

$$
\mathrm{E}(\mathrm{X}) \geq \mathrm{E}(\mathrm{Y})=\mathrm{kP}(\mathrm{X} \geq \mathrm{k}),
$$

Thus,

$$
\begin{equation*}
\mathrm{P}(\mathrm{X} \geq \mathrm{k}) \leq \frac{E(X)}{k} . \tag{2}
\end{equation*}
$$

Equation (2) is called the Markov inequality and can be generalized thus: For any $\mathrm{j} \geq 0, \mathrm{k}$ $>0$

$$
\begin{equation*}
\mathrm{P}\{|\mathrm{~W}| \geq \mathrm{k}\} \leq \frac{E I W I^{j}}{k^{j}} \tag{3}
\end{equation*}
$$

The proof of Chebychev's inequality is an immediate consequences of (3) by putting $\mathrm{j}=$ 2 and $\mathrm{W}=\mathrm{X}-\mu$, we obtain
P $\{|X-\mu| \geq k\} \leq \frac{E(X-\mu)^{2}}{k^{2}}=\frac{\sigma^{2}}{k^{2}}$
Since $(X-\mu)^{2} \geq k^{2}<=\Rightarrow|X-\mu|>k$, we have

$$
\mathrm{P}\{|\mathrm{X}-\mu|>\mathrm{k}\}=\mathrm{P}\left\{(\mathrm{X}-\mu)^{2} \geq \mathrm{k}^{2}\right\} \leq \frac{\sigma^{2}}{k^{2}}
$$

Thus

$$
\mathrm{P}\{|\mathrm{X}-\mu| \leq \mathrm{k}\} \leq \frac{\sigma^{2}}{k^{2}}
$$

Example 8.1
Let X be a random variable having Poisson distribution with mean $\lambda$ and variance $\sigma^{2}$. Use Chebychev's inequality to show that (i) $\mathrm{P}\{\mathrm{P}|\mathrm{X}-\lambda| \geq 1\} \leq \lambda$ (ii) $\mathrm{P}\left(X>\frac{3 \lambda}{2}\right) \leq \frac{4}{\lambda}$.

## Solution .

Using Chebychev's inequality with $\mu=\lambda$, and $\sigma^{2}=\lambda$ we have
(i) $\quad \mathrm{P}\{|\mathrm{X}-\mu| \geq \mathrm{k}\} \leq \frac{\lambda}{k^{2}}$.

Putting $\mathrm{k}=1$ we obtain

$$
\mathrm{P}\{|\mathrm{X}-\mu| \geq \mathrm{k}\} \leq \lambda .
$$

(ii) $\operatorname{Let} \frac{\sigma^{2}}{\mathrm{k}^{2}}=\frac{4}{\lambda}===>\sigma^{2}=\frac{4 k^{2}}{\lambda}$

On substituting for $\sigma^{2}$ we have

$$
\lambda^{2}=4 \mathrm{k}^{2}, \mathrm{k}^{2}=\left(\frac{\lambda}{2}\right)^{2}, k=\frac{\lambda}{2} .
$$

Thus

$$
\mathrm{P}\left\{|\mathrm{X}-\mu| \geq \frac{\lambda}{2}\right\} \leq \frac{4}{\lambda} .
$$

Since $|X-\lambda| \geq \frac{\lambda}{2}$ if and only if $X-\lambda<\frac{-\lambda}{2}$ or $X-\lambda>\lambda / 2$, we see that

$$
\begin{gathered}
\mathrm{P}\left\{|\mathrm{X}-\lambda| \geq \frac{\lambda}{2}\right\}=\mathrm{P}\left\{\mathrm{X}-\lambda<-\frac{\lambda}{2}\right)+P\left(X-\lambda>\frac{\lambda}{2}\right) \\
=\mathrm{P}\left(\left(X<\frac{\lambda}{2}\right)+P\left(X>\frac{3 \lambda}{2}\right) \leq \frac{4}{\lambda}\right.
\end{gathered}
$$

Since $\mathrm{P}\left(X<\frac{\lambda}{2}\right) \geq$, we have

$$
\mathrm{P}\left(X>\frac{3 \lambda}{2}\right) \leq \frac{4}{\lambda}
$$

### 8.2 The Law of Large Numbers of Bernoulli Trails

Let $\mathrm{X}_{1}, \mathrm{X}_{2}, \ldots, \mathrm{X}_{\mathrm{n}}$ be n independent and identically distributed Bernoulli random variables and let $\mathrm{X}=\mathrm{X}_{1}+\mathrm{X}_{2}+\ldots+\mathrm{X}_{\mathrm{n}}$ be Binomial random variables (number of successes), with parameters $n$ and $p$. The mean and variable of $X$ are $n p$ and $n p q$ respectively.
The mean $\mu$ grows as n increases but the standard deviation grows only as $\sqrt{n}$, Using Chebychev's inequality

$$
\mathrm{P}\{|\mathrm{X}-\mathrm{np}|>\varepsilon\} \leq \frac{n p q}{\varepsilon^{2}} \leq \frac{n}{\varepsilon^{2}} .
$$

## Theorem 8.2

Let X be the number of successes in n independent Bernoulli trails with probability p of success. For any $\varepsilon>0$.

$$
P\left\{I \frac{X}{n}-P I>\varepsilon\right\} \leq \frac{p q}{n \epsilon^{2}} \leq \frac{1}{4 \epsilon^{2} n}
$$

and

$$
\lim _{n \rightarrow \infty} P\left\{I \frac{X}{n}-P I>\varepsilon\right\}=0
$$

Proof:
Applying Chebychev's inequality

$$
\begin{aligned}
& E\left(\frac{X}{n}\right)=P, \operatorname{Var}\left(\frac{X}{n}\right)=\frac{1}{n^{2}} \cdot n p q=\frac{p q}{n} \\
& \frac{\operatorname{Var}\left(\frac{X}{n}\right)}{\epsilon^{2}}=\frac{p q}{n \epsilon^{2}}->0 \text { as } n->\infty \\
& p q=(1-p) p \leq \frac{1}{4} \text { for all } p, 0 \leq p<1
\end{aligned}
$$

Hence

$$
P\left\{\left|\frac{X}{n}-p\right| \geq \epsilon\right\}->0 \text { as } n->\infty
$$

This means that for large number we can be almost certain that $\frac{X}{n}$ will be very close to probability p of success. This shows that the relative frequency of success in independent Bernoulli trails converges (in a probabilistic sense) to the theoretical probability p of success at each trail. This important result can be stated more precisely as the law of large numbers.

## The Law of Large Numbers

### 8.3 The Weak Law of Large Numbers:

Let $\mathrm{X}_{1}, \mathrm{X}_{2}, \ldots, \mathrm{X}_{\mathrm{n}}$ be independent and identically distribution random variables with all $E\left(X_{i}^{2}\right)<\infty$ and let $S_{n}-X_{1}+X_{2}+\ldots+X_{h}$.
We know that

$$
\begin{aligned}
& \mathrm{E}\left(\mathrm{X}_{1}\right)=\mathrm{E}\left(\mathrm{X}_{2}\right)=\ldots \mathrm{E}\left(\mathrm{X}_{\mathrm{n}}\right), \mathrm{E}\left(\mathrm{~S}_{\mathrm{n}}\right)=\mathrm{nE}\left(\mathrm{X}_{1}\right) \text { and } \operatorname{Var}\left(\mathrm{S}_{\mathrm{n}}\right)=\mathrm{n} \operatorname{Var} \mathrm{X}_{1} \\
& E\left(\frac{S_{n}}{n}\right)=\frac{1}{n} E\left(S_{n}\right)=\frac{1}{n} \cdot n E\left(X_{1}\right)=E\left(X_{1}\right) \\
& \operatorname{Var}\left(\frac{S_{n}}{n}\right)=\frac{1}{n^{2}} \operatorname{Var}\left(S_{n}\right)=\frac{n \operatorname{Var} X_{1}}{n^{2}}=\frac{1}{n} \operatorname{Var}\left(X_{1}\right)
\end{aligned}
$$

This shows that expectation of $\frac{S}{n}$ is equal to the expectation of $X_{i}$ and the standard deviation of $\frac{S_{n}}{n}$ is

$$
\sqrt{\left\{\frac{\operatorname{Var} X}{n}\right\}}=\frac{S t d X_{1}}{\sqrt{n}}
$$

Which tends to zero as $n$ tends to infinity. Thus, the distribution of $\mathrm{S}_{\mathrm{n}} / \mathrm{n}$ becomes more and more concentrated near $\mathrm{E}\left(\mathrm{X}_{1}\right)$.
We state the more general result in the following theorem.
Theorem 8.3: A (WLLN) Weak Law of Large Numbers for Independent Random Variables. Let $X_{1}, X_{2} \ldots X_{n}$ be independent and identically distributed random variables with finite mean $\mu$ and $\sigma^{2}$. Let $S_{n}=X_{1}-X_{2}+\ldots+X_{n}$. then for $\delta>0$.

$$
\begin{equation*}
\lim _{n \rightarrow \infty} P\left(\left|\frac{S_{n}}{n}-\mu\right|>\delta\right)=0 \tag{4}
\end{equation*}
$$

## Proof:

Applying Chebychev's inequality to $\frac{s_{n}}{n}$, we have

$$
\begin{aligned}
& \mu=E\left(\frac{S_{n}}{n}\right) \cdot \operatorname{Var}\left(\frac{S_{n}}{n}\right)=\frac{1}{n^{2}} \operatorname{Var}\left(S_{n}\right) \\
& P\left\{\left|\frac{1}{k} S_{n}-E(X)\right|>\delta\right\} \leq \frac{2 \sigma^{2} X}{\sigma^{2} n}
\end{aligned}
$$

For at least one k satisfying $\mathrm{n} \leq \mathrm{k} \leq \mathrm{m}\}$.

## Corollary 1:

Let $\mathrm{f}(\mathrm{x})$ be a continuous real function on $[0,1]$. Then as $\mathrm{n}->\infty$ uniformly with respect to $\mathrm{p} \varepsilon[0,1]$

$$
E\left\{f\left(\frac{s_{n}}{n}\right)\right\} \rightarrow f(p)
$$

## Corollary II: Weierstress Approximation Theorem.

Let $f(X)$ be a continuous real function on $[0,1]$ defined on the real interval $0 \leq p \leq 1$ and let

$$
\mathrm{P}_{\mathrm{n}}(\mathrm{p})=\sum_{k=0}^{n} f\left(\frac{k}{n}\right)^{\mathrm{n}} \mathrm{C}_{\mathrm{k}} \mathrm{p}^{\mathrm{k}}(1-\mathrm{p})^{\mathrm{n}-\mathrm{k}}
$$

Then $P_{n}(p)->\infty f(p)$ as $n->\infty$ and the convergence is uniform in $p . P_{n}(x)$ is called the Bernstein Polynomials.

## Theorem 8.5

A WLLN for independent but not necessarily identical random variables.
Let $\mathrm{X}_{1}, \mathrm{X}_{2}, \ldots \mathrm{X}_{\mathrm{n}}$ be independent random variables with all
$\mathrm{E}\left(\left(\mathrm{X}^{2}\right)<\infty\right.$ and let $\mathrm{S}_{\mathrm{n}}=\mathrm{X}_{1}+\mathrm{X}_{2}+\ldots+\mathrm{X}_{\mathrm{n}}$ and $\mu=\mathrm{E}\left(\frac{S_{n}}{n}\right)$, then

$$
P\left\{\left|\frac{S_{n}}{n}-\mu_{n}\right| \geq \epsilon\right\} \leq \frac{1}{\epsilon^{2} n^{2}}\left\{\operatorname{Var}\left(X_{1}\right)+\operatorname{Var}\left(X_{2}\right)+\cdots+\operatorname{Var}\left(X_{n}\right)\right\} . \varepsilon>0 .
$$

When $\operatorname{VarX}_{\mathrm{i}} \leq \mathrm{M}$ for all I, that is when the variances are all bounded bya constant which does not depend on $n$, then we have

$$
P\left\{\left|\frac{S_{n}}{n}-\mu_{n}\right| \geq \epsilon\right\} \leq \frac{M}{\epsilon^{2} n}->0 \text { as } n->\infty
$$

### 8.5 The Central Limit Theorem

The central limit theorem is a fundamental result in the theory and application of probability. The law of large numbers asserts that $\frac{S_{n}}{n}$ in a series of n independent trails
with constant probability p of success in one trail tends (in a certain probabilistic sense) to p as n increases. But this assertion does not tell us anything about the distribution of $\frac{s_{n}}{n}$ as $n$ becomes large. The answer to this question is given by the so called central limit theorem. The theorem asserts that under quite general conditions the sum of independent variables has the Normal distribution in the limit.

Theorem 8.6: Central limit theorem
Let $X_{1}, X_{2}, \ldots, X_{n}$ be a sequence of independent random variables with $E\left(X_{i}\right)=\mu$ and $\operatorname{Var}\left(X_{i}\right)=\sigma_{i}^{2} I=1,2, \ldots$ Let $S_{n}=X_{1}+X_{2}+\ldots+X_{n}$. Then under general conditions,

$$
Z_{n}=\frac{S_{n}-E\left(S_{n}\right)}{\sqrt{\operatorname{Var} S_{n}}}=\frac{S_{n}-\sum_{i=1}^{n} \mu_{i}}{\sqrt{\sum_{i=1}^{n}{\sigma_{i}^{2}}^{2}}}
$$

Has approximately the standard Normal distribution.

## The Identically Distribution Case

## Theorem 8.7

Let $\mathrm{X}_{1}, \mathrm{X}_{2}, \ldots, \mathrm{X}_{\mathrm{n}}$ be independent identically distributed random variables. Then
(i) $\quad Z_{n}=\frac{s_{n}-n \mu}{\sqrt{n \sigma^{2}}}$
(ii) $\quad Z_{n}=\frac{\frac{s_{n}}{n}-\mu}{\sqrt{\sigma^{2} / n}}$
tend to the standard normal distribution as $n->\infty$.
What is remarkable about this theorem is that all we need to know about X is its mean and variance and there is no need to specify the nature of its distribution. Also $\underline{X}$ can be discrete, continuous or both. The outline of the proof is given below,

## Proof:

Let $\mathrm{M}_{\mathrm{X}},(\mathrm{t})=\mathrm{E}\left(\mathrm{e}^{\mathrm{tX}}\right), \mathrm{S}_{\mathrm{n}}(\mathrm{t})=\left[\mathrm{E}\left(\mathrm{e}^{\mathrm{tX}}\right)\right]^{\mathrm{n}}$
Let $\mathrm{Z}_{\mathrm{n}}=\frac{s n-n \mu}{\sqrt{n \sigma^{2}}}=\frac{s n}{\sqrt{n \sigma}}-\sqrt{n} . \frac{\mu}{\sigma}$.
The m.g.f of $Z_{n}$ is

$$
M_{z_{n}}(t)=e^{(\sqrt{n \mu / \sigma) t}}\left[M_{X}\left(\frac{t}{\sigma \sqrt{n}}\right)\right]^{n}
$$

Taking log we have

$$
\operatorname{In} M_{Z_{n}}(t)=-\sqrt{n} \frac{\mu}{\sigma} t-n \operatorname{In} M_{X}\left(\frac{1}{\sigma \sqrt{n}}\right) .
$$

Using Maclaurin series

$$
M(t)=1+M^{\prime}(0) t+M^{\prime}, \frac{(0) t^{2}}{2!}+\cdots
$$

From above we have

$$
\begin{equation*}
\operatorname{In} M_{Z_{n}}(t)=-\sqrt{n} \frac{\mu t}{\sigma} t+n \operatorname{In}\left[1+\frac{\mu t}{\sigma \sqrt{n}}+\frac{\left(\mu^{2}-\sigma^{2}\right) t^{2}}{2 n \sigma^{2}}+A\right] \tag{7}
\end{equation*}
$$

where A is the remainder term from Maclaurin series. Similarly, when the Maclaurin series

$$
\operatorname{In}(1+\mathrm{x})=\mathrm{x}-\frac{x^{2}}{2}+\frac{x^{3}}{3}+\cdots
$$

is used to expand $\operatorname{In}\left(1+\frac{\mu t}{\sqrt{n \sigma}}+\frac{\left(\mu^{2}+\sigma^{2}\right)}{n \sigma^{2}} t+A\right)$.setting $x=\frac{\mu t}{\sqrt{n \sigma}}+\frac{\left(\mu^{2}+\sigma^{2}\right) t^{2}}{2 n \sigma^{2}}+A$, we find that
$\operatorname{In}\left(1+\frac{\mu t}{\sqrt{n \sigma}}+\frac{\left(\mu^{2}+\sigma^{2}\right)}{n \sigma^{2}} t+A\right)$
$=\frac{\mu t}{\sqrt{n \sigma}}+\frac{\left(\mu^{2}+\sigma^{2}\right)}{n \sigma^{2}} t+A-\frac{1}{2}\left[\frac{\mu t}{\sqrt{n \sigma}}+\frac{\left(\mu^{2}+\sigma^{2}\right)}{n \sigma^{2}} t+A\right]^{2}+\cdots$
It is left as an exercise to show that for large $n$.

$$
\left|\frac{\mu t}{\sqrt{n \sigma}}+\frac{\left(\mu^{2}+\sigma^{2}\right)}{2 n \sigma^{2}}+A\right|<1 .
$$

On substituting in (7) we obtain

$$
\begin{aligned}
\operatorname{In} M_{Z_{n}}(t)= & -\sqrt{n} \frac{\mu t}{\sigma} \\
& +n\left\{\frac{\mu t}{\sigma \sqrt{n}}+\frac{\left(\mu^{2}-\mu^{2}\right)}{2 n \sigma^{2}}+A-\frac{1}{2}\left[\frac{\mu t}{\sigma \sqrt{n}}+\frac{\left(\mu^{2}+\sigma^{2}\right) t^{2}}{2 n \sigma^{2}}+A\right]^{2}+\ldots\right\}
\end{aligned}
$$

It can easily be shown that as $n->\infty$

$$
\operatorname{In} M_{Z_{n}}(t)=\frac{t^{2}}{2} .
$$

Hence,

$$
\lim _{n \rightarrow \infty} M_{Z_{n}}(t)=e^{t^{2} / 2},
$$

the moment generating function of a random variable having the standard normal distribution.

## Theorem

Let $\mathrm{X}_{\mathrm{n}}-\mathrm{n}>1$, and X be random variables such that $\lim _{n \rightarrow \infty} M_{X_{\infty}}(t)=M_{X}(t),-\infty<t<$ $\infty$. Then Lim FXnx $=$ FXxat all points where $F X x$ is continuous.

## Example 8.2

A boy throws a fair die 100 times. What is the probability that his mean score will exceed 3.

Let X represent the outcome of each toss.
Possible values of X are 1, 2, 3, 4, 5, 6.
$\mathrm{E}(\mathrm{X})=3.5 . \operatorname{Var}(\mathrm{X})=2.92$.
That is $\mu=3.5 . \sigma^{2}=2.92$
Let X be the mean score. By the central limit theorem X is normally distributed with mean 3.5 and $\operatorname{Var} \sigma^{2} / n$.

$$
\frac{\sigma^{2}}{n}=\frac{2.92}{100} .
$$

Hence,

$$
Z=\frac{\bar{X}-3.5}{\sqrt{0.029}}
$$

has a standard normal distribution.

$$
P(\bar{X}>3)=P\left(Z>\frac{-0.5}{0.170}\right)=P(Z>-2.94)=0.9984
$$

## Example 8.3

Marks in an I.Q examination are normally distributed with mean 55 and standard deviation 10 . What is the probability that
(i) the mean mark of a group of 10 students will be above 50
(ii) the mean mark of a group of 20 students will be between 40 and 50 .
(iii) the sum of the marks of the 10 students will be less than 500 .

## Solution

Let $X_{1}, X_{2}, \ldots X_{10}$ be the mark scored by each student respectively.

$$
\begin{aligned}
& \mathrm{E}\left(\mathrm{X}_{1}\right)=\mathrm{E}\left(\mathrm{X}_{2}\right)=\ldots=\mathrm{E}\left(\mathrm{X}_{10}\right)=55 \\
& \sigma_{X_{1}}=\sigma_{X_{2}}=\sigma_{X_{n}}=10 .
\end{aligned}
$$

(i) $\bar{X}=$ mean, be the central limit theory (assuming $\mathrm{n}=10$ is large enough for this distribution) $\frac{\bar{X}-55}{\sigma / \sqrt{n}}$ has a standard Normal distribution.

$$
\begin{aligned}
& \frac{\bar{X}-55}{10 / \sqrt{10}}=\frac{\bar{X}-55}{\sqrt{10}} \\
& P(\bar{X}>50)=P\left(\frac{\bar{X}-55}{\sqrt{10}}>\frac{50-55}{\sqrt{10}}\right)=0.9306
\end{aligned}
$$

(ii) The mean mark of a group of 20 students between will be between 40 and 50 . In this case, $\mathrm{n}=20$.

$$
\begin{aligned}
& P(40<\bar{X}<50)=P(\bar{X}<50)-P(\bar{X} \leq 40) \\
& P(\bar{X} \leq 40)=P\left(z \leq \frac{40-55}{\sqrt{5}}\right)=P(Z \leq-3 \sqrt{5})=0.00 \\
& P(\bar{X}<50)=P\left(z<\frac{50-55}{\sqrt{5}}\right)=P(Z<-\sqrt{5})=0.01
\end{aligned}
$$

Hence

$$
\mathrm{P}(40<\bar{X}<50)=0.01-0.00=0.01
$$

(iii) $\mathrm{S}_{10}=\mathrm{X}_{1}+\mathrm{X}_{2}+\ldots+\mathrm{X}_{10}$
$\frac{s_{10}-n \mu}{\sqrt{n \sigma^{2}}}$ has a standard Normal

$$
\frac{s_{10}-550}{\sqrt{1000}}=\frac{500-550}{10 \sqrt{10}}=\frac{-50}{10 \sqrt{10}}=-1.53
$$

Hence,

$$
\mathrm{P}\left(\mathrm{~S}_{\mathrm{n}}<500\right)=0.057 .
$$

### 8.6 Normal Approximately to the Binomial Distribution

Let $\mathrm{X}_{1}, \mathrm{X}_{2}, \ldots, \mathrm{X}_{\mathrm{n}}$ be n independent identically distributed Bernoulli trails where

$$
X_{i}=\left\{\begin{array}{lc}
1 & \text { with probability } \mathrm{P} \\
0 & \text { with probability } 1-\mathrm{P}
\end{array}\right.
$$

$\mathrm{E}\left(\mathrm{X}_{\mathrm{i}}\right)=\mathrm{p}$ and $\operatorname{Var}\left(\mathrm{X}_{\mathrm{i}}\right)=\mathrm{p}(1-\mathrm{p})$. From theorem 2, the distribution

$$
\frac{S_{n}-E\left(S_{n}\right)}{\sqrt{n \sigma^{2}}}-->\text { standard Normal. }
$$

where $S_{n}=X_{1}+X_{2}+\ldots+X_{n}$

$$
\begin{gathered}
E\left(S_{n}\right)=n p \\
\operatorname{Var}\left(S_{n}\right)=n p(1-p), \sigma^{2}=p(1-p) .
\end{gathered}
$$

Note that $S_{\mathrm{n}}$ has binomial distribution with mean np and variance $\mathrm{np}(1-\mathrm{P})$.

$$
\mathrm{P}\left(\mathrm{~S}_{\mathrm{n}} \leq \mathrm{y}\right)=\sum_{k=0}^{y} \quad{ }^{\mathrm{n}} \mathrm{C}_{\mathrm{k}} \mathrm{P}^{\mathrm{k}}(1-\mathrm{p})^{\mathrm{n}-\mathrm{k}}
$$

For large $n$

$$
\begin{aligned}
& \mathrm{P}\left(\mathrm{~S}_{\mathrm{n}} \leq \mathrm{y}\right)=P\left\{Z_{n} \leq \frac{y-n p}{\sqrt{n p(1-p)}}\right\} \\
& \varphi=\left(\frac{y-n p}{\sqrt{n p(1-p)}}\right)
\end{aligned}
$$

where $\mathrm{Z}_{\mathrm{n}}$ is standard Normal random variable. Thus, from above we have

$$
F_{S_{n}}(y)=P\left(S_{n} \leq y\right)=\sum_{k=0}^{y} \quad{ }^{\mathrm{n}} \mathrm{C}_{\mathrm{k}} \mathrm{p}^{\mathrm{k}}(1-\mathrm{p})^{\mathrm{n}-\mathrm{k}}=\varphi\left(\frac{y-n p}{n p(1-p)}\right)
$$

## Example 8.3

It is claimed that $60 \%$ of the voters I a given ward are going to vote for party A. assuming that all voters will vote, and that there are 100 voters. What is the probability that Party A receives at least 50 votes.

Let $\mathrm{p}=0.6$. prob. Of voting for $\mathrm{A} . \mathrm{n}=100$. Assuming independent voting $P\left(S_{n}>50\right)=\sum_{k=50}^{100} 100 \mathrm{C}_{\mathrm{k}} \mathrm{p}^{\mathrm{k}}(1-\mathrm{p})^{100-\mathrm{k}}=\sum_{k=50}^{100} 100 \mathrm{C}_{\mathrm{k}}(0.6)^{\mathrm{k}}(0.4)^{100-\mathrm{k}}$
Using normal approximation (6) above, we have
$\mathrm{P}\left(\mathrm{S}_{\mathrm{n}}>50\right)=P\left(Z \quad \geq \frac{50-100 \times 0.6}{\sqrt{100(0.6)(0.4)}}\right)=P\left(Z \geq \frac{50-60}{\sqrt{24}}\right)=0.9793$

### 8.7 The Normal Approximation to the Poisson Distribution

If a random variable $X$ has a poisson distribution whose mean is $\lambda$, then for large $\lambda$ the standardized random variable.

$$
Z=\frac{x-\lambda}{\sqrt{\lambda}}
$$

has a standard Normal Distribution. you will recall that $\mathrm{E}(\mathrm{X})=\lambda, \operatorname{Var}(\mathrm{X})=\lambda$, Continuity correction may be introduced.

It has been shown that the approximation is good for $\lambda>5$.

## Example 8.4

A system suffers random breakdown at a constant rate of 10 per month. Find the probability that there will be at least 8 breakdowns in any month.

Let X be the number of time the system breaks down in any month. Then X has a poisson distribution with $\lambda=10$. Thus

$$
P(X>8)=\sum_{k=8}^{\infty} \frac{e^{10}(10)^{k}}{k!}
$$

Using Normal approximation, we have

$$
\begin{gathered}
\frac{X-10}{\sqrt{10}} \text { has } \mathrm{N}(0.1) \\
P(X \geq 8)=P\left(Z>\frac{8-10}{\sqrt{10}}\right)=P\left(Z>\frac{-2}{\sqrt{10}}\right)=0.7357
\end{gathered}
$$

1. It is claimed that $30 \%$ of the voters in a given local government area are going to vote for party A in a local government election. Assuming that all voters will vote, there are 4000 voters and the claim is based on a proper (unbiased) sampling method. What is the probability that Party A will receive more than 1,500 votes.
2. (a) Suppose that a system consists of components each of which has a probability of 0.05 of failing during a specific time. The system functions properly when at least 150 components function. Assuming these components function independently of one another, what is the probability that the system functions properly during a specific time.
(b) Suppose that the above system is made of n components each having probability of 0.90 of not failing during a given time. The system will
function if at least 80 percent of the components function properly. Determine n so that the probability that the system functions properly during a specific time is 0.96 .
